

Laundering Black Lives Matter

The "*Democrat*" Party and its ideological allies in the corrupt leftist media stubbornly refuse to criticize ***Black Lives Matter*** (BLM,) which has routinely engaged in rioting, arson, aggravated assault, looting and even murder. Yet, the harshest criticism any "*Democrats*" or their corrupt leftist media allies can muster is to refer to BLM riots as "*peaceful protests*."

The inability of the left to criticize BLM may occur because it is a valuable source for what are probably illegal campaign contributions to many "*Democrat*" candidates. That is, "*Democrats*" have a vested financial interest in BLM: In return for BLM's contributions to the DNC or "*Democrat*" officials, "*blue*" mayors and district attorneys ignore its violence and terrorism. Police are told to "*stand down*," while county DAs release BLM members without charges.

BLM is a *non-profit* organization that has lately received tens-of-millions in contributions, but it does not have tax-exempt status from the IRS. This fact requires BLM to be very inventive at "*end-running*" its legal obligation to pay income taxes on donations laundered through its organization.

All contributions to BLM are "*redirected*" to ***ActBlue Charities***, through an arrangement the IRS refers to as "*Fiscal Sponsorship*." ***ActBlue Charities*** is a 501 (c) (3) tax-exempt organization, **AND THE COMMUNIST WING OF THE DEMOCRAT NATIONAL COMMITTEE'S FUNDRAISING ACTIVITIES**. Funds it collects are then laundered through ***Thousand Currents*** which, in turn, circuitously returns those original donations to BLM as "*grants*." These "*bundled*" donations are never taxed, and donors are able to deduct their contributions.

Thousand Currents is also a 501 (c) 3, whose stated purpose is to fund those working to develop "*alternative economic models*" for nations and communities across the globe. In other words, those promoting Marxism in all its treacherous and sordid varieties.

This complicated financing scheme allows donations to BLM to be both tax deductible AND available to "*Democrat*" candidates for public office. **ActBlue Charities** operates as a **LAUNDERING** conduit for BLM donations, and in return, it charges approximately 4% on all funds it launders through BLM and **ActBlue**.

This means that money laundered through BLM and ActBlue can eventually find its way into the Biden/Harris Campaign -- or to campaigns of other "Democrat" candidates -- and despite murky and dubious origins, all those "bundled" monies can be treated as legitimate campaign contributions made by INDIVIDUAL donors.

Since 2004, **ActBlue** has collected over **\$5 Billion** in donations. And, in just the last three years, BLM and **ActBlue** have jointly collected tens of millions of dollars in donations, many of them from incredibly stupid and gullible U.S. corporations who seem unable to say "no" to black criminal terrorists.

ActBlue distributes these funds to **Thousand Currents**, which acts as a management company for BLM by performing all its legal, financial, administrative, accounting, and government compliance functions. The rest go back to BLM to fund its terrorist activities.

The usual liars on the left claim that reportage on this circuitous money laundering arrangement is a "*right-wing conspiracy theory*," and that

donations to BLM through **ActBlue** go only to BLM and no other group. We know that's a lie from statements made on **ActBlue's** own website.

Now you know why all those fake and corrupt news media sources dance all over the lot when it comes to criticizing the illegal and violent behavior of *Black Live Matter*, and why they never tell you who those associated with BLM *REALLY* are!
