"Buzzy" Ginsberg Bites the Dust

"Nothing became her in life like the leaving..."

Like all Jewish-communist traitors who have labored to subvert the U.S. Constitution over the past 100 years, Ruth "*Buzzy*" Ginsberg was a treacherously dishonest foe of America's *Founding*, Christianity, the U.S. Constitution, nationalism, American patriotism, and even the very principle of *Rule of Law*.

She and her co-conspirators at the **American Communist Liars Union** (ACLU,) devoted their lives to serving Zionism and International Socialism by working to subvert many traditional and common-sense principles of the Constitution. Sneaky and dishonest Jews like Ginsberg have wrought profound damage on the Constitution, while displaying their animus for the men who drafted it. Their contempt stems from the limitations the Constitution imposes on their capacity to subvert and destroy the United States. Specifically, it obstructs their efforts to usher in a Zionist and socialist "New World Order," run by the same folks who brought you the Bolshevik Revolution.

In 2009, Ginsberg stated on Egyptian television that she could not recommend the U.S. Constitution as a model for Egypt's newly-founded government. Her criticism of the Constitution – the document she swore an oath to support and defend – was based on it being *"rather old,"* as she put it.

Instead, she recommended that Egypt adopt the new **South African Constitution**, a document that has permitted black and communist savages to gird up their courage and their loins before massacring over 3,000 white farmers and their families, whose lands they then seized with impunity.

Her phony concern with the age of the Constitution is one of those diversionary tactics -- or *"sleight-of-hand"* techniques -- that Marxist Jews have mastered.
