

Al Capone Was a Piker !

I've written for years that there are two basic "*wings*" of the so-called "*Democrat*" Party: One is its communist wing, led by the Obamas and Ocasio-Cortez; and the other is the organized crime wing, run by Joe Biden and the Clintons.

Recently, I learned an interesting fact supporting my theory that Joe Biden is nothing less than an organized crime figure: One of the business partners of Biden's son Hunter at *Rosemont Seneca Partners* is a guy named James Bulger. Another partner, Devon Archer served with Hunter Biden on the Board of the corrupt Ukrainian natural gas company named ***Burisma Holdings***. Both Hunter Biden and Archer were paid \$83,000 per month to serve on its Board, despite having no knowledge of the natural gas industry, no ability to speak Russian or Ukrainian, and despite the fact that neither could find the Ukraine on a map.

They are also alleged to have laundered large sums of ill-gotten wealth for the corrupt Ukrainian owner of ***Burisma***, whose name is Mykola Zlochevsky. (Pronounced "*Zo-low-shev-ski*.") Archer and Bulger were both partners of Hunter Biden at ***Rosemont Seneca Partners***, an investment firm that received \$1.5 Billion from communist China to invest for them.

In return for its investment in ***Rosemont Seneca Partners***, China's communist government -- through its ***Aviation Industry Corporation of China*** -- was permitted to purchase ***Henniges Automotive***, a producer of

strategic technologies that reduce engine vibration to enhance its "stealth" features. Despite the deal involving "stealth" technology and its role in national security, the deal was brokered by **Rosemont Seneca Partners** and approved by Barack Hussein Obama.

The obvious but unpleasant conclusion is that Joe Biden was shaking down the Ukraine, while selling the influence of the Vice President's office to further the ambitions of two mortal enemies, China and Russia. His family were the direct beneficiaries of his bribery, his son Hunter in particular.

That's why Russia was so desperate to see Hillary Clinton win the Presidency in 2016: Putin and the criminals who run Russia recognized the organized crime wing of the "Democrat" party were people with whom they could "do business." Hillary Clinton proved this in 2012 when, as *Secretary of State*, she sold Russia 20% of U.S. Uranium reserves in return for hundreds of millions in contributions by Russian oligarchs to the **Clinton Family Crime Foundation**.
