

Biden's Tangled Web

("Oh, what a tangled web we weave...when first we practice to deceive.")

10% to "*the Big Guy*" (Joe Biden)

Tony Bobulinsky confirmed that Joe Biden was to receive 10% of all proceeds from the Chinese bribe money, but Joe Biden's "*cut*" was to be held by Hunter Biden.
