

# Concrete Evidence

The Jews' Media reflexively parrot the lie that there's no evidence of voter fraud from the November 3rd Presidential Election. It's the same lie they've repeated for more than a decade of elections, because it alleviates any obligation on their part to investigate their political allies in the "*Democrat*" Party, where **ALL** U.S. election fraud occurs.

Isolated instances of vote fraud don't carry much weight with judicial authorities because alone, they can't influence the outcome of an election. To get the attention of federal judges, there must be **systemic or widespread evidence of vote fraud**. Fortunately, the "*Democrat*" Party's vote-fraud machine overplayed its hand so badly in attempting to defeat Donald Trump, it left a rich trail of evidence in the process. Let's take a look at some of that evidence.

The strongest evidence of **Constitutional issues** surrounding the November 3rd election occurred in Pennsylvania prior to the election. PA's Jewish Governor attempted to impose radical changes to that state's election laws, including granting the authority to local election boards to count ballots received **AFTER** election day. When the state's Republican legislature rejected these dubious "*reforms*," PA Governor Wolf used his state Supreme Court to impose them by fiat.

Former Federal Appeals Court Judge Kenneth Starr called Governor Wolf's actions "*flagrant*" violations of Constitutional Law. That's because the U.S. Constitution -- the document Jewish "*Democrats*" despise -- grants state legislatures the sole authority to establish the details of their state's election laws. It does **NOT** grant state courts any such authority.

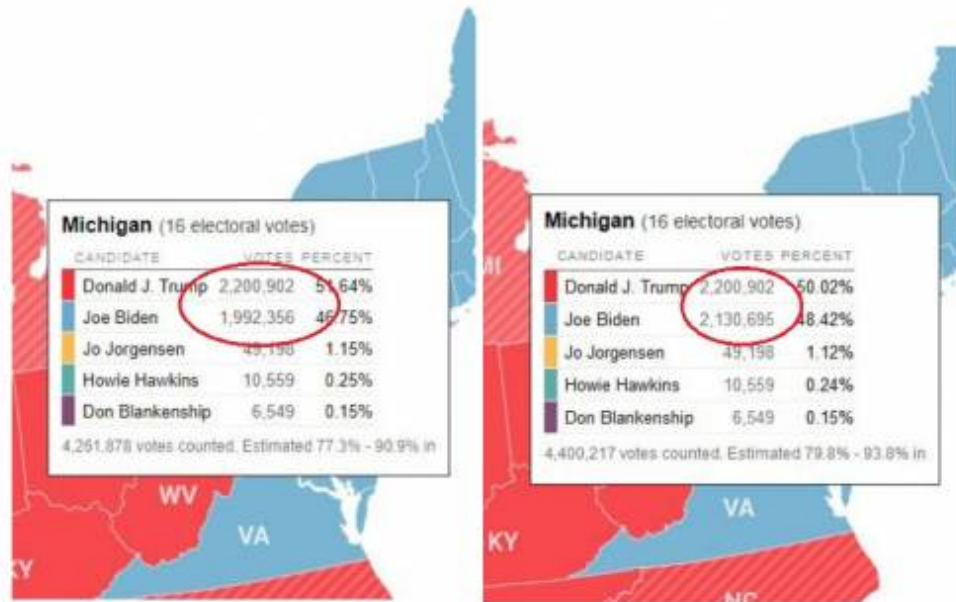
This could be the issue that will permit the Supreme Court of the United States (SCOTUS,) to pry the lid off of systemic "*Democrat*" election fraud. Once Trump's attorneys can reach the threshold of a Constitutional issue, SCOTUS can begin to consider actual evidence of voter fraud.

For example, many poll "*observers*" in Detroit and Philadelphia were prevented from observing the actions of poll-workers and some were actually escorted out for daring to object to being rendered ineffective. This is contrary to state and federal law, and the actions of PA election officials suggest that they were engaged in behaviors they wished to hide from the public.

**Examples of activities they may have been trying to hide from the public involved two large "*dumps*" of ballots that occurred in Detroit and Milwaukee in the early morning hours of November 4th, after poll workers inexplicably stopped counting and left. This created a situation where no one was present to observe or validate the handling of all those ballots. According to Michigan's own election officials, all 139,339 ballots that mysteriously appeared in Detroit that night went to Biden, nearly a statistical impossibility.**

We know this occurred because Michigan election authorities provided a continuously updated table of votes received by both Biden and Trump, and Biden's count can be observed to jump by 139,339 votes in the early morning hours of November 4th. In the meantime, there were no changes in the vote count going to Donald Trump. Election authorities disingenuously attributed this phenomenon to a "*statistical error*."

Immediately prior to this anomaly, a number of suitcases and coolers were observed being rolled into the ***Detroit Voting Center*** in the early morning hours of November 4th. It is suspected that they were stuffed with fraudulent ballots rather than beverages.



A similar example occurred on November 4th in Wisconsin, where the number of reported statewide votes revealed a stunning 90% turnout. Seven Wards in Milwaukee reported more votes cast than the number of registered voters found within their Voter Rolls. This anomaly is probably attributable to the 100,000 ballots that were mysteriously "dumped" under the cover of darkness in the early morning hours of November 4th, when no one was present to monitor the disposition of ballots except Milwaukee "Democrat" election officials.

In a separate incident, 5,500 ballots cast for President Trump were wrongly credited to Joe Biden in one Michigan county. This time the error was attributed to a computer software "glitch." The two computer software programs involved -- named "Hammer" and "Scorecard" by their proprietor, **Dominion Voting Systems** -- are used in 65 Michigan counties and in 1,300 large population centers in 29 U.S. states. Besides Michigan, they were used on November 3rd in Georgia, Pennsylvania, Arizona, and, Nevada, each of which is currently a contested state.

The *Hammer* and *Scorecard* software used by ***Dominion Voting Systems*** in Michigan was found to have caused "*glitches*" in Georgia, as well. Proving there's no such thing as a coincidence in politics, the Jewish husbands of Nancy Pelosi and Dianne Feinstein are both investors in ***Dominion Voting Systems***. One D.C. lobbyist for ***Dominion Voting Systems*** is Nancy Pelosi's former *Chief of Staff*, Nadeam Elshami.

Meanwhile, the FBI is investigating ***U.S. Postal Service*** employees in Traverse City, Michigan following claims by a whistleblower that he was ordered to fraudulently date ballots arriving after November 3rd. According to the whistleblower, a supervisor ordered postal workers to postmark late ballots by backdating them to "*November 3rd*," thereby enabling them to be counted. The scandal was exposed by James O'Keefe's ***Project Veritas***.

The president's personal attorney, Rudy Giuliani claims that Trump's legal team has found hundreds of dead people who voted in PA and NV from the grave. Since these dead people needed a great deal of assistance casting their ballot, there was clearly **systemic fraud involved**.



**While it may be an uphill battle to successfully demonstrate the fraudulent and criminal nature of "*Democrat*" participation in the November 3rd election, it offers an unprecedented opportunity for the Trump legal team and the U.S. Supreme Court to purge systemic voter fraud from U.S. elections for generations to come. That's because "*Democrats*" left a significant trail of evidence.**

When things seemed particularly bleak during the initial stages of the *Battle of the Bulge* in December of 1944, of all the generals gathered at Verdun for an emergency meeting, ONLY George Patton recognized the opportunity the situation offered. He remarked to Eisenhower and other assembled generals that "*The Kraut's stuck his head in a meat grinder, and this time I've got the handle.*"

Hopefully, Trump's legal challenge offers a similar opportunity and will produce an equally fortuitous result.
