

U.C.R. = Untrue, Corrupted & Ridiculous

Recently, the *Uniform Crime Report for 2019* were released by the FBI and a summary of its "*highlights*" were reprinted on this website. Unfortunately, the imbeciles at the FBI who compile such data drew some absurd and laughable conclusions, so it was removed by the site's webmaster.

The FBI claims that 52.5% of all 2019 "*hate crimes*" reported by law enforcement in the U.S. were committed by whites. This should have been immediately recognizable as absurd on its face, even by the corrupt and demonstrably dishonest fools who practice legerdemain at the FBI.

It is an empirical fact that blacks are 50 times more likely to commit an interracial violent crime against whites than the reverse. That is, in the FBI's own 2018 Uniform Crime Reports (UCRs,) blacks committed 10 times as many violent crimes against whites (593,598) as the reverse (56,394,) even though the white population is about five times as large as the black population.

Thus blacks are 50 times (5 X 10) more likely to commit a violent crime against a white than are whites likely to commit a violent crime against a black. This statistic is a far better indicator of the number of hate crimes committed in the U.S. each year, and it is also an infinitely better measure of which race commits the vast majority of hate crimes. Only a liar or a fool would conclude that whites exceed blacks in any statistical measure of so-called "*hate crimes*."

Clearly, there's a reluctance on the part of prosecutorial agencies to charge blacks with hate crimes, no matter how obvious the role that race hatred plays in the commission of a violent black-on-white crime. Race-hustlers may have succeeded in convincing stupid and dishonest blacks of the fraudulent notion that "*blacks cannot be racist*," so blacks probably engage in jury nullification when a black defendant is given the additional charge of a hate crime. Rather than risk an acquittal of a violent offender, prosecutors may forego the hate crime charge.

In 2017, a 22-year-old nigro named Frederick Demond Scott murdered five middle-aged whites in the Kansas City area. His victims were white men between the ages of 54 and 67, most of whom were fatally shot from behind by this cowardly and sub-human example of a truly savage and under-evolved species.

According to court records, in 2014 Scott threatened to shoot up a school and "*kill all white people*," but was not arrested for terrorist threats because of Black Skin Privilege. As if scripted by the Jews' Media, police said they "*did not know if the shootings were racially motivated*." One genius police spokeswoman stated she "*saw no clear motive*" for the killings.

This incident is hardly unique. In September of 2019, an unsuspecting 59 year-old white man named **John Weed** joined the body-count of innocent white victims murdered by sub-human, black rat-apes. He was the victim of two nigro "*youths*" who were entertaining themselves by engaging in the "*knockout game*" at a County Fair in Frederick, Maryland.

After the two rat-apes dropped Mr. Weed with a sucker-punch, they laughingly danced around his dead body and spat upon it, just as their primitive and savage ancestors have done for a million years. Neither murderous n*gger savage was charged with a hate crime and, in fact, both were given probation by the court.

Norman Bledsoe was that 75 year-old white man who was savagely beaten on videotape by a 20 year-old rat-n*gger in a Detroit nursing home back in May of 2020. The sub-human rat-ape beat Mr. Bledsoe for several minutes, giving him a broken jaw, broken fingers and broken ribs, injuries that eventually led to his death. The n*gger was not charged with a hate crime, although he divulged his motive by engaging in a social media tirade declaring that "***black people are supposed to rule the Earth.***"

Likewise, an elderly white couple in their 80s were hunted down and assassinated by a 29 year-old nigro stranger with a scoped rifle in May of 2020. Their murderer was named Sheldon Francis and the incident occurred in Delaware. The elderly couple were from Maryland and were innocently visiting their son's grave at a veteran's cemetery at the time of their murder.

Similarly, in 2017, an eight-month-old white baby named Reese Bowman was intentionally murdered at a daycare center on videotape. The child's nigress murderer, Leah Walden eventually pled guilty to first degree murder.

A police official described the videotaped incident as "*torture,*" and claimed that Walden can be seen swinging the baby by one arm, body-slammng her, and striking the baby. She also appeared to smother the baby with blankets and pillows, and is shown on the tape looking around furtively to ensure no witnesses observed her conduct.

A 40 year-old white mother of four named Wilma Hochstetler and her husband were returning from a construction site when they got a flat tire in Indianapolis, Indiana in September of 2020. The couple did not resist as a pack of violent and armed n*gger savages descended upon them to rob them and shot both parents as an afterthought, killing Wilma Hochstetler and wounding her husband. The police have denied there was any "*racial angle*" involved.

As in the case of Wilma Hochstetler and thousands like her, no matter how vicious and savage a black-on-white violent crime may be -- including even aggravated MURDER -- none of these black bastards were ever charged with a hate crime.

This demonstrates how worthless and unreliable the UCRs really are when it comes to this particular category. Such statistics are as fraudulent as the fabricated crime, itself, and we won't publish the lies of the left.
