In the Footsteps of Stalin

Some well-meaning conservatives and white nationalists argue that we should abandon the term "*communist*" because it is "*antiquated*" and no longer relevant in the 21st Century. Ironically, communism is a greater threat to America now than it has ever been: the difference from earlier eras is that communism is now an **INTERNAL THREAT** masquerading in the guise of the so-called "*Democrat*" Party, along with its Jews' Media comrades and the "deep state" they've created.

The hallmark of true freedom resides in the extent and quality of rights that a government recognizes and defends, and paramount among these is a legitimate and meaningful plebiscite. The U.S.S.R. Cuba and the Eastern Bloc nations all sponsored "*elections*," but they were as fraudulent as the enormous majorities most communist dictators received. It is no coincidence that America recently experienced its own stolen Presidential Election, resulting from massive voter fraud carefully orchestrated by the *New Communist Party of the United States of America* (New-CPUSA,) wrongly referred to as the "*Democrat*" Party.

Immediately following the stolen November election, pathological liars in the Jews Media like Chris Hayes at **MS-NBC**, Bolsheviks like AOC, and Jewish swamp creatures like former Clinton Labor Secretary Robert Reich proposed a "**Truth and Reconciliation Commission**" to punish Trump supporters for their political views. **Their inspiration for such an exercise** was the old Soviet "Gulag," whose purpose was to ensure that dissidents "GOT THEIR MINDS RIGHT."

A further glimpse into their true ideology was evident at the trial of General Michael Flynn. Despite conclusive proof that Flynn was innocent

and framed by corrupt Obama holdovers, the n*gger judge sitting on Flynn's four-year inquisition refused to dismiss his case **EVEN AFTER THE JUSTICE DEPARTMENT DROPPED ALL CHARGES AGAINST FLYNN**. In doing so, Judge Emmett Sullivan – a Clinton appointee – assumed the functions of both PROSECUTOR AND JUDGE by arbitrarily, illegally and unconstitutionally perpetuating Flynn's show trial for four years.

The Flynn case was an effort by the New-NCPUSA to scare away potential reformers by entrapping President Trump's *Director of National Security* using fabricated charges against him before the Trump Administration could even take office. Sullivan was merely following in the tradition of Soviet judge and prosecutor Andrey Vyshinski, who conducted the infamous *Moscow Show Trials* of the early 1930s. These were Stalin's device for exterminating political rivals.

The Flynn case was by no means the only "*show trial*" by communists who control America's "*deep state*." Its majority in the House enabled the New-CPUSA to Impeach President Trump using demonstrably false and fabricated charges. They even repeated the exercise while Trump was in the process of leaving office. This was reminiscent of Stalin sending a hit-squad of NKVD assassins to Mexico to murder Leon Trotsky, long after Trotsky had fled the Soviet Union and was no longer a threat.

The New-CPUSA is also engaged in a war against America's middleclass, or what communists refer to as the hated "bourgeoisie." It should now be obvious that the real purpose behind prolonged "lockdowns" of small businesses in New York, California, New Jersey, Michigan and other deep "blue" states is a broader strategy to destroy middle class entrepreneurs who built or own those businesses. Biden and his New-CPUSA allies who control blue cities and states recognize that small business owners are their GREATEST POLITICAL OPPOSITION, since most tend to be conservative, libertarian, Republican, or are at least independently-minded.

By using the pretext of the Wuhan Virus, politicians in the New-CPUSA knowingly *shuttered* millions of businesses and sabotaged the ability of their political opposition to earn a livelihood by bankrupting the businesses they've spent their adult lives building. This is reminiscent of the way Stalin intentionally starved to death 10 million middle-class Ukrainian "*Kulaks*" in 1932 and 1933 by forcibly confiscating their entire agricultural output.

By destroying small businesses, the New-CPUSA seeks to impose a new socialist agenda on America, where the middle-class is decimated and the impoverished masses that result are entirely dependent upon scraps from New-CPUSA commissars. Meanwhile, its political allies -- such as the plutocrats of *social media* -- are granted legislative favors and political protection in exchange for massive campaign contributions and their censoring of conservative opposition. In this sense, *Twitter, Facebook, Google* and *Apple* have not only joined the Jews' Media to become propagandists for the New-CPUSA, they have even become an American "*Nomenklatura*."

The New-CPUSA's war against the "*Bourgeoisie*" is one reason why police in *blue* cities were told to "*stand down*" while rioters looted and burned small businesses to the ground. It is also why no rioters were ever charged with a felony for torching or looting someone's business. In fact, many prominent New-CPUSA officials -- including now-Vice President *Commie* Harris -- established a **FUND TO POST BAIL** for those charged with violent felonies in several large cities.

That small businesses were arbitrarily, capriciously and strategically singled out for lockdowns was evident when *"big box"* stores like *Walmart, Target, Home Depot* and *Lowes* were allowed to remain open

despite the ongoing pandemic. Because of their enormous daily traffic, it is clear large retailers are **MORE LIKELY** than small businesses to help spread the China Virus, yet they were permitted to remain open, nonetheless. In return, they showered the New-CPUSA with campaign contributions in 2020.

Another anomaly was the New-CPUSA's prohibition against religious services in many blue states, even as abortion clinics, liquor stores and marijuana shops were permitted to remain open. With the exception of the "*lip service*" some give it, most New-CPUSA officials correctly recognize that religious faith cannot co-exist with Marxism and reject the "*Natural Rights*" philosophy of the Framers of the Constitution that our basic rights are bestowed upon us by God. That's why religion was cruelly suppressed in the Eastern Bloc, Cuba, China and most communist regimes, and why the New-CPUSA must suppress it here, as well.

George Orwell once stated that "*The most effective way to destroy people is to deny and obliterate their own understanding of their history*." The culture war waged against America by the New-CPUSA does NOT merely target Southern culture and its heroes, it targets every aspect of American culture since its founding. Even Lincoln's memory isn't safe from its commissars, nor is that of George Washington or any other Framer of the Constitution. Like the Bolsheviks, the New-CPUSA and their henchmen are intent on extinguishing America's historical and cultural traditions.

In this they have closely followed the Bolsheviks, who immediately set about destroying Russia's historical and cultural memory and "*rewriting*" history upon seizing power. In the Soviet Union, thousands of Christian Churches were burned to the ground or "*re-purposed*" by Bolsheviks, and most educational and historical texts were "*revised*." Meanwhile, the only sources of news available were state-sponsored organs of the *Communist Party of the Soviet Union*, which set about trying to brainwash the Russian people by creating a *cult of personality* surrounding Josef Stalin.

Finally, all would-be totalitarian communists find it essential to outlaw the private ownership of firearms -- lest the serfs should revolt -- so Immediately after the Bolshevik Revolution, the private ownership of firearms was prohibited by the *Communist Party of the Soviet Union*. Likewise, one of the very highest priorities of the Biden Administration and the New-CPUSA is to disarm America by whatever means are available, the Second Amendment notwithstanding. Biden has already floated a proposal to tax, register and ultimately confiscate what are ludicrously called "*assault rifles*."

It should be patently obvious that the many similarities between the modern "*Democrat*" Party and Soviet communism are not some sort of coincidence, and that to reject the term "*communist*" when characterizing the modern "*Democrat*" Party would be a grave error. No better or more appropriate framework exists for chronicling the lies and subversion of the *New Communist Party of the United States*.
