Obituary: *Semper Fi* Chuck Pitman

One of the courageous but unsung heroes of our age, Lt. Gen Charles "Chuck" Pitman, passed away on February 13th of this year after a lengthy battle with cancer. He served in the **Marine Corps** for almost 40 years, service that included three combat tours in Viet Nam as a helicopter pilot.

In addition to being shot down 7 times by enemy fire, Lt. General Pitman earned numerous *Silver Stars*, *Distinguished Flying Crosses* and a *Purple Heart*. **Ironically, the mission of which he was most proud was unauthorized, and almost led to his Court Martial.**

On *New Year's Eve* of 1972 in New Orleans, a negro serial murderer named Mark James Essex began a week-long bloodbath that eventually claimed nine lives and dozens of wounded victims. Armed with a rifle, Essex began his spree by targeting police officers at the NOPD's central lock-up facility before safely sneaking away.

Essex continued his killing spree a week later at a New Orleans motel by murdering two employees and a honeymooning couple, and then set fire to several rooms in order to murder police when they arrived at the scene. There he murdered three police officers and wounded several more.

Having watched this seemingly unending horror on TV, Lt. Colonel Pitman then conceived the plan for which he is most renowned. He requisitioned a helicopter without authorization from the *Belle Chase Marine Air Unit Station* that he commanded, and organized a volunteer flight crew to assist him.

With each man risking both his life and his career that night, Pitman then flew to an area near the scene of the on-going shooting and motel fire where several armed NOPD officers were invited to board his helicopter.

Despite having to retreat several times under sniper fire by Mark Essex, Lt. Colonel Pitman carefully timed his mission by flying over the rooftop of the building where the sniper was concealed. When the sniper emerged to fire upon his helicopter, Lt. Colonel Pitman illuminated the sniper with a powerful spotlight, thus enabling police snipers to ventilate the black bastard more than 200 times.



Instead of receiving a medal, Lt. Colonel Pitman initially faced a Court Martial for unauthorized use of military equipment and personnel. Thankfully, U.S. Congressman F. Edward Ebert of New Orleans was Chairman of the **House Armed Services Committee** at the time, thus preempting any possibility of military discipline for Lt. Colonel Pitman.

To borrow a line from the film "*High Noon*," if you have to ask why Chuck Pitman would risk his life and career in such a manner, you probably wouldn't understand the answer. May he rest in peace.

Black Crime Roundup: The response to my *Black Crime Roundup* in the March, 2020 issue was overwhelming. Several Members asked me to include a similar column in every issue, and I will try to oblige.

"Democrats": The political party that wants to administer your health care -- and the U.S. economy in general -- can't even run its own *Iowa Caucus*. "Standing" as a Strategy

Not long after Obama was nominated in 2008, many conservatives took an interest in efforts to challenge his nomination and later, his inauguration because of legitimate concerns about his dubious Constitutional eligibility. Many cases were brought before a number of federal courts, including the Supreme Court, but these cases never got anywhere. This wrongly led many to conclude that there were no real issues involved.

All those cases claiming credible proof of Obama's lack of Constitutional eligibility never got to the stage where evidence was examined, because they were rejected **based upon each Plaintiff's lack of standing to bring their case before the court!** For instance, the case brought before the Supreme Court alleging irregularities in the *2008 Pennsylvania Democrat Primary* by Pennsylvania's Attorney General was dismissed for that reason.

The case involved allegations of cheating by the Obama campaign in Pennsylvania's Democratic Primary, handing the state's Delegates to Obama. How a chief judicial officer of an American State can lack standing in such a matter as the eligibility of a candidate running for President of the United States is difficult to imagine.

In a nutshell, the matter of standing means that complainants have no right under law to bring their case before the court of jurisdiction. For instance, Plaintiffs cannot sue Defendants on behalf of another person not a Plaintiff to the action. Such a decision was rendered in one of the many "Confederate monuments" cases heard by a federal court.

In that case, the **Sons of Confederate Veterans** were found to be without standing to litigate to protect histor-

ic memorials to their ancestors. One has to wonder just who *would* have standing if the descendants of those for whom the monuments were erected -- and who often *paid for those monuments* -- do not? The natural conclusion is that *no one* does!

The use of "standing" is a powerful and effective technique often used by the federal judiciary with the potential to render existing laws null and void if local, state and federal authorities choose to ignore or abridge them. The court never gets to the stage of actually ruling on the merits of the issue at hand, even if they involve actual violations of law. Indeed, they never get close.

The courts often use the concept of "standing" when politically incorrect groups with whom they are not sympathetic seek relief from oppressive or improper actions of local and state government officials. This is particularly true of efforts to save Confederate Heritage or Southern history, now very much in danger of being obliterated by Cultural Marxists.

If the courts refuse to *recognize* those seeking redress, then they never have to consider the merits of a case, or be concerned about whether or not the authorities are breaking or ignoring the law. In effect, *both the government and the courts* may indulge in criminal activity without consequence.

Those judges involved do not openly break their oaths to "uphold the law," they simply prevent those involved from bringing their complaints *before* the courts in the first place! In effect, violators of the law and those appointed to protect us from violators work together to

devise a process to remove many legal protections guaranteed to the American people.

This same strategy has allowed the courts to "*legislate from the bench*" by "cherry-picking" easy cases that reinforce judicial doctrines they like, and by rejecting the standing of Plaintiffs in "tough" cases that might work to

undermine doctrines or legal principles they happen to prefer.

Who has standing? Apparently, only those whose aims and goals are acceptable to the political elite and their henchmen in the federal judiciary. Outside of that incestuous relationship, few other Americans appear to have legal standing in the opinion of the American federal judiciary.

Religion Editor's Column *Hiding an Obvious Truth* By Dr. Ed DeVries

(This letter from Dr. DeVries was submitted to a number of Southern Baptist publications, but rejected by all of them. He intends to bring these concerns to the attention of the Southern Baptist Convention to be held in June.)

Congratulations to the author of the recent **Baptist News** column titled "**ERLC, George Soros and the Evangelical Immigration Table.**" The **Southern Baptist "leadership"** -- on whose behalf it was written -- has done a masterful job of hiding the truth in plain sight.

It dismisses recent **Breitbart.com** reportage exposing the **Evangelical Immigration Table** (EIT) as nothing more than a leftist organization masquerading as representatives of "conservative" Christianity.

Their agenda is evident in their having deceived the governors of several "red" states into believing the latter will lose the "Christian" vote if they don't flood their respective states with Muslims and other dubious "refugees," a fact the column appears to confirm.

The column also denies **Breitbart.com's** claim that the Southern Baptist Convention -- through its **Ethics and Religious Liberty Commission (ERLC)** -- has been funded by Marxist billionaire George Soros. The author of the editorial emphatically states that "*These claims have proved to be false.*"

However, a few paragraphs later he concedes: that "*EIT is supported by the National Immigration Forum,*" an organization chaired by George Soros who also awarded it grant money.

The author first denies that George Soros has funded the EIT, but then describes the very money-trail, itself! The fact that Soros money was first **LAUNDERED** through the **National Immigration Forum** -- before reaching the **EIT** -- doesn't make it any less tainted.

George Soros has contributed hundreds of millions of dollars to more than 200 leftist groups, many of whom advocate "open borders" and amnesty for Third World illegal aliens. The circuitous route of Soros funding is designed to obscure its origin and confuse gullible individuals like the author of the editorial. Or, as I suggested above, its purpose is to hide the truth in plain sight so **Southern Baptist** readers won't notice.

Another troubling fact hidden in plain sight appears in the quote by Ali Noorani, Executive Director of the **National Immigration Forum**: "*Quite simply, there has never been a single penny from George Soros that has gone toward the work of the Evangelical Immigration Table.*"

A search of the **National Immigration Forum** shows it to be a Muslim advocacy group, and Mr. Noorani a Muslim of Pakistani descent.

Strange Doings in Iowa

The political party that wants to "manage" your health care -- and the entire U.S. economy -- can't even run its own *Iowa Democrat Caucuses*. The cause is uncertain, but the **Democrat National Committee** has such a long tradition of voter fraud, it's hard not to conclude that chicanery was involved.

After releasing the vote totals 72 hours late, it seems the final tallies were larger than initial tallies in many precincts. This isn't supposed to happen. That's because the rules dictate that only those present at 7 p.m. were eligible to participate in the Iowa Caucuses, and anyone arriving later was ineligible.

Yet, in at least 77 of Iowa's 1,711 precincts, the number of participants actually grew during the course of the evening. For example, in WDM-312, there were 61 votes reported for the *initial* preference round, but 339 votes reported for the *final* preference round. Other precincts reported zero for the initial preference round, but hundreds for the final preference round.

In addition to "Democrat" incompetence, it's pretty obvious that some form of deceit was also involved, most likely a conspiracy to harm the candidacy of Bernie Sanders (Socialist -- Moscow,) from winning the Democrat Nomination for President. This is reminiscent of the cabal by the Clinton Campaign and DNC to deny Sanders the 2016 nomination.

Immediately prior to the Iowa Caucus on February 3rd, a campaign was orchestrated among high-profile "Democrats" to damage Sanders. Their purpose was to derail the nomination of an avowed socialist in order to allow the "Democrat" Party to preserve some pretense of "moderation."

Not only is Sanders an avowed socialist, but he is feared by the "Democrats" for a great many things he has said

Black Crime Roundup, June of 2020

The Jews' Media exhibit a real aversion to the truth by vilifying anyone who accurately reports incidents of black-on-white violent crime. That's because Interracial violent crime only serves their purposes when the victim is black and the perpetrator is white.

The Jews' Media's standard narrative is one in which innocent black victims are constantly under assault by violent white assailants, and those who disprove this false narrative are subject to their full wrath and fury.

In fact, the ***Southern Prevarication Lie Center*** (SPLC,) has even accused the CofCC of spreading what it calls "***a false narrative of a victimized white majority under siege by allegedly violent people of color in the United States.***"

To advance their false narrative, any white-on-black violent crime committed in the U.S. instantly becomes the "lead" story for days on end: Meanwhile, black-on-white violent crimes are routinely "*spiked*" by the Jews' Media and receive only local coverage, if any.

If the Jews' Media were to report black-on-white violent crime the way they sensationalize the far less frequent cases of white-on-black violent crime, we rubes in "flyover country" might get the wrong idea about *Africanus criminalis*, that 13% of the population that commits 90% of all murders in the U.S. each year.

Below is a small sampling of the many violent black-on-white incidents that give *Africanus criminalis* its well-deserved reputation, one that the Jews' Media has been unable to successfully "*spike*" because of the evolution of a conservative and alternative news media that includes the CofCC.

LAW ENFORCEMENT: Nick Hopkins was a white, 33 year-old Illinois State Trooper who was in the process of serving a search warrant on a nigro drug-dealer in East St. Louis, Illinois when he was shot to death in August of 2019. Trooper Hopkins was a 10 year veteran of the ***Illinois State Police*** and leaves behind three children and a wife.

His murderer is a subhuman rat-ape with a long arrest record, who has been charged with first degree murder, being an armed habitual criminal, unlawful possession of a weapon by a felon, two counts of armed violence and three counts of unlawful delivery of a controlled substance. (A fairly common *resume* for this species of baboon.)

Michael Langsdorf was a St. Louis County police officer who was murdered by a subhuman rat-ape in North St. Louis County when he responded to a call in June of 2019. His murderer was a 26 year-old black bastard from North Carolina with a long and violent arrest record, who was attempting to pass a bad check to a store owner. Officer Langsdorf may have been struck and disabled by another nigro in the store as he was scuffling with his murderer.

ELDERLY WOMEN: **Francis Jane Schultz** was a 73 year-old white woman whose husband found her bound with duct tape and shot to death in their Zachary, Louisiana home in March of 2019. She was murdered in the course of a burglary and robbery by three black rat-monkeys, one of whom had previously worked for the elderly couple. Apparently, this was how this baboon's under-evolved Frontal Lobes decided to repay their generosity and kindness.

Mimi Perry was a 63 year-old white woman who was struck in the head with a blunt object, and then raped and strangled in her home by her next-door nig in Fayetteville, Georgia. Typical of this species, her murderer had three prior felony convictions, including one for an earlier stabbing of another neighbor at a different location.

YOUNG PEOPLE: **Johnny Peluyera** was an innocent, 16 year-old white teen who was attempting to sell an ***Xbox*** to some black bastards in Gary, Indiana when they murdered him to avoid paying for it. He was gunned down in June of 2019, as his father helplessly watched in the family car nearby. His assailants were described as two black males in their late teens or early 20s.

Mark Mason: This young man was the eight year-old son of a very foolish white woman in New Castle, Pennsylvania who made the mistake of dating a black rat-ape who had previously served a 20-year sentence for murder in an earlier stabbing.

In July of 2019, an argument between the woman and her boyfriend led him to assault her, and then abduct two of the woman's children in her vehicle before stabbing one of them to death. The cowardly black bastard screamed "die" to his innocent victim as he repeatedly stabbed the eight year-old to death in front of two siblings.

Amber Horton: This 18 year-old white girl was shot and killed in Charlotte, North Carolina by a nigra who may have mistaken the car in which she was riding for another vehicle. The rat-monkey who murdered her in June of 2019 was out on bond on a recent weapons charge.

Madison Harris was a white teenager in Biloxi, Mississippi, who was murdered by five teenage nigras during a robbery in February of 2020. Police indicated the five Biloxi teens attempted to rob Harris with a firearm, which led to an altercation during which Harris was shot to death. One nigra was out on bond for an earlier aggravated assault.

WHITE FEMALES: 22 Elderly White Women were all victims of a black baboon in Texas, who murdered these women while ostensibly caring for them. Their serial murderer is an illegal immigrant and nigra from Kenya named Bill Chemirmir, who -- for some odd reason -- has been the recipient of very little coverage by the Jews' Media for his misdeeds!

As any self-respecting illegal alien and nigro serial murderer would do, he stole their valuables immediately after murdering them. At least he doesn't appear to have raped them, as most nigs would have done.

Melanie Crow: This white woman was a 39 year-old mother of two who became a victim of the church shootings in Antioch, Tennessee in September of 2017. Her murderer was a nig from the Sudan, who shot and murdered her in an incident TOTALLY ignored by the Jews' Media.

Fortunately, rat-monkeys are so stupid and incompetent that the rest of his shooting victims managed to survive. This black baboon even shot himself by accident but, unfortunately, survived his self-inflicted wound.

WHITE MALES: Serge Fournier was a 74 year-old white man who was pushed off a bus to his death when his head struck the pavement in Las Vegas, Nevada. He was killed by a fat, ugly, loud-mouthed female rat-nigress in March of 2019. The nigress had been arrested twice before for assault. This kindly gentleman made the mistake of asking her to be nicer to people after hearing her curse out other passengers on the bus.

Joey Allen was a 41 year-old white man who worked as a convenience store clerk in Salt Lake City, Utah. He was stabbed to death in July of 2019 by an illegal alien and rat-monkey from the Ivory Coast. Allen was the father of four girls and a boy.

Despite being in the U.S. for a short time, the sub-human garbage that murdered Joey Allen managed to run up an extensive criminal record including assault, domestic assault, unauthorized control of a vehicle, failing to stop for law enforcement and numerous alcohol-related offenses.

There are two common elements that stand out in each of these sad incidents: With the exception of law enforcement officers, in each case the victim would have significantly improved their chances of survival if they had merely taken the trouble to arm themselves against what is a violent, savage, witless and predatory black criminal element.

Moreover, each would have been safer had they been more wary of blacks in their vicinity, and taken greater precautions.

The Problem of “Filtered” News

One of my personal heroes was prolific author and syndicated columnist M. Stanton Evans, whom we lost in 2015 to cancer. Stan emphasized that the problem with the Corrupt Leftist Media wasn't merely the lies they report, but also **the facts they intentionally withhold from the public that undermine their leftist narratives.**

The practice of “filtering” the news is motivated by a desire to withhold evidence from conservative, Republican, Libertarian and other patriots whom the Corrupt Leftist Media view as mortal enemies. At the same time, it keeps the Corrupt Leftist Media's patrons oblivious to any evidence that might encourage them to question their allegiance to the “Democrat” Party, those dominant media narratives, or even their Marxist ideology.

This phenomenon has created an enormous disparity between the evidence available to patrons of **Fox News** and the **Rush Limbaugh Show**, and that available to our ideological enemies who are spoon-fed by the Corrupt Leftist Media. Perhaps more than anything else, this factor accounts for the divisiveness that now plagues our political system. It certainly explains a lot of the venom directed at President Trump by many on the left.

For example, a day before New Hampshire's 2020 *Democrat Primary*, Sean Hannity asked some woman at a “Democrat” rally what she thought of Joe Biden getting the Ukrainian prosecutor fired who was investigating Joe Biden's son serving on the Board of **Burisma Holdings**. It was patently obvious from her dead eyes and vacant stare that she had never heard of Hunter Biden, **Burisma Holdings**, or even the Ukraine.

Several examples of “filtered” news have been exposed in detail by the **CITIZENS INFORMER** in past years. These include efforts by the Corrupt Leftist Media to prevent

the general public from exposure to the following empirical facts:

The death penalty is a very effective general deterrent to murder; Concealed Carry Laws are the most effective means of reducing violent crime ever studied; and finally, the disparity between white and black incomes isn't caused by racism, it's exclusively the result of higher average white IQs.

The following are two more recent examples of news filtered by the Corrupt Leftist Media, with very significant consequences for a well-informed electorate:

Fusion GPS: Robert Mueller testified before the **House Judiciary** and **House Intelligence Committees** on July 24, 2019 after publication of his “*Special Counsel's Report*.” His purpose was to answer questions about conclusions from his two-year witch hunt into President Trump's alleged role in “*colluding*” with Russia to influence the 2016 Presidential Election.

Yet, after \$36 Million, two years of the *Special Counsel's* inquisition of President Trump -- including 1,000 subpoenas, 500 interviews of Trump campaign personnel, and 14 foreign nations visited -- *Special Counsel* Robert Mueller confessed to these two House committees that he had never heard of **Fusion GPS**, the opposition research firm that concocted the phony “*Steele Dossier*.”

This is staggering, since the *Steele Dossier* was the sole justification or “*predicate*” submitted as evidence to obtain warrants from the **Foreign Intelligence Surveillance Court** to spy on candidate Trump beginning in mid-2016, and continuing after President Trump was elected to office.

During Mueller's testimony, Rep. Steve Chabot of Ohio innocently asked Mueller if he knew the name of the firm that compiled the *Steele Dossier*. In reply to Chabot, Mueller testified **"I'm not familiar with that."** Later, in reply to questions about *Fusion GPS* and its owner, Glen Simpson, Mueller responded that such questions **"...are outside my purview."**

For the Special Counsel never to have heard of *Fusion GPS* in the course of his investigation into "Russian collusion" by Donald Trump, is akin to the Warren Commission never having heard of Lee Harvey Oswald in their investigation of the Kennedy assassination.

If true, this can only mean one thing: Robert Mueller's sources of information are so limited, biased and skewed, that even after two years of scrutinizing every aspect of Donald Trump's life, Mueller didn't know what **EVERY FOX NEWS VIEWER AND RUSH LIMBAUGH LISTENER HAS KNOWN FOR TWO FULL YEARS**. It also demonstrated that he had little participation in the investigation by his own office.

Biden Videotape: In a September 19, 2019 interview of Rudy Giuliani on the **Communist News Network** (CNN), its village idiot, Chris Cuomo, claimed never to have heard of the famous videotape in which former Vice President Joe Biden incriminated himself in front of the **Council on Foreign Relations** (CFR).

Earlier -- in January of 2018 -- Biden crowed to a roomful of the CFR's globalist plutocrats that he successfully engineered the firing of Ukrainian Prosecutor-General Victor Shokin, by threatening to withhold over one billion dollars in U.S. aid to the Ukraine unless this was done.

Shokin was in the process of investigating **Burisma Holdings**, a natural gas company owned by a crooked former Ukrainian official, who paid Joe Biden's son \$83,000 per month to serve on its Board. This, despite the fact that Hunter Biden had no background in energy, is not a geologist, can't speak Ukrainian or Russian, and probably

couldn't find the Ukraine on a map. Hunter Biden was also discharged from the **Naval Reserve** for testing positive for cocaine.

Hunter Biden's lack of qualifications is significant because CNN shills have repeatedly stated that there's no basis for any investigation of Joe or Hunter Biden's business dealings in the Ukraine. CNN did exactly what all Corrupt Leftist Media organs do when a "Democrat" runs afoul of the law: It pretended the allegation was already investigated and proved to be **"unfounded."**

In the course of his interview with Chris Cuomo on CNN, Giuliani stated candidly that Biden apparently committed bribery of a foreign official, whereupon Cuomo reflexively asks for proof or evidence. Giuliani replied **"You know what the proof is? Joe Biden, 2018, January, in front of the Council on Foreign Relations saying the whole thing."**

In a skeptical manner, Cuomo asks: **"He said 'I'm gonna give you this money if you get rid of the prosecutor'?"** To which Giuliani responds, **"Hundred percent! Exactly!"** Cuomo then asks Giuliani to provide evidence of the allegation: **"Send me the transcripts."**

Of course, the videotape has been around for quite some time. It has been viewed by practically every **Fox News** viewer many times over in the past two years, and its audio portion is familiar to every **Rush Limbaugh** listener.

Cuomo has inadvertently exposed the basic problem inherent in CNN routinely filtering all news that is harmful to its leftist allies: It means that even CNN reporters, editors and other shills don't know what the average Fox News viewer or Rush Limbaugh listener has known for two full years or more.

This phenomenon of "filtered" news should be quite familiar by now. Not only is this technique routinely employed to frame President Trump, it has been used for decades to further the cultural Marxism that animates the Corrupt Leftist Media and its allies.

Appeasement as a Strategy

Appeasement: pacifying a potential enemy to avoid conflict, often by granting concessions.

Concession: compromising in some way, often grudgingly.

Compromise: resolution of a dispute where all parties agree to accept less than originally demanded.

Ronald Reagan used to tell the story of the man trying to drain a swamp who finds himself surrounded by hungry alligators. In a panic, he starts throwing his fellow workers to the monsters to protect himself. But of course, the end result is still the same: he *will* inevitably be eaten, as well! Reagan was illustrating the futility of appeasement, which gains nothing for the user but a little time.

Many people confuse appeasement with compromise. This is easy if one is inherently honest. In a compromise, *both* sides accept what is agreed upon as the final determination. But when one party considers the agreement a step *towards* the desired end rather than the solution to the problem, it becomes an act of “appeasement” no matter what it is called.

For far too long, conservatives have believed that each “compromise” we have made with our liberal foes is the final answer to that particular problem, only to find out that in a day, or a week, or a year, the liberals are back demanding more and greater “compromises” on an issue that conservatives previously considered settled.

Now, the first time this happens, no blame obtains to conservatives. We were honest, but our adversaries were not. However, the *second* -- not to mention every time thereafter -- that the *same* thing happens, we lose the right to call ourselves ill-used. We cannot blame “the other side” when we knew, or *should* have known, that the concept of “compromise” existed on our part alone, while our adversaries were determined to continue to work towards total victory, however incrementally.

Indeed, I am willing to state unequivocally, that the results of all of our negotiations with liberals represent not compromise but appeasement and to continue down that particular road will end in our extermination. Whatever we choose to call these arrangements, they are concessions on our part. To paraphrase Reagan yet again, if it looks like a duck, and it walks like a duck and it quacks

like a duck, *it's a duck*, no matter what you choose to call it.

Given this situation, how *should* we deal with our adversaries? Is there *any* hope of valid compromise or are we dealing with an unrelenting, uncompromising, intractable mindset that will settle for nothing less than the total victory? Sadly, the answer to the above questions is, “no,” there *is* no hope and “yes” we are dealing with a mindset that will accept nothing less than the total extermination of whites, Western culture, our history and our heritage.

Furthermore, no amount of manifest good will or conciliatory gestures change a damned thing. If we do not recognize this existing state of affairs, we are not only woefully naïve – stupid, actually -- but we blunder towards our own extermination.

Having accepted the matter as it stands, what then is left for us to do? First, we must not “concede” or “compromise” without understanding that such “solutions” are nothing but appeasement, whose only benefit to us is to create a momentary lull in the struggle. Secondly, we must make *much* better use of any such lull in order to forestall total defeat, even if we cannot achieve total victory. We must also understand that all such “agreements” are incremental victories for our adversaries. We must also understand that there must come a time when these “incremental victories” cannot be overcome, and there is no way to forestall our defeat.

Most important, we must be prepared to use the time to regroup and go on the offensive rather than congratulating ourselves that we have at least forestalled total defeat, even if only temporarily. At the *very least* we must understand that the other side will *never* compromise on its stated goals, period. Therefore we must develop strategies to use when the enemy's assault is mo-

Looking Ahead

California will become insolvent at some future date, as surely as the Sun will rise in the East. It will almost certainly occur within the next decade, because there are a number of dramatic and irreversible trends that make this outcome inevitable and easily predictable. Symptomatic of California's infirmities is the fact that its state pension funds have **ONE TRILLION DOLLARS** in unfunded liabilities.

It's large population of low-skilled, illegal aliens – who don't speak English -- are an enormous financial drain on the state's resources and their numbers are exploding. Meanwhile, over-taxed but legitimate citizens are leaving California in droves each year, often taking their jobs or businesses with them.

One interesting fact to consider is that individual states cannot declare bankruptcy -- and “repudiate” their debts -- as cities and counties may legally do. This fact affords a golden opportunity for a GOP Congress and the Trump Administration to demand dramatic legal and financial reforms from California, in return for whatever bailout that state will ultimately request from U.S. taxpayers.

Border Wall: No matter who is President when the state's insolvency occurs, it should be the very highest priority to demand that California allow the **Department of Homeland Security** and the U.S. **Corps of Engineers** to erect a wall across the state's entire southern border with Mexico. Any state interference, particularly environmental objections, should void the federal government's financial assistance.

Sanctuary Status: Secondly, the federal government must demand an amendment to the state's Constitution prohibiting any form of “*sanctuary*” status for illegal aliens in California's cities, counties, or anywhere within

the state, itself. Interference by California officials with immigration authorities in pursuit of their lawful duties -- even California law enforcement officials -- should be treated as a violation of federal law and punishable by incarceration and a fine on each count.

Honest Elections: It would be wise for the *Department of Justice* to oversee or conduct a “*purge*” of the state's voter rolls. All counties should be required to participate and comply with the **National Voter Registration Act of 1993**. The purge should target ALL illegal voting, whether by non-citizens, dead people, fictitious names, duplicate names or household pets.

It might also be a good idea for state election officials at every level to post a bond guaranteeing their conduct. If found to be engaged in illegal conduct in the course of their electoral duties, they should forfeit their bond immediately after their conviction, and just before serving their prison sentences.

Welfare for Illegals: Finally, California should be required to adopt an amendment to its state constitution prohibiting it from dispensing any kind of welfare services to illegal aliens, including **TANF**, **SNAP** cards, **WIC** vouchers, **Medicaid**, **Section 8** vouchers, or any other free service that is intended for U.S. citizens.

It might also be prudent for Congress to insist that all those who have held elective office in California within the last decade should be prohibited from serving any additional terms. All statewide elected officials, state representatives and those elected to the state senate should be required to resign their offices: afterwards, they should be prohibited from running for public office in California for the duration of their natural lives.

A small committee of accountants, actuaries and attorneys should be appointed to administer the financial affairs of the state, until such time as fair and legitimate elections can be held.

So-called “Democrats” and cowardly Republican “RINOs” will balk at this idea. However, as the catastrophe in California continues to regress into anarchy, this will impose ever greater urgency upon Congress to act, and California to accept the reforms imposed upon them.

The Gay Agenda

What is presented here isn't rumor or lies or hearsay. I have witnessed it over the course of many years! Of course, not every homosexual is involved in advancing the "Gay Agenda," but there are very few who would not rejoice in its total victory.

We don't want to be condemned for being as nature made us. We only want the same tolerance as other people receive who are considered 'different.' Remember, we represent 10% of the population so we should not be singled out negatively!”***

This new demand was problematic, especially for Bible-believing Christians and Jews, because to *tolerate* is not the same as to *ignore*. Toleration included a demand that

others not judge the gay lifestyle as morally wrong. There were laws on "the books" against sodomy and other unnatural sex acts practiced by homosexuals, and to remove them from the books indicated a **societal acceptance** of what had previously been rejected both culturally and morally.

In the end, just as so much of the culture was changing for the worst, most Americans took the attitude that while they opposed removing legal prohibitions against homosexual acts, it was none of their business. Yet, it should have been a warning that homosexuals were prepared to **lie** to advance their cause by dishonestly representing their number as 10% rather than the two percent found by researchers.

Poetic Justice (Part 1)

Although credit is often mistakenly attributed to Shakespeare, it was the 17th Century literary critic Thomas Rymer who coined the term “*poetic justice*.” Poetic justice occurs when some particularly vile or menacing individual receives a fitting and appropriate end, and usually with irony in abundance.

The following are examples of poetic justice, and many are so perfectly appropriate that they even hint at the possibility of *Divine Intervention*:

Amy Biehl: Filled with the self-righteousness that leftist Jews seem to feel towards blacks with whom they never have contact, Amy Biehl traveled to **South Africa** in 1993 to help register them to vote in the 1994 **South African National Elections** that ended “*apartheid*.”

She must have assumed her degrees from **Stanford** would insulate her from the routine violence of black savages. However, to quote an African proverb, “*the leopard cannot change its spots*.”

That election almost immediately transitioned **South Africa** from a *First World* civilization into a *Third World* cesspool. It also ushered in a new era in which black communists and black savages gird up their courage and their loins before murdering white farm families and stealing their land with impunity.

In the course of her efforts to participate in the South African Elections, Amy Biehl was returning from a political meeting on August 24, 1993 when the vehicle she

was driving was stopped by a group of these same black savages she wished to liberate. They immediately pulled her from the car and stabbed and stoned her to death. Like any self-respecting “Third World” black would do, they of course robbed the victims as well.

Four sub-human, black rat-apes were arrested and charged with her murder, but after their convictions, all four were pardoned by **South Africa's** so-called “*Truth and Reconciliation Commission*.” The latter is anything BUT a source of “*truth*” or “*reconciliation*,” and their pardons are conclusive evidence that South Africa is now as lawless as Haiti, Zimbabwe, and every other black shit-hole.

If ever there were a perfect example of poetic justice, it is Amy Biehl's brutal and senseless murder at the hands of the same black savages she worked to “liberate.” It is hardly a coincidence that little in the way of a penalty was experienced by her murderers.

Amy Biehl and her tribe feel an insane impulse to empower the most violent, savage, witless and predatory race in human history. Julie Laible: This woman was raised on a farm in a nearly all-white region of Illinois. She studied Spanish at the **University of Illinois**, where she was greatly influenced by a

black teaching assistant who opened her eyes (*wink, wink*) to racial and ethnic injustice in America. At his suggestion, she attended graduate school at the **University of Texas at Austin**, where she could get all the exposure to Hispanics she might ever want.

For her Ph.D. dissertation, she studied predominately Hispanic high schools in the illusory hope of finding ways to improve the academic achievement of Hispanic students. She even traveled to Mexico to teach education courses to elementary school teachers.

A teacher who taught Miss Laible in the fourth grade and remained in touch with her stated, ***"She found her calling to help Hispanic people. It brought a sense of meaning to her life."***

In March of 1999, she was in route to visit her parents in Naples, Florida over Spring Break. As she drove South on I-75 in Manatee County, a 22-pound rock crashed through her windshield, killing her instantly. Juan Cardenas, a 19-year-old son of Mexican immigrants, was charged with second-degree murder for throwing the rock off an overpass.

Cardenas and a group of other Hispanic teenagers had spent hours entertaining themselves by throwing rocks at passing traffic. They began by throwing small rocks, and worked their way up to much heavier rocks. Cardenas and one of his friends, 17-year-old Jesus Dominguez, were tried and convicted of murder.

Steven Otter: Steven Otter was a self-righteous author and *"journalist,"* who routinely vilified other white people for what he charged was their *"misperception"* of black crime in South Africa.

In a truly delicious example of poetic justice, Otter's home was invaded on December 16, 2016 -- South Africa's *"Reconciliation Day"* -- by two black criminals who stabbed him to death. He died in the arms of his mixed-race "partner," Nathalie Williams.

Here is an example of Otter's writings, found in his book ***Khayelitsha***, (probably translates to *"shit-hole,"*) his memoirs from living in that rural township:

"I knew deep down that racism didn't make any sense, but I very often thought racist things. What unfolded in Khayelitsha, therefore, was a journey to the heart of my racism, the only journey powerful enough to drown out the racist voices of the majority within the white society of my youth."

In truth, Otter was just another foolish white race-traitor, who affiliated with violent, black, Marxist, revolutionary parties found in South Africa, including the ***Pan-African Congress***, and the ***Afro-Marxist Economic Freedom Fighters***.

Judging by their universal, genetic predisposition to steal and murder, Otter's assailants must not have read his book or his dispatches, and never learned how noble, innocent and peaceful they actually are.

In any event, had Otter listened to all those *"racist thoughts"* and *"racist voices"* from his childhood -- that he made it a point to reject -- he might very well be alive today to further lecture us about how wrong we all are about blacks and their savage and violent inclinations.

Kirsten Brydum: This was a 25 year-old *"social activist"* who was on a nationwide tour campaigning for Barack Hussein Obama for President. She was gunned down in New Orleans in 2008 by a nigro serial killer named Joseph Brant, who shot her in the head and then robbed her. Brant may also have raped her.

Brydum was in New Orleans with a group called ***Collective Autonomy***, which supposedly assists minorities and the *"underprivileged"* by indoctrinating them with Marxism and other lies fabricated by losers engaged in their phony *"class struggle."*

She was found dead after being shot in the head and robbed of what few possessions she had. Apparently, she was riding an old bicycle through the Ninth Ward after an evening spent socializing with friends before falling prey to Brant.

Her truly clueless mother stated, ***"I hope this will wake people up to activism and staying involved and speaking for people who can't."***

According to **Brookings**, "*Significant sectors of our society are dying prematurely from preventable deaths (deaths from despair,) and almost 20% of prime aged males are out of the labor force.*" High rates of opioid addiction and deaths are two measures of this phenomenon.

Another indicator of this trend is U.S. life expectancy for white males, which has been declining for much of the past decade. In contrast, blacks and Hispanics have continued to improve in terms of life expectancy, despite starting at lower levels than whites.

ON THE OTHER HAND, for decades, universal college education was touted as the path to an enlightened and prosperous future. Everyone was encouraged to go to college: As a result, the curriculum soon became *dumbed-down* to an unimaginable extent at most institutions. Meanwhile, so-called "blue-collar" jobs were denigrated by our political class, and those who filled them were routinely ignored, except when their votes were solicited by candidates for public office.

However, so-called "higher education" has become an enormously expensive scam, consisting of little more than four years of Marxist indoctrination and a curriculum consisting of worthless falsehoods. Except where technical training is an essential prerequisite -- as in the sciences, applied sciences and accounting -- what purpose does a Liberal Arts degree really serve anymore?

Rejecting "higher education" alleviates the staggering debt associated with student loans, avoids four years of Marxist indoctrination and nonsense, and allows for a great deal of personal freedom and self-expression.

Opportunities are boundless for ambitious individuals in the building trades -- such as carpenters, electricians, HVAC contractors, and other mechanical contractors -- because these are jobs most *Millennials* and *Gen-Xers* consider "beneath" them.

"And you shall know the truth, and the truth shall make you free." (John 8:32, New King James Version.)

Actually, since there are mathematical geniuses in all races and genders, it is a childish notion to consider mathematics *racist*.

The real damage being done to society by this failure to embrace reality is that when reality actually ***does*** intrude, wishful thinking is a poor defense against disaster. Even when men acknowledged and affirmed absolutes, still mankind was often *unreasonable*! How much worse will it be when there is no longer a social foundation based upon truth and reason?"

The people in Johnstown believed that they could build their city in a dangerous place despite the warnings **because they wanted to believe it**. The Post Modernists believe there are no moral absolutes **because they want to!** For a long time the people of Johnstown were spared the disaster prophesied by the Indians, yet all they had to do was look with a clear eye at the realities of the existing situation and they could have anticipated the inevitable consequences. But they were blinded by a desire that overcame reality. Yes, the city remained where it was built, but that did not protect those who perished when their luck ran out.

Another clear example of a belief being destroyed by reality can be found in women's sports. Remember Title 9? What is the cause of this madness? **A refusal by far too many people and their government hirelings to accept reality when they prefer to embrace false prophets and ideologies.** The danger grows daily but the really sad thing is that those of us who **do** accept truth and recognize Absolutes are not immune to the disasters perpetrated by those who do not.

Ignore Dominant Media Narratives

During the Obama Regime, its ideological allies in the Jews' Media abandoned all pretense of objectivity or fairness, and frequently fabricated a **"dominant media narrative"** to drown out other voices and obscure the truth. This was necessary to prevent the electorate from learning damaging facts surrounding the many scandalous activities that plagued Obama's demonstrably corrupt and treasonous regime.

The Jews' Media's efforts were often used to salvage Obama Administration appointees and other "Democrat" office-holders who ran afoul of the law, even as it simultaneously targeted and libeled all conservatives, most Republicans, all Christians, and every white nationalist. Clearly, this tactic has been successful because even years later, no Obama Administration official has been investigated in a serious manner, much less brought to justice.

The most recent scandal to require the "spin" services of the Jews' Media has been the events surrounding President Trump's July 25th phone call to congratulate newly-elected Ukrainian President Volodymyr Zelensky. In his call, President Trump urged Zelensky – an avowed re-

former — to continue to pursue the Ukraine's investigation into the role Zelensky's predecessors may have played in interfering with the 2016 U.S. Presidential Election.

Victor Shokin told John Solomon of **The Hill** that he had **"specific plans"** to investigate **Burisma Holdings**, one that encompassed **"all members of the Executive Board, including Hunter Biden."**

The telling reaction of the Jews' Media and House **"Democrats"** has been to scrupulously ignore all evidence involving the Bidens. Instead, they have fixated exclusively on the hearsay and inaccurate claims of a suspect **"whistleblower,"** who alleged that Trump extorted

Doing God's Work

One of the more urgent tasks facing America prior to the 2020 Elections is to reduce opportunities for "Democrat" voter fraud. One excellent way to approach this is to force states and counties to comply with the **National Voter Registration Act of 1993** (NVRA,) and that's exactly what **Judicial Watch (JW)** has been doing for several years.

JW has sent letters to 19 large counties in five states putting them on notice that they are in violation of the NVRA. **JW** intends to sue unless these states make reasonable efforts to comply with NVRA and remove ineligible voters from their voter rolls. Those states are California, Virginia, Colorado, North Carolina, and Pennsylvania.

According to a **JW**, analysis of data from the **U.S. Election Assistance Commission**, there were 378 U.S. counties in 2019 in which the number of registered voters **EXCEEDED** the number of voting-age citizens residing within them. In fact, the number of excess voters in those five states totals 2.5 Million.

For example, San Diego County, California removed the names of 500,000 inactive voters following earlier litigation by **JW**, but its voter registration **STILL** exceeds its voting-age population by 17%.

Unusually high voter registration rates are a clear indication that these counties are not removing deceased voters from their rolls, nor have they taken measures to purge those who have moved to other venues, as federal law requires.

JW has been relentless: In 2018, the Supreme Court upheld a massive purge of Ohio's voter rolls stemming from litigation by **JW**. California settled a similar lawsuit with **JW**, prompting Los Angeles County to remove around 1.5 million "inactive" names from its voter rolls. Also, Kentucky undertook a cleanup of around 250,000 names in 2019 after entering into a consent decree in another **JW** lawsuit.

It is nearly impossible for "Democrats" to fraudulently "vote" anyone not registered in the voter rolls, which is why they spend so much time and money working to register new voters.

Inaccurate voter rolls often mean stolen or questionable elections. It's just common sense that ineligible voters -- and those who die or move away -- should be "purged."

The controlling Supreme Court decision occurred in *Elk v. Wilkins* in 1884, in which the Court held that "***Absolute jurisdiction excludes any children who might owe allegiance to another sovereign such as "children and subjects of any foreign government."***"

As the left has so often done in many other contexts, the 14th Amendment has been distorted by its henchmen in the judiciary, academia and public office to advance the cause of national suicide and treason through the artifice of illegal immigration!

Identity Politics Backfires

I've often written about the enormous hostility directed at Donald Trump by leftist Jews and their allies in the Jews' Media. Their hatred is unprecedented and best understood in this manner: President Trump's election seriously derailed their scheme to convert America into a socialist and *Zionist Occupied Government*.

Following the damage done to the economy and our national security after eight years of the Obama Administration, leftist Jews could almost taste and smell victory in their 100-year quest to hand-deliver America into the clutches of the international socialist orbit.

One hint that leftist Jews have "*doubled-down*" on socialism and will never abandon their quest is evident in the fact that at least four Jews entered the "*Democrat*" Primary for president. They are *Crazy* Bernie Sanders, Amy Klobuchar, *Mini* Mike Bloomberg and Tom "*Liar*" Steyer.

I'm not sure that many could have coherently described just exactly who the Jews are, but their attitudes appear to have been cultivated by their personal dealings with the pawn-brokers, landlords, owners of food-shops and liquor stores and rental companies in black areas that were often owned by Jews during the second half of the 20th Century.

Blacks are children in many respects, and they will always insist on resolving any dispute in a manner most advantageous to themselves. This characteristic isn't conducive to engaging in commerce with Jews, whose customers are often held strictly to the terms of their agreement by Jewish merchants.

This probably accounts for most of the black hostility directed at Jews, because any business owner who held blacks to the actual terms of their agreement was assumed to be cheating them or "*ripping them off*." Blacks are often genuinely incensed at being forced to live up to their own agreements, and frequently embittered by such an experience.

Crazy Bernie, Tom Steyer and Amy Klobuchar did poorly in the ***South Carolina Primary***. The poor showing of these four may be attributable to their being Jewish. *Mini* Mike Bloomberg sat out this primary, but would have performed even worse had he not done so.

Meanwhile, the *rump-ranger* -- Pete Buttigieg -- did poorly as well because he is queer. That's another characteristic that didn't endear him to South Carolina's black voters, whom we are told make up 60% of all "*Democrats*" in South Carolina. Elizabeth Warren did poorly because even the blacks finally recognized she is a pathological liar.

There are costs and benefits to every human endeavor, but during a crisis it's often difficult to recognize the benefits. This principle is analogous to the notion of a "silver lining" in every raincloud.

I was reminded of this principle when it was recently reported that Iran is "Ground Zero" for the Corona Virus in the Middle East. And, an added benefit is that it has claimed at least one victim as deserving as any human being could be.

That victim is **Masoumeh Ebtekar**, Iran's former *Vice President for Women and Family Affairs*. She was also the spokeswoman for the Islamic terrorists in 1979, who seized our U.S. Embassy in Tehran and kidnaped 52 of our diplomatic personnel for 444 days.

Ebtekar lived in the U.S. for many years while her father studied at the **University of Pennsylvania**, and developed a demonstrable proficiency in English. Because of this, she routinely appeared on American TV as a translator and spokeswoman for the so-called "students" who seized our embassy.

Book Review

The Plot against the President: The True Story of How Congressman Devin Nunes Uncovered the Biggest Political Scandal in U.S. History.

Lee Smith. Hachette Book Group, 2019. 368 pp.

The Plot Against the President by Lee Smith examines the evidence surrounding America’s gravest political scandal, the first attempted *coup* against a sitting President. Although much conclusive evidence has yet to see the light of day, Smith has done an exceptional job of connecting the dots to explain the scandal with the evidence at hand.

The author follows the investigation pioneered by Chairman Devin Nunes and Republicans in the House Intelligence Committee from 2016 through 2018. They are the true heroes of this tale, who exposed the conspiracy against Donald Trump’s candidacy and presidency by corrupt Obama “holdovers” in the FBI, Justice Department, CIA, State Department and National Security Agency.

They persevered in this quest despite the endless lies and traitorous activities of Adam Schiff (D-Moscow,) Eric Swalwell (D-Havana,) and other ostensible “Democrats” on the House Intelligence Committee, in addition to the

latter’s allies and co-conspirators in the Corrupt Leftist Media.

Smith describes the murky and extremely secretive interactions among the Corrupt Leftist Media, shadowy foreign “contractors” employed by the intelligence community, and high-ranking traitors among Obama holdovers in these federal agencies. However, the precise origins and details of this treasonous conspiracy may well remain elusive until the *Durham investigation* is completed.

Smith speculates that this orchestrated smear campaign against Trump did not originate with the “*Steele Dossier.*” This was the fraudulent opposition research funded by the Clinton Campaign and the DNC, and concocted by **Fusion GPS** with funds laundered through the **Perkins-Coei Law Firm** in Washington.

Smith makes reference to a number of what he called “*proto-dossiers,*” which were eventually synthesized into the final “*Steele Dossier*” by a team at **Fusion GPS** that

included Nellie Ohr, the wife of the number four man at the Justice Department, Bruce Ohr.

Steele was a former employee of British intelligence, who made no effort to hide the fact that he hated Donald Trump and was willing to fabricate any falsehood the Obama Administration conspirators would swallow in their relentless and illegitimate efforts to destroy Trump.

Smith believes the contents of the Steele Dossier were not primarily intended to harm Trump's campaign or assist Hillary's: Instead, he believes that from its inception, it was intended to initiate an open-ended intelligence investigation of Donald Trump and every aspect of his life. Like many dishonest people who "project" their own faults on others, they assumed Trump was as corrupt as they are and that their investigation would inevitably expose some kind of dirt.

The key to their efforts was the fact that the threshold of evidence required for an *Intelligence Investigation* is far less stringent than that required for a *Criminal investigation*, since the latter must meet the Fourth Amendment's standards of Probable Cause for arrest and Reasonable Cause for a search. The fruits of their efforts eventually manifested in Bob Mueller's *Special Counsel Investigation*, an open-ended inquisition in search of a crime.

Although the Steele Dossier was phony, sophomoric and impossible to verify, its false accusation of a Trump

"collusion" with Russian officials was deemed adequate to initiate **Foreign Intelligence Surveillance Act (FISA)** warrants to spy on President Trump and his campaign. It was also used by the **National Security Agency** to illegally "un-mask" the identity of several hundred Trump associates and campaign advisors whose only "crime" was their association with Donald Trump and the GOP.

Of course, the Corrupt Leftist Media were willing accomplices: The "echo-chamber" they helped create was designed to validate or appear to "confirm" the contents of the Steele Dossier. These efforts consisted of repetitions of the same lies found in the Steele Dossier, but reported as if they originated from different sourcing.

Perhaps the most unique feature of **The Plot against the President** is Smith's meticulous synthesis of the interactions and coordination between the various conspirators. These include the tactics by various bureaucrats, and the dissemination of a dominant media narrative to frame President Trump by overwhelming the truth with endless recitations of false and frightening allegations of presidential misconduct.

Smith brilliantly examines the evidence exposing this scandal, but has also taken time to describe the "back-story," including the key players and when and why they engaged in the treasonous acts they did.

I've watched from ringside as St. Louis regressed to the depths of Detroit, and reached a point where nothing lies ahead but anarchy and *graftocracy*. Its demise is glaringly evident in the following crime story, which is a metaphor for the fate of this once great city.

and attacked her. As Alicia Clarke states, **"...he comes back with a weapon. He is on top of me. There was blood everywhere. I was literally fighting for my life at that point."**

This was no exaggeration: Hassan stabbed Alicia Clarke in the head, broke her nose, and stabbed her face in close proximity to her left eye with a metal rod that may have been a screwdriver. She has multiple staples in her head and under her eye where he stabbed her.

According to Alicia Clarke's sister, Hassan **"has broken into Alicia's car 3 different times and broken into another neighbor's house. The police were involved every single time and reported that nothing could be done since he was a minor."**

Despite this most recent aggravated assault, the **St. Louis Juvenile Court System** quickly dismissed the case against Hassan. As Alicia Clarke indicates, **"The most hurtful thing of all of this is the dropped charges...That was much more hurtful than the physical assault."**

A juvenile court official told a local TV station that a staff attorney deep-sixed Hassan's case long before it ever got in front of a judge. Alicia Clarke said she was told her attacker was found incompetent to stand trial because of his 49-point IQ.

This means Hassan and other retarded black bastards have been given a license to commit violent assaults with impunity in St. Louis. Hassan may be retarded, but he quickly recognized that he can get away with almost anything from his previous scrapes with the law and the sorry nature of their eventual dispositions.

In fact, the prosecutor assigned to Alicia Clarke's case told her that even if Hassan had **MURDERED** her, the outcome would be no different and his prosecution would be dismissed. That prosecutor is Sakina Ahmad, and according to Alicia Clarke and her sister, that is a *verbatim* quote.

MY COMMENTARY: With an IQ of 49, Hassan is more than qualified to run for public office in what is left of St. Louis, and could eventually be elected to the office of Mayor.

This is another example of Black Skin Privilege, a common phenomenon in predominately black cities like St. Louis, where retarded black criminals are often acquitted by a corrupt and dysfunctional system of justice, staffed by thoroughly corrupt and incompetent black officials.

The city is governed by a black organized criminal element. History & Unintended Consequences

Most people are familiar with the *Law of Unintended Consequences*. It is a truism reminding us that not all consequences of a given behavior or action can be identified in advance. Moreover, since there are costs and benefits to every human endeavor, ultimately, some costs may be worse than the problem to be remedied.

For example, if **Abraham Lincoln** had not been assassinated by John Wilkes Booth in 1865, it is unlikely that the South would have been subjected to so-called "Reconstruction." Boothe's motives were clear: He felt he

was justified in striking a blow against tyranny, and even yelled "*sic, semper Tyrannus*" after committing his infamous act.

Lincoln had shared his vision of a post-war union in his *Second Inaugural Address* less than two months before his assassination. He called for unity to "***bind up the nation's wounds and achieve...a just and lasting peace.***" His vision was one of Christian forgiveness, and included the memorable phrase "***with malice toward none, with charity toward all.***"

Nowhere in his inaugural address was there any hint of a desire to subjugate the South with what would become *Reconstruction*, an imposition of martial law that would be as damaging to the South as Sherman's war against civilians in his "*March to the Sea.*" (It was Reconstruction that prompted my maternal ancestors to abandon the Virginia county named for them, and move to East Texas.)

"*Radical Republicans*" like Thaddeus Stevens and Charles Sumner garnered all the rationalization they would ever need from Lincoln's assassination: afterward, they were nearly unimpeded in their quest to punish the South by imposing martial law and promoting the takeover of state legislatures in the South by black imbeciles.

Lincoln's assassination also precipitated the ***Civil Rights Act of 1866*** and the 14th Amendment, the latter being the source of more mischief than any other provision of the Constitution.

Likewise, the assassination of **Martin Luther King** also changed the course of history, and precipitated nearly as much damage and mischief to this country than even the *War of Yankee Aggression*. Cowed by unprecedented levels of black violence and arson that followed King's murder -- and intimidated by the glare from a self-righteous and leftist news media -- politicians in both parties caved to black demands like a cheap tent in a tornado.

To placate blacks in the wake of their nationwide rioting and arson, cowardly elected officials ushered in a new era of welfare bribes and new and expansive Civil Rights legislation. These were accompanied by a host of terrible

Supreme Court decisions, including newly-invented rights for criminal defendants, the routine federal court-supervision of state Congressional redistricting, and renewed enthusiasm for the forced integration of "*public accommodations*," public schools and residential housing.

Predictably, these were followed by soaring black crime, accelerating welfare dependency and illegitimacy, and the white abandonment of our largest cities, once considered the "*gems*" of our civilization. King's assassination also manifested in the travesty of a "holiday" for this Soviet asset and sexual deviant.

This brings us to a more recent but equally destructive example of horrifically unintended consequences, Dylan Roof's murder of nine innocent blacks in 2015 at a church in Charleston, South Carolina.

Not only did this evil and inexcusable crime give the Corrupt Leftist Media all the ammo it needed to attack every "*neo-confederate*" and conservative enemy, it also made it impossible for those in elective office to prevent or defend against the wholesale destruction and removal of monuments honoring Southern and Confederate Heritage.

Immediately after this sad and misguided young man murdered nine innocent blacks in Charleston, Governor Nikki Haley of South Carolina reflexively ordered the *Confederate Battle Flag* banned from the Capitol Grounds in Columbia. She was the first high-profile office-holder in the South to do so, and her actions ignited the war waged by Cultural Marxists and other garbage against every vestige of Confederate or Southern Heritage in the South and elsewhere.

Two and a half centuries ago, Voltaire wrote, "*History is a pack of lies agreed upon*," an aphorism just as true today as it was then. In fact, considering the Marxist invasion and subversion of academia in recent decades, it may be even truer today than it's ever been.

Those in the White Nationalist movement who are tempted to engage in illegal acts should include this consideration in their calculations, and recognize that it's highly unlikely they will successfully anticipate every consequence of their actions. It is also highly unlikely their actions will not irrevocably damage our movement.

Lessons from Director John Ford

The message of John Ford's timeless western, *The Man Who Shot Liberty Valance*, is much simpler and more straightforward than its complex plot: *Rule of Law* may be the cornerstone of Western Civilization, but it is the Second Amendment and its *Right to Keep and Bear Arms* that safeguards and allows all other rights to flourish.

When a society is besieged by lawlessness, any return to Law and Order first requires courageous men who are willing to risk their lives to confront and defeat such evil, even if that requires deadly force: only then can a just and safe society emerge. The same principle applies to Freedom of the Press, Freedom of Speech, private property, commerce, schools and every other liberty protected by the Constitution.

It was the rough and fearless John Wayne character (*Tom Doniphon*), not Jimmy Stewart's character -- a fussy and principled lawyer named *Ransom Stoddard* -- who actually ended the vicious and tyrannical reign of Liberty Valance. This fact was pointedly brought home to Stoddard when Doniphon faced down Liberty Valance in the town's restaurant, just as Valance was about to murder Stoddard for the pure, sadistic pleasure of it.

As Doniphon pointedly and bluntly remarked and Stoddard grudgingly acknowledged, it was Doniphon's gun and not Stoddard's law books that saved Ranse Stoddard's life.

Later, although "*Ranse*" Stoddard got the recognition for doing so, it was actually Tom Doniphon who delivered the fatal bullet that killed Liberty Valance. This paved the way for Ransom Stoddard to become a legend -- eventually becoming Governor and Senator -- and reap the ac-

claim that should rightly have gone to Tom Doniphon, had Doniphon ever sought any such thing.

Freed from the terror of a psychopath, this permitted the town of Shinbone to become a safe, law-abiding and prosperous place to live for the first time since Liberty Valance arrived.

When Ranse Stoddard and his wife return many years later to Shinbone to pay tribute to Tom Doniphon upon his death, they ask why his gun is not being buried with him. They were told by the former Sheriff that **"...he stopped wearing a gun years ago."** Doniphon's gun was no longer necessary once he restored Law and Order by dispatching the town's primary source of lawlessness and evil.

John Ford is also saying that we stand on the shoulders of courageous men who were willing to use deadly force to confront and defeat evil, and thereby carve out an environment in which Rule of Law and other cherished principles could take root and flourish. Most received very little recognition for their efforts or the risks they took, and many, like Tom Doniphon, never sought any.

These are the true, often anonymous and unheralded heroes who actually deserve the credit for taming the "*Wild West*," and making it a viable place for decent people to settle and raise families during the "*Westward Expansion*." It could never have happened without firearms and the Second Amendment's Right to keep and bear them.

Also, it would never have happened without men like Tom Doniphon.

THE BELLESILES SCANDAL

Since it was gleefully interpreted by the left as more ammo to fire at the Second Amendment's defenders, ***Arming America*** received rave reviews from twice the usual suspects, including ***The Washington Post***, ***Chicago Tribune***, ***National Journal***, ***Atlantic Monthly*** and ***New York Times***. Syndicated liar Garry Wills wrote a particularly fawning review of it in ***The New York Review of Books***, and Bellesiles eventually received several prestigious awards, including the ***Bancroft Prize*** from Columbia University.

Its author's basic thesis is that widespread gun ownership did not exist in America prior to 1840, and that our image of the armed citizen-soldier of Colonial Times is mythical. In support, Bellesiles attempted to demonstrate that guns were so scarce that serious hunters were as rare as competent militiamen, and the few guns that *did* exist were mostly broken or in poor condition.

These quaint notions would have seemed odd to our pioneer forebears, who were compelled to hunt for much of their food on the frontier, even as they defended themselves from hostile Indians. It would almost certainly have come as a shock to the ***Minutemen*** at Lexington and Concord, as well as to General Washington's army.

(With apologies to Ralph Waldo Emerson)

***By a crude trick and sleight of hand;
His masterwork by leftists driven;
Stands now Bellesiles, from Emory banned;
His Bancroft from his clutches riven.***

Not at all coincidentally, by arguing that guns were of little concern during the Colonial Period, Bellesiles' conclusions helped promote a limited interpretation of the Second Amendment, in which the Constitution guarantees only a ***"COLLECTIVE" rather than an "INDIVIDUAL" Right to Keep and Bear Arms.***

LEFTIST "SCHOLARSHIP"

According to Bellesiles, much of the data used to support his thesis came from the inventories of early probate records: few of which he found to contain firearms, and those firearms which ***were, in fact*** itemized, were either broken or in very poor condition.

The fact that few weapons were itemized in probate records simply demonstrates the tradition of freemen giving their weapons to their sons after they grow too old to use them. Beyond any doubt, much of Bellesiles' evidence was entirely fabricated and his conclusions based on fraudulent documentation.

Without delving too mind-numbingly into the mountain of evidence against him, suffice it to say that one particular source of evidence cited by Bellesiles to support his conclusions were probate records from San Francisco: As luck would have it, ***all such records were lost in the 1906 San Francisco earthquake and resulting fire.*** After this claim was exposed to be fraudulent, his "explanations" changed so frequently and became so paranoid and bizarre, they are hardly worth considering here.

It is often said that **"A liar is halfway around the world before the truth can get its boots on."** Fortunately, there are many Second Amendment scholars and truly honorable historians in America, whose knowledge, integrity and scholarship overwhelm even the dishonesty and fraud of those who comprise America's gun-control lobby.

Arming America was received with such bewilderment by weapons historians, firearms scholars, and Second Amendment scholars that it eventually aroused the suspicions of Bellesiles' employers at Emory University.

In the wake of mounting accusations against one of their celebrated **"researchers,"** Emory Administrators initially required Bellesiles to defend his thesis. In response to his claim that a **"flood"** had destroyed his notes, (at least he didn't claim his dog ate them,) the university appointed a committee of scholars to investigate. Eventually, that committee produced a 40 page indictment, which concluded that Bellesiles was guilty of **"unprofessional and misleading work,"** and that his **"failure to identify his sources moves into the realm of falsification."**

To add insult to injury, for the first time in the 55-year history of its prize, Columbia University revoked the Bancroft Prize awarded to Bellesiles in 2001. Columbia even demanded that he return the \$4,000 stipend that accompanied it. Bellesiles was also fired by Emory University, effective Dec. 31, 2002.

THE ANTI-GUN LOBBY

This sort of dishonesty is hardly novel for members of the anti-gun lobby: Readers may recall that television celebrity Rosie O'Donnel, an extremely vocal opponent of handguns and an organizer and participant in the so-called **"Million Mom March,"** was later revealed to have hired a handgun-toting security guard to protect her adopted child!

Another classic insight into the character of those who comprise the anti-gun lobby occurred in 1997, after Prof. John Lott first published what is, arguably, the most exhaustive and comprehensive study in the history of criminal justice, in which he demonstrated the effectiveness of concealed-carry laws in reducing violent crime.

Frequently termed the **"Lott/Mustard Study,"** Lott examined violent crime rates in every U.S. County from 1977 to 1992, eventually concluding that **"...Concealed-Carry laws are the most cost-effective means of reducing violent crime ever studied by economists..."** (**JOURNAL OF LEGAL STUDIES** (January, 1997.)

Lott approached several people to obtain comments on his study, including Susan Glick, of the **Violence Policy Center**, who refused to provide him with a comment because she might **"help give...publicity to the paper."** When Lott asked her if he could at least send her a copy of his study, she said, **"Forget it. There is no way that I am going to look at it. Don't send it."**

However, when the first newspaper article mentioning Lott's study appeared in **USA Today** on August 2, 1997, Miss Glick (among many others) left telephone messages desperately requesting a copy. The media were calling, and she indicated that she **"needed his paper to be able to criticize it."**

Later that day, ABC News reporter Barry Serafin called Lott for a response to the many charges critics had leveled against his study: Among those critics was Susan Glick, who remarked that Lott's study was **"flawed."** Lott then called Susan Glick to see if she now wanted a copy, to which she responded that she needed one right away and wondered if he could fax it to her.

Lott then noted that her request seemed odd, since she had just told Barry Serafin that the study was "flawed." Lott asked her how she could know it was flawed when she hadn't even read it (?), at which point she hung up on him.

CONCLUSION

Even more troubling than the dishonesty of Bellesiles is the disparity in news media treatment accorded the book when first received, in contrast to the silence that now greets its scandalous author's *denouement*. Were it not for **NATIONAL REVIEW**, the N.R.A and Fox News Channel, the public might very well remain totally oblivious to any scandal involving either the book or its author.

Perhaps the most valuable lesson to be gleaned from the sad and tawdry case of Michael Bellesiles is the extent to which leftists in this country will embrace any effort, no

matter how implausible or laughable, in their continuing efforts to undermine provisions of the Constitution with which they lack sympathy. This is particularly true concerning the Second Amendment, and the original intent of the Framers in drafting this provision of the Bill of Rights.

Whether one considers himself to be a “gun nut” or not, those committed to protecting and defending the Consti-

tution must be ever vigilant in its defense, and particularly skeptical of revisionist notions promoted or advocated by those who would modify the Constitution without benefit of the Amendment Process or a Constitutional Convention.

As the Bellesiles scandal clearly reveals, the anti-gun lobby and its allies in the news media appear to be the most virulent of those who would visit such damage upon this Sacred Document, the practical source of all our cherished liberties.

MORE GUNS, LESS CRIME

“Concealed-Carry laws are the most effective means of reducing violent crime ever studied by economists...”

This was the conclusion reached by an academic Economist and a Legal Researcher at the University of Chicago, who undertook the most comprehensive study in the history of criminal justice.

Frequently termed the “Lott-Mustard Study,” and later published in the University of Chicago’s extremely prestigious **JOURNAL OF LEGAL STUDIES** (Jan., 1977) these two academicians **studied violent crime rates in every county in the United States from 1977 until 1996.**

(Eventually, the data was expanded to cover 1977 until 2005.)

To date, not a single glove has been laid on them or their study, despite an hysterical and concerted assault by the most intellectually dishonest leftists in the nation and their enablers and cheerleaders in the Corrupt Leftist Media.

Yet, as fascinating as the conclusions of this meticulously researched study are, even more interesting is the response of various gun control advocates. For example, in the weeks and months leading up to Missouri’s statewide referendum on Concealed-Carry, which took place April 4, 1999, **not once was the Lott-Mustard Study even mentioned by name in POST-DISPATCH’s endless coverage of the issue.** This is the intellectual equivalent of omitting any reference to Thomas Edison in a narrative describing the history of the lightbulb.

Moreover, Lott-Mustard’s conclusions were given equal credence with the laughable conclusions of another study involving **only three** (!) U.S. counties, which purported to demonstrate the ineffectiveness of concealed-Carry laws in deterring violent crime. In contrast to this latter study, with its arbitrary and intentionally deceptive use of only three counties, **Lott-Mustard (ultimately) studied violent crime rates in all 3,054 U.S. counties over 25 years!**

John Lott relates one fascinating anecdote that occurred immediately after his original study was distributed for peer comment, and illustrates what decent and honest people are confronted with when they offer unpalatable truths to the Cultural Marxists who have seized control of academia and the Corrupt Leftist Media.

One of the perfidious Jewesses who seem to dominate the many treasonous organizations of the left – a woman from the so-called Violence Policy Center named Susan Glick -- described Lott’s study as “flawed” when she was asked to comment on it by some Corrupt Leftist Media apparatchik.

Upon returning home, Lott was surprised to find that Susan Glick had obsessively called his home phone number many times, desperately requesting a copy of his study so that she **“could criticize it.”**

Being the gentleman that he is, Lott returned her call and asked if she was still in need of a copy of his study, to which she replied yes, and could he please Fax it to her?

Lott then nailed her by asking how she could have concluded that the study was “flawed,” when she hadn’t even read it. At this point, she slammed down the phone.

Although Jewish Marxists may be oblivious to the fact that concealed weapons dramatically deter violent crime, it is a phenomenon well known to N.R.A. members for years: Every issue of the National Rifle Association’s three publications carry a column entitled **“The Armed Citizen,”** in which many truly inspiring anecdotes are reprinted from newspaper accounts.

These often involve some frail and elderly woman, frequently a multiple crime victim, who takes matters into her own hands and successfully defends herself against an armed attacker.

Lest “bleeding-hearts” sympathize too much with the 2 million potential predators who come face-to-face with the muzzle of a firearm (and their Maker) each year in the U.S., some 98 percent of the time, potential crime

victims needn’t even fire the weapon and need only display it to adequately deter an attacker.

Moreover, as reflected in the **“The Armed Citizen”** columns, the greatest benefits under concealed-carry laws are experienced by women who -- until feminists successfully repeal the laws of physiology -- offer a more attractive target to violent criminals than their male counterparts.

The ability of women to carry a concealed weapon makes them far less attractive to violent criminals and greatly increases the potential costs of committing a violent crime: Indeed, according to Prof. Lott, the benefit to women from concealed-carry laws is three times the benefit to men.

There’s an old adage that **“God made every man different, but Colt made them all equal.”** A concealed firearm places even the smallest, most timid women on equal footing with the largest, strongest and most vicious predators in her community.

Moreover, as the adage goes, **“...a well-armed society is a polite society...” (END)**
