## President's Column Organizational Details By Earl P. Holt III

**Black History Month:** This is our issue celebrating *Black History Month*, an observance that begins in early January of each year and ends in late December. As you can see, most articles were written by our prolific and able Senior Editor, who was pounding out copy faster than I could read it.

**Warning to the Wise:** If you subscribe to the *INFORMER* and your subscription was not made through our Potosi, Missouri P.O. Box, you are unwittingly participating in a **FRAUD**. Any such arrangement denies the CofCC any benefit from your membership dues. I send many free issues to those who request them, but **legitimate subscriptions and Memberships should be made through our P.O. Box.**

**Jared Taylor's Legal Successes:** Jared Taylor's *New Century Foundation* keeps winning in federal court. In September of 2018, he sued the State of Tennessee for the outrageous costs of security charged exclusively to the sponsors of white nationalist conferences in Tennessee State Parks. He won a preliminary injunction.

In December of 2019, he won his case and received \$46,000 in legal fees. The *CofCC* and *American Freedom Party* may eventually be refunded part or all of the money extorted from both groups in order to hold our national conferences in 2018 and 2019.

**2019 Financial Statement:** The CofCC's 2019 *Financial Statement* is available on page 39. I believe it's a good idea for all Members to see the financials for this organization. This was not done in the past, and it has occasionally led to suspicion and mistrust, some of which was well deserved. Publishing our "*financials*" substitutes for a *Treasurer's Report* at national conferences.

**Glen Allen to Appeal:** Readers may recall the case of Glen Allen, an attorney fired by the city of Baltimore after a vicious campaign of libel against him by the *Southern Prevarication Lie Center* (SPLC.) He is suing the SPLC, Heidi Beirich and Mark Potok for their "*carefully orchestrated destruction of my legal career...and reputation as*

*an attorney.*" More important for our purposes, he is also challenging the SPLC's tax-exempt status at the IRS.

Unfortunately, his case was heard by a Clinton appointee in the Fourth Circuit named Katherine Blake, who dismissed it. ## The Evil of Equality

The present culture employs many “watch-words” in its orthodoxy. After “*racist,*” one of the words most often used is “*equality,*” a derivative of the word “*equal.*” But, of course, the gist of the word itself is questionable outside certain academic disciplines. Once one leaves mathematics and science, the concept of “*equal*” becomes ambiguous, especially when applied to human beings.

Without question 2 plus 2 *does* equal 4, but among people, it is not possible to make any demand for “*equality*” as defined above save in *two* instances: **before Almighty God**—and **before the Law**. In both of these circumstances, all people can (and should) be considered “*equal.*” God is no respecter of persons so whether the one standing before Him for judgment is a “*somebody*” or a “*nobody*” in **our** estimation, it matters not. As well, the Law is *supposed* to exercise this same absence of concern for human externals. But that, alas, is not true despite being the acknowledged ideal! That is why *Lady Justice* wears a blind-fold.

However, in all things “*human,*” we have at once lost and, at the same time, *enlarged and transformed* the understanding of equality. Before the law, it is evident that the Lady Justice’s blindfold has not only slipped, but has been *removed* by the culture. The result is that in our justice system *at least two* standards are now in effect. And if *two* standards exist, for all practical purposes, *no* standards exist! Thus, before the Law, at least, the concept of equality is dead.

But far worse is the fact that, on the *other* side of the equation, the concept of “*equality*” has been enlarged like a malignant growth to the point of becoming fatal to society! Over the decades, a demand has arisen not for

*equality of opportunity,* something that *supposedly* has been desired in the West, but a demand for *equality of results* and that is nonsense! The very fact that individual humans cannot *be* “*equal*” in all aspects—whether physical or mental—rules out any possibility of achieving total equality among them.

Even in the animal world, in some circumstances, men strive to produce “*equality.*” For instance, a superior racehorse carries a heavier weight in a race than an animal of lesser ability while in golf, inferior players are provided with handicaps to “*level the playing field.*” While harmless in themselves, these attempts indicate a belief that—other than in some sports—there is something fundamentally *wrong* with any person or group being intrinsically superior. Yet, that is simply the nature of things and while racehorses and golfers may benefit from an artificial effort to produce “*equality,*” matters become much more problematic when those efforts go beyond the trivial and frivolous. You don’t mind your golf partner getting a “*leg up*” on the greens, but you don’t want your heart surgeon to have achieved his place in the operating room through such deceitful manipulations.

It is this wrongful understanding of the value and need of “*equality*” in human affairs that has led us to the point at which not only a whole race—Caucasians—but a whole way of life—Western Civilization—has been declared null and void and worthy of extinction. For where there is freedom, there will be human ***IN-equality*** and as equality is now the only permissible standard, the obvious consequence will be a complete loss of freedom and the rise of a culture more in keeping with insects—the hive—than people. And yet, if we look carefully, we will note that

# HOW GOD CREATED THE RACES

Even in Christian circles there are many explanations for how the races came into being. They range from the absolutely absurd -- such as Christian Identity's "seedline" doctrine -- to even more questionable explanations that expose just how much the Theory of Evolution has poisoned Christian understanding. These explanations are false, and supported by neither the Bible nor by science.

No matter how much we try to ignore it, the subject of race refuses to go away. So, as someone who believes his **King James Bible** literally -- every word of it -- I offer the following basic explanation of how the races of man came into existence from both a biblical and scientific point of view. When you refuse to get sidetracked by sociology and politics, the subject of race is really very simple, and so the following discussion avoids both.

Some teach that the races were separated by God at the Tower of Babel in *Genesis* 11:1-9. But even a cursory reading of these verses demonstrate that it was man's LANGUAGE, not race, that was divided by God at Babel.

Others cite *Genesis* 4:11-15 to teach that the races were separated when God cursed Cain. The problem with this theory is that the descendants of Cain were all destroyed in the *Great Flood*, which is why I reject the "seedline" theory. When I ask those who preach the "seedline" theory to explain how Cain's cursed race continued through the Flood, they are forced to concede that they do not interpret their Bibles literally.

Which leads us to the 3rd possibility from Scripture, which occurred shortly after the Flood in *Genesis* chapter 10. Here, we read in the Bible that eight souls entered the Ark: Noah, his wife, the three sons of Noah (Ham, Shem, and Japheth), and Noah's three daughters-in-law. Shortly after the Flood, God dispersed Noah's three sons, sending each and his wife to populate a different part of the Earth.

So to break the post-flood Bible genealogy down into the simplest possible interpretation, Shem's progeny settled in the Middle East, Ham's people went south into Africa, and Japheth's descendants migrated north into Western Asia and Europe. Thus, Shem fathered the races we now know as Orientals, Ham fathered the black peoples of Africa, and Japheth fathered the European or white peoples of the world.

A more detailed reading of the Bible, and a study of the peoples of Africa -- especially the Ethiopians -- shows the descendants of Ham as having been of all three colors. This becomes important as one studies genetics and how it works. So let's look a little deeper at just how genetics works.

Noah's three sons and their progeny were dispersed over the whole of the Earth, but the physical characteristics of each was not entirely unique to any of the three. Each son, grandson, great-grandson, etc. could and did produce offspring with different characteristics.

So how did the descendants of Japheth, Ham, and Shem -- all coming from the common genetic makeup of Noah -- manifest in three distinct races of people? The shortest possible explanation is this: As the migration from the Ark's landing place proceeded from what is now modern day Turkey, each of Noah's sons and their families came less frequently into contact with other members of their greater extended family. As each nuclear family became increasingly isolated from the larger extended family of Noah and his wife, their gene pool became smaller. Thus, as Japheth, Ham, and Shem's peoples grew more isolated, their children increasingly intermarried within their own groups. Today we'd call this inbreeding.

An example of how isolated gene pools can cause unusual genetic traits to emerge is evident in the Amish People. Their self-imposed isolation from the modern world has resulted in many years of inter-marriage within their community, usually involving cousins marrying cousins. As a result, a disproportionately large number of the Amish have an extra toe or finger — called “*polydactyly*” — or bear other “*recessive*” genetic traits that are relatively common to their community, but rare where gene pools are not isolated.

Without such isolation, the emergence of different races would never have occurred. In addition to the *Bible's* describing how the ancient peoples migrated throughout the Earth after the Great Flood -- and where they settled -- it is equally important to understand the role genetics played in causing the different physical characteristics of those people. Genetics and geographic division precipitated what we now know as the various and unique “*races*” of peoples.

Just like the Amish, as Noah's sons and their wives and offspring migrated, their respective families grew further and further apart geographically, forcing the children to intermarry. As a result, certain genetic traits emerged within their small gene pools, while others became latent. Within just a few generations, the emergent genes produced the skin color, hair color, hair texture, bone structures, and other physical traits that make each race distinctive. The peoples of Europe remained white. Africans became black. (God's curse upon Ham may have been a contributing factor to this but that is a discussion for another article.) The people of the Middle East and of the far East developed off-white, dare I say yellow and olive complexions and skin tones.

Evolution is not science, it is a THEORY, and a particularly weak one at that. On the other hand, genetics is solid science that, combined with the *King James Bible*, helps explain how the races came to become separate and distinct from one another. The races came about not as a direct matter of creation, but as a result of the physical laws of genetics that God Himself put into place when, in Genesis 1:27, He “*created man in his own image...*”

## Black Crime Roundup

In 2018, a 25 year-old black woman in Louisiana named Felicia Marie-Nicole kidnapped a six month-old white baby and burned him to death. The infant's body was found smoldering by some railroad tracks. She was arrested and charged with first degree murder.

Interestingly, this news story first appeared in Britain's *Daily Mail* because it was intentionally “spiked” by our domestic sources of disinformation, otherwise known in these pages as “*The Jews' Media.*”

**In contrast to the frenzy that would accompany such an incident if the races were reversed, there has been nary a peep out of the Jews' Media regarding this case. You see, interracial violent crime only serves the Jews' Media's purposes when the victim is black and the perpetrator is white.**

If the Jews' Media were to report black-on-white violent crime the way they sensationalize the far less frequent cases of white-on-black violent crime, we rubes in

“*flyover country*” might get the wrong idea about *Africanus Criminalis*, that 13% of the population that commits 90% of all murders in the U.S. each year.

In fact, the *Southern Prevarication Lie Center* (SPLC,) has even accused the CofCC of spreading what it calls “*a false narrative of a victimized white majority under siege by allegedly violent people of color in the United States.*”

Below are just a few of the violent black-on-white incidents that give *Africanus Criminalis* its well-deserved reputation, one that the Jews' Media has been unable to successfully “spike” because of the evolution of a conservative and alternative news media that includes the CofCC.

**Tortured to Death:** In 2017, an eight-month-old white baby named Reese Bowman was murdered at a daycare center in Baltimore, Maryland by a nigrass. Police say **Leah Walden**, a 23-year-old black savage was captured

on videotape intentionally murdering this white baby. She eventually pled guilty to first degree murder.

A police official described the videotaped incident as “torture,” and claimed that Walden can be seen swinging the baby by one arm, body-slammng her, and striking the baby. She also appeared to smother the baby with blankets and pillows, and is shown on the tape looking around furtively to ensure no witnesses observe her conduct.

**Eight Murders:** In 2017, a nigro in Mississippi engaged in one of those senseless mass murders for which the black race is so well renowned. By murdering eight people in cold blood, Willie Corey Godbolt has been arrested for a rampage that began as a custody dispute with his ex-wife.

The murder victims include a Deputy Sheriff and two minors, and took place at three separate crime scenes across the state. The rampage ended only because Godbolt ran out of ammo. Upon his arrest, Godbolt stated that *“I ain’t fit to live...not after what I done.”* (Let’s hope the jury agrees.)

**Unsafe Anywhere:** In March of 2017, a 20-year-old white girl named Taylor Brandenburg was babysitting for a family in Dayton, Ohio when she heard a commotion in the front yard. After she stepped outside to investigate, she was shot to death by 38-year-old Chuckie Lee, a nigro with a long arrest record that includes serving four years on drug charges, in addition to assault charges, weapons violations, and more drug charges.

**Predators:** In October of 2018, a predatory black animal murdered a beautiful but naïve white girl named Lauren McCluskey, who was a Senior track star at the **University of Utah**. Her murderer was a black baboon named Melvin Rowland, whom she dated until discovering Rowland was a registered sex offender.

Like most members of the species *Africanus Criminalis*, Rowland lied to McCluskey about his name, his age his criminal history and no doubt, his lack of employment and source of income. In fact, it’s safe to assume the only thing he didn’t lie to her about was his race. The only redeeming thing about this tragedy is that when police

closed in on him, the black bastard killed himself with the same weapon he used to kill Lauren McCluskey.

**Knock-Out Game:** In September of 2019, an unsuspecting 59 year-old white man named John Weed joined the body-count of innocent white victims murdered by sub-human, black rat-apes. He was the victim of two nigro “youths” who were entertaining themselves by engaging in the “*Knockout Game*” at a County Fair in Frederick, Maryland.

**Five White Victims:** In 2017, a 22-year-old nigro named Frederick Demond Scott murdered five middle-aged white men in the Kansas City area. He was charged Tuesday in two killings and named as a suspect in three more. His victims were white men between the ages of 54 and 67, most of whom were fatally shot from behind by this cowardly and sub-human example of a truly inferior species.

According to court records, in 2014 Scott threatened to shoot up a school and *“kill all white people,”* but was not arrested for terrorist threats because of *black skin privilege*. As if scripted by the Jews’ Media, police said they *“did not know if the shootings were racially motivated.”* One brilliant police spokeswoman stated she *“saw no clear motive”* for the killings.

**Driving While White:** In 2017, an unsupervised black four year-old ran into traffic and was slightly injured when struck by a vehicle. However, according to Cincinnati Police, the white driver of the vehicle -- 44 year-old Jamie Urton -- was ventilated and beaten to death by the niglet’s apelike father and his accomplice.

The niglet was treated at a hospital and then released. No such luck for the victim, who witnesses say begged for his life as his murderers pumped round after round into him and beat him unconscious.

Arrested were two black rat-apes named Deonte Baber – the shooter – and Jamall Killings, the appropriately-named father of the niglet.

**More Driving While White:** A naïve 24-year-old white male was savagely beaten to death on Detroit’s west side in 2019 after a minor fender-bender. The murder victim’s name was Tyler Wingate, a young man that friends and

family say moved to Detroit because he loved diversity, and wanted to help return Detroit to its former glory.

Surveillance video from a nearby gas station showed the driver of the other vehicle approached Wingate after the incident and dropped him with an unexpected “*sucker-punch*.” As black savages will do, the assailant continued to furiously hit and kick Wingate until he no longer resisted. The murderer and his black accomplices then left the victim for dead.

**He Axed Dem:** In one of those incidents that gives Brooklyn its exotic reputation, a nigro who called himself “the *Grim Creepa*” on social media used an axe to murder and nearly decapitate a pregnant women, and then savagely chop up his former girlfriend.

Arrested is a 34 year-old nigro named Jerry Brown, whom police believe was known to both victims. The injuries to his former girlfriend were almost as appalling as those to the murder victim, including extensive slashes to the throat, neck, chest and head. The only silver-lining is that both victims were Hispanic rather than white.

**Wheelchair Victims:** In recent years, wheelchair-bound victims have been attacked and robbed in Chicago, Cleveland, Minneapolis, Philadelphia, New Orleans, Los Angeles and Saint Louis. In each case, witnesses described the suspects as black or dark-complected. Each of these cities has many individuals who fit this description, which accounts for their high violent crime rates.

**Savage Instincts:** In 2019, Emmanuel Deshawn Aranda went to the *Mall of America* in Minneapolis intending to kill someone. He settled on a five year-old white boy that he tossed over the third floor balcony to the first floor, below. Fortunately, the boy survived and is in reasonably good condition.

Aranda is a *nigrito*, a black ape with an Hispanic surname. This 24 year-old black savage has been charged with attempted first degree murder.

**More Savagery:** In 2017, a lovely 36 year-old woman named Carissa Oakman was murdered by a sub-human black gorilla in Detroit. She was found strangled to death with her wrists and ankles bound, and was disposed of in two black garbage bags. Her murderer was a big, black sub-human rat-ape named Antenidus M. Collier.

**Savage at ANY Age:** An 18-year-old Barnard College student named Tessa Majors was fatally stabbed near the school’s Manhattan campus on December 11th, 2019. The perpetrators were two savage black teens, whose initial attempts to rob her progressed to murder when she resisted.

The courageous young woman was stabbed multiple times in the stomach, face, neck and under an arm in Morningside Park. She managed to struggle back up a flight of steps to a security guard’s booth, only to collapse and die there. The guard found her after returning from his rounds.

While this naïve young woman had been a college student for only part of one semester, she learned the lesson of a lifetime when she came in contact with these two black savages.

Police contend Tessa Majors was planning to buy marijuana from the two black apes that murdered her. Whether this is true or not, she hardly deserved to die at the hands of these savages.

As nigros often do, they probably decided to “*rip her off*,” and keep both her money and the dope they had allegedly planned to sell her.

Outside of the academic “echo-chamber,” feelings used to be dismissed because they were subjective and amorphous. ## Why Trump Is Right

There is nothing so meaningful as experience. Pictures, books and even first-hand accounts do not teach as experience does. When we hear from somebody “in the trenches,” we’d be mad to discount what that person says merely because it doesn’t fit some conventional narrative.

In January of 2018, a young woman -- Karin McQuillan -- wrote about her experience in Senegal, West Africa as a member of the **Peace Corps**. She was 21 when she left our civilized shores and found herself in that country. She assures us that **“Senegal was not a hellhole,”** and that **“Very poor people can lead happy meaningful lives in their own cultures’ terms. But they are not OUR terms.”** And that is the point of Ms. McQuillan’s article.

She was told upon her arrival that the greatest danger she faced was to her health because, Senegal “...was, in the words of the **Peace Corps** doctor, **a ‘fecalized’ environment. In plain English, sh\*t is everywhere. People defecate on open ground, and the feces are blown with the dust onto you, your clothes, your food, the water.**” She then went on to say they were warned to avoid the water because **“human feces carry parasites that bore through your skin and cause organ failure.”**

**“Never in my wildest dreams,”** said Ms. McQuillan, **“would I have imagined that a few decades later, liberals would be pushing the lie that Western civilization is no better than a third world country. Or would teach two generations of our kids that loving your own culture and wanting to preserve it is racism.”**

In her account, she declares that **“I loved Senegal...but the longer I lived there, the more I understood...that the Senegalese are not the same as us...Their reality is totally different. You can’t understand anything in Senegal using American terms.”**

The rest of her article goes to illustrate the reality of “ordinary” society in Senegal and the rest of sub-Saharan Africa, as well. **“Family was a few hundred people...all the men in one generation were called ‘father.’ The Senegalese are Muslims with up to four wives. Girls had their clitorises cut off at puberty.”** She writes that she witnessed this horror in the belief that **“...I thought (it) was going to be a nice coming-of-age ceremony like a bat mitzvah or confirmation.”**

She learned that **“Love and friendship in marriage were Western ideas...Fidelity was not a thing. Married wom-**

**en would have sex for a few cents to have cash for the market."**

Even more interesting at least for our stupid feminists who embrace Islam is that every day she witnessed that **"...the women were worked half to death."** They did all the hard work while **"Their husbands lazed in the shade of the trees."** She also pointed out that while many in the West complain about the "kleptocratic elites" of Africa, she discovered that thievery extends throughout the entire culture.

The medical clinic in the town in which she lived and worked received medicines donated by international agencies, but the medicines were stolen by the workers and then sold at the local store. **"If you were sick and didn't have money, drop dead."** That attitude, she assured her readers, was **"normal"** and doesn't change with the venue. The article goes on about life in Senegal and all of sub-Saharan Africa: **"The more I worked there and visited government officials doing absolutely nothing, the more I realized that no one in Senegal had the idea that a job means work. A job is something given to you by a rela-**

**tive. It provides the place where you steal everything to give back to your family."**

In the end, she couldn't wait to get home and then asks, **"So why would I want to bring Africa here? Non-westerners do not magically become Americans by arriving on our shores."** Oh, she does believe that the people of Senegal will eventually solve their own problems but, as she put it, **"on their terms, not ours. The solution is not to bring Africans here."**

In her last paragraph, McQuillan states, **"We are lectured by Democrats that we must privilege third world immigration by the hundred million with chain migration. They tell us we must end America as a white, Western, Judeo-Christian, capitalist nation to prove we are not racist."** Then she states emphatically, **"I don't need to prove a thing."**

She continues, **"Leftists want open borders because they resent whites, resent Western achievement, and hate America. They want to destroy America as we know it. As President Trump asked, why would we do that? We have the right to choose what kind of country to live in. I was happy to donate a year of my life as a young woman to help the poor Senegalese. I am not willing to donate my country."**

## Black Pseudo-History

As part of multiculturalism's never-ending efforts to glorify blacks, sources such as the **Black Inventions Museum** claim to chronicle the genius of African-American inventors. It is claimed that the world would find itself without the helicopter, peanut butter, light bulbs, automobiles or the phonograph, were it not for black inventors. Unfortunately, all of these claims are pure humbug!

For example, there's delicious irony in the claim that a race unable to invent the wheel was somehow able to invent the first automobile. In 1885, a white man named Karl Benz invented the first automobile that combined an internal combustion engine with an integrated chassis:

Despite this, many promoters of multiculturalism credit a black man named C.R. Patterson with having done so.

Another ludicrous claim is that another black man -- Paul E. Williams -- invented the helicopter. The first functional helicopter was actually invented by Igor Sikorsky in 1936, which he called the VS-300. Six years later he had his invention in mass production. While Paul Williams WAS awarded Patent # 3,065,933 in 1962 for his Lockheed Model 186 (VH-51) -- which incorporated design modifications on Sikorski's original model -- this occurred 24 years after Sikorski's VS-300 prototype.

Another well-known example involves George Washington Carver and the claim that he invented peanut butter in 1903.

Yet, according to Barry Mackintosh—a historian with the **National Park Service** that manages the **G. W. Carver National Monument**—most of Carver’s peanut creations were either **not** original, or else they were impractical or of questionable effectiveness. (Barry Mackintosh. “George Washington Carver: The Making of a Myth.”)

None of the products created in Carver’s laboratory were ever widely adopted. On the other hand, peanuts – which are native to the New World tropics -- had been made into a paste by the Aztecs for hundreds of years before G.W. Carver’s research began in 1903. In fact, the first modern patent for peanut butter (US Patent #306727,) was issued in 1884 to Marcellus Gilmore Edson, a white man from Montreal, Canada.

Below is a sampling of other technological advances alleged to be invented by blacks, which are juxtaposed with a brief description of their true inventors. Its purpose is not to deride blacks but to correct the historical record:

**Dirigible:** A black man named J.F. Pickering is often credited with inventing the airship, or “*dirigible*” in 1900. In fact, a French engineer named Henri Giffard successfully flew a powered airship in 1852, half a century earlier. Hundreds of inventors received patents for early airship designs and modifications, but there is no evidence that Pickering’s ever got off the ground.

**Lightbulb:** A black man named Lewis Latimer is alleged to have invented the incandescent lightbulb. Yet, the first practical lightbulb – one that didn’t burn-out quickly -- was invented by Thomas Edison and patented in 1880. Lewis Latimer was actually a very talented researcher who had earlier worked for a competitor of Edison, Hiram Maxim, and did not begin working for Edison until 1884, four years after Edison’s patent was granted.

Neither Latimer, Edison or Maxim were actually the first inventors of the incandescent lightbulb: English chemist and physicist Joseph Swan experimented with a carbon filament in 1860 and by 1878 had developed the first incandescent lightbulb, which was then patented in Britain.

**Refrigeration:** A black man named John Standard is often credited with inventing refrigeration. In fact, a white man named Oliver Evans first designed a method of refrigeration based on a “vapor-compression” cycle in 1805. The first functional model incorporating Evans’ design was built by another white man, Jacob Perkins, in 1834.

In fact, John Standard’s design did not incorporate the vapor-compression” system that has been adopted today, but was merely an old-fashioned “ice box” system used as a low-tech method of cooling air which was useful but hardly a revolutionary technology.

The first modern system for controlling both temperature and humidity of indoor air was built by Dr. Willis Carrier, who received the first of many patents in 1906 for his “*Apparatus for Treating Air.*” In 1911 he published the scientific basis for modern air conditioning design, and four years later founded the **Carrier Engineering Corporation**, which is still in existence today.

While there have been many successful black inventors, those who promote “black pseudo-history” are merely disseminating fraudulent and misleading information. What their efforts actually reveal is that there are many who are willing to sacrifice the accuracy of the historical record on the altar of multiculturalism.

It is fairly simple to understand how this situation evolved, one in which blacks are wrongly credited with technological advances that were actually created by whites.

The “curator” of the **Black Inventions Museum** in Hammond, Louisiana is a man named Brother Umar Bey. “Bey” is a common surname among Black Muslims in the U.S., many of whom converted to Islam while serving a stretch in their state’s penitentiary.

Few readers need to be reminded that Islam – especially as it’s practiced by blacks in the U.S. – incorporates a liturgy that falls somewhere between fantasy and psychotic delusion. For example, the **Nation of Islam** teaches that a black scientist created the white man in a test tube, a claim that provides a great deal of insight into the exhibits found in the **Black Inventions Museum!**

# The Mythology of M. L. King Jr.

From January through about June of each year, this nation celebrates **Martin Luther King, Jr. "Day."** King was granted sainthood by the left after he was assassinated in 1968, but even then a growing body of evidence was beginning to emerge that drew a stark contrast between King's media-concocted "sainthood" and the *real* man. While King's life was not exactly an open book, his moral failings were becoming sufficiently well known to quash any notions of "*sainthood*."

But to prevent the truth from coming to light and ruining the scam, two things were necessary: First, the *worst* of King's excesses had to be filtered by the news media and second, his manufactured persona had to become part of a false narrative. For instance, even King's *name* was fraudulent. His father, Rev. Michael King, Sr. "borrowed" the name "*Martin Luther King*" without benefit of a legal name-change. Thus did son Michael Jr. become "Martin Luther King Jr." in the same manner. We must accept the title "Reverend" because he functioned as such when he wasn't drinking and whoring, but his claim to the title "*Doctor*" is as bogus as his name.

**As in the cases of Abraham Lincoln and John and Robert Kennedy, King's assassination granted him martyrdom and immunity from having the truth about his private life exposed. It also elevated him to the status of a saint who wanted only brotherhood between the races. Those who knew King best knew that he had a very different opinion of whites than those appearing in his scripted sermons.**

King came to the attention of the government when he became involved with the **Communist Party of the USA**

(CPUSA). A lot of high-profile blacks -- including Rosa Park, who "refused to sit at the back of the bus" -- were groomed by CPUSA to participate in the black "civil rights movement." Of specific interest to the FBI was King's association with Jewish attorney Stanley D. Levison, a "*secret*" member of the CPUSA. On the orders of Robert Kennedy, the FBI began wire-tapping King's home and office in November of 1963.

**Eventually, King's private life became as great a source of interest to the FBI as his questionable *political* associations. It soon became evident to the FBI that King was a sexual libertine with a morally reprehensible personal life. At one point, King and several associates met in his hotel room and discussed which female members of his congregation were most suitable for engaging in certain sex acts with him. When one of the women who were present objected, King stood by laughing as one of his deputies forcibly raped her.**

A handwritten addendum stated: "*King looked on, laughed and offered advice.*" The document's final pages narrated events until March 30, 1968, suggesting that the unfinished revision was abandoned after King's assassination, though Justice Department investigators publicly testified in 1977 that the tapes and the transcripts were genuine and accurate. Throughout the 1960s, when no precedent for the public release of FBI documents existed or was foreseen -- such as the **Freedom of Information Act** -- FBI agents never anticipated their work would see the light of day, so they had no motive to embellish the recordings or their transcripts, which currently remain under court-ordered seal.

After King's assassination, it was determined unwise to release the full transcripts and recordings for fear of a further and more violent racial "*backlash*." Thus the FBI's recordings and transcripts were sealed by court-order until 2027. Even so, hundreds of FBI reports and surveillance summaries have appeared over time on the internet. Many websites posting such materials -- such as the National Archives -- are poorly-annotated and difficult to explore. For those seeking the truth about MLK Jr., the search has often been endless and laborious, indicating

the intent of the government to keep these facts well hidden!

While King's sexual adventures claimed the interest of the FBI, of far greater importance was his relationship with Stanley Levison who first met King in 1956. Levison and his close friend -- Alice Rosenstein Loewi -- considered King very useful to the CPUSA and gave him a total of \$10,000 in cash gifts, the equivalent of \$87,000 in current dollars. In retrospect, the FBI's failure to investigate Levison's generosity towards King is as baffling as its failure to inform Attorney General Robert Kennedy that those gifts mirrored Levison's ongoing contributions to the CPUSA!

Although it was known that Levison and MLK's aide Fred Bennett made personal contributions to the CPUSA until March of 1963, only *now* have internal FBI documents revealed the amounts involved: \$25,000 in 1957, \$12,000 in 1958, \$13,000 in 1959, \$12,000 in 1960, \$12,000 in 1961 and at least \$2,500 in early 1962. That total of \$76,500 is the equivalent of more than \$650,000 today. Yet, in March, 1964, when the FBI received information from the IRS about King, the FBI was fixated primarily on his personal conduct, eclipsing far more important concerns about possible communist manipulation of King.

On Wednesday, November 18, Hoover told a group of women reporters that King was ***"the most notorious liar"*** in the U.S., a quote that generated headlines. King responded with a telegram telling Hoover that he was ***"appalled and surprised at your reported statement maligning my integrity"*** and made a public statement asserting that the 69-year-old Hoover ***"has apparently faltered under the awesome burden, complexities and responsibilities of his office."***

On January 5, 1965, agents listening in on the Atlanta wiretaps heard King and his aides discussing a troubling tape he had received. After a highly-publicized meeting between King and Hoover, FBI officials were instructed to have all of the hotel room recordings transcribed in full and to prepare new summary reports while warning agents *not* to let the matter become public.

The FBI then sent King an anonymous letter with copies of the tapes warning that ***"you will find on the record for***

***all time (evidence of) your adulterous acts, your sexual orgies (involving) various evil playmates"*** and instructed: ***"King, there is only one thing left for you to do. You know what it is. You have just 34 days in which to do so...There is but one way out for you. You better take it before your filthy, abnormal fraudulent self is bared to the nation."*** Obviously, Hoover was demanding that King take his own life or be exposed for the charlatan and hypocrite he was.

The most significant issue raised by the FBI's documents involves the inevitable reconsideration of Martin Luther King's public reputation that will take place when the sealed FBI tape recordings and transcripts are eventually released to the public in 2027. It is inevitable that those with a vested interest in preserving the man's "sainthood" will call for the physical destruction of all such records with the claim that they were *"illegitimately obtained,"* though that claim is false.

**Some believe the allegation that King *"looked on and laughed"* during a forcible rape makes efforts to protect his reputation impossible. Since it is known that King tolerated and personally employed violence against women, that alone poses an insurmountable challenge to those laboring to preserve his historical stature.**

On March 3, 1968 -- a month before his death -- King told his *Ebenezer Baptist Church congregation* that ***"There is a schizophrenia, as the psychologists or the psychiatrists would call it, going on within all of us. There are times that all of us know somehow that there is a Mr. Hyde and a Dr. Jekyll in us."***

These may be the words of a man who recognized the inevitability that the truth might ultimately destroy the myth.



# Truth None Dare Speak

Sadly, we live in a world in which wishing frequently "trumps" reality. One of the realities that can't be tolerated by Cultural Marxists is the concept of "measurable intelligence," identified by the term IQ. It is an established fact that Intelligence is NOT equally distributed across the human race. This reality is rejected and despised by the left, but this changes nothing.

The very concept of IQ is rejected by the left because the many hundreds of IQ tests conducted world-wide over the last century have examined *every conceivable variable*, with the result that Blacks *always* rank at the bottom, even in non-verbal tests. There has never been a legitimate IQ test with results that deviated from this outcome. Naturally, in our hideously race-conscious society, this cannot be tolerated.

Interestingly enough, even using culture-free, unbiased testing designed by *Black* psychologists, no amount of analysis or wishful thinking is able to generate any improvement in Black IQ. One particular test -- Raven's "Progressive Matrices" -- is completely non-verbal, yet even the brightest of African Blacks (South African university students) still score 15 to 18 points below the average white IQ score.

In the United States, race and IQ have been variables in well over 600 scientific studies, and each has demonstrated a 15 to 18 point average IQ disparity favoring whites over blacks. This translates into between 11 and 16 percent of the black population having an IQ above 100, the general population median. These results consistently mirror college admissions tests such as the *Scholastic Aptitude Test* and the *Graduate Record Examination*, as well as standardized tests for job applicants in the corporate sector and in the military.

But the mean intelligence of American Blacks is much lower than that of American Whites. The least intelligent ten percent of Whites have IQs below 81; forty percent of Blacks have IQs that low. Adjusting for population differences, only one Black in six is more intelligent than the average White, while five Whites out of six are more intelligent than the average Black. These differences appear in every test of general cognitive ability that anyone

of any race or nationality has yet been able to devise.

Furthermore, these disparities are endlessly reflected in everyday life, proving the old adage that "**Life is an IQ test.**" Why? Because IQ tests expose the lie that higher incomes and superior academic accomplishments of whites are attributable to racism and "*white privilege*," rather than native intelligence. Obviously, too many apologists for black failure have a vested interest in such false narratives, and cannot permit them to gain common currency.

There is also a strong correlation between IQ and financial success. Along with psychologists, *economists* have started taking an interest in the value of human capital, particularly the factor that psychologists call *COGNITIVE ABILITY*, or the ability of a person to solve problems efficiently. Those possessing cognitive ability *think through* problems and act based upon logical conclusions. It is worth noting that Blacks possess ten times more of the MAOA gene -- also known as the "*warrior gene*" -- than the other races. This gene is associated with violent or impulsive behavior. All available crime statistics tend to validate this finding.

Widespread intelligence testing also shows that a country's average IQ influences its *Gross Domestic Product* (GDP.) In a study made some years ago, it was found that each one-point increase in the average IQ of its population increases the per capita GDP by \$229. An even bigger increase is found where the top 5% of a country's population has unusually high IQs: In that case, every additional IQ point raises the GDP a further \$468! These are not inconsequential findings and they tend to explain a lot of what is alleged to be "*financial inequality*" among nations and races.

This is readily apparent in the fate of sub-Saharan Africa, Haiti, Zimbabwe and other nations run by blacks. For example, when South African whites handed over political power to blacks, its economic successes were quickly converted to these predictable and disastrous results.

This information and its conclusions are forbidden narra-

# Racing to The Bottom

With the rise of the Civil Rights Movement in the 50s and 60s, blacks began to have greater exposure in the entertainment industry. Both film and television featured blacks either as “sidekicks” to whites – such as Bill Cosby with Robert Culp in *I Spy* -- or as the lead in various sitcoms or as a seminal member of a group in action adventures such as *Mr. T* in *The A-Team*. Earlier there had been realistic all-black programs such as *Amos and Andy* on radio and television, but as the number of blacks in the entertainment arena increased, very great care was taken to portray them as differing from their white counterparts *only* in race.

In the very popular *Cosby Show* and other family oriented shows like *Julia* and *Family Matters*, the setting was typically middle class and most could just as easily have been white sitcoms. *Good Times* was considerably more “black” in its presentation of a lower middle-class ghetto family, but it was hardly typical. It depicted an intact family where the parents were married, the father was present, and the mother was a hard-working and decent Christian woman. Moreover, the children were articulate, well behaved and intelligent, all of whom spoke English rather than “Ebonics.” In other words, most all-black programs did not depict blacks as outside the norm of American culture.

Yet, I remember one white man writing about how much he had enjoyed the *Cosby Show* as a boy, but recalled his father’s response at the time: “Remember, son,” he had said, “they don’t live that way!” Of course, we know that there were (and are) middle-class blacks who “live that way,” but the father was speaking of ordinary blacks whose life experiences were as removed from those of his white, middle class son as that child’s life experiences were removed from the life experiences of the Windsors!

Black life, as it was portrayed on predominately white television and film, depicted a certain degree of “normalcy,” or at least that is what the white majority was supposed to believe *and accept!* Unfortunately, we were being sold a bill of goods: that there was no difference between the races beyond skin color, since this blessed normalcy appeared every week on TV, complete

with familiar and sympathetic black characters we grew to know and love. We were assured that whites had nothing to fear from blacks moving from the margins of society into its mainstream. Indeed, that was *supposed* to be the point of the entire *Civil Rights Movement*: the “normalization” of both whites and blacks in American culture that would usher in a new age without racial tensions.

But as often happens, “*the best laid plans of mice and men*” were never realized or, in the alternative, the exact *opposite* occurred. But *was* this an unfortunate accident or was the *actual* plan carefully hidden from ordinary white Americans until it was far too late to do anything about it? The incidence and numbers of blacks on television have risen to such a point that a visiting Martian watching television could reasonably assume that most Americans *are black*, and that the whites who appear are either stupid or wicked, depending upon the genre of the offering.

Even worse, ***no longer do black shows emulate white culture!*** Now, black actors and those appearing on “*reality TV*” flaunt their *own* sub-culture, often in its least flattering terms. Had blacks been portrayed in the 1950s and 1960s the way they routinely appear today, there would have been a huge public outcry. Yet, since the establishment is no longer concerned with white “*backlash*,” blacks are permitted to flaunt their sub-culture without any concern for how it plays out in middle America! And it will only get worse!

“White” shows are becoming equally stupid and violent and include so much “diversity” as to make them “white” only insofar as some of the leading characters are concerned. Indeed, aside from foreign offerings, there are few television shows or movies that do not include lots of “diversity,” even when the subject matter is exclusively white.

But it is not the prevalence of blacks in today’s entertainment industry that is so destructive! It is the acceptance of a black sub-culture that we have been assured for dec-

ades existed only in the minds of white racists. It turns out that those who warned against a lower class "black

sub-culture" knew exactly what they were talking about, because that black sub-culture has -- for all intents and purposes -- contaminated *American* culture to its detriment.

## Fred Reed on Race

Fred Reed is a writer and commentator who has a website, **Fred on Everything**. One of his most powerful and insightful commentaries was entitled "*Black Power: A Done Deal*." Not surprisingly, it was roundly condemned by race-hustlers, communists and various other "sensitive" individuals.

In it, Reed points out the nature of America's present enslavement to blacks. First, he notes how curious it is that blacks are able to dominate our national politics, since they are "*the least educated thirteen percent of the population, the least productive, the most criminal and the most dependent on government charity*." Yet, he assures us they do. In Fred's enlightened opinion, America is being dominated from the slums.

Says Reed, "*Virtually everything revolves around what blacks want, demand, do, or can't do. Their power seems without limit*." The rest of the column goes on to point out such truths as:

**Courses of instruction and policies in academia must be approved by blacks, and they must be admitted to schools for which they are not even remotely qualified;**

**Voter I.D. Laws to prevent voter fraud must be abolished because blacks consider voter fraud a legitimate electoral strategy;**

**If Blacks don't like Southern heritage, symbols or heroes, these too, must go;**

**If they disapprove of certain books, those must be banned, even if they haven't read them or couldn't read them, anyway;**

**Crime statistics must be suppressed: In other words, if a white man protects himself against a violent black criminal, this is racist by definition, and if a black**

**attacks a white it is unimportant and should not be included in the statistics;**

**Nothing must ever be said to upset blacks, although virtually everything does. As a result, the law no longer applies equally across the population but must always be interpreted so as to protect Blacks.**

As a result of the above, Fred declares that non-Blacks now live in a society that is constantly on the defensive for fear of being labeled "*racist*." This defensive behavior has become so deeply ingrained, it is no longer even recognized.

For example, in Washington, a White who complains about affirmative action will *never* speak openly on the subject, but will "*lean forward, lower his voice, and look furtively over both shoulders to see whether anyone might overhear*." Reed calls this "*the DC Hesitation*," and claims that this sort of thing has become so prevalent, people don't even realize that they are doing it anymore.

According to Reed, white defensiveness has resulted in the equivalent of a sort of "*Masonic recognition-ritual*" among them in social gatherings. He notes that this power to control speech and even thought has become so strong that one has "*to avoid mentioning watermelons, or that neighborhoods of high crime must delicately be called 'sketchy' instead of 'black' though all understand . . . what is meant*." One must also avoid words such as "*niggardly*" because many people are too ignorant to understand their meaning.

Reed then refers to an earlier column (1981) in which he wrote a piece for *Harper's* warning that the nation's "teachers' colleges" were turning out "*an incredible portion of incompetent black teachers*," a fact beyond dispute. He also pointed out they weren't doing too well with whites, either, because a competency exam in Flori-

da (cited in *Time Magazine* in 1980), revealed **25% of the whites and 79% of the Blacks failed**. All that was required by the exam was to read at a 10th Grade level and do arithmetic at an Eighth Grade level. In Reed's opinion, they should have had their B.A.s rescinded.

Reed then bemoaned the manner in which blacks have a disproportionate influence over the presidency and the appointment of an Attorney General. He stated correctly that Obama was elected **because he was black** and, as often happens when blacks are in charge, Obama surrounded himself with **other** blacks whose competency and integrity were as suspect as his own.

Reed believes that despite their power, black problems are now primarily "self-inflicted." They continue to "consume inordinate amounts of public and governmental attention" with no resolutions in sight, because blacks are offended when real solutions are offered by non-blacks!

In the end, Fred asks, "Why do I have to hear, endlessly, about the "achievement gap? Whether of genetic or of cultural origin, it seems as immutable as Avogadro's Number, and I can do nothing about it. I raise my children. They need to raise theirs. They rule. It is astonishing."

## On The Other Hand

It has been alleged that blacks cannot be "racists" because they lack the power necessary to exhibit that trait. Only those with power can be "racist," they claim, so the obvious implication is that only *whites* can be racists. But let us look more closely at this irrational proposition.

First, in today's usage, a racist is someone who hates or discriminates against people solely because of their race, and ignores the fact that the term was a creation of communist Leon Trotsky to silence dissent. The concept of racial hatred -- previously identified as bigotry or prejudice -- has nothing whatsoever to do with "power," since one can be totally powerless and *still* hate! Indeed, the powerless are far more likely to seethe with hatred than those *with* power, who often have better things to do with their time and energy.

Secondly, the idea that American blacks are *without* power is ridiculous! Like Jews, blacks have power disproportionate to their percentage in the population. There are blacks represented in the upper echelon of every aspect of society, and *especially* in government. Indeed, we have just survived two terms of a "black" president who was elected and kept in office primarily *because he was black*! Had Barack Obama been white, he would not have remained in office, never mind elected to a second term! But Obama's race was a virtual *carte blanche* for his lawless administration. So the idea that blacks have no power is nonsense!

Contemporary history demonstrates not only that the majority of blacks are "racist" in their dealings with whites, but also that this attitude has manifested in black-on-white violence that goes well beyond ordinary criminality! If honestly reported by the news media, the horrendous nature of most black-on-white crimes would have quickly manifested in levels of white "racism" we are routinely assured exist! The nature and extent of black-on-white violent crime is carefully suppressed to allow the news media to use race as a weapon against whites. Despite this, the average black politician and other "race hustlers" relentlessly whine about "*white supremacy*," and warn that America is returning to the days of the Klan and *Jim Crow*.

This begs the question why whites -- the creators of Western Civilization -- are considered the "*scourge*" of the planet. Indeed, we are told that there is *no* evil in existence that has not been instigated and perpetuated by whites! They came to the *New World* and the *Third World* and stole the land from the native population, killing and enslaving them. We are told that *only* whites have brought evil and chaos to these supposed "utopias."

Sadly, far too many whites believe this lie. For instance, consider the charge of "stealing the lands" of "native peoples": let us not forget that in the New World, long

before the coming of the white man, the indigenous non-white populations routinely preyed upon each other. And this same situation existed in Africa with its endless tribal wars.

Furthermore, as far as Africa is concerned, *what exactly did the white man "steal" from the native black population?* Did whites steal the continent's mineral wealth? Africa is indeed rich in minerals, but the native population mindlessly trod over its mineral wealth and remained oblivious to its existence and value, so it could hardly be argued that the white man's techniques for extracting it were a matter of "theft."

Did whites steal their land? Africa is indeed rich in fertile land, but the native population made no more use of the land than they did of its minerals. Aside from small plots for growing a few vegetables, there were no vast tracts of land under cultivation by the native population before the white man arrived.

And what about Africa's wildlife and timber? Again, the natives hunted and gathered but only as their primitive ancestors had done. Nor did they build boats able to sail upon the waters to catch the abundant harvest of fish that awaited off-shore for those with the technology to

do so. As far as "civilization" is concerned, most sub-Saharan African dwellings were mud and grass huts that protected them from marauding beasts only by using wild thorn bushes, as had been the case since the dawn of time.

But the coming of the white man to Africa *did* make a difference: He brought the blessings of civilization including medicine, public health, infrastructure and the ability to use natural resources in ways previously unknown to the native populations. He also brought Christianity that often displaced tribal wars, voodoo and savage rituals. This "invader" also brought inventions that provided clean water and permitted agriculture on a scale that improved and expanded the native African's lifespan.

Given what the West has actually bestowed upon the black man, condemnation and extermination seem a very poor recompense indeed! In fact, our history with blacks and other *Third-Worlders* is probably best characterized by the old adage, "**No good deed goes unpunished.**" Rather than denunciation, these mindless ingrates should be thanking us for dragging them out of the "*Stone Age.*" But, as white influence declines, it won't be surprising to see savagery return.

**EASY Predictions**

years ago. If one looks at these sports it is impossible to ignore the fact that both basketball and football are dominated by blacks. Blacks account for 90% of NBA players, 75% of WNBA players and 70% of NFL players.

Major league baseball is the only sport that comes close to reflecting the racial composition of the general population: It is 60% white, with the remaining 40% of players are Hispanic or black. Even so, in combination, blacks form a consistent majority of professional athletes in the three major American sports. Not surprisingly, there is no outcry from the “black community” about an “unfair” distribution of *white* players in the NBA or the NFL!

**The sports media have become as leftist as their “betters” in the traditional news media. At a very early stage, all members of the news media – except those in the “alternative” or conservative news media – learn that no one ever succeeds unless they adopt what is called a “woke” political and cultural perspective. Sports journalists are also dependent on the athletes themselves for interviews and access, since these are their stock-in-trade.**

Hence, the leftist sports media is heavily dependent upon a large repository of black opinion on matters of the day. It is not far-fetched to see the increasing role of sports figures in political commentary as being directly connected to the *race* of those voices.

The tenure of Jeff Sessions as Attorney General (AG) is best characterized as cowardly and incompetent: It profoundly disserved President Trump and should not be forgotten or forgiven by any Alabama Republican Primary voter.

Sessions reminds me of Hamlet in the famous tragedy by William Shakespeare of the same name. In every Shakespearean tragedy, the main character (or “protagonist”) possesses a fatal flaw that leads to his own tragic demise: In *Hamlet*, that fatal flaw is *INDECISION*, a trait best captured in Hamlet's famous soliloquy:

*“To be or not to be: That is the question. Whether 'tis nobler in the mind to suffer the slings and arrows of outrageous fortune, or to take arms against a sea of troubles...”*

A.G. Sessions showed Hamlet-like indecision from the start: On his first day in office – upon the advice of the same *Justice Department* officials who conspired to frame President Trump with the phony “Steele Dossier” -- he recused himself from any role in that investigation. His failure to act decisively paved the way for Special Counsel Robert Mueller's endless and open-ended witch-hunt.

This recusal by Sessions allowed a subordinate of dubious loyalty and integrity -- Deputy AG Rod Rosenstein -- to appoint Robert Mueller as Special Counsel, and in a manner that violated numerous Constitutional protections

The potential penalties include 14 years in prison and \$30,000 in fines.

The affidavit from the *Michigan State Police* alleges disparities between a number of Absentee Ballots cast during the election and the Qualified Voter File, the official roster of registered voters. County officials uncovered her fraud during a post-election audit of Southfield's election returns.

Hawkins' fellow "Democrat" -- Michigan Secretary of State Jocelyn Benson -- was quick to issue the following statement in order to allay concern over the misconduct of Sherikia Hawkins:

*"I want to be clear, the allegations that the Southfield clerk falsified official election records did not alter the outcome of any elections...There were no races that were won or lost as a result, and there were no voters who are disenfranchised."*

**This statement by Benson ignores the fact that Michigan is rife with voter fraud, and that focusing exclusively on the consequences of a single bad actor is to turn a blind eye to the cumulative effect of many black criminals working in concert to subvert every election.**

**Supreme Fools Strike Again!**

Demonstrating their lack of judgement and inability to understand the Constitution, the Supreme Court has ruled that the 2020 Census will not be permitted to include a question about citizenship.

I was an *enumerator* in the **2010 Census**. In accord with mandated procedures in 2010, we counted every living resident: We counted visa over-stays, Green Card holders, foreign diplomats, legal immigrants, illegal aliens, and all children over three months of age. This resulted in a Census count of 308,745,539.

Moreover, in many "group counts" – such as hospitals or military and police barracks -- we counted everyone on a specified date, even though many of those counted were only temporarily assigned, resulting in significant over-counts. In fact, The over count in the 2010 census probably exceeded 30-million.

The Census is required by the Constitution every 10 years to establish an accurate numerical count for the purpose of Congressional Apportionment. Based on a population of 308 million citizens, each Congressional District should have 711,000 citizens residing there. (Maxine Waters' district has the required number but over 110,000 of them are Mexican nationals.)

Prohibiting a question about citizenship is a ploy to help generate a demographic upheaval, and establish a permanent "**Democrat**" majority, just as it has already been done in California.

California has been run by Democrats for the last 25 years, and now has over 10-million Mexican and Central American residents. In short order, the country will follow the same path if "**Democrats**" gain control of the Congress and Presidency.

**More Black Skin Privilege**

A high-profile black criminal defense attorney in Baltimore has been indicted for racketeering, money laundering, and drug distribution. His arrest demonstrates two things: First, the five years it took to finally bring an indictment validates my theory of "Black Skin Privilege"; And secondly, it demonstrates the way in which the beneficiaries of race quotas in professional schools do NOT become good Americans, they merely become wealthy black crooks and race-hustlers.

Federal prosecutors recently charged Ken Ravenell with these crimes, which prosecutors allege were committed in an effort to assist a wealthy Jamaican drug lord named Richard Byrd to obscure the crimes involved in his drug operations. **Drug Enforcement** agents claim Byrd's operation was one of Baltimore's largest in recent memory.

A federal grand jury indictment was unsealed on September 11, 2019 disclosing the results of a closely-guarded investigation of Ravenell and his client, Richard Byrd. The investigation followed raids on Ravenell's office by federal agents in June of 2019, as well as an earlier raid in 2014.

Federal prosecutors claim that from 2009 to 2014, Ravenell conspired with Richard Byrd to assist his drug operation. They allege Byrd and his crew paid Ravenell for *illegal* advice on how they could avoid detection by law enforcement. According to the indictment:

***"Ravenell instructed members of the conspiracy to utilize certain drug couriers, to utilize specific modes of transportation, and to transport shipments of drugs and money at particular times of day, all for the purpose of evading law enforcement...Ravenell and other members of the conspiracy used the law firm's bank accounts to***

***launder money and funnel hundreds of thousands of dollars to and from various businesses and individuals."***

They also claim that Ravenell advised Byrd's operation to avoid wiretaps by communicating exclusively in person. He also allegedly advised them to use disposable cell-phones and to camouflage their intended travels by booking dozens of trips at one time and cancelling all but the intended trip at the last minute. Byrd and his partners were also counseled to adopt false identities to obscure their banking activities.

Despite the advice of Ravenell -- an attorney clearly empathetic with his client's criminal activities -- Richard Byrd pled guilty in 2016 to conspiracy to distribute drugs and launder their proceeds. He was sentenced to 26 years in federal prison, ordered to pay \$20 Million in fines and forfeited \$1.6 Million in drug money seized by federal agents.

Proving there is no "honor" among black crooks, Byrd then "dropped a dime" on Ravenell in an effort to get his own conviction overturned or his sentence reduced.

**A Modest Proposal**

## WHITE PRIVILEGE CHECKLIST: A Response

This is a list supposedly illustrating examples of “*white skin privilege*” that were posted in Yudof Hall at the *University of Minnesota*.

Each complaint is followed by the response of a non-communist adult, one who remains unindoctrinated by the lies of race-hustlers and other false prophets of cultural Marxism:

**1. I can arrange to be in the company of people of my race most of the time.**

(It is a universal truth that most people prefer the company of their own race, and this principle applies to blacks as well as to whites or Asians or anyone else. But if you must abandon the company of fellow blacks, according to the FBI’s *Uniform Crime Reports* you are demonstrably safer in the company of whites or Asians.)

**2. I can go shopping alone most of the time, pretty well assured that I will not be followed or harassed.**

(This is fictitious. Blacks are infinitely safer shopping in predominately white areas than in black areas. Blacks primarily need to be wary of other blacks, who prey on them all the time. Many are capable of murdering each other over something as trivial as wearing the wrong-colored garment.

If you are referencing the fact that blacks receive greater scrutiny by merchants than other races, don’t you think it might have something to do with “*flash-mobs*,” or the fact that infinitely higher rates of shop-lifting occur with items marketed to blacks? )

**3. I can turn on the television or open up the front page of the paper and see people of my race widely represented.**

(If blacks ever manage to do anything noteworthy -- except commit violent crimes and then complain about law enforcement -- then they may receive the news coverage

they apparently desire. Meanwhile, the SPORTS section of the news is saturated with the exploits of blacks.)

### BOOK REVIEW:

#### ***Black-Listed by History: The Untold Story of Senator Joe McCarthy and His Fight against America's Enemies.***

M. Stanton Evans; Crown Forum Publishing, New York; 2007. (662 pp.)

The French philosopher Voltaire once observed that ***"history is a pack of lies agreed upon."*** He didn't know the half of it, because he died almost two centuries before the *"McCarthy Era."*

There are two things Voltaire could never anticipate, however: The first is the truly heroic efforts of men such as Stan Evans, who is like a pit-bull with a bone when it comes to correcting the historical record. The second is the recent release of transcripts by U.S. Army cryptanalysts who, back in 1943, began deciphering coded cables transmitted by Soviet intelligence to their myriad agents engaged in espionage against the West.

Since the release of these ***Venona Cables***, things have never been quite so easy for the left in this country. The effect of *Venona* has been to expose the true nature of American Communism, as well as initiate the resurrection of Joe McCarthy's reputation. These must be infuriating blows for the left to endure since, to paraphrase Ann Coulter, their reflexive use of the term ***"McCarthyism"*** has allowed them to escape legitimate criticism for nearly six decades.

This book ***should*** become the definitive history of the McCarthy Era: It is a staggeringly thorough and monumental analysis of the penetration of the U.S. Federal Government by Soviet espionage in the mid-20th Century. It is also a fascinating history of Senator Joe McCarthy's crusade to publicize Soviet subversion of the United States, and the sinister forces that were able to thwart his efforts. If at times the author seems inclined toward overkill when hammering a point, it is because he has literally left no stone unturned, nor failed to taxonomize every night-crawler to be found thereunder.

Such diligence no doubt reflects the author's recognition of the inevitable double standard confronting those who would defend Joe McCarthy, but his caution is wisdom: Most histories of the McCarthy era are content to parrot conventional falsehoods, so that an entire tapestry of deceit has been woven from the many lies and errors compounded by previous efforts. It is difficult to improve on the author's pithy description of the problem:

***"...we are left in many cases with secondhand data of doubtful value that are nonetheless recycled from place to place as supposed truths of history...The net effect of such compounded error is an almost complete inversion of the empirical record on McCarthy and his cases."***

### SOURCES

In order to avoid contributing to this problem of compounded error, Evans has taken great care to rely almost exclusively on ***original sources*** of information. To wit:

\* ***The Venona Cables***, which consist of ***U.S. Army Signal Corp*** interceptions and translations of Soviet intelligence cables to their agents in the U.S., many of which actually identify these agents by workname. (These were so ***ultra-secret*** that even President Truman was never told of them which, in retrospect, was a wise decision on the part of the FBI and Army Intelligence...)

\* The FBI's voluminous ***Counterintelligence Archives***, in which literally thousands of individuals were scrutinized because of their contacts with Soviet spies and so-called

"front groups." These became available in the very late 20th Century.

\* Senator Joe McCarthy's own Papers, as well as newly available Senate Executive (or closed) Hearings of Senator McCarthy's own **Senate Permanent Subcommittee on Investigations** (PSI), which have remained unavailable to the public for the previous 50 years. They first became publicly accessible in 2003, thanks to *Freedom of Information* lawsuits by the author and others.

\* The papers of two of McCarthy's Senate enemies, Milard Tydings (D-MD) and William Benton (D-CN). These sources were invaluable, because they permitted Evans to access many crucial documents mysteriously missing from the **National Archives** (a la Sandy Berger,) and thereby cross-check them against documents from other sources. **This allowed Evans to identify many of McCarthy's heretofore anonymous cases by name and nature of federal employment.**

### HISTORICAL ANTECEDENTS

It is nearly impossible to understand the motives and actions of Senator Joe McCarthy outside their historical context, and without resort to at least a brief summary of earlier initiatives by others in the area of security and loyalty at the federal level.

Beginning with Congressman Hamilton Fish (R-NJ) in 1930, the U.S. House of Representatives showed a continuing interest in security and loyalty issues involving federal employees. This produced additional hearings in 1934 and 1935, and then in 1938, spawned the **House Committee on Un-American Activities** (HUAC). It was the HUAC before whom many former communists, such as Whittaker Chambers (Soviet code name "Karl") and Elizabeth Bentley (Soviet code name "Myrna"), testified about their earlier espionage activities and those of fellow federal employees.

Their testimony was shocking to many, because they revealed two things not generally grasped by the public at that time. They proved not only that communist activities in the U.S. were totally subservient to Moscow, but also that their ultimate purpose went far beyond stealing classified government documents. In fact, according to

Chambers and Bentley, their ultimate objective was to place agents in positions of authority within the federal government in order to influence policy-making decisions.

Then, in 1939 the **Hatch Act** was passed, which forbade the hiring or retention of federal workers who "advocated the overthrow of our constitutional form of government." In 1941, this measure was further strengthened by passage of **Public Law 135**, which authorized the FBI to investigate federal employees who were members of subversive organizations advocating the overthrow of the federal government.

However, with the advent of W.W. II, when the Soviet Union became our ostensible ally against the Axis Powers, the use of strict security clearances was waived when vetting the many individuals needed to staff a variety of federal agencies organized in response to the war effort. This produced a situation in which many people who would normally have been deemed security risks -- due to Communist Party membership or affiliation -- had this aspect of their resume` overlooked. Among these were a significant number of employees at the CIA's predecessor, the *Office of Strategic Services* (OSS,) as well as at the *Board of Economic Warfare* (BEW,) the *Office of War Information* (OWI,) and the *State Department*.

Also in the early 1940s, Francis Biddle, FDR's Attorney General, became briefly interested in communist infiltration of the federal government, thus making him nearly unique within the Roosevelt Administration. He produced a roster of 11 "front" groups, whose communist origins and purposes he documented, relying on intelligence from the FBI. This **Biddle List** was distributed to cabinet level agencies for the purpose of security vetting of prospective employees.

Later, during the peacetime summer of 1946, a State Department official named Sam Klaus penned a 106 page confidential memo, once again about security problems at the State Department. This **Klaus Memo** voiced many concerns, among them that a number of alleged Communist Party members, "sympathizers" and "suspects" were employed at State, as well as some individuals thought to be Soviet agents by security personnel. The memo included the names of 33 such individuals, among whom was Alger Hiss (Soviet code name "Lawyer").

In response, Congress passed the **McCarran Rider** in July of 1946, drafted by Pat McCarran (D-NV), which gave the Secretary of State authority to fire any State Department employee if he deemed it in the national interest, irrespective of Civil Service rules and regulations. This was presumed to offer an expeditious solution to State's security problems, since it greatly increased the Secretary's discretion and bypassed the need for the FBI to divulge the nature and sources of its information in employee hearings.

Then, in Late 1947, a former FBI agent named Robert Lee was assigned the task of organizing a group of investigators to review security records at the State Department. His actions were prompted by bipartisan pressure from the House Appropriations Committee and other members of Congress, who had been critical of lax security at State for almost a decade. ***This list of 108 security cases became known as the "Lee List," and provided the majority of cases Joe McCarthy initially introduced to the Senate.***

**THE REASON FOR THIS HISTORICAL SURVEY IS SIMPLY THIS: Despite all the testimony of former communists who named names before the HUAC, despite the *Hatch Act* and *Public Law 135*, despite the *Klaus Memo* and *Lee and Biddle Lists*, and despite the new and expedited means of removing security risks at State in the form of the *McCarran Rider*, practically every federal employee who had ever been exposed as a communist was still employed by the federal government in 1950 when Senator McCarthy arrived in Washington.**

In many instances, these security risks were simply permitted to resign, but were then immediately rehired by the federal government, frequently at their original agencies. For all intents and purposes, there was no security vetting of federal employees during the Roosevelt and Truman Administrations: Indeed, Communist Party membership appears to have been a résumé enhancer rather than a hindrance to employment at State. Thus did Joe McCarthy seize the gauntlet and begin the process which, sadly and wrongfully lead to his own demise ...

Evans repeatedly turns to two historic events which clearly illustrate the capacity of Soviet agents to infiltrate the federal government, and then profoundly influence U.S. foreign policy to its detriment. These involve the nearly simultaneous campaigns during World War II to champion Mao's Chinese communists over Chiang Kai-shek's rival anti-communist forces, and an almost identical campaign to promote Tito over the anti-communist General Mihailovich in Yugoslavia, thus ensuring both nations remained safely within the post-war Soviet orbit.

Regrettably, during the war, American interests in China were "represented" by two Soviet espionage agents acting as observers for the U.S. These two were John Stewart Service of the State Department and Treasury attaché Solomon Adler (Soviet code name "*Sachs*"). These two homosexual roommates teamed up to carry out a relentless and feverish campaign to vilify and subvert Chiang Kai-shek's anti-communist Kuomintang regime, while they worked diligently behind the scenes to nudge the U.S. into a strategy of favoring and assisting Mao Tse-tung's rival communist regime in Yenan.

In concert with their silent partner and another roommate named Chi Chao-ting, a Soviet agent of Chinese ethnicity, they sent prolific memos and reports, all "mutually-reinforcing" and all viciously critical of Chiang, while heaping voluminous praise on Mao. The author trenchantly describes this phenomenon:

***"In dispatches totaling 1,200 pages, Service couldn't find a good word to say about the anti-communist Chiang Kai-shek. What poured forth instead was a steady stream of venom, an exercise in which the major challenge appeared to be finding different ways of making the same charges ad infinitum...While many aspects of the Service memos might be usefully examined, one in particular is worth a note in passing: The extent to which he presented the Chinese Reds as democratic, non-radical, pro-American, not really communist, and so on."***

Their campaign was so breathtakingly dishonest that it even went so far as to argue that only Mao's forces were actively engaged in fighting the Japanese, while claiming that Chiang's forces were engaged in collaboration and

treason. Despite the truly massive extent of their lies and disinformation, the claims of these two men soon became official policy in Washington.

Their dispatches stand in stark contrast to the reports of objective observers, such as Gen. Albert Wedemeyer who, for many months, was the Army's commanding officer in the war against Japan on Chinese soil. Gen. Wedemeyer observed little interest on the part of Mao's forces to engage the Japanese – indeed, he accused **them** of collaborating with Japan – and argued instead that they seemed exclusively concerned with seizing the areas vacated by Chiang's forces when the latter retreated under pressure from Japanese offensives. (Mao ultimately confessed as much in his definitive biography written by Jung Chang.)

Equally crucial for the fate of China was the additional collusion between Solomon Adler and another Soviet agent at the Treasury Department named Harry Dexter White (Soviet code name "*Richard*"). At the urging of Adler and without any authority, whatsoever, White "financially strangled" Chiang by withholding \$200 Million in gold promised to Chiang by FDR. Thus, with little or no hard currency to finance his simultaneous wars against the Japanese and Mao's forces, Chiang's army was eventually driven to the Island of Formosa by Mao's forces, with a deft assist by the Stalin's agents at State and Treasury.

Unbelievably, an almost identical scenario transpired regarding our policy toward Yugoslavia in the latter stages of World War II. Here an OSS agent named Linn Farish (Soviet code name "*Attila*") teamed up with Wild Bill Donovan's top assistant, Duncan Lee (Soviet code name "*Kokh*") and Soviet moles in British and Canadian intelligence to manufacture a staggeringly fraudulent picture of the communist guerrilla leader Tito, while engaged in a massive disinformation program to defame the anti-communist and anti-Nazi guerrilla leader, Gen. Draja Mihailovich.

While ignoring the inconvenient fact that Tito never engaged the Nazis until **after** the Hitler-Stalin Pact ended with the Nazi invasion of Russia, these worthies depicted Tito as not only democratic, but credited his forces with doing all the fighting as well. Meanwhile, Mihailovich was

portrayed as a Nazi collaborator. In addition, Farish and others conspired to wildly inflate the size of Tito's forces, while also crediting Tito with many successful operations actually carried out by Mihailovich.

Farish's dispatches were adroitly placed in the hands of FDR immediately prior to the Teheran Summit, where the decision to favor Tito's forces and abandon those of Mihailovich miraculously became the first item on the agenda. As the author observes:

***"Thus did Linn Farish's tribute to Tito and condemnation of Mihailovich make their way to the loftiest reaches of global power. As Churchill was already persuaded and Stalin needed no persuading, this priming and conditioning of Roosevelt helped seal the doom of anti-Communist forces in the Balkans...It would be only a matter of weeks before the renunciation of the anti-Communist leader was explicit."***

At the war's end, with an escort consisting of Russian tanks, Tito entered Belgrade and imposed a communist dictatorship that would last for 35 years. **His** first agenda item involved the search for, capture, show trial and execution of Mihailovich.

In reference to the subversion of U.S. policy towards China, the author made a fascinating observation that only someone as astute as he can make:

***"Among the striking features of these memos is how closely they resemble the material being supplied, not long before this, to U.S. and British authorities about the struggle for the Balkans. Point for point, the Service-Adler papers track the comments of Linn Farish...often with the identical images and charges, and sometimes the identical phrasing. It was the same drill throughout, with Chiang the Mihailovich of China, Mao the surrogate for Tito."***

(Astute readers may also recognize the similarity these two campaigns bore to more recent and equally successful efforts to topple Somoza in Nicaragua and the Shah of Iran, two other pro-western heads of government who were quickly replaced by Marxist dictatorships.)

### CONCLUSION

Authors who have compiled a total of those martyred by communism in the 20th Century, such as Professor Francis Randle and Robert Conquest, generally arrive at a figure approximating 100 million victims. Their total is at least one victim short, because it fails to include Joseph McCarthy.

Space limitations prevent a thorough description of Joe McCarthy's demise, but suffice it to say that he was undone by a political party willing to accept the subversion of the U.S. Government in order to avoid giving its political opponents a powerful campaign issue. Moreover, the majority party was assisted in this effort by a number of cowardly and incompetent individuals from the Republican opposition, so little has changed in 50 years.

Readers may also be fascinated to learn, contrary to everything else we've ever been mis-taught in high school history, that the oft-repeated claim that McCarthy cheat-

ed on his taxes is about as accurate as everything else the usual suspects say about Joe McCarthy and the era that bears his name: In 1955 the I.R.S. actually refunded \$1,056 to McCarthy for over-paying his taxes !

While it is too late to avenge the injustices done to a great and courageous man, and far too late to bring the many culprits to book, it can never be too late to set the historical record straight. This work has accomplished that and more, and has done so in such a thorough and meticulous manner that it would please the former Junior Senator from Wisconsin.

Readers who wish to assist Stan Evans in the process of correcting the historical record and, in so doing, honor the memory of a great patriot who has been vilified in histories written by the usual suspects, could do far worse than purchase multiple copies of this book and donate them to public libraries or universities. After all, if there is one thing this book proves beyond question, it is that, as long as America remains the land of the free and the home of the brave, ***the truth will eventually out...***
