LETTER FROM THE EDITOR

Save the White Farmers!

South Africa's white farmers have recently been targeted by the black predators and the other communists who run South Africa. The South African "*Parliament*" has voted to expropriate their land without compensation.

This is one more step in South Africa's planned genocide of whites, a program of extermination that began when the communist Nelson Mandela took power in 1994. About 3,000 farmers and their families have been murdered by black savages since then, many suffering gruesome deaths.

Congress should immediately enact a U.S. refugee policy that allows these white farmers and their families – currently threatened by genocide -- to enter the U.S. In 1990, Congress acted in this manner with the notorious **Lautenberg Amendment**, whose purpose was to resettle Soviet Jews into the US despite little proof they were actually being persecuted. The **Lautenberg Amendment** was later expanded in 2003 to allow persecuted Iranian Christians to be resettled in the U.S.

President Trump need not wait on an obstructionist **House** to take action: He holds all the executive authority he needs to pull off a sweeping rescue mission of South African refugees. A provision in the **1980 Refugee Act** allows for emergency extraction of vulnerable populations, subject only to a Congressional hearing that does not require any accompanying legislation.

Ideally, the President should also lean on New Zealand and the United Kingdom to participate and accept some of these farmers threatened with genocide. Australia has been accepting them in small batches over a long period of time, and Russia has agreed to accept about 15,000 of them in an area already settled by some South Africans. Canada is hopeless as a potential sanctuary, because it is only interested in replacing its founding peoples with non-whites.

There are areas in South Africa where it is already illegal for whites to own land. The misnamed **South African Eq-**

uity Act requires all companies doing business with the South African government to have employment rosters that mirror the racial composition of the country as a whole. Thus, no company doing business with the South African Government can have more than 8% white employees, so the most qualified engineers and scientists in the country have been laid off and many forced to live in "squatter" tents.

The sad truth is that most Americans have no idea what is really going on in South Africa, due to an intentional news blackout by the Corrupt Leftist Media. If Americans were truly aware of the threatened genocide of white farmers, they would almost certainly support a massive refugee airlift.

According to the **1951 Geneva Convention on the Status of Refugees**, a refugee is defined as a person who has a "**well-founded fear of persecution due to their religious or political beliefs, or their racial or ethnic background.**" No one fits this definition better than white South African farmers.

Presently, 95% of the refugees admitted to the US are hand-picked by the **United Nations**, a notoriously leftist body of Third World savages and criminals with venomous anti-white predispositions. If South Africa's white farmers are going to be rescued, it will have to be in spite of the efforts of the **United Nations**.

Such a move by President Trump could have profound consequences: White European nations currently being swamped by Islamic and African invaders might well be inspired to demand resettlement of white South African farmers in their own nations, where bastions of Western Civilization still remain uncontaminated.

Will President Trump answer the call to rescue the endangered white farmers in South Africa? There's a very important reason why he should: To be re-elected in 2020, he needs to re-energize the white and nationalist

base that got him elected in 2016. By championing the U.S. as a sanctuary for white South Africans, he will draw attention to their plight and spark renewed racial consciousness among his core constituency.

OUR "SPECIAL RELATIONSHIP"

Since the establishment of the nation-state of Israel in 1948, a lot of political and theological damage has been inflicted by both Christian and Jewish clergy and politicians. The damage comes from assuming that the modern nation-state of Israel -- and Israel of the Bible -- are one and the same. They are not.

In the **Old Testament**, God made several strong promises to His chosen nation. Some of these are reiterated in one way or another in the **New Testament**. (See for example **Romans** 9:4-5 and 11:28-29.)

The modern nation-state of Israel was founded by European and American politicians as a safe haven for Jews fleeing anti-Semitism in the aftermath of WWII. It may also have been used as a means to penalize Germany by diverting billions of WWII reparations monies being assessed against the former Nazi state.

The modern nation-state of Israel is NOT biblical Israel, and it is NOT the heir of God's promises to ancient Israel. Here are a couple of reasons why:

First, Ancient Israel was a theocracy and a nation having a very specific covenant with God, one based upon the laws of the **Bible** as given to Moses. Although the modern nation-state of Israel makes special provision for Jewish citizenship, it claims no covenant with The Almighty. Further, modern Israel has declared itself a SECULAR, liberal democracy: As such, it does not claim the Bible as the source of its laws.

Many people mistakenly equate "Israeli" with "Jewish," just as many people wrongly equate "Palestinian" with "Muslim": In fact, a significant portion of the Palestinian population is Christian, and a significant minority is Jewish. Thus, while "Israeli" actually designates nationality, "Jewish" is a religious or ethnic designation.

Also, the demographics of Israel are diverse: 20% of Israelis are Arab and most of those are practicing Muslims, while another 20% are Christians. While most of the remaining 60% of Israelis identify as "Jewish," nearly half of them also identify as "secular Jews." In other words, they consider themselves to be culturally Jewish (celebrating holidays, etc.,) but they do not practice Judaism as a religion.

Secondly, even if the modern nation-state of Israel shared the laws, culture, and demographics of its ancient counterpart, it still would not be the heir of God's promises because the Scriptures indicate otherwise.

God's promises to the Israel of old go back to Abraham. In **Genesis** chapters 12, 15, and 17, God makes a three-part promise to Abraham: God promises to bless Abraham with innumerable descendants; God promises those descendants a clearly defined parcel of real estate; And finally, God promises to bless all the peoples of the earth through Abraham and his descendants. All three components of His promise are crucial to our understanding.

Notice also that God blesses "the few" (Abraham's descendants) in order to bring blessing to the whole (humanity). God need only bless one person, i.e. Abraham, David, Jesus, etc., in order to bring His blessings to all people. Throughout the Bible, God chastises those who would keep His blessings to themselves. The Scripture is clear that God blesses people so that through them, He can bless others.

This idea is obvious in the covenant God makes with Abraham's descendants, as well as His covenant with Jacob -- Abraham's grandson -- concerning the nation of Israel. This second covenant, found in the **Book of Exodus**, establishes Jacob's descendants as the nation of Israel. In doing so, God repeats the same promises He

made to Abraham and specifically commands Jacob's descendants to be a blessing to the nations around them.

But this covenant, given through Moses, contained one very crucial difference from the covenant that God made with Abraham. In the second covenant, the "national" covenant, God based these conditions on His promise: **IF, as a nation and as a people, Israel obeys God's law, then and only then will God fulfill his promise.**

While many modern Christian and Jewish theologians argue that some of the promises are yet to be fulfilled, the argument is moot because it is clear that, according to ancient Israel's own prophets -- **Jeremiah** 11:1-13, **Deuteronomy** 31:16-21, just to cite a couple -- that ancient Israel broke their covenant with God. Ancient Israelites breached the covenant and forfeited its promises when they disobeyed God's law by engaging in idolatry and other violations.

Despite the sins of Israel of old, in his mercy God promised a new covenant (**Jeremiah** 31:31-34, **Ezekiel** 16:59-63, etc.). This covenant would not be conditional upon Israel's obedience, but rather, it would be based solely on God's love and faithfulness.

In the **New Testament** we read that God fulfills His new covenant through Abraham's descendant, Jesus. Specifi-

cally, the Apostle Paul tells us in **Galatians** 3:16 that: **"Now to Abraham and his seed were the promises made. He saith not, And to seeds, as of man; but as of one, And to thy seed, which is Christ."**

Through this new covenant, God's promises to Abraham and to Israel are fulfilled. Through Jesus, the blessings previously given to the few are now extended to all. Which is why the Apostle Paul further states in **Galatians** chapter 3: **"There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female: for ye are all one in Christ Jesus. And if ye be Christ's, then are ye Abraham's seed, and heirs according to the promise."**

While it is in the best interest of the United States to maintain friendly diplomatic relations with the modern nation-state of Israel, it has never been in our nation's best interest to blindly support any nation in all of her policies.

Since there is no biblical or historical basis for recognizing the modern nation-state of Israel as the modern-day fulfillment of Bible prophecy, we will not reap any political or spiritual blessing from encouraging our politicians to sacrifice the interests of our own nation to those of another, even when that nation-state calls itself by the name of Israel.

Assigning "Mid-Term" Blame

Other House Republicans are not without blame, either: Long ago, someone with a modicum of guts should have made a "**Motion to Vacate the Speakership**." They might not have succeeded in retiring Ryan as Speaker, but at least Ryan would have received some well-deserved comeuppance for his disloyalty. Any of those who aspired to become Ryan's successor could have demonstrated their leadership by performing this valuable public service.

There are other factors at work, of course: 80% of the middle-class received a tax cut in 2017, but according to a **Rasmussen Poll**, half are too stupid to recognize this fact. This is glaring evidence of the effects of Third World

immigration and the breeding habits of mailbox-watchers, who have caused the average American IQ to decline from 100 to somewhere in the low 90s.

Meanwhile, Republicans increased their majority by several seats in the Senate, where federal judicial nominees and high-level administrative appointments must be confirmed. It also appears that the Republican Party managed to retain a majority of state governorships, although several were lost in traditionally "red states."

The good news is that once the American public gets a dose of the new "Democrat" Chairmen of House Committees — the likes of Jerry Nadler, Adam Schiff and Maxine Waters -- they will be struck by how much the House of Representatives now resembles that bar scene from the "**Star Wars**" movie, and will rectify the situation in November of 2020.

Fighting the "Juggernaut"

Forty years after the seeds of our current demographic crisis were sowed by the **Immigration and Nationality Act of 1965**, I discovered an ancient woman diligently yanking down notices from a public bulletin board in the local library. When I asked what she was doing, she smiled, and said with a distinct accent, "**These notices are written in ten different languages, with translations paid for with my tax dollars. If someone had the right to put them up, I have the same right to pull them down. Let them learn English, as I did.**"

As I pondered the woman's response, she trundled out the door and down the street, away from the scene of her mischief. She turned out to be Colette Berger, an immigrant herself and a woman who resided in a house whose roof was visible from my own residence. In our next encounter, I observed her at the supermarket, hiding Spanish language magazines behind English publications. Again, the mischievous smile of a disobedient child, and a quip: "**If I'd wanted to live in Guatemala, I'd have moved there.**"

Over time, I learned she'd come from France after World War II as a refugee. But there was much more to the story, as I learned in pieces over the years. She'd been born in a village near Reims in Northern France, and during the

war, she and her brother were hired as depot guards to guard both cargo trains and German troop trains in a freight yard. She eventually revealed she'd been sufficiently trusted by the Germans to receive passes to travel on both German troop trains and truck convoys.

She met a German soldier, had a baby by him, and then placed the baby for adoption when the end of the war culminated in her hasty exit from Europe. "**They weren't asking about civilians' motivations,**" she said. "**The Maquis (the French Resistance) were lining people up against the walls and shooting them.**"

She'd immigrated to America, lost a young husband to cancer, struggled with poverty, lost a second child to the gulag called foster care, worked hard, bought a house, and survived in her old age by opening an illegal beauty parlor in her basement and an illegal rental cottage in her detached garage. Throughout our long acquaintance, she continued to make veiled references to her activities during the war.

Finally, one day I stated flatly: "**You, Colette, were on the wrong side.**"

She did not shrink from the comment. **"Yes," she readily confessed: "The Germans' sins were considerable, but they would have ensured the West's survival in some recognizable form. No one else is going to do that now. I understood from the beginning what the Bolsheviks would do to Europe and the world if they won, and they have indeed won. They have repeatedly forced the West into a trajectory that can only lead to our extinction, a trajectory that has always left us with no other recourse but to fight back."**

It was an "A ha!" moment. She was not only an ideological renegade, like myself, but someone who was apparently willing to take genuine risks in order to act on her beliefs and risks ranging far beyond pulling down public bulletins. As I came to know Colette, she indeed turned out to be a one-woman army, battling what we both perceived as the forces of darkness: A vague and toxic Cultural Marxism manifested in the promotion of things like socialism, miscegenation, white guilt, social and moral decay, nihilism, multiculturalism, and relentless assaults on all things traditional.

Colette contended that these things were merely the incarnations of an effort to destabilize and deconstruct American society. Without hesitation, she rejected the notion that America -- the world's last real bastion of freedom -- was a *"propositional nation,"* one in which patriotism must consist exclusively of loyalty to our political system, rather than our history, culture, race or Christianity, itself: She scoffed at the belief that such loyalties were a form of bigotry or chauvinism. **"To insist on such a thing,"** she said, **"is to deny human nature itself."**

She argued that erasing loyalty to one's nation and culture, was a tragic insanity that would almost certainly destroy America. That goal, she insisted, was our enemies' ultimate intent. **"They plan nothing short of our destruction. That is what gives us the right and the duty to resist,"** she would say. We talked for endless hours about the reasons for America ceaselessly accommodating the poisons destroying its foundations, and she summed it all up in two sentences: **"Human beings, in general, are herd animals, driven by the need to conform, and white people, in particular, often deal in abstractions. It will be their epitaph, because the rest of the world deals in realities."**

Colette's activism took many forms, and in much of it I soon joined her. She manned petition tables, and lobbied for restrictive immigration legislation, despite the irony of doing so in accented English. She campaigned for political candidates, gave them money she couldn't afford to donate and spoke her mind with jaw-dropping frankness. She wrote letters to newspapers, trolled websites, and engaged in other forms of "soft" sabotage. She trolled internet trolls to locate their battles and fight in them. Once, serving on a hiring panel, she deducted Affirmative Action points from applicants that her colleagues had been asked to add in order to benefit job applicants. **("Bolshevist social engineering," she called it).**

She boycotted businesses that promoted social decay in the name of "progressive" ideologies and she had six email accounts she used to badger political and cultural luminaries. She paid for books like **"Alien Nation," "The Death of the West,"** and **"Adios, America,"** and mailed them to prominent people, attempting to reshape social policy. She was dogged in her determination, and her battle motto was **"We fight until we win."** She never wavered in this resolve, despite a framed Whitaker Chambers quote on her office wall, to the effect that **"We must fight simply because it is morally correct for us to fight. We must fight, even though it is virtually impossible to fight for a people who will not fight for themselves."**

"These things are the best I can do," she said, **"because I'm too old and too frightened to put dynamite under bridges."** Because of the inherent danger in resisting the powers that be, she in fact recommended covert and nonviolent sabotage: **"There can be no full-frontal assaults on the enemy until we have sufficient strength and a chance to win."** Despite her bravado, there was little evidence any of our activities made any impact: In sum, they were mere flailings against a juggernaut.

Colette regarded both the Democrats and the Republicans with an almost equal contempt, but when a specific act of violence against Republicans occurred in our neighborhood, it spurred her to greater action. The violence had been incited in the heart of a down-and-out person who had wandered up and down our neighborhood's commercial strip, where he'd absorbed a steady diet of messages discrediting the Trump administration's lawful election to power. Up and down that commercial ave-

nue, trees and lamp poles were festooned with banners, signs, and even hand knitted messages urging the locals to **"Resist Trump," "Fight the Power,"** and **"Reject Hate."**

Smiling, she remarked, **"Not a bad operation for a cowardly crone and two village idiots."**

Whatever she may have thought of herself, Colette was no coward. On more than one occasion, I saw her on the receiving end of some "progressive's" idea of kindness, which she had a knack for quickly transforming into rage and contempt. One such encounter at a petition table ended with a wad of spit being deposited on her fore-

head. She remained tranquil in such encounters, strengthened by a moral certitude that I have only begun to acquire as America's situation has become more visibly dire.

It was my honor to have fought in the opening skirmishes of our conflict with this tiny, graying French woman, a woman who had fought her way through life, yet also found the strength to fight in the eternal battle against the massive forces of evil now arrayed against us.

Three days before her death and anticipating it, I asked her how I could best honor her life. From her quick response, it was obvious she had expected the question. **"You can remember me by continuing to fight," she said. "Do whatever you can, whenever you can. Resist in every way in which you are capable of resisting, regardless of all of the might and scorn and fury that may oppose you. I will leave this life knowing that I and my village idiots, in just one Sunday morning -- spent tearing down banners -- were worth ten thousand Marines who understand our fate and do nothing."**

It was important for me to speak honestly, in the face of her approaching death. **"We did not accomplish all of the things that we needed to accomplish,"** I said.

"It does not matter," she responded. **"We will fight until we win."**

FIRE, Ready, Aim

On **New Year's Day**, the joys of "*multi-culturalism*" were reiterated on the streets of Houston when a car pulled alongside another and shots were fired into the second vehicle. Killed was a seven year-old black girl named Jazmine Barnes, and others were also injured.

The story received enormous media attention because witnesses reported seeing an approximately 40 year-old white man in a red truck driving away from the scene of the incident.

The usual suspects who studiously ignore news of black-on-white murders every day of their lives – as well as carefully ignore black-on-black murders, as well -- went into FULL COMBAT MODE.

King tweeted this on New Year's Day to his 1.1 million followers. It garnered more than 31,000 *re-tweets*, helping to publicize a false and inaccurate description of the actual murderer. His flawed description fit his ideological predisposition, but it worked to delay the arrest of the

real murderer, who turned out to be a **NIGRO**, of all things!

Proving that their lack of Frontal Lobe development renders them incapable of feeling either shame or admitting when they're wrong, Shaun King remained impenitent about his attempted vigilantism. He clearly wished to unleash an angry, violent and savage black mob upon an innocent white bystander who could easily have been murdered.

Sunday morning, police arrested Eric Black Jr. – a 20 year-old **NIGRO** -- for the murder of Jazmine Barnes. It turns out this "*brane dokter*" mistook the car driven by Jazmine Barnes' mother for the vehicle of someone else he intended to murder in cold blood.

This statement followed an earlier furor In 2007, when Watson was quoted as saying he was *"inherently gloomy about the prospect of Africa (because) all our social policies are based on the (notion) that their intelligence is the same as ours – whereas all the testing says not really."*

Cold Spring Harbor Laboratory – where Watson has been a fixture for decades -- relieved him of all his administrative responsibilities after the 2007 controversy. He remained an honorary figurehead, but now he has been stripped of even those titles. In a Press Release, **Cold Spring Harbor Lab** stated:

"Dr. Watson's statements are reprehensible, unsupported by science, and in no way represent the views of CSHL...The Laboratory condemns the misuse of science to justify prejudice."

This is an interesting statement coming from an ostensibly "scientific" enterprise, since there are over 600 empirical studies proving a 15-point disparity favoring whites over blacks in average IQ levels in the U.S. This

Caravans, Pharisees & Disinformation

As the lackeys of the Jews’ Media always do, they parroted identical language to spin their false narratives.

The first lie of the Jews’ Media was its claim that the caravan didn’t really exist, and was a fabrication of President Trump’s fevered imagination and fueled by the upcoming mid-terms. After video evidence of it began to appear on **Fox News**, that lie quickly transitioned into the claim that it was thousands of miles away, and thus posed no threat to us.

This lie was repeated by that nigro communist, Muslim and pathological liar who used to occupy the White House: It probably fooled only the patrons of CNN (the **Communist News Network**), MS-NBC (**Mediocre Sodomites of the Nigro Broadcasting Corporation**), or NPR (**National Proletariat Radio**.)

Yet, in no time at all, the caravan miraculously traveled more than 1,000 miles and mysteriously appeared in Tijuana. It soon began to menace the residents of Tijuana and quickly turned that city into the kind of shit-hole from which the caravan claimed to be fleeing. The caravan quickly overstayed its welcome in Tijuana, where it overwhelmed the city’s capacity to absorb them, much as earlier waves of illegal aliens have swamped America’s public services for decades.

The second mendacity of the Jews’ Media was that the caravan was a “spontaneous” migration, and did not receive any financial or logistical support from outside agencies. This lie was quickly exposed, when it was demonstrated that convoys of expensive buses were hired to transport thousands of participants from Mexico’s southern regions to its northern border. Individuals were also videotaped handing out cash to caravan participants.

Moreover, recent reportage on Fox News reveals that a communist organization – **Pueblos Sin Fronteras** – was at least one of the collaborators in funding and organizing the caravan and its assault on U.S. Sovereignty. The organization’s name translates as “*People Without Borders*.”

The third prevarication the Jews’ Media disseminated was that the caravan was comprised primarily of women and children. According to many real journalists embedded in the caravan, it consisted of more than 90% males, and most were between the ages of 20 and 35. At times, women and children were placed in front of the caravan, but only when video cameras were rolling for the video equivalent of a “team photo.”

The fourth form of disinformation by the Jews’ Media was the claim that the caravan consisted primarily of “*asylum seekers*.” That claim was quickly dispelled when experts pointed out that asylum-seekers are required by International Law to seek asylum in the first nation they enter after exiting the nation from which they are fleeing. (No one believed that particular lie, anyway.)

The fifth falsehood of the Jews’ Media was that the caravan had very few criminals. American and Mexican immigration authorities now claim to have identified more than 600 known criminals in the caravan. (Most of us knew that was the case, anyway.)

Their sixth and last fabrication was that U.S. troops were unnecessary, because the caravan -- that supposedly didn’t even exist in the first place -- was peaceful and orderly. That narrative was abandoned when several hundred of its members attempted to forcefully cross the border and began throwing rocks and bottles at U.S. troops and Border Patrol Agents. Fortunately, they were turned back with tear gas and non-lethal methods used by those very troops the Jews’ Media assured us were unnecessary.

Now that they’ve been denied mass entry to the U.S. and many have announced their intentions to begin the long journey home, we will soon discover just how sincere the “humanitarian” motives of **Pueblos Sin Fronteras** really are. You see, thousands of impoverished caravan members are now stuck in Tijuana, in squalid conditions and

Voting With Their Feet

During the Cold War, conservative commentators coined an expression to describe those enslaved in *Eastern Bloc* nations who courageously attempted to flee communist oppression for freedom in the West: They were said to be "**Voting with their feet.**"

This expression was facetious – and full of irony -- implying that since legitimate voting did not take place anywhere behind the Iron Curtain, the only "vote" available to its captive populations was to get the hell out if they could.

Several U.S. states under the control of the misnamed "Democrat" Party routinely exhibit characteristics not unlike those in the former *Eastern Bloc*, especially their reliance on confiscatory state income taxes. These states include New Jersey, California, Connecticut, New York and Illinois.

These high-tax states are experiencing significant losses of population, as former residents seek greener pastures and lower taxes elsewhere. President Trump's federal tax cuts limit the deductibility of state and local taxes, and may be providing much of the impetus driving residents out of these high-tax states and into low-tax states. Residents of high-tax states are no longer subsidized by those of us in "*fly-over country.*"

United Van Lines (UVL) tracks the state-to-state migration patterns of customers in its annual **National Movers Study**. According to UVL, more people fled New Jersey than any other state in 2018. In fact, 67% of moves by New Jersey residents were "*outbound*" moves to other states. New Jersey was followed closely by Illinois (66%), New York and Connecticut (62% each.)

One consequence of these differences in state income tax rates is that those with low tax-rates -- or no income tax at all -- are growing much faster in population than states with high taxes. Four of the eight states whose populations are growing the fastest are Nevada, Texas, Florida and Washington, none of which have a state income tax. It's no surprise these states are also among those with the fastest job growth.

It is also no coincidence that Florida's population increased by 1.2 million people since 2010, the largest net gain among all states from new residents leaving other U.S. states. Many of Florida's new residents are tax refugees from the Northeast, who have helped to increase its population to 21.3 million.

Not surprisingly, the slowest growing states are those renowned for excessively high state income tax rates. They are California, New York, Illinois, Connecticut and New Jersey. These are beginning to mirror the signs of stagnation that characterize many European socialistic nations.

For example, California's population is still growing, but at a rate well below its long-term trends. Were it not for California's legal immigrant population and the many illegals for whom it provides "*sanctuary cities,*" that state would have experienced dramatic declines in population over the last several years.

High taxes, onerous zoning restrictions and excessive regulations — all of which act as a "*form*" of taxation -- have combined to force many California businesses to vote with their feet as well. According to a business relocation consultant named Joe Vranich, about 13,000 companies have left the state since 2008, and 1,300 businesses

moved at least some of their employees or capital out of California in 2016.

Illinois' population has declined as well: According to a research outfit named **Wirepoints**, a net of 114,000 residents left the state in 2018 and nearly 1.5 million residents have left since 2000. While Illinois' population has declined by 0.8% since 2010, the neighboring states of Indiana and Wisconsin have grown in population by 3.1% and by 2.2% over the same period, respectively.

In the 1990s, a test developed by NASA was administered to select children ages 4 and 5. The tests showed that 98% of these young children were "creative geniuses."

The same test was administered to the same children every five years. It was learned that by age 10, just 30% of the children had retained similar levels of creativity, and by age 15, the number had dropped to 12%. When administered to them as adults -- ages 25 and up -- fewer than 2% showed the same creative impulses they had shown as young children.

MISCEGENATION REPORT

Mixed-race marriages are on the rise, according to a study by the liberal **Pew Center**. Its study, titled "**Intermarriage in the U.S. 50 Years After Loving v. Virginia**," claims that one-in-six newlyweds in America are married to a spouse of a different race. They underestimate the problem.

Pew interviewed 1,800 people about their perceptions of interracial marriage and analyzed census information over many years. They allege that white Americans are

less likely to marry someone of another race, with white women slightly less likely than white men to do so. The study alleges that Asian women are most likely to marry someone of another race than other groups.

Unfortunately, this study by the **Pew Center** gives a very "skewed" perception of the phenomenon: One important statistic it ignores is the tendency of white women to merely "*shack-up*" with someone of another race rather than marry them. This is an increasingly common arrangement in America, where our popular culture endlessly promotes miscegenation in advertising and film, and tends to denigrate marriage altogether.

The liberal Pew Center also fails to distinguish between conventional marriage and "*queer marriage*," an abomination of recent origin that masquerades as holy matrimony, today. Where two queers of the same "gender" enter into such an unconventional relationship, there should be little doubt that interracial marriages are far more common than in conventional marriages, thus "skewing" the study's conclusions.

ROOTS OF JEWISH ETHNOCENTRISM

For two millennia, Jews and Christians have viewed each other with suspicion and distrust. This was true long before 20th Century Jewish immigration from Europe infected America with virulent ideologies derived from Marxism, such as liberalism, multi-culturalism or "feminism," ***The Ladies Auxiliary of Marxism.***

The suspicion and distrust with which the two groups have traditionally viewed each other is not a recent phenomenon, nor did it stem from those aberrant ideologies so central to the world-views of many Jews. In fact, the seeds of distrust were sown two thousand years before, and like the proverbial **"road to hell,"** were probably paved with good intentions.

After the destruction of the 2nd Temple in Jerusalem in 70 A.D., many learned Rabbis of the era met in the Israeli town of Yavneh. There, they crafted a Judaism based on the **Old Testament** and the imperative of maintaining discrete and close-knit Jewish communities, separated from Christians and others by discouraging contact with outsiders.

Their motive may well have been the fear of losing members as converts to Christianity, which these learned elders obstructed by complicating interactions between Jews and Christians. The laws they codified in the Talmud to achieve these aims represent Orthodox Judaism, even today.

After the Temple Mount was destroyed, the local synagogue became the focus of Jewish life: Since **Sabbat** laws were included in the **Talmud** to prohibit riding animals or walking long distances on the Sabbath, these laws made it necessary for Jews to live in close proximity to their synagogue and to each other.

Interactions with non-Jews were also discouraged by establishing that the Sabbath be observed on Saturdays

rather than on Sundays, the practice of most early Christians. The Talmud also prohibited work on the Jewish Sabbath, which had the effect of discouraging commerce between Jews and Gentiles.

Other **Talmudic** Laws discouraged interactions with outsiders through *Kashrut* (or keeping kosher). The codification of kosher laws had the effect of discouraging "*food fellowship*" with Gentiles, and served as an additional means of discouraging interactions between Jews and Christians.

For meat to be kosher, the animal must be slaughtered in a manner prescribed by the **Talmud**: Since refrigeration did not exist until the early 20th Century, it became essential for Jews to live close to each other -- and in proximity to Kosher butchers -- to obtain fresh meat.

Another technique for differentiating Jews from all others was the **Talmud's** explicit prohibitions against inter-marriage between Jews and everyone else, whether Christian or pagan.

By discouraging interactions with Christians in a variety of ways, **Talmudic Law** was responsible for creating discrete communities of Jews that were subtly but effectively discouraged from interacting with Christians.

It can be reasonably inferred that these **Talmudic** Laws are at the very heart of the suspicion and distrust that has lingered between these two groups, and are largely responsible for generating what is often seen as Jewish ethnocentrism.

On March 6, Oregon's Multnomah County Sheriff Mike

Reese arrested a 45 year-old illegal alien named Martin Gallo-Gallardo on a domestic violence charge. Gallo-Gallardo quickly posted bond and was released on March 8.

According to federal law enforcement, Gallo-Gallardo is a Mexican national who has been arrested numerous times entering the U.S. illegally and with no documentation. Hence, at the time of Gallo-Gallardo's arrest on March 6, Reese was contacted by **Immigration Control and Enforcement** (ICE) Agents wishing to place an immigration hold or "*Detainer*" on Gallo-Gallardo prior to his release from the hospitality of the County.

Reese's Department did not honor the ICE Detainer, and released Gallo-Gallardo two days after the incident without contacting ICE. This permitted Gallo-Gallardo to return home where he murdered his wife (Coral Rodriguez-Lorenzo) seven months later by stabbing her multiple times and dumping her body in a ditch.

ICE claims that if Multnomah County had held Gallo-Gallardo as requested, he would have been in federal custody rather than permitted to return home to murder his wife. Needless to say, this has created quite a rift between ICE and the Multnomah County Sheriff's office, which was forced to lie to the news media to cover its ass by claiming Reese never received notice of the ICE Detainer.

Moreover, Reese claims he was powerless to honor an ICE detainer under any circumstances, based on a 2014 federal court ruling involving "sanctuary" cities and states. The only problem is that 2014 federal court ruling was overturned, and he doesn't appear to know it.

The office of County Sheriff does not require office-holders to be rocket scientists, but they DO need to acquaint themselves with laws that directly affect the performance of their jobs, at least after FOUR YEARS. Reese was probably too busy pursuing "*social justice*" or some other liberal enthusiasm to acquaint himself with the applicable laws.

FUNDRAISING APPEAL

Glen K. Allen, Esq. v. Beirich, Potok, and SPLC

What does freedom mean to you — freedom to think nonconforming thoughts, to associate with nonconforming people, to advocate nonconforming viewpoints? To me, freedom is essential to a good life, the oxygen that, if missing or taken away, renders our world “*weary, flat, (and) stale*,” as Shakespeare’s *Hamlet* says. To really breathe at all, we must be free to wander off the reservation of received and approved opinion.

What are the enemies of freedom? There are many: Poverty, poor health, social chaos, despotic governments, the lack of avenues to express freedom. But a particularly offensive and insidious kind is one that purports to advance the public good when in reality its primary aims are to enrich itself while destroying its political adversaries.

This describes perfectly what the **Southern Poverty Law Center** (SPLC) has become today. Drawing on a massive surveillance model reminiscent of a Communist regime, motivated by lucrative fundraising aims and employing fundraising techniques decried across the political spectrum as deceptive, the SPLC’s avowed goal, under the leadership of Heidi Beirich, Mark Potok, and others, is to destroy, through public shaming, loss of employment, and harm to reputation, those groups and persons the SPLC broadly defines as political enemies of its leftist agenda.

Their carefully orchestrated destruction of my legal career was severe, causing my termination as an attorney for the City of Baltimore and destroying the reputation as an attorney I had achieved over decades by performing ethical and competent work, including frequent and substantial pro bono work for African-Americans and others.

The cause of free expression itself is another victim, for the SPLC has become one of the most effective and terror-inspiring censors in the country, and every success it achieves emboldens it further.

I am defying the SPLC’s fraud and intimidation. I need your help. I am fighting not for myself alone but for all who need breathing space to think and express unconventional and unpopular opinions. In particular, I am challenging the SPLC’s 501(c)3 status, which it uses so effectively to impoverish honest and robust debate on controversial issues such as immigration and race relations.

My complaint is a true David v. Goliath struggle, but my claims have merit and I will pursue them vigorously. But litigation of this nature is expensive. I must engage co-counsel and pay litigation expenses, and cannot hope to stay in the ring with the SPLC, with its \$450 million endowment and large staff of attorneys, without financial help from friends and supporters. The SPLC openly boasts about its destructive aims and successes, which unfortunately are many. Please help me strike a blow for freedom against these self-appointed thought police.

Jews' Media Ethics Exposed

A German practitioner of U.S. Jews' Media "ethics" has been exposed for falsifying a significant number of articles he wrote over the course of several years. It is NO coincidence that he once worked for CNN, and was awarded CNN's *Journalist of the Year Award* in 2014.

Claas Relotius, a reporter and editor at *Der Spiegel* was exposed by an internal investigation to have invented sources, characters and quotes in at least 14 articles he wrote for that publication. Investigators claim his fabrications "**mark a low point in the 70-year history of Der Spiegel.**"

One article was particularly illuminating: It was a cheap shot at the town of Fergus Falls, Minnesota, which was titled "**Where They Pray for Trump on Sundays.**" The internal investigation at *Der Spiegel* revealed that practically every element of the article was a prevarication.

Relotius fictionalized every source, quotation and fact about the town except the town's population, its average temperature and the names of a few businesses that actually do exist. The two investigators for *Der Spiegel* – Michele Anderson and Jake Krohn -- called it "**endless pages of an insulting, if not hilarious, excuse for journalism.**"

Ironically, Relotius, himself is actually a victim of the fake news industry as it's practiced by the Jews' Media. He is no worse an offender of journalistic "ethics" (cough, cough, ahem) than each of the crews at *CNN*, *MS-NBC*, *ABC*, *NBC*, *CBS*, *NPR*, the *WASHINGTON POST* and the *NEW YORK TIMES*. The only distinction is that Relotius got caught.

Young journalists learn very quickly there are two techniques that lead to rapid advancement in the Jews' Media: The first is to sensationalize your work to make it more interesting to readers; The second is to adopt the perspective of a Cultural Marxist, and find ideological enemies to sneer at and then ambush.

It's hardly surprising that most of Relotius' articles have a leftist slant: Journalistic "ethics" have regressed to such a low level that it's often not necessary to consume the efforts of the Jews' Media in order to recognize the bias that animates its authors and the extent to which it infects their work.

In addition to his hit-piece on Fergus Falls, Relotius also fabricated an interview with the parents of NFL-reject Colin Kaepernick and another about a woman alleged to be a volunteer witness at executions. He did the same thing with a story he filed about militia on the Arizona border, in which all of his supposed interviews were concocted.

His deceptions are no worse than those of the liars and whores at CNN or MS-NBC, and they are certainly in the great tradition of the *WASHINGTON POST*, *NEW YORK TIMES*, *NPR* and all the networks.

Dan Rather at CBS intentionally defamed George W. Bush with a false story about his military service, and Janet Cooke won a Pulitzer Prize at the *WASHINGTON POST* for fictionalized accounts of a young heroin addict.

Likewise, Stephen Glass falsified a great many articles for *The New Republic*, one of which included phony accounts of drunkenness and sexual misconduct at – of all places -- the 1997 *Conservative Political Action Conference*.

Jayson Blair – another nigro from the "*Janet Cooke School of Journalism*" – was simply a serial liar, who forced his editors at the *NEW YORK TIMES* to question just about everything Blair ever wrote while under their employ.

During his in-house investigation, Relotius confessed to investigators that "**I am sick and I need to get help.**" No doubt he is correct in his assessment, but the remaining 90% of his profession will remain just as sick as Relotius, and learn nothing from this scandal.

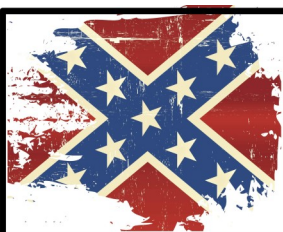
I do this without compensation of any kind, but I am

NO Polite Word for It !

Ann Coulter was right: Trump caved on the border wall and government shut-down. He blinked, and the **New Communist Party** of Nancy Pelosi and Chuck Schumer grinned victoriously. Historians may date the beginning of the end of the Trump Administration to January 25, 2019. His re-election is as likely as my winning a **Pulitzer Prize**, but it didn't have to be like this.

President Trump is at his best when he is aggressively pursuing an agenda: He seems to be almost uniquely focused when doing so, and his economic and foreign policy successes speak for themselves. When he adopts a defensive posture -- and sits back waiting for others to advance his agenda without his personal input -- it is an unfamiliar role and he appears to flounder. This describes his administration since early 2018.

President Trump has always been known for his boldness, but for the past year he has been uncharacteristically indecisive and overly patient. He could have won the test of wills over the border wall and government shut-down if he had merely invoked the 1977 **Presidential Emergency Powers Act** to order the Corps of Engineers to begin construction on the border wall. Schumer and Pelosi would probably have scurried back from their vacations to negotiate an end to the government shut-down.

He did the same thing with the State of the Union address. He allowed Nancy Pelosi to buffalo him when he could have done any of several alternatives, such as give it from the Oval Office, give it to the Senate Chamber, or give it to a Joint Session of Congress, even if the **New Communist Party** chose to boycott it. He blinked here, too, giving our mortal enemies another victory.

Trump has shown this same, uncharacteristic indecision in other contexts. For two years he heeded the advice of his legal team and abstained from firing Jeff Sessions,

Rod Rosenstein or Robert Mueller. His lawyers failed to understand that we are in uncharted territory, and their legal advice was ill-suited to Trump's REAL problem: Never before has a rogue and treasonous element from the Deep State engaged in a coup against a President by fabricating charges against him to initiate a surveillance operation with the President as its target.

Doubtless, he was advised by his lawyers to remain above the fray to avoid any charge of Obstruction of Justice. I believe he has been badly disserved by his counsel with this particular piece of advice. Normally, their advice would have been wise, but there is a staggering volume of evidence to indicate that the FBI and DOJ engaged in a coup to remove him from office. His Hamlet-like indecision has probably jeopardized any window of opportunity to bring the many FBI and DOJ conspirators to justice.

His uncharacteristic patience has allowed the Mueller investigation to metastasize into every facet of his personal life. The Mueller Team has been left free to expand its witch hunt into Trump's personal life, his dealings with his private attorney, his lawyer's business affairs, Trump's business ventures, his familial relationships, and indict nearly everyone who was involved in his campaign for the Presidency.

The Special Counsel no longer makes even a pretense of confining its investigation to some illusory "collusion" with Russia: It has metastasized into every facet of Trump's life because its TRUE agenda is to remove President Trump from office and destroy him. Moreover, there are no rules or limits governing the Special Counsel's office, as there should have been and must be: It is an investigation in search of a crime.

President Trump has nothing to lose at this point, and can still save his Presidency: However, he must reverse

Gay: Buggery and perversion by any other name.

Globalism: A preference for international entanglements undermining the sovereignty of independent nations: An inclination common to socialists, communists and Zionists, as well as businessmen who "champ at the bit" to sell them the rope needed to hang us.

Liberal: A Cultural Marxist by any other name, and one who desperately feels the need to camouflage his ideology.

Letter to Former Congressman Tom Garrett (R-VA) By Valerie Protopapas

We also overpay our senile Yankee Webmaster \$500 per month to maintain our CofCC website at **cofcc.us**. (All Independent Contractors are CofCC Members.)

Our June Conference at **Montgomery Bell State Park** in Tennessee cost the organization \$2,846.12. This figure includes part of a security deposit and the cost of printing and mailing two color fliers to advertise it. It also includes some cost over-runs from the

conference, including a large bill for the extravagant security provided by the state.

We have cut many expenses and now have only one P.O. Box, the one in Potosi, MO. Also, since we no longer accept Credit Cards, we no longer subscribe to any Merchant Services. (These absorbed much of the revenue received.) We were assessed no bank fees, legal fees or licensing fees in 2018.

We published four excellent issues of the **CITIZENS INFORMER** in 2018 and we held a highly-acclaimed joint conference in June. Our website grows in popularity by the day.

THE (DIS)TEMPER OF THE TIMES

Years ago I worked as a volunteer with a local animal rescue group. Though we “rescued” anything that needed our help, most of our efforts involved feral cats and their kittens. When a mother cat and her litter were brought in to our local vet, after being examined, they were given a distemper vaccination. Distemper is a very serious disease and no examination of a feral animal was conducted without this essential treatment.

However, a significant percentage of those receiving the shot died fairly quickly. I learned that when this occurred, the animals already had distemper but didn’t show overt signs. Thus, the vaccination merely hastened the onset and virulence of the disease, sometimes causing death in a matter of hours. The inoculation was not the cause of death, distemper was: The treatment merely hastened the inevitable.

The more I study our present cultural and political quagmire, the more I am reminded of this painful lesson about the consequences of matters that should not -- under ordinary circumstances -- have produced such a disaster. Rather, the disaster was the result of an *underlying* condition that had been incubating for a period of time, but was not yet evident except to the highly trained or experienced. For instance, the election of Barack Hussein Obama -- illegitimate and perilous as it was -- should not have led to our present crisis, the exposure of a traitorous “Deep State” and its ongoing *coup d’état* against the duly-elected President of the United States!

In the two years since Donald Trump’s election, every branch of government has engaged in a seemingly open rebellion against the man whom *We the People* elected to office! Most of the supposedly “free press” has joined the Deep State in its efforts to nullify the election of 2016! For those of us over the age of 65, such an intrigue is a great shock. Many found it difficult to believe that

responsible individuals would not step forward and restore the Rule of Law, but so far, this has not happened. Indeed, we are assured it is not *going* to happen, and that our “political class” is even now scheming to prevent the election of any candidate not of their choosing, whether it be Donald Trump or any other reformer.

Whether it was dress or entertainment or racial customs or religion or education, *all acceptable norms* were being questioned and discarded in favor of what was “new” or “fashionable.” Everything old became *passé*: Not just music or books or fashions, but morals, ethics, traditions and truths. Every generation after the 1950s witnessed our continuing decline, but it was done incrementally. Despite such eye-opening novelties as bare breasts, buttocks and four-letter expletives in movies and TV, for the most part, the poisoning of the culture was mostly

ignored. Those who spoke out were condemned as prudes, squares and killjoys.

But even *less* obvious were the changes taking place in American politics! Yet, as the worst became obvious even to the oblivious and apathetic, most Americans did little more than complain and bemoan the loss of “the good old days.” At this point, the Obama Presidency catapulted the body politic into a death spiral where little hope remained that equilibrium might be restored. Many believed that the presidency of outsider Donald Trump would at least “reboot” our politics. And, for a year or so, it seemed that “middle America” might actually be returned to its rightful position of power and influence.

The Dope on Legal Pot

A number of political and economic factors are at work to generate a seemingly irresistible momentum favoring unrestrained medical and recreational use of marijuana in the U.S.

One impetus involves the alleged medical benefits of the drug, which are said to include pain relief, the alleviation of anxiety, lowered risk of diabetes, better sleep, alleviation of the severity of seizure disorders and increased appetite among chemotherapy patients.

There are as many studies that refute the claims of the drug's beneficial effects as there are studies promoting them. Since most studies are fairly recent, the side effects of long-term use have yet to be properly evaluated.

However, there are costs and benefits to every human endeavor. Despite its alleged medical benefits, here's what one insightful and very bright physician concluded after watching a number of his children mess up their lives by engaging in recreational marijuana use: ***"Your emotional development ceases the day you begin to use marijuana."***

There is a general absence of safety standards for the consumption of pot or its active ingredient, even under medical supervision. In some ways, the current medical acceptance of marijuana and its claimed benefits mirror earlier enthusiasms for opioids, which precipitated our current opioid epidemic.

It shouldn't surprise anyone if a campaign were to soon blossom that promotes pot as a substitute for opioids, based on their greater affordability, as well as the fact that they can be home-grown and that neither its acquisition nor its consumption would require a physician's prescription.

As a matter of fact, the ***New York State Department of Health*** has enacted regulations that would allow the use of medical marijuana as a substitute drug for any condition for which opioids are prescribed. The result

might well be that instead of using one drug to replace another, we could very well initiate full-blown epidemics involving the use of both drugs.

The decriminalization or legalization of pot is fundamentally a leftist crusade, with some philosophical justification provided by the Libertarians. Once the left embarks on a crusade like this, their flacks in the corrupt Leftist Media will relentlessly promote it until these enthusiasms eventually become accepted public policy.

There is little political opposition to this movement: The Democrat Party has included decriminalization or legalization of pot in its Party platform for years; Republicans have mostly remained silent on this issue, just as they often do while testing political winds for the scent of campaign donations or support; And, the Libertarians are enthusiastic about decriminalization and legalization, just as they are about every other destructive vice.

Legalization of pot by all fifty states is estimated to garner nearly \$50 Billion in annual sales tax revenues and an estimated one million jobs. Since many states are currently experiencing static or declining tax bases, the marijuana industry is viewed as a potential windfall to help sustain their spendthrift ways. Politicians of all stripes will feel pressured to support pot if for no other reason than its fiscal benefits.

Marijuana stocks have been promoted intently since the campaign for decriminalization or legalization began to gain momentum. This will drive up demand for these stocks and increase the number of people holding these stocks. In turn, they will then have a vested financial interest in marijuana, further increasing the pressure on politicians to enact or adopt "pro-pot" legislation.
