

Poetic Justice IV

Kirsten Brydum: Kirsten Brydum was a 25 year-old “*social activist*” who died while on a nationwide tour campaigning for Barack Hussein Obama for President. She was gunned down in New Orleans in 2008 by a negro serial killer named Joseph Brant, who shot her in the head and then robbed her. Brant may also have raped her.

Brydum was in New Orleans with a group called ***Collective Autonomy***, which supposedly assists “*underprivileged*” minority communities by indoctrinating them with Marxism and other lies fabricated by those engaged in their phony “*class struggle*.”

She was found dead in the 3000 block of Laussat Place after being shot in the head and robbed of what few possessions she had. Apparently, she fell prey to Brant while riding an old bicycle through the Ninth Ward after an evening spent socializing with friends.

Her truly clueless mother stated, “*I hope this will wake people up to activism and staying involved and speaking for people who can't.*” The mother appears oblivious to the fact that it was her “*activism*” that got Kirsten Brydum murdered in the first place. Even more ironic, her daughter was murdered by one of the very objects of her grossly misplaced sympathies.

Equally fascinating is the fact that earlier on her nationwide tour, she had been protesting against the ***Republican National Convention*** being held in Minneapolis: There, she had been infinitely safer, even if too stupid and deranged to recognize this fact or its irony.

Unidentified Idiot: A 24 year-old rioter -- who attempted to steal cash from an ATM during the "George Floyd Riots -- blew himself to bits in Philadelphia in early June of 2020.

Philadelphia Police indicate that there had been a "*coordinated*" effort by the various communist organizations participating in Philadelphia's George Floyd Riots to steal cash from ATMs in order to fund their criminal endeavors. As many as 30 ATMs were destroyed with explosive devices over the previous two nights.

This wanna-be "revolutionary" was thrown to the ground with massive trauma to his chest and abdomen. Like his comrades, the only thing "revolutionary" about him was the depth of his depravity, mis-education and destructiveness.

In addition to destroying the property of people who actually work for a living -- rather than parasitically residing in their parents' basements -- these violent dilettantes destroyed a famous sculpture by James West titled "***The Bond***," which portrayed George Washington and Benjamin Franklin.

Apparently, Washington and Franklin are now enemies of the *Second Bolshevik Revolution*, as well.

Ernesto Miranda: In March of 1963, Phoenix Police arrested Ernesto Miranda for armed robbery, and the abduction and rape of a 17 year-old girl based on circumstantial evidence. Miranda's criminal "*career*" began in the 8th Grade and left him serving numerous sentences in state and federal prison. After two hours of interrogation, Miranda confessed to the rape charge in a signed confession.

Included on the form on which Miranda signed his confession appeared the following typed statement: "***I do hereby swear that I make this***

statement voluntarily and of my own free will, with no threats, coercion, or promises of immunity, and with full knowledge of my legal rights, understanding any statement I make may be used against me."

The Supreme Court overturned Miranda's conviction in an extremely controversial 5 to 4 decision written by Chief Justice Earl Warren, who was President Eisenhower's greatest regret. The Court held that unless a suspect has been explicitly warned of his rights and has voluntarily waived them, the "*coercive nature*" of police interrogations render confessions inadmissible under the Fifth Amendment's *Right Against Self-Incrimination* and the Sixth Amendment's *Right to an Attorney*.

Warren then created more Constitutional Law from thin air by imposing a "*code of conduct*" upon every law enforcement official in the nation with his now infamous *Miranda Rule*:

"The person in custody must, prior to interrogation, be clearly informed that he has the right to remain silent, and that anything he says will be used against him in court; he must be clearly informed that he has the right to consult with a lawyer and to have the lawyer with him during interrogation, and that, if he is indigent, a lawyer will be appointed to represent him."

In 1967, Arizona retried Miranda on the same charges, but without his confession: In the second trial, the state relied on different evidence and the testimony of witnesses to successfully convict. The chief witness against Miranda at retrial was his live-in girlfriend at the time of the original charges, who testified that Miranda confessed to her that he did, in fact, commit the crimes with which he was charged.

In an example of "poetic justice" worthy of Shakespeare, Miranda was eventually stabbed to death in a bar fight in 1976: However, the man who was Miranda's likely killer -- after being given HIS *Miranda*

Warning -- exercised his right to remain silent, and the police were ultimately forced to release him for lack of evidence.

Michael Rockefeller: A book titled *Thy Will Be Done* blames Nelson Rockefeller for exploiting the so-called "Third World," and explains how Rockefeller's son, Michael, was killed and eaten by *Third-Worlders* when he went off to save them from his father.

In 1961, while Nelson Rockefeller was governor of New York, Michael was in New Guinea sheltering natives from the ravages of Western materialism. During an expedition to collect tribal art, he had a boating accident and was forced ashore.

As he emerged from the water, one of the locals speared him in the chest. To quote from the book: "He was still alive when taken up the river, killed with an ax, and in the religious manner of cannibals seeking the strength of their victims, cooked with sago palm and eaten."

Tyler Wingate: This was a naïve 24-year-old white male who was savagely beaten to death on Detroit's west side in 2019 after a minor fender-bender. The murder victim was described by friends and family as someone who moved to Detroit because he "loved diversity," and wanted to help return the City of Detroit to its former glory.

Surveillance video from a nearby gas station showed the nigro driver of the other vehicle approached Wingate after the incident and dropped him with an unanticipated "sucker-punch." As black savages will do, the assailant continued to furiously hit and kick Wingate until he no longer resisted. The nigro murderer and his nigro accomplices then left the victim for dead.
