

Rules for Radicals

In his book ***Rules for Radicals***, a slimey and traitorous Jewish communist named Saul Alinsky advised fellow communists to "**Accuse your enemies of that which you are doing, it will sow confusion into their ranks.**" His advice was what psychologists often call "*projection*," and recommended it as a diversionary tactic to deflect attention from their own treason and redirect attention onto their enemies using a shamelessly corrupt and compliant news media.

Alinsky's advice is now apparently standard operating procedure among every "*Democrat*" in America: They falsely accused Donald Trump of stealing the 2016 election, just as they falsely accused George Bush of stealing the 2000 election. Both were legitimate victories that occurred despite massive vote fraud by "Democrats." **Now, audits in Arizona have begun to reveal that massive voter fraud is the PRIMARY ELECTORAL STRATEGY practiced by the "*Democrat*" Party.**

In August of 2020, Hillary Clinton advised Joe Biden not to concede the November Presidential Election "***under any circumstances.***" She also warned that Republicans might attempt to "***mess up absentee balloting***" in order to steal the election for Donald Trump. **She clearly knew in advance that massive "*Democrat*" voter fraud was in the works, and that late-arriving and fraudulent *Absentee Ballots* would hand Joe Biden an illegitimate and stolen electoral victory.**

In another example of projection, many patriots protesting the stolen 2020 Presidential Election in Washington on January 6th have been charged with "***sedition***" and "***treason.***" Many remain incarcerated in solitary confinement without bail, while some have been beaten. These

POLITICAL PRISONERS have been arrested on trumped-up charges for demonstrating their outrage at what was clearly a stolen election.

In contrast, the communists in ***Black Liars Murder*** and ***Antifa REALLY WERE*** engaged in *sedition* and *treason* by rioting and burning dozens of **BLUE** cities in order to sow chaos and provoke a violent revolution in America. Most of them were released on minimal bail or on their own recognizance, and remain uncharged in the **BLUE** cities and counties where they rioted and torched vehicles and businesses following the *George Floyd Riots* of 2020.

Projection is further evident among the lying and traitorous carpet-baggers at the ***Southern Prevarication Lie Center*** (SPLC,) who have made a career promoting the phony narrative of innocent blacks being under assault by violent white assailants. They turn the truth on its head by accusing their conservative enemies of creating “***a false narrative of a victimized white majority under siege by allegedly violent people of color in the United States.***”

This is a tactic to divert attention from the violence, savagery, witlessness and predatory nature of their black clients, who commit about 90% of all murders in the U.S. every year. Moreover, blacks are 50 times more likely to engage in a violent crime against a white than the reverse. It is **RARELY** conservatives or white nationalists who commit acts of violence against blacks, it is almost always blacks themselves.

"*Democrat*" projection became a matter of public record when Hunter Biden sold his father's influence to the Ukraine, and received enormous sums in return. Later, Joe Biden -- with his usual good judgement -- bragged on videotape to the ***Council on Foreign Relations*** that he threatened to withhold U.S. aid from the Ukraine unless its chief prosecutor closed his investigation into a corrupt natural gas firm named ***Burisma Holdings***, on whose Board Hunter Biden served.

When President Trump merely broached the subject with the newly-elected Ukrainian President, "*Democrats*" denounced that as *extortion*, and immediately moved to Impeach Trump and remove him from office. They knew that Trump smelled a rat, and they used false charges against him to put him "*off the scent*." **As one writer succinctly quipped, "It was cool for Joe Biden to 'extort' the President of the Ukraine, but it was an impeachable offense when Donald Trump asked him about it."**

Moreover, "*Democrats*" across America have denounced Arizona's courageous audit of the *2020 Presidential Election* as "***election meddling***." Many holding public office have also refused to cooperate with efforts to investigate the legitimacy of that election by ignoring subpoenas requested by auditors in Arizona and elsewhere.

Any thinking person should recognize that the 2020 Presidential Election was stolen by a massive criminal conspiracy orchestrated by the "*Democrat*" Party at all levels, while using a variety of illegal techniques. **That's what those auditors are discovering in Arizona, and it scares the hell out of "*Democrats*" that their 60-year criminal conspiracy against the American People may finally be exposed along with their tactic of *projection*.**

What's more, many **BLUE** cities are experiencing accelerating violent black crime rates. Some public officials in those areas are now attributing their rising violent crime rates to "*white racism*," although few whites are ever involved. These public officials fear a backlash from voters, so they reflexively blame "*white racism*" as their default mode.

The frauds who hold office in **BLUE** cities and states have enabled and coddled blacks for decades, most recently those who called for their police forces be de-funded, while county prosecutors refuse to charge rioters engaged in arson and other acts of violence during the *George Floyd Riots*. **It is "*DEMOCRAT*" RACISM in the form of profoundly**

lowered standards for black behavior -- not some fabricated and illusory "*white racism*" -- that has encouraged the savage instincts in blacks, and which is actually responsible for recent and historically-high violent crime rates.

Finally, the communists and liars in the "*Democrat*" Party routinely accuse conservatives and Republicans of being "*science-deniers*." That accusation is often flung at sensible people who are merely distrustful of the supposedly "*scientific*" climate research at ***East Anglia University*** in England and our own ***National Oceanic and Atmospheric Administration*** (NOAA,) whose very own e-mails acknowledged that their data was "*fudged*" in order to exaggerate global temperature increases.

Yet, it is the "*Democrats*" and the entire left that refuse to acknowledge profound differences in IQ favoring whites over blacks, a disparity of 15 to 20 points that "*explains*" all disparities in wealth and academic achievement between the races. **No phenomenon in the history of the social sciences has been demonstrated more times and in more ways than this double-digit IQ disparity, demonstrated in approximately 650 empirical studies. The accusation of "*science-denier*" is clearly just another example of their use of Saul Alinsky's advice.**

The lesson here is to never accept the claims of any "*Democrat*" at face value, and this includes the phony narratives fabricated by their allies, the Jews' Media. It's a pretty safe conclusion that any allegations by either will be a lie, and more likely true of THEM than true of ANY conservative or Republican enemies.
