

## Saved by *Black Skin Privilege*

Bill Cosby's rape conviction was recently overturned by the ***Supreme Court of Pennsylvania***. That's the same bunch of crooks who ratified the arbitrary, capricious and unconstitutional changes to Pennsylvania's election laws by its corrupt Jewish Governor, which facilitated the theft of the 2020 Presidential Election.

There really are two systems of justice in this country, one for black criminals like Bill Cosby and another for whites, unless they happen to be "*Democrats*." Like many prominent black criminal defendants and other "*Democrats*," this sexual predator got special legal consideration from start to finish owing to his *Black Skin Privilege*.

It took Montgomery County, Pennsylvania 11 years to finally prosecute Cosby -- despite numerous complainants -- and then only because a new county prosecutor was elected. Cosby's arrest came mere days before the *statute of limitations* ran on his 2005 rape of Andrea Constand, a self-professed lesbian.

During his second trial for the drugging and raping of Constand at his Pennsylvania estate -- a "*hung*" jury ended the first trial -- the trial judge permitted several other Cosby rape victims to testify to similar experiences. In states where the courts aren't corrupt, this is called "*prior bad act testimony*," and helps establish a pattern of behavior by a criminal defendant.

Basically, when there are no witnesses to an alleged crime other than a defendant and a complainant, the claims of victims like Constand appear to have greater credence if others testify to similar experiences with the same criminal defendant. Yet, Cosby's conviction was ruled a mistrial in

Pennsylvania because *prior bad act testimony* supposedly "*tainted*" Cosby's criminal trial. Even Pennsylvania's Court of Appeals disagreed with the state Supreme Court.

**Thus Bill Cosby -- a serial rapist -- now joins a long line of corrupt but prominent negro criminals who got a free or nearly free pass from the justice system due to *Black Skin Privilege*.**

He joins Jesse Jackson, who was never prosecuted for embezzling enormous sums from his tax-exempt organizations, which he used to pay "*hush-money*" to the mothers of his bastards. Naturally, George H. W. Bush's Justice Department did not prosecute Jackson's high-profile tax fraud case, a decision that could ONLY have been made in the Oval Office.

Likewise, "*Reverend*" Al Sharpton organized a violent protest against legal and reasonable actions by owners of ***Freddy's Fashion Mart*** in New York. Sharpton's rhetoric so incensed a protestor in the crowd that he entered the store, shot several employees and set fire to the store causing multiple fatalities. Although this is merely one of many riots with fatalities initiated by Sharpton, he was never prosecuted for any of them.

More recently, a queer, Chicago n\*gger named Jesse Smollett -- whose acting career was on the decline -- decided to garner some publicity and sympathy by fabricating a "*hate crime*" against himself. He paid two nigger thugs to pantomime "*roughing him up*," and then reported it as a "*hate crime*" perpetrated by "*Trump supporters*." No prosecution occurred here, either, even though *Chicago Police* spent thousands of hours investigating this phony hate crime.

Following the belated investigation of a hotly-contested St. Louis election in 1991, five n\*gger Election officials in North St. Louis confessed under oath to the FBI that they forged the signatures of thousands of

black voters -- who never appeared at the polls -- and then "voted" them. Under Missouri Statutes, they should have been fined between \$2,500 and \$10,000, and spent up to five years in prison. Instead, their only punishment was to be barred from serving as election officials in future elections.

O.J. Simpson beheaded his ex-wife and also murdered the unfortunate waiter who was returning her glasses from the **Mezzaluna** restaurant where she mistakenly left them. The L.A. County District Attorney -- Gil Garcetti -- chose to hold this murderous black bastard's trial in Los Angeles rather than Brentwood, where the two murders actually took place. This venue guaranteed a jury consisting of corrupt and retarded n\*ggers, who acquitted Simpson despite **MOUNTAINS** of conclusive evidence.

In 2010, Obama's corrupt n\*gger Attorney General -- Eric Holder -- and other Obama officials set up an operation in which "straw" parties were permitted to illegally purchase firearms in the U.S. and then deliver them to the Mexican drug cartels.
