

# Who Is *REALLY* "Nuts" ?

In the 1950s and 1960s, many leftists in the psychoanalytic professions devised a tactic to dismiss the fledgling conservative political movement by diagnosing us with a condition they fabricated called "***Authoritarian Personality Syndrome***." This "*diagnosis*" was as phony as judge-made law from the Warren Court, having no clinical or empirical basis, whatsoever.

These charlatans and quacks were the predecessors of today's leftists, who feverishly work to politicize science in the name of their gods, Marx and Saul Alinsky. The enemies of truth now call their opponents "*science deniers*," whereas the epithet of *Authoritarian Personality Syndrome* was employed to label conservatives in the '50s and '60s.

**Of course, the irony is that ideologies like Marxism are anathema to true scientific inquiry, but the dictates of Cultural Marxism require that its pernicious influence must be permanently embedded wherever possible. The left is also oblivious to the fact that history offers few examples of individuals more "*authoritarian*" than the communist dictators the left has reflexively defended and to whom they've routinely paid *homage*.**

A second irony is that those who work so hard to advance Cultural Marxism's "*long march through the institutions*" must often ignore patently obvious truths and empirical facts to advance their cause, such as the relationship between race and IQ. In so doing, they often exhibit the characteristics of a true *delusional psychosis*. In common parlance they are flat-out *NUTS*, but the left is perfectly comfortable among the mentally-ill, and treats their rantings and delusions as if they were legitimate grievances.

For example, in the Summer of 2017, America experienced a highly-publicized Solar Eclipse. In response, a Jewish female Law Professor at **Brooklyn Law School** suggested in **THE ATLANTIC** that the **solar system was "racist"** because the eclipse fell across areas of North America populated primarily by white people. (Alice Ristroph. "American Blackout." **THE ATLANTIC**, August 18, 2017.)

She wasn't kidding, and her piece was tagged "science" and NOT humor by **THE ATLANTIC**. Here is her blathering in her own words: "**On August 21, 2017, a total solar eclipse will arrive mid-morning on the coast of Oregon. It has been dubbed the Great American Eclipse, and along most of its path, there live almost no black people.**" If nothing else, her article exposes the clinical obsession the left has with the subject of race.

A second Jewish charlatan at **Brooklyn College** declared on **Twitter** that "*The idea that math (or data) is culturally neutral or in any way objective is a MYTH.*" This silly female who contends **math is racist** is Laurie Rubel, and she is a "Professor of Math Education" which probably means that she instructs fourth-rate prospects in how to mis-educate students at fifth-rate institutions. She is not alone in disseminating this insanity: It is a basic tenet of *Critical Race Theory* and *her claim was re-Tweeted* by several other fraudulent "academics."

Another example of lunacy occurred when the tribe at the **Communist Broadcasting System** (CBS,) decided to impose Marxist speech codes to dictate what are acceptable terms to use in public discourse. In their infinite willingness to pander to blacks, **CBS News** decided that any term containing **the word "black" is de facto racist**. So much for the word "*blackmail*," which I've always felt was a perfect *portmanteau* for the chronic inability of *Africanus misdeliverus* to carry mail to its intended recipients.

CBS apparently intends to follow the lead of the **NEW YORK TIMES** by promoting the *1619 Project*, and seems intent on attempting to "re-educate" America as to its racist origins, particularly those involving slavery. They appear to have concluded that the way to do this is to "police" the language at CBS and obsess on the institution of slavery that ended more than 150 years ago. **You can be certain of one thing: the word *black* will never be used in reference to the first, legally recognized slave owner in America, a BLACK MAN named Anthony Johnson. "Transgenderism" is another area where the left really shows its lunacy. Senator Elizabeth "Pocahontas" Warren (D-Mars) vowed during the 2020 "Democrat" Primaries that if elected, she would eliminate the segregation of inmates by gender in our federal prison system. Thus, she would permit so-called "**transgenders**" to run amok amongst the **female inmate populations** in order to pander to those sad and psychologically disturbed individuals with "*gender identity problems.*" Transgenders are not necessarily queer, and many are sexually attracted to females.

A similar example involved threats by Obama's Justice Department (DOJ) against the state of North Carolina in 2016. North Carolina enacted a law requiring "*transgendered*" individuals to use public restrooms based on to their *biological* gender. However, the Obama DOJ insisted that these **circus freaks be allowed to use bathrooms based on their SELF-IDENTIFIED GENDER.** Since *transgendered* freaks are not necessarily queer, the problems that would accompany the DOJ's policy were obvious to everyone but the lunatics in the Obama DOJ.

Likewise, a couple of years ago **People for the Ethical Treatment of Animals** (PETA,) released a video **equating milk with white supremacism** or even *Nazism*. Here's one excerpt from the video: **"Did you know that milk has long been a symbol used by white**

**supremacists?"** Apparently, PETA thinks that white milk has been used as a symbol for "*racial purity*" for many years. (Does that make black coffee a symbol of black violence, or chocolate milk a metaphor for miscegenation?)

When the *ChinaVirus* pandemic hit, a number of irresponsible black idiots declared that **racism explained the greater mortality rate among blacks from COVID-19**. That was the claim of one so-called "*science reporter*" named Justine Calma, writing on an obscure site called *The Verge* on April 8, 2020. Her headline was that "**America Set up Black Communities to be Harder hit by COVID-19.**" The commies at *MOTHER JONES* joined the chorus by declaring in its August 8, 2020 headline that "**Black People Are Dying From COVID-19 at Higher Rates Because Racism Is a Preexisting Condition.**"

**Of course, anyone with a three-digit IQ recognizes that blacks experienced greater mortality rates from the *ChinaVirus* because they are FATTER, they have a greater incidence of DIABETES, they SMOKE MORE, they DRINK MORE, they get LESS EXERCISE, and they are less concerned with HYGIENE.**

Finally, The *Ladies Auxiliary of Marxism* -- or "*feminism*" -- involves the rejection of obvious physiological and psychological differences between males and females. Much as lunatics claim that race is a "*false construct*," feminists argue that **gender is a false construct**, as well. Feminists are angry, bitter and delusional females whose irrationality and childish behavior render them incomprehensible to adults of almost any age or gender. They are literally at war with their own physiology, and both their misogyny and misanthropy are clinical.

**The first legally-recognized slaveowner on the North American Continent was a nigro! Below is a condensed narrative describing this fact and its source:**

Anthony Johnson was a black man who came from what is modern-day Angola: He was captured by an enemy tribe and then sold to Arab slave-traders, who in turn sold him to the *Virginia Company* as an indentured servant in 1619 to grow tobacco.

After seven years, Johnson was released by *The Virginia Company* and became a free negro. He was given 50 acres of his own, which was the custom under the terms of indenture at the time. By the 1650s, he managed to successfully build his own farm until he possessed 250 acres and five indentured servants.

However, in 1651, when it came time for Johnson to release John Casor -- one of Johnson's OWN indentured black servants -- Johnson reneged (pronounced *re-nigged*) on the terms of his contract with Casor by refusing to release him or convey to him the land to which he was entitled. Casor then left Johnson to work for another farmer named Robert Parker.

**When Johnson learned of this, he sued Robert Parker and won in Northampton Court in 1655. The Court ruled that Johnson could hold John Casor indefinitely, despite the terms of his indenture. Both were black men: Casor became the first legally recognized slave in the American Colonies, and Johnson became the first legally recognized**

**slave-owner.**

Even though Johnson was, himself, freed from his indenture by his WHITE Masters, when it came time to free his OWN black indentured servant, Johnson reneged (pronounced "*re-nigged*") on the contract, and insisted upon unilaterally extending John Casor's servitude indefinitely and converting it into chattel slavery.
