

Don't Be Hoodwinked

White parents of public school students in New York City don't need another reason to flee, but Mayor Bill de Blasio just gave them one. He plans to end **accelerated learning classes** for elementary grades in the *New York Public Schools* (NYPS,) because too many white kids are enrolled in them.

Although about 70% of NYPS students are black or Hispanic, 75% of students in accelerated learning classes are white or Asian. This is unacceptable to race-hustlers and promoters of *Critical Race Theory*: as with race and IQ, they are uncomfortable with merit-based systems and the statistical disparities they generate.

Mayor de Blasio's term as mayor ends in three months, but he intends to run for Governor of New York (which should be entertaining!) Hence, he must shore-up his support among his Third World constituencies, possibly the only residents left in New York City who are foolish enough to vote for him again.

The "*Democrat*" Nominee for mayor in New York is a black guy named Eric Adams, whose proposed solution is to expand accelerated learning classes and establish more of them in low-income neighborhoods. This sounds plausible on its face, but white New Yorkers should not fall for it.

The liars and traitors who promoted federal court-ordered school desegregation in the *St. Louis Public Schools* (SLPS,) employed a similar tactic to fool white parents of public school students into supporting the *deseq* program that has now destroyed both St. Louis City and its school system.

Reluctant parents were promised that the SLPS would expand the number of "*Magnet Schools*" so most students could attend one.

Attending a *Magnet School* was voluntary, and it was intended that the racial composition of their student bodies would be 50% white and 50% black, thereby achieving the "*Holy Grail*" of racial "*balance*."

To those unfamiliar with the chicanery of politicians and school administrators, it was implied that "*Magnets*" were somehow imbued with *magical* properties to ensure a superior education. This was a sales pitch to attract white kids into voluntarily enrolling in *Magnets* that were 50% black.

The first *Magnet Schools* probably did have slightly better teachers, administrators and enriched curricula as an incentive for white students to participate. However, they soon regressed to the mean as white students fled the system after being beaten up or *rolled* for their lunch money by 19 year-old black Freshmen.

There was never anything magical about magnet schools: in fact, the frauds and charlatans who ran the SLPS in the 1980s and 1990s discovered they could apply the label "*Magnet*" to practically any school in order to achieve the racial balance they desperately pursued. **Their chicanery worked until the "*Magnet Program*" was over-expanded, just like mayoral candidate Eric Adams proposes for "*accelerated*" classes.**

St. Louisans watched helplessly as the SLPS rapidly and dramatically regressed under desegregation, and the City of St. Louis mirrored its decline. Neither is salvageable any longer because whites with school-age children fled St. Louis City for St. Charles County to the West and Jefferson County to the South.

The purpose of this exercise is merely to convey a warning to white parents of school-age children in New York City: DON'T ALLOW YOURSELVES TO BE HOODWINKED BY PROFESSIONAL LIARS WHO SUGGEST THAT "*ACCELERATED*" CLASSES CAN BE SIGNIFICANTLY

EXPANDED WITHOUT DESTROYING THEIR EFFECTIVENESS AND PURPOSE. All that will do is lower the academic standards in every one of those "*accelerated*" classes so blacks can successfully matriculate.

Fight to ensure your NYPS system is worth attending for whites, or get out while you still can and move to saner areas.
