

# NCPUSA: Masters of Disasters

The so-called "*Democrat*" Party -- more accurately referred to as the ***New Communist Party of the USA*** (NCPUSA) -- has been uniquely disastrous everywhere it's assumed power. At the federal, state and local levels, the NCPUSA has consistently demonstrated that it's **NOT** even remotely capable of governing, although it's proved to be quite adept at stealing elections and seizing power.

**That's because the NCPUSA consists of an unholy alliance of corrupt and greedy black race-hustlers, communists, queers, swamp creatures, phony "*environmentalists*," mailbox watchers, surly black public officials, communist Jews, union thugs, feminists, vegetarians and nudists. Simply put, the ideology that frames their bizarre and infantile worldview just doesn't work in the real world.**

This generalization has been true for many decades, and only the lies, disinformation and fraudulent narratives of its comrades in the Jews' Media have prevented the entire American public from recognizing the NCPUSA's extensive legacy of incompetence, failure and treason.

## [A BLUE Federal Government](#)

Communist China recently fired a "*hypersonic*" ballistic missile against which experts believe we currently have no defense. China obtained the necessary missile guidance technology from the CEO and Chairman of ***Loral Space & Communications***, Bernard Schwartz, who sold it to China in 1996. Normally, the Pentagon or State Department would intervene to prevent the **sale of U.S. technology with military applications** to hostile foreign nations: however, President Bill Clinton approved the sale

because Schwartz had contributed \$6 Million to the ***Democrat National Committee*** to fund Clinton's 1996 reelection. The technology sold to China dramatically enhanced the reliability of communist China's long-range nuclear missiles targeted at the United States.

Likewise, because the Jews' Media have run interference for them for decades, the NCPUSA has never been held accountable for creating the catastrophic "***Sub-Prime Mortgage Crisis***" in 2008. Its seeds were sown in the late 1970s when the NCPUSA controlled the presidency and both Houses of Congress, allowing it to enact the ***Community Reinvestment Act of 1977***. This law imposed race quotas on lending institutions, which were ***forced to lend to deadbeat minorities with terrible credit histories***. The law was predicated on the falsehood that "*discriminatory*" lending practices have created America's black "*ghettos*," rather than vandalism, laziness and irresponsibility. Its consequences were TRILLIONS of dollars in defaulted mortgages assumed by ***Fannie Mae and Freddie Mac*** for which taxpayers are still paying. The resulting financial crisis generated a major recession that helped elect Obama and allowed his NCPUSA to introduce all kinds of treasonous mischief into the U.S. economy during his administration.

Readers may also recall that the FDR and Truman Administrations served as employment agencies for Stalin's Soviet military intelligence (GRU,) and Soviet civilian intelligence (NKVD, later named the KGB.) Both Administrations were honeycombed with traitors who spied against America and for the Soviets, even while we were supposedly W.W. II "*allies*." The alliances and tactics they devised to insulate each other from investigations and promote each other through the bureaucracy have clearly been adopted by the denizens of America's "*deep state*" or "*swamp*" of today. Careful readers should never forget how Donald Trump inherited Obama's FBI and Justice Department in his first days as President , which had become the two most corrupt and **traitorous law enforcement** agencies in American history. Eight years of the Clintons and eight more of Obama and Biden had "*transformed*" what used to be the world's foremost law enforcement agency into a Western version of the Soviet KGB. A dozen officials from both agencies perjured themselves before four FISA Courts to obtain warrants to spy on President Trump and his advisors. They then knowingly brought fraudulent charges of "*Russia Collusion*" against Trump and his advisors in an **attempted coup to serve the NCPUSA**.

Likewise, we should also never forget that a Clinton Administration appointee, Deputy Attorney General Jaime Gorelick, was the **architect of 9-11** by issuing her "**Gorelick Memo**" that prohibited the *intelligence community* from sharing information with federal law enforcement agencies. That's why the FBI in 2000 and 2001 couldn't act on multiple reports of sweaty Moslems learning to fly **Boeing 747s**, but having no interest in learning how to **LAND** them. The CIA knew they belonged to *Al Qaeda* and were also aware they planned to commit terrorist acts with commercial airplanes, but both the CIA and the FBI's *Intelligence Division* were prohibited from sharing their data with the FBI's Criminal Division.

During the Clinton Administration, Usama Bin Laden orchestrated the following terrorist acts against Americans: The first attack on the **World Trade Center** in 1993, killing six Americans; A truck bomb at the *Saudi National Guard Communications Center* in Riyadh that killed two American soldiers in 1995; Another truck bomb in 1996 at the **Khobar Towers** that killed 19 Americans; Suicide bombings at the U.S. embassies in Tanzania and Kenya that killed 12 Americans; And the attack upon the **U.S. Cole** in 2000 that killed 17 sailors. **THREE TIMES BILL CLINTON WAS OFFERED USAMA BIN LADEN BY THE GOVERNMENTS OF FOREIGN**

**NATIONS, BUT ALL THREE TIMES HE REJECTED THEIR OFFERS. The consequences of his betrayal were the events of September 11, 2001.**

Readers may recall that the Biden Administration cancelled the **Keystone XL Pipeline** and prohibited oil and gas exploration on public lands, two Executive Orders that immediately generated **rising petroleum prices** and an **end to America as a net energy exporter**. This prompted Biden to beg Russia and OPEC to raise crude oil production in August of 2021. Readers should also be familiar with the fact that Biden discarded Trump's highly successful "**Remain in Mexico**" immigration policy, and substituted the failed Obama Administration's "**Catch and Release**" policy that has generated a *tsunami* of 2 million illegal immigrants thus far in 2021.

We have recently learned that not only did the **Wuhan Institute of Virology** create the *ChinaVirus*, but that the increased virulence and transmissibility of the virus -- called "**gain of function**" research -- was **funded by U.S. taxpayers!** During the Obama regime in 2014, Anthony Fauci's **National Institute of Allergy and Infectious Diseases** (NAIAD,) and the Pentagon conspired to shower millions of dollars in grants to fund what essentially became **China's Virologic Warfare Program** at the Wuhan Lab. This funding was laundered through **EcoHealth Alliance** of New York, which in turn directly funded the *Wuhan Lab's* research that created the *ChinaVirus* that has killed 800,000 Americans thus far.

More recently, we observed the debacle of our **disorderly retreat** from Afghanistan that left \$80 Billion worth of sophisticated weapon systems in the hands of the Taliban and other Islamic terrorists. Biden ignored his Secretary of Defense and Joint Chiefs by ordering a "**short-notice**" and **impromptu withdrawal** of U.S. forces and air power from Afghanistan. Foolishly, Biden evacuated the military first, leaving many U.S. civilians at the mercy of the Taliban. Biden's retreat from Afghanistan heralded the collapse of American foreign policy, generated humiliating chaos at

the Kabul Airport, invited a suicide bombing that killed 13 U.S. military personnel, and was punctuated with a flawed U.S. drone strike that mistakenly killed 10 members of a friendly Afghan family.

### BLUE Cities & Counties

The NCPUSA has been just as disastrous and treasonous at the city and county level. Readers may recall when the *ChinaVirus* pandemic hit, San Francisco began **housing its homeless population in the city's luxury hotels**. The homeless were provided free rooms, room service, cigarettes, alcohol **and even heroin** (for those "*who wish to continue using,*") at a cost of \$100 Million. City officials were astonished to find growing numbers of filthy vagrants arriving from elsewhere and demanding to know where their hotel room was.

While San Francisco's homeless were luxuriating at the ***Adam's Mark***, Seattle officials were studiously ignoring the violent seizure of six city blocks in its *downtown business and government district* by communists from ***Black Liars Murder*** and ***Antifa***. The latter illegally established an "*Occupation Zone*" where police were prohibited from entering. After months of timid negotiating, Seattle's hapless city officials were finally compelled to clear out this "***Capitol Hill Autonomous Zone***" when its nigs began gunning each other down in the middle of the night over drug deals, just as they do in every other **BLUE** city.

Portland may be even more poorly run than most other **BLUE** cities, as evidenced by the **nine months of nightly riots** engaged in by its own motley collection of nigs and communists. Although city officials insisted on calling them "*peaceful demonstrations,*" their levels of violence and arson indicated otherwise. Portland's hapless NCPUSA Mayor, Ted Wheeler, arrogantly rejected offers of federal assistance from President Trump, but finally relented and was forced to beg the Biden

Administration for assistance after nightly rioting lasted from May 31 of 2020 well into February of 2021.

NCPUSA Officials in most **BLUE** cities **ordered police to "stand down"** while communists and nigger rioters engaged in arson and violent assaults with impunity. Then, NCPUSA county **prosecutors refused to indict** even the most violent rioters among them. A fund was even established to **bail out rioters** to which Kamala Harris and other prominent members of the NCPUSA contributed. In the wake of these riots, there is now a move afoot in many of these **BLUE** cities to **reduce the budgets of their police departments**, even as their violent crime rates explode. Many of these same cities are also currently experimenting with **abolishing cash bail** for felony suspects.

Recently, the **Loudon County School Board** in Virginia and its county prosecutor tried to minimize the rape and sodomy of a 15 year-old girl by a "*transgendered*" male in a restroom at one of its schools. The prosecutor is one of those D.A.s elected with large donations by communist Jew, George Soros. The NCPUSA prosecutor gave the rapist a generous plea deal that didn't fully charge him with multiple offenses, and he was transferred to another school where he committed more sexual offenses. The victim's father was later arrested at a **Loudon County School Board** meeting when he attempted to expose the truth about its policy allowing "*transgendered*" biological males to use female restrooms. After being censored and arrested by the school board, the girl's father was then denounced as a "*domestic terrorist*" by the **National School Boards Association**, and charged by the NCPUSA's **Loudon County Prosecutor** with disorderly conduct and resisting arrest.

Not surprisingly, the most restrictive gun laws in America are found in its **BLUEST** cities like New York, L.A., Chicago, D.C. and San Francisco. After effectively disarming their law-abiding citizens with gun control ordinances, city officials began **emptying their county jails of violent**

**criminals** in 2020, based on an exaggerated fear of COVID-19's transmissibility and virulence to inmates. Many of those released were violent felons and murderers, many of whom took the opportunity to celebrate their freedom by immediately killing other citizens or committing other acts of violence.

### BLUE State Governments

The dolts and *poseurs* who serve as NCPUSA city and county officials in **BLUE** areas have nothing over the NCPUSA's governors who run **BLUE** states. For example, New York Governor Andrew Cuomo **negligently killed as many as 15,000 elderly New Yorkers** living in retirement homes. They died from COVID-19 after Cuomo irresponsibly issued an *Executive Order* that required COVID patients to be moved to retirement homes for treatment. Cuomo clearly did this out of spite to avoid using the U.S. Navy's medical ship ***Comfort***, which President Trump had dispatched to New York in late March of 2020 after Cuomo had begged Trump for assistance in quarantining and treating COVID-19 cases. **15,000 elderly New Yorkers died because Cuomo conspired to prevent President Trump from receiving credit for expeditiously dispatching the USNS *Comfort* to New York.**

Equally crazy, in 2014, California essentially "**legalized**" **shoplifting with Proposition 47**. Prop 47 made the theft of items valued at less than \$950 a misdemeanor rather than a felony. This was immediately interpreted by California's niggers, illegal aliens, drug-addicts and homeless garbage as a **green light** to shoplift at will. It has been a catastrophe for retail outlets: **Walgreens** experienced so much theft under Prop 47 that it closed 17 stores in San Francisco in the last five years, alone. The cost of theft to **Walgreens** is **FOUR TIMES** the average for its stores located where shoplifting has not been legalized by idiots.

During the COVID-19 scare, NCPUSA officials in the **BLUE** states of New Jersey, Michigan, Minnesota and California showed their true priorities by ordering churches and places of worship to be "*locked-down*," while granting permission for abortion clinics, liquor stores and marijuana shops to remain open. Likewise, small businesses were ordered closed, while larger retailers -- many of whom have been extorted into contributing to the NCPUSA's candidates for public office -- were permitted to remain open. The **selective lockdown of small businesses** in **BLUE** cities and states by the NCPUSA was a tactic intended to damage President Trump's robust economy and harm his reelection efforts: however, quarantines and lockdowns were maintained for so long that many small business owners picked up and fled to greener pastures in **RED STATES**.

New York, New Jersey, Illinois and California are so terribly mismanaged, they each have between \$500 Million and \$1 Trillion in **un-funded liabilities in their state employee pension funds**. All four have been extremely generous to their public employees who, in turn, contribute to NCPUSA candidates for public office at election time through their union *check-off* systems. The crooks who participate in this scam and vote for NCPUSA candidates don't seem to realize that their state government then "*borrow*s" enormous sums from those pension funds, thus depleting them, in order to enrich other NCPUSA constituencies. As their respective tax bases have fled and sought refuge in better managed states with lower taxes, the response of **BLUE** state governors and mayors has been to impose yet, **HIGHER TAXES** on those unfortunate or foolish enough to remain.

Similarly, California's State Legislature is heavily controlled by the NCPUSA and has been so busy pandering to the "*environmentalist lobby*," it is no longer capable of governing intelligently. Caving to pressure from environmentalists in the 1990s, it enacted regulations that **prohibit county fire officials from cutting "*fire-breaks*"** through forested



lands to contain wildfires when "*endangered*" species are present. California's regulations also prohibit homeowners from creating fire-breaks around their homes or from clearing deadwood that fuel wildfires and help them spread. California environmentalists were more concerned with the Kangaroo Rat and sand fleas than with the lives and homes of humans. The rampaging wildfires that have routinely occurred since enactment of those regulations have destroyed millions of acres of forests, untold wildlife, and tens of billions of dollars worth of property.

Moreover, NCPUSA mayors weren't the only idiots releasing dangerous criminals from imprisonment: several NCPUSA Governors did so as well, and some of these criminals celebrated their release from prison by murdering innocent citizens. The nigger who abducted and murdered a Pennsylvania Amish girl named Linda Stoltzfoos in April of 2021 had been **given early release in late 2019** by Pennsylvania's ***State Parole Board***, an agency controlled by Jewish governor Tom Wolf. (Wolf is the same guy who intentionally subverted Pennsylvania's election laws to help steal the November, 2020 Presidential Election.)

Likewise, that queer NCPUSA Governor of Colorado, Jared Polis -- who just married his boyfriend -- **paroled a savage nigger** from Colorado's state prison system out of fear that the black bastard might contract COVID-19. The nigger almost immediately murdered an innocent 21 year-old white woman named Heather Perry. The nig had a rap sheet that extended back 10 years. Like most NCPUSA members, Colorado's queer, Jewish governor was more concerned with the wellbeing of murderous nigger savages than with vulnerable and innocent citizens.

Some **BLUE** states – such as New York, Illinois, California, Maryland and New Jersey – have followed the lead of their NCPUSA comrades in **BLUE** cities by experimenting with abolishing cash bail for felony suspects. This enables murderers, rapists and armed-robbers to continue practicing their craft while awaiting their criminal trials.

The NCPUSA at every level also appears intent on imposing *Critical Race Theory* wherever possible, by funding its inclusion in the curricula of **BLUE** city and county school systems, by pressuring the Human Resource Departments of large corporations and even imposing it on the U.S. armed services. Those who object to being indoctrinated with Marxist propaganda are frequently labeled "*domestic terrorists*," and may find themselves under scrutiny by the same FBI that Attorney General Merrick Garland recently dispatched to harass and investigate parents who openly oppose *Critical Race Theory* in their schools. That's how they did it in the Soviet Union.

**All three levels of American Government no longer function rationally where they are in the grasp of the NCPUSA. They have been subverted and mismanaged by the infantile application of Marxism in all its manifestations, including socialism, communism, multi-culturalism, trans-genderism, environmentalism and feminism.**

**The decline of American government at all levels provides a glimpse at the very bleak future facing freedom-loving Americans if we fail to end the traitorous and incompetent rule of the corrupt and treasonous NCPUSA.**
