

## FBI Corruption (cont'd)

In the Late Winter Edition of the 2021 **INFORMER**, I described the dramatic decline of the FBI after eight years under Bill & Hillary Clinton, and eight more under Barack Hussein Obama, America's first communist and Moslem president. Sadly, there is further evidence of FBI corruption and the Bureau's conversion into a weapon of the *New Communist Party of the USA* (NCPUSA,) sometimes mistakenly called "*Democrats*."

On *Columbus Day*, October 12, the FBI raided the private residence and Manhattan headquarters of Ed Mullins, President of the 13,000 member ***Sergeants Benevolent Association*** (SBA) of New York. Mullins is an outspoken supporter of Donald Trump, and a harsh critic of both New York Mayor Bill de Blasio and disgraced former New York Governor Andrew Cuomo. The FBI raid is further proof that the *Bureau* has totally lost its bearings under its hapless Director, Christopher Wray.

**Using *Twitter*, Mullins has been a prolific critic of Mayor Bill de Blasio's regime in New York City for several years. In May of 2020, he probably became a target of the NCPUSA for posting the arrest report of de Blasio's daughter, Chiara de Blasio, when she was arrested for participating in New York's version of the "*George Floyd riots*."**

In a scathing comment in May of 2021, Mullins accused former New York Governor Andrew Cuomo of "***never (having) met a murderer he did not want to parole.***" Likewise, Mullins incurred the wrath of Mayor de Blasio and former Governor Cuomo many times for his criticisms, both of whom he accused of "***never passing up an opportunity to bash the police.***"

The rapier wit of Mullins was much too accurate for the corrupt politicians he targeted, especially the leftist and anti-police sleaze-balls

in New York. For example, the following is his quote concerning the cause-and-effect nature of police-bashing by New York's leftist politicians:

*“Words have consequences and, since first taking office in 2014, de Blasio’s incendiary anti-police rhetoric has already resulted in three police officers being executed while sitting in police vehicles, Molotov cocktails being lobbed at officers and into police vehicles, armed assaults on police facilities, cops being pelted with debris, and wholesale damage to police and public property.”*

Rather than the "*beacons of hope*" to minority neighborhoods that these leftist politicians portray themselves to be, there has been a 166% increase in shootings from April of 2020 to April of 2021 in New York City. As Mullins put it in reference to the dubious NYC *Police Reform Package*:

*"The 2020 'reform' package has done nothing but kneecap the police and increase violent crime to levels not seen since the early 1990s. All the progressive changes meant to even the playing field for minority residents has only resulted in scores of Blacks and Hispanics becoming victims of crime."*

Although too busy to investigate the theft of the 2020 Presidential Election, the FBI under clueless Director Christopher Wray is clearly willing to do the dirty work of the *New Communist Party of the USA* by attempting to silence some of its more outspoken critics. Several months ago they targeted Rudi Giuliani with a raid in which they seized all his electronic devices, but had no interest in Hunter Biden's laptop.

More recently, Attorney General Merrick Garland sent FBI agents to harass and investigate outspoken opponents of *Critical Race Theory* at county school board meetings, and their most recent target was Ed Mullins. This exposes the institutional corruption at the FBI, and its
