Strange Times, Indeed

Being a "*progressive*" locale, the *Loudon County School Board* (LCSB) in Virginia adopted a policy that allowed *transgendered* male students to use restroom facilities normally reserved for biologically female students in less "*enlightened*" areas. The public was assured by deep-thinking *progressives* on the LCSB that any reservations over such a policy were "*misplaced*."

On May 28th of 2021, a 15 year-old white girl at Loudon County's *Stone Bridge High School* was raped and sodomized by a "*transgendered*" male in one of those *Stone Bridge High School* girls' restrooms. The offender was also 15, and often wore a dress to school to demonstrate that *he* was equally as "*woke*" as the *Loudon County School Board*.

Strange things happen in *enlightened* areas and Loudon County is no exception. The parents of the victim were told by school authorities only that their daughter had been in a "*physical altercation*" with a male in a restroom. The school clearly intended to handle the incident *in house* to avoid lawsuits and bad publicity. In addition, he was transferred to another school where he soon engaged in a SECOND SEXUAL ASSAULT against a female student after forcing her into a vacant classroom, holding her against her will and molesting her. (I'm betting he's a NIGGER!) The prosecutor in Loudon County is one of those "*progressives*" whose campaign for public office received \$850,000 through third-party organizations funded by that Jew-communist, George Soros. Her name is **Buta Biberaj**, and she an Albanian Moslem immigrant who campaigned against incarceration. She is also a close ally of the leftist trash that dominates the supposedly "*enlightened*" *Loudon County School Board*.
