

Truth Will "Out"

A favorite adage of mine is that "*a lie is half-way around the world before the truth can get its boots on.*" In the case of the *Steele Dossier* and its claims of "*Russia Collusion*" by President Trump, liars were able to circle the globe about a thousand times.
