

## Film Review: ***2000 Mules***

Following the 2020 election, the ***New Communist Party of the USA*** (NCPUSA) -- laughingly called "*Democrats*" -- and their whores in the Jews' Media parroted the lie that the 2020 presidential election was "***the most secure in American history.***" To make that claim, election officials would necessarily have had to examine the security of every prior election, but no such examination ever took place.

Thanks to the cowardice of such RINO "*leadership*" as Mitch McConnell and Kevin McCarthy, prior elections have ***NEVER*** been adequately examined, and the stolen 2020 election was no different. Those braying that the 2020 election was somehow "*secure*" were often the very people who repeatedly obstructed efforts to audit or investigate its returns. The blizzard of lies claiming the 2020 election was secure was the usual false narrative used to overwhelm any honest debate.

Thank God for Catherine Englebrecht and her organization, ***True the Vote!*** Her researchers took the novel approach of examining data from cell tower "*pings*" in the *swing* states of Arizona, Georgia, Michigan, Pennsylvania and Wisconsin, in addition to those in Texas. This data was gathered between October 1 and November 6, 2020.

The cell towers from which they gathered their so-called "*geospatial and temporal*" data were those near ballot drop-boxes, UPS facilities, and the many Soros-funded NGOs (non-governmental organizations) that played a large and sinister role in the theft of the 2020 election. ***True the Vote*** examined a total of 10 TRILLION (10,000,000,000,000) cell phone *pings!*

**Using *True the Vote's* research, the film *2000 Mules* convincingly proves that the 2020 presidential election was probably the least**

secure election ever, and that it was clearly stolen from President Trump, just as he alleges. True the Vote estimates that 275,000 votes were illegally "*trafficked*" in Pennsylvania, 125,000 in Michigan, 30,000 in Georgia, 20,000 in Arizona, and 14,000 in Wisconsin, for a grand total of 464,000 illegal votes. That total is more than enough to have stolen the election from Donald Trump and wrongly handed it to the organized crime figure and pathological liar wrongly occupying the White House. Without the illegal ballots in those six swing states, Trump's *Electoral College* vote total would have been at least 279 to Biden's 259.

**The criminals who trafficked in illegal ballots are referred to as "*mules*" in the film. It should come as no surprise that many *mules* possessed phone numbers identical to individuals who participated in the "*George Floyd Riots*" in 2020, meaning that many *mules* were also communists from *Black Liars Murder and Antifa*.**

For several weeks, prior to election day, each mule collected stacks of illegal ballots stored in so-called "*stash houses*," and then transported them to ballot drop boxes in the dead of night like the crooks they are. According to researchers, a *mule* was defined as someone making "*at least 10 visits to drop boxes*," but mules actually averaged 23 visits to ballot drop boxes. If the definition of "*mule*" is relaxed **from 10 to at least five visits**, the number of fraudulent votes more than **DOUBLES**.

According to Engelbrecht, the key to vote fraud in America originates with "*dirty*" voter rolls containing invalid voter registrations, a common phenomenon in many **BLUE** counties. These often include dead people, illegal aliens, fictitious identities and those who have moved to another

county. A recent examination of its voter rolls exposed the fact that Wisconsin has seven million "*registered voters*," but only four million residents of eligible voting age.

For years, ***Judicial Watch*** has laboriously sued county election officials in many of these states to obtain court orders requiring election officials to "*purge*" invalid or dirty registrations in these locales, but these court orders were often ignored. Many of those same counties routinely experience voter turnout that greatly exceeds their voting-age populations, an anomaly that ALWAYS benefits the NCPUSA.

Led by individuals like Joe Biden, Nancy Pelosi, Hillary Clinton and the Obamas, the NCPUSA is no longer a legitimate political party, it is an **ORGANIZED CRIMINAL ENTERPRISE** masquerading as a political party.
