

A Convenient Reference

I never dreamed I'd say this, but the Jews' Media has become a very convenient and reliable reference source for determining the accuracy of any prominent news story. **No matter what position the Jews' Media take, it's safe to conclude the EXACT OPPOSITE of their unfailingly false "narratives."** Their record over the last six years bears me out.

For example, when candidate Donald Trump publicly alleged in the summer of 2016 that his office in **Trump Tower was bugged**, he was ridiculed as "*paranoid*" by the entire Jews' Media and laughed at by his "*Democrat*" opposition. Since then, Special Counsel John Durham's investigation has amassed evidence that Hillary Clinton's personal spy network illegally hacked into Donald Trump's private e-mail servers in **Trump Tower** and even those in the *Oval Office* after Trump was elected.

In the fall of 2016, while embroiled in her e-mail and influence-peddling scandal from her days as Obama's *Secretary of State*, Hillary engaged in a diversionary tactic to rescue her faltering campaign for president. One day she declared that computer experts had uncovered a "**covert server linking**" Donald Trump's campaign with a Russian bank named **Alfa Bank**. **This one-woman crime wave was in an ideal position to know about that "link" because she paid her tech spies to fabricate it.**

Durham's filing against Clinton lawyer Michael Sussman in February of 2022 exposed the fact that a tech executive hired by the Clinton Campaign devised a technique to spy on Trump as both a candidate and as president. With the assistance of a team of researchers at **Georgia Tech University**, the **Clinton Spy Network** intercepted all internet traffic between Trump and his staff at both **Trump Tower** and the Oval Office. That political espionage formed the basis of Trump's complaint of being

spied upon. **However, rather than investigate the validity of this complaint, all Trump received was ridicule from the vile Jews' Media in order to intentionally give Clinton a free pass.**

According to court filings by Special Counsel Durham, the *Clinton Spy Network* always had two distinct goals: The first was Hillary's campaign to smear Donald Trump with false allegations of Trump's "*collusion*" with Russia to improve her chances of being elected president in 2016; and the second was to destroy Trump's Presidency and facilitate his removal from office in the event he defeated Hillary.

The second goal evolved into a treasonous, attempted "*coup*" in which Clinton loyalists at the DOJ and FBI were enlisted to frame Trump with the phony charge of "***colluding with Russia***" to steal the 2016 election. Their fraudulent investigation continued until Trump was finally vindicated by the ***Mueller Report***, reluctantly written by his enemies three years later in 2019.

In both cases, Trump was treated with ridicule by the Jews' Media, which never investigated his complaints of being spied upon nor his denial of his "*collusion*" with Russia. Both were ignored and never pursued by the traitorous scum masquerading as "*journalists*," even as they actively collaborated with the Clinton Campaign to disseminate her lies and fraudulent allegations.

A similar phenomenon occurred in 2020 when Hunter Biden became too dissipated to retrieve his three personal laptop computers that he left at a Delaware computer repair shop. Their contents exposed the full extent of Hunter Biden's drug usage, sexual deviancy and his **sale of influence** all around the globe using his father's position as Vice President as his leverage. Donald Trump attempted to raise this issue during a 2020 Presidential Debate, but he was repeatedly interrupted by Chris Wallace, the Jewish swamp-creature who was supposedly "*moderating*" the debate.

Most importantly, Hunter Biden's three laptops contained e-mails describing his agreement to split the ill-gotten gains from his extortion-racket with "*the Big Guy*," a code that Hunter Biden and his business partners adopted to camouflage the participation of our current president, Joe Biden. **The Jews' Media "spiked" this story for nearly two years, but are now attempting to salvage what little remains of their reputations. They occasionally report on the *Biden Family Crime Syndicate's* investigation by the U.S. Attorney in Delaware: however, they scrupulously omit any mention of the participation of Joe Biden, "*the Big Guy*."**

Not long after the ***ChinaVirus scamdemic*** appeared, President Trump began to recognize that he was getting poor advice from Anthony Fauci, head of the ***National Institute for Allergies and Infectious Diseases*** (NIAID.). Trump wisely ignored Fauci's opinion that restricting airline flights were "*irrelevant*," and banned all flights from China. Trump also attempted to alleviate growing public panic over the *ChinaVirus* by recommending *Hydroxychloroquine Sulfate* (HCQ) as a "*game-changer*" in combatting this new virus. Trump was immediately set upon by the Jews' Media, which attacked him as "*xenophobic*" for banning flights from China and belittled him for recommending HCQ. **In fact, Trump was correct on both counts and the Jews' Media were wrong as they always are when pushing their political agenda instead of merely reporting the news.**

It turns out that the ***Wuhan Institute of Virology*** in China was the original source of the COVID-19 scamdemic, which means that Trump's decision to ban airline flights from China showed great courage, wisdom and foresight. Also, we now know that Anthony Fauci -- one of the most devious of swamp creatures -- was waging a secret war against HCQ because his benefactors at *Big Pharma* could not benefit from its use as a treatment for the *ChinVirus*. The U.S. Patents for HCQ expired decades

ago, so it was a plentiful, inexpensive, non-invasive and highly effective anti-viral drug that could have saved many lives in the U.S. if only Fauci and the Jews' Media had not waged a campaign against it to embarrass Trump. Unlike Fauci, many physicians who practice medicine rather than politics have effectively and safely treated millions of patients with HCQ. **One physician even claims that the campaign against HCQ by Fauci and the Jews' Media alone cost a million American lives.**

Finally, for two years, the Jews' Media reflexively parroted the lie that there's no evidence of **voter fraud** from the November 3rd, 2020 Presidential Election. "Democrats" and their whores in the Jews' Media parroted the lie that the 2020 presidential election was "***the most secure in American history.***" Not surprisingly, these were often the very people who repeatedly obstructed efforts to audit or investigate its returns, and their blizzard of lies about the security of the 2020 election was the usual false narrative used to overwhelm any honest debate. The Jews' Media didn't want to look because they knew they would find damning evidence, and found it expedient to simply dismiss such claims as "*conspiracy theories.*"

Following the 2020 election, researchers from Catherine Englebrecht's ***True the Vote*** examined data from cell tower "*pings*" in the *swing* states of Arizona, Georgia, Michigan, Pennsylvania and Wisconsin, in addition to those in Texas. This data was gathered between October 1 and November 6, 2020. The cell towers from which they gathered their data were those found near ballot drop-boxes, UPS facilities, and the many George Soros-funded non-governmental organizations that played a large and sinister role in the theft of the 2020 election. ***True the Vote*** examined a total of **10 TRILLION** (10,000,000,000,000) cell phone *pings*!

Using *True the Vote's* research, the documentary *2000 Mules* convincingly demonstrates that the 2020 presidential election was the least secure election in U.S. history and that it was clearly stolen from

President Trump, just as he alleges. The data that *True the Vote's* researchers mined -- in combination with video surveillance -- offers proof of a massive, illegal and coordinated ballot-harvesting operation that occurred in many swing states and Texas.

The criminals who trafficked in illegal ballots are referred to as "*mules*" in the documentary. It should come as no surprise that many *mules* possessed phone numbers identical to individuals who participated in the "*George Floyd Riots*" in 2020, meaning that many mules were also communists from *Black Liars Murder and Antifa*.

For several weeks prior to election day, each mule collected stacks of illegal ballots stored in so-called "*stash houses*," and then transported them to ballot drop boxes in the dead of night like the thieves they are. According to researchers, a *mule* was defined as anyone making "**at least 10 visits to ballot drop boxes,**" but the actual average for each mule was 23 visits. If the definition of "*mule*" is relaxed **from 10 to five visits**, the number of fraudulent votes more than **DOUBLES**.

On the basis of the traffic patterns of mules between stash houses and ballot drop-boxes, *True the Vote* estimates that 275,000 votes were illegally "*trafficked*" in Pennsylvania, 125,000 in Michigan, 30,000 in Georgia, 20,000 in Arizona, and 14,000 in Wisconsin, for a grand total of 464,000 illegal votes. That total was more than enough to have *flipped* the election returns in each of those *swing* states and wrongly hand the election to the organized crime figure and pathological liar currently and illegally occupying the White House. Without the illegal ballots in those six swing states, Trump's *Electoral College* vote total would have been at least 279 to Biden's 259.

In conclusion, the Jews' Media intentionally spiked or ignored the following scandals: A political rival illegally intercepts communications of an opponent for years, even after that opponent is elected president;

That same president was framed with fraudulent charges concocted by Clinton loyalists at the Justice Department that eventually led to his wrongful, three-year investigation by those same crooked cops; A high-ranking "*expert*" in the health care bureaucracy routinely gave intentionally misleading advice to a president during a "*pandemic*" that caused a million unnecessary American deaths; The son of the current president jetted all over the globe shamelessly selling his father's influence and then -- in his own words -- split his ill-gotten proceeds with his father; And, massive voter fraud stole an election from an incumbent president.

Those were the *FIVE BIGGEST NEWS STORIES* of the 21st Century, and maybe the 20th Century, as well. What they have in common is that each was universally ignored and spiked by the Jews' Media, which dismissed each story as a "*conspiracy theory*." In each case the narrative the Jews' Media adopted was 180 degrees from the truth, and it continued to *spike* each scandal long after the truth began to surface.

Led by the *NEW YORK TIMES*, the *WASHINGTON POST*, the networks and most of cable news, America's Jews' Media has abandoned whatever pretense of "*journalism*" it may have once practiced. It has willfully and shamelessly adopted its new role of ***DISSEMINATING DISINFORMATION*** for the *New Communist Party of the USA*, wrongly called the "*Democrat*" Party.

In doing so, it has helped subvert the democratic process throughout the U.S. and needs to be thoroughly investigated by the next Congress and an *honest* Justice Department using the RICO statutes and Anti-Trust Laws.
