

American Stalinism

Communism is a greater threat to America now than it has ever been, even compared to the *Cold War* era. The difference from earlier eras is that communism is now an **INTERNAL THREAT** from the **New Communist Party of the USA** (NCPUSA,) masquerading in the guise of the misnamed "Democrat" Party. The NCPUSA, its Jews' Media allies and the "deep state" they've created have every intention of delivering America over to international socialism and a "one-world government" scheme.

In order to achieve their goal, they have become increasingly dictatorial, so their policies and behaviors often bear a striking resemblance to those previously found in Leninist and Stalinist Russia. The conversion is nowhere near a *fait accompli*, but **many aspects of the way the NCPUSA and its leaders behave are strongly reminiscent of the former Soviet Union.**

DISARMING CIVILIAN POPULATION: All would-be communist dictators outlaw the private ownership of firearms to prevent their subjects from resisting inevitable encroachments on their liberties. For the past 50 years, one of the very highest priorities of the NCPUSA has been to disarm America by whatever means was available, the *2nd Amendment* notwithstanding. The NCPUSA hates firearms because they are just about the only deterrent obstructing the NCPUSA's agenda to impose a one-world socialist state upon us, run by "enlightened" and "superior" folks like themselves. Thus, Biden has seriously floated a proposal to tax, register and ultimately confiscate any weapon with a high-capacity magazine, including so-called "assault rifles" and semi-automatic pistols. **Not coincidentally, immediately after the Bolshevik Revolution, the private ownership of firearms was prohibited by the Communist Party of the Soviet Union.**

WAR AGAINST RELIGION: The NCPUSA's war against religion began in the early 1960s with the leftist and traitorous Warren Court's "*re-interpretation*" of the First Amendment's *Establishment Clause*. They reversed its original intent 180 degrees and substituted the fraudulent notion that the Framers intended to establish an entirely secular society and promote *irreligion*. A more recent example was the NCPUSA's persecution of religious services in many **BLUE** states during the COVID scamdemic by shuttering places of worship and prohibiting religious services, even while abortion clinics, liquor stores and marijuana shops were permitted to remain open.

With the exception of the phony "*lip service*" some blasphemous hypocrites give it -- such as Nancy Pelosi and Joe Biden -- most NCPUSA officials correctly recognize they must pursue an unrelenting war against religion. Their crusade against religion is based on the principle that religious faith cannot co-exist with Marxism, since Marxism rejects the "*Natural Rights*" philosophy of the Framers of the Constitution. This is the belief that our basic rights are bestowed upon us by God, and not merely granted to us by the state. **That's why the Russian Orthodox Church was cruelly suppressed in the Eastern Bloc, and thousands of Christian Churches were burned to the ground or "re-purposed."**



WAR AGAINST AMERICA'S HISTORY: George Orwell once stated that "*The most effective way to destroy a people is to deny and obliterate their own understanding of their history.*" The culture war waged against America by the NCPUSA does **NOT** merely target Southern culture and its heroes, it targets every aspect of American culture since its founding. Even Cristopher Columbus and Abraham Lincoln's memories aren't safe from its commissars, nor is that of George Washington or any other Framers of the Constitution. Like the Bolsheviks, the NCPUSA and their allies among ***Black Liars Murder*** and ***Antifa*** are intent on eradicating America's historical and cultural traditions, *root and branch*.

The NCPUSA routinely subsidizes and promotes the lies of the most dishonest and witless niggers imaginable, such as the ludicrous ***1619 Project*** or ***Critical Race Theory***. The *1619 Project* is a fraudulent misinterpretation of America's founding, which communists allege was based primarily on slavery and therefore illegitimate. Of course, the black "*scholar*" who devised this scam is likely unaware that the date 1619 refers to the first importation of so-called "*slaves*" into North America, an event that occurred **a full 157 years before America even became a nation!** They were imported by the ***Virginia Company*** to grow tobacco as **indentured servants** -- not slaves -- and were given 40 acres and their freedom after each completed their seven year indenture. Many later became prosperous farmers. Likewise, so-called *Critical Race Theory* is merely Marxist Theory with race substituted for class.

Meanwhile, NCPUSA hit squads in the form of ***Black Liars Murder*** and the communists in ***Antifa*** have engaged in arson, murder and aggravated assaults in nearly every large, **BLUE** urban area in the nation, and have done so with nearly universal impunity from local authorities. Moreover, county school districts in **BLUE** areas subject grade school kids to "*gender counseling*" and nearly all students to *Critical Race Theory*, or a so-called "*White Privilege*" curriculum, and dozens of other absurd and traitorous

ideologies. **Here, the NCPUSA has closely followed the Bolsheviks, who immediately set about destroying Russia's historical and cultural memory and "rewriting" history immediately upon seizing power. Most educational and historical texts were "revised" by the Bolsheviks just as the NCPUSA labors to do here.**

WAR AGAINST THE MIDDLE-CLASS: The NCPUSA is engaged in a war against America's middle-class, or what Marxists refer to as the hated "*bourgeoisie*." It should now be obvious that the true purpose behind prolonged "*lockdowns*" of small businesses in New York, California, New Jersey, Michigan and other deep "**BLUE**" states was a broader strategy to destroy middle class entrepreneurs who built those businesses. By using the pretext of the *ChinaVirus scamdemic*, politicians in the NCPUSA knowingly shuttered millions of businesses and sabotaged the ability of their middle-class political opposition to earn a livelihood by bankrupting the businesses many spent their adult lives building.

By destroying small businesses, the NCPUSA seeks to impose a new socialist agenda on America, where the middle-class is decimated and the impoverished masses that result are entirely dependent upon scraps from NCPUSA commissars. Meanwhile, the NCPUSA's political allies -- such as the plutocrats of social media -- are granted legislative favors and political protection in exchange for massive campaign contributions from social media and their censoring of conservative opposition. In this sense, *Twitter, Facebook, Google and Apple* have joined the Jews' Media to become an American "*Nomenklatura*."

The NCPUSA's war against the "*Bourgeoisie*" is one reason why police in **BLUE** cities were told to *stand down* while rioters looted and burned small businesses to the ground. It is also why few if any rioters were ever charged with a felony for torching or looting someone's business. Biden and the NCPUSA recognize that small business owners are their **GREATEST POLITICAL OPPOSITION**, since most tend to be conservative, libertarian, Republican, or at least independent-minded. **The NCPUSA's**

war against America's middle-class is reminiscent of the way Stalin intentionally starved to death 10 million middle-class Ukrainian farmers ("*Kulaks*") in 1932 and 1933. He forcibly confiscated nearly their entire agricultural output and starved them to death for resisting his "*collectivized agricultural program.*"

POLITICAL PRISONERS: On January 6th of 2021, mostly well-intentioned Trump supporters walked into the **biggest *sucker-punch* in the history of American politics.** They were exercising their First Amendment Rights to peaceably assemble and petition the government for redress of grievances because they were indignant over the theft of the presidential election in November of 2020. Unfortunately, Pelosi, Schumer and the NCPUSA *were* prepared for them, and set a devious trap into which these mostly law-abiding Trump supporters ventured with their eyes wide shut.

Nancy Pelosi and Chuck Schumer repeatedly rejected President Trump's offers of 15,000 National Guardsmen to maintain order on January 6th because they had a very different objective in mind than maintaining order: they wanted to precipitate a riot they could politically exploit as an "*insurrection*" and blame Trump for instigating it. Their many *agents provocateur* and Capitol Hill Police opened doors and welcomed demonstrators into the Capitol Building in order to trap them and create a phony "*insurrection.*" The result is that a year and one-half later, approximately 200 Trump supporters remain in the D.C. jail without charges and without legal representation. Even House members have been denied access to them. **Their mistreatment is far worse than that accorded murderers and terrorists, and no doubt inspired by the old Soviet Gulag or the *Lubyanka*, where dissidents were sent "*to get their minds right.*"**

SHOW TRIALS: Another glimpse into the NCPUSA's true agenda was evident at the trial of General Michael Flynn. Despite the absence of any

evidence that Flynn was guilty of anything, he was framed by corrupt Obama holdovers. Then, the n*gger judge sitting on Flynn's four-year inquisition refused to dismiss his case **EVEN AFTER THE JUSTICE DEPARTMENT DROPPED ALL CHARGES AGAINST FLYNN**. In doing so, Judge Emmett Sullivan – a Clinton appointee, of course -- assumed the functions of both **PROSECUTOR AND JUDGE** by arbitrarily, illegally and unconstitutionally perpetuating Flynn's show trial for four years.

The Flynn case was an effort by the NCPUSA to preempt investigations into criminal and treasonous misdeeds by Obama's DOJ, FBI and NSA using fabricated charges to destroy President Trump's nominee for **Director of National Security** before the Trump Administration could even take office. **The thoroughly corrupt "judge" Sullivan was merely following in the tradition of Andrey Vyshinsky, who conducted the infamous Moscow Show Trials of the early 1930s. Vyshinsky assumed the role of both judge and prosecutor, and is alleged to have told Stalin, "Show me the man and I will show you the crime."**

Later and immediately following the stolen November election, commissars in the NCPUSA proposed a "*Truth and Reconciliation Commission*" to punish Trump supporters for their *politically-incorrect* views and their anger over a stolen presidential election. These "*dissidents*" correctly recognized the 2020 election was reminiscent of fraudulent elections held in the former Soviet Bloc, Albania, Cuba, Venezuela and in every black, Marxist dictatorship in Africa. Later, the *kangaroo court* known as the *January 6 Committee* and the arrests that prompted it furthered the NCPUSA's Stalinist agenda. **Their inspiration for such an exercise were the old Soviet "show trials," fundamentally dishonest "legal proceedings" that Stalin used to rid himself of political opposition or dissidents.**

WEAPONIZING LAW ENFORCEMENT: The Flynn case and January 6 Committee were by no means the only "*show trials*" by NCPUSA communists who control the "*deep state*." Its majority in the House

enabled the NCPUSA to Impeach President Trump using demonstrably false and fabricated charges. They even repeated the exercise while Trump was in the process of leaving office. **This was reminiscent of Stalin sending a hit-squad of NKVD assassins to Mexico to murder Leon Trotsky, long after Trotsky had fled the Soviet Union and was no longer a threat.**

The NCPUSA has adopted a tactic that's unprecedented in American History: it has begun illegally and unconstitutionally using the FBI and Justice Department to wage war against its innocent political opposition using false charges to frame them. It first began during the Obama regime when a host of upper-level FBI and DOJ flunkies perjured themselves in front of four ***Foreign Intelligence Surveillance Courts*** using phony evidence to obtain warrants to spy on Trump and his advisors during his 2016 campaign. The FBI then executed arrest or search warrants against innocent Trump advisors like George Papadopoulos, Steve Bannon and Roger Stone to scare away potential Trump supporters or potential nominees to his administration. It has recently done the same against Trump loyalists such as Peter Navarro and Rudy Giuliani.

More recently, Attorney General Merrick Garland has dispatched the FBI to harass and investigate parents whom the Biden Administration deemed "*terrorists*" for exercising their First Amendment rights by speaking out at county school board meetings. Some criticized their local school boards for adopting the unabashedly Marxist *Critical Race Theory*, while others were incensed at elementary schools that engage in "*gender counseling*" of young kids -- without parental knowledge -- who are encouraged to consider the possibility they are "*transgenders*." **These were attempts by federal law enforcement to intimidate political opponents and dissident parents, just as Lenin and Stalin routinely dispatched the NKVD and its predecessors to terrorize political dissidents in the old Soviet Union.**

IMPUNITY OF NOMENKLATURA: Stalinists always establish a two-tier system of justice that grants leniency and impunity to political allies for their misdeeds, while imposing harsh penalties on ideological adversaries and political rivals. There is irrefutable evidence that Hunter Biden and the ***Biden Family Crime Syndicate*** sold "*the Big Guy's*" influence all around the globe and extorted weak nations like the Ukraine, Romania and Kazakhstan who receive U.S. aid. Likewise, Nancy Pelosi and her husband have made millions engaging in "*insider trading*" based on secret knowledge of impending laws and regulations.

Hillary Clinton -- a one-woman crime wave -- destroyed her ***Blackberry***, her private e-mail server and 33,000 incriminating e-mails with impunity, although they were all evidence that had been earlier subpoenaed by the FBI. The destroyed evidence would have revealed her own sale of influence all around the globe to fund the ***Clinton Family Crime Foundation*** while she was Obama's *Secretary of State*. Likewise, *Black Liars Murder* and the commies in *Antifa* have also escaped serious legal consequences in **BLUE** areas -- where they committed violent crimes and torched buildings and businesses -- because they are "*team-players*" in good standing with the NCPUSA. **Much like in the old Soviet Union, America's Nomenklatura has complete immunity from investigation or prosecution.**

CONTROLLED NEWS MEDIA: The NCPUSA and its allies in the Jews' Media are merely two left wings of the same enterprise: both are part of the movement in the West to promote international socialism. The NCPUSA is the political wing of the movement, while the Jews' Media and *social media* comprise the public relations wing. The latter "*spike*" all news that's damaging to the NCPUSA's elected officials, and lob softball questions to NCPUSA officials. It's also willing to lie for the NCPUSA with "*fake news*" whenever needed, or engage in a blitz of disinformation to drown out competing news reportage from honest

sources. In fact, there is an obvious "*revolving door*" between NCPUSA officials and the Jews' Media, because their objectives are identical.

In defense of its allies in the NCPUSA, the Jews' Media willfully "*spiked*" the five biggest news stories of the 21st Century. No matter how massive the evidence or how significant each story was, each of the five was ridiculed and dismissed as a "*conspiracy theory*" and then studiously ignored. In return, the Jews' Media and the cesspool known as "*social media*" receive protection from elected officials of the NCPUSA. Yet, to help obscure their role as co-conspirators, when evidence supporting those five stories slowly surfaced, the Jews' Media quietly altered old news stories they had published, lest their subscribers finally learn how dishonest and biased the Jews' Media truly is.

In the last six years, the Jews' Media intentionally spiked or ignored the following scandals: Hillary Clinton, a one-woman crime wave, illegally intercepted communications to and from the Trump Oval Office; Trump was framed with false charges concocted by NCPUSA loyalists at the DOJ, eventually leading to his wrongful, two-year investigation by these same crooked cops; Anthony Fauci -- head of the NIAID -- intentionally gave false and misleading advice to President Trump during a "*pandemic*" that precipitated a million unnecessary American deaths; The son of the current president jetted all over the globe shamelessly selling his father's influence, and in his own words, split his ill-gotten proceeds with his father; And, the NCPUSA employed massive voter fraud to steal the 2020 Presidential Election from Donald Trump.

Led by the ***NEW YORK TIMES***, the ***WASHINGTON POST***, the networks, PBS and most of cable news, America's Jews' Media has abandoned whatever pretense of "*journalism*" it may have once practiced. It has willfully and shamelessly adopted its new role of ***DISSEMINATING***

DISINFORMATION for the *New Communist Party of the USA*, wrongly called the "*Democrat*" Party.

In the old USSR, experience taught most citizens to reject the narratives disseminated by state-sponsored news organs loyal to the Soviet Communist Party, such as *TASS*, *PRAVDA* and *IZVESTIA*. The same phenomenon is transpiring here in the United States, and for very good reasons.
