

# America's Jewish *Putsch*

I used to scoff at the use of the acronym "**ZOG**" by some in the white nationalist movement, an abbreviation that stands for **Zionist Occupied Government**. It implies a conspiracy by traitorous and Marxist Jews to gradually seize control of the U.S. Federal Government and deliver America into the international socialist orbit. Over the last seven years, it's been patently obvious that this expression only hints at what's been transpiring.

Marxist and traitorous Jews have been planning their putsch for more than 100 years, or ever since Baron Ricard **Coudenhove-Kalergi** drafted its blueprints in his book, **Practical Idealism**. This book was similar to **The Protocols of the Elders of Zion**, and proposed subjugation and even genocide of the white race using non-white, mass immigration as its instrument. Jews, of course, would become the world's "*nobility*" after the destruction of the white race and demise of Western Civilization.

The first attempt at a putsch by commie Jews probably began during the Roosevelt Administration in the 1930s, when FDR became the world's largest employer of Soviet NKVD and GRU agents outside the USSR. Most were Jewish communists and CPUSA members, who spied for the Soviet Union and reported to either the NKVD or GRU. (Earl P. Holt III. Their infiltration of the federal government persisted into the Eisenhower Administration, when Wisconsin Senator Joe McCarthy's **Senate Permanent Subcommittee on Investigations** brought the activities of some to public attention.

**TARGETING THE TEA PARTY:** Their intended *putsch* became readily apparent when it was restarted in 2010, after a **JEWESS** at the IRS named

Lois **Lern☆r** perfunctorily denied tax-exempt status to conservative groups including the **Tea Party**. Between 2010 and 2013, Lerner visited the White House more than 30 times to get her marching orders from America's first communist president, while her immediate boss -- another **JEW** named Douglas **Shulm☆n** -- visited the White House 157 times. Conservative and Republican groups were organizing for the 2010 mid-terms, but Lerner at the *Exempt Organizations Unit* of the IRS repeatedly denied them tax-exempt status. Tax-exemption is routinely granted to any 501 (C) 3 or 4, but Lerner and her bosses made it their mission to handicap the activities of every fledgling conservative group.

**RUSSIA COLLUSION:** In 2016, **JEWISH** slanderers and their **Jews'** Media organs knowingly parroted false and libelous allegations that Donald Trump "*colluded*" with Russia to steal the 2016 presidential election. The charge has repeatedly proved to be a fabrication and the product of a conspiracy by Hillary Clinton's 2016 presidential campaign and a host of fellow co-conspirators such as Debby **Wasserm☆nn-Schultz**, Chairman of the DNC. The role of the Jews' Media was to create the illusion of "*confirming*" the contents of Hillary's bogus "*Steele Dossier*" by repeating its lies and making their stories appear to be "*validations*" by third-party sources. Its most salacious content -- that President Trump paid Russian prostitutes to urinate on a bed in which the Obamas had slept -- was ultimately exposed to be an off-color joke told over drinks at some bar.

Jeffery **G☆ldberg** of *The Atlantic*, Michael **Issik☆ff** of *Yahoo! News*, David **C☆rn** of *Mother Jones*, Miriam **Eld☆r** and Mark **Sch☆ofs** of *Buzzfeed*, and David **Ign☆tius** of the *Washington Post* all collaborated in its dissemination. Their contacts in the Clinton Campaign were: A **State Department** bagman of Hillary Clinton's named Jonathon **Win☆r**; An equally sleazy Clinton operative and bagman named Sidney **Blum☆nthal**; And Clinton lawyer Michael **Sussm☆n** at *Perkins-Coei*. All knowingly participated in what has turned out to be a treasonous criminal conspiracy to destroy a duly-elected president who has been

demonstrably and conclusively proved innocent of **EVERY** charge levelled against him.

**CROSSFIRE HURRICANE:** A **JEW** FBI Attorney named Kevin **Clinesmith** pled guilty in 2021 to *Special Counsel* John Durham's charge that he intentionally altered a document from the CIA in 2017. The document was an e-mail that tried to inform the FBI that Trump advisor Carter Page was a CIA source of information or "*asset*." Clinesmith reversed the content of the CIA's e-mail to make it appear that Page had no CIA connection. Clinesmith did this in order to renew warrants from the ***Foreign Intelligence Surveillance Court*** to spy on Carter Page and then entrap him. This permitted the treasonous and criminal conspiracy by Obama DOJ holdovers -- participating in "*Crossfire-Hurricane*" -- to continue perjuring themselves before the FISA Court to obtain warrants to wiretap Donald Trump. Their intent was to destroy Trump by entrapping his advisors like Page, and forcing them to give perjured testimony about Trump.

**MUELLER INVESTIGATION:** The fraudulent charge of "*Russia Collusion*" against Donald Trump precipitated a three-year investigation by many of the very same people in the DOJ and FBI who participated in fabricating the charges against Trump in the first place. Among these were Peter Strzok and his lover, Lisa Paige. The investigation was actually run -- and its report probably written -- by a rabid **JEW** who considered the investigation an opportunity to destroy Trump. Despite Robert Mueller's titular head as *Special Counsel*, the investigation was actually run by an FBI Agent named Andrew **Weissman**, who called the shots because Mueller had either become as senile as Joe Biden or as big a liar. (Mueller claimed in Congressional testimony that he'd never heard of the "*Steele Dossier*" or the firm ***Fusion GPS***, which is like the *Warren Commission* claiming never to have heard of Lee Harvey Oswald.) After \$40 Million spent giving Trump the legal equivalent of a public rectal exam, the

disappointed *Mueller Investigation* was reluctantly compelled to report that it **FOUND NOTHING**.

**GEORGE SOROS**: This vile communist **JEW**, George **Soros**, has spent tens of millions of dollars attempting to destroy America by funding *Black Liars Murder* and *Antifa* rioters in **BLUE** cities. He also lavishly funded the elections of about 80 traitorously corrupt and communist district attorneys in counties with large populations of dangerous and violent black criminals. The fruits of Soros' labors have been skyrocketing violent crime rates in nearly EVERY county where a Soros-funded DA is in office. These DAs refuse to prosecute a long list of crimes, and rarely request adequate bail even for dangerous and violent criminals. Like most Jew communists, the goal of Soros is to overwhelm our criminal justice system and create enough chaos that his ilk can seize power in a communist and Jewish *putsch*.

**FIRST IMPEACHMENT**: In 2019, a member of Trump's *National Security Council* -- a **JEW** named Alexander **Vindman** -- brought false allegations against President Trump by claiming that Trump "*extorted*" Ukrainian President Volodymyr Zelenskyy in a phone call soon after Zelenskyy's election. Vindman never anticipated that Trump might release a transcript of the call, so the unprecedented release of an unredacted transcript proved Vindman was a liar, and that Trump did nothing wrong and Zelenskyy agreed. Nevertheless, the momentum for Impeachment proceedings were already underway against Trump using this fraudulent charge as a pretense. Vindman was merely transferred elsewhere in the Washington "*swamp*," while two of the prosecutors in Trump's First Impeachment trial were Adam **Schiff** and Jerry **Nadler**, both traitorously leftist Jews.

Prior to 2020, Congressman Adam **Schiff** (D-Sodom) lied approximately 300 times in front of the Jews' Media's cameras and microphones, claiming that he had personally seen conclusive evidence "*proving*"

Trump engaged in *collusion* with Russia. No such evidence ever existed and this pathological liar knew he was lying, but he's still Chairman of the **House Select Intelligence Committee** and has never paid a price for his endless lies.

**ZUCKERB★RG'S TREACHERY:** This arrogant and self-righteous **JEWISH** traitor spent \$419 Million of his personal funds to illegally bribe local election officials in the so-called "*Democrat*" Party, and help them steal the 2020 election using massive voter fraud in swing states. **Zuckerb★rg** illegally funded access to county election offices by Soros-funded operatives, who then engaged in all kinds of corrupt and illegal election tactics. He also funded the placement of mass-mail ballot depositories in **BLUE** areas to facilitate the "*Democrat*" Party's practice of "*ballot-harvesting*" hundreds-of-millions of mass-mailed ballots. Zuckerberg's illegal money funded the theft of the 2020 Presidential Election by facilitating a variety of illegal practices by "*Democrats*" that helped perpetrate massive voter fraud in many *swing* states.

**SECOND IMPEACHMENT:** Donald Trump's second Impeachment -- that occurred as he was leaving office in 2021 -- was to ensure that Trump could never return to the presidency and avenge himself against the traitors and criminals who persecuted and falsely charged him with crimes during his first term. (By NO means a coincidence, it was similar to the way that Josef Stalin sent the NKVD to Mexico to murder Leon Trotsky, so Trotsky could never return to the USSR and challenge Stalin's leadership.) At least two of the prosecutors in Trump's second Impeachment were **JEWS**, Jamie **Rask★n** (D-Moscow,) and David **Cicill★ne** (D-Gomorrah.)

**JANUARY 6 COMMITTEE:** This American version of the *Moscow Show Trials* was formed for exactly the same reason as its earlier inspiration in 1930s Moscow. In both cases, their purpose was to destroy the democratic opposition of would-be totalitarians who relentlessly seek

power by persecuting and prosecuting their political opposition by making false and unsubstantiated charges against them. To ensure there was never even a veneer of fairness observed by the **January 6 Committee**, it was stacked with traitorous **JEW**s, whose lack of ethical standards clearly resemble those of Josef Stalin or his prosecutor, Andrey Vyshinsky. These include Adam **Schiff** (D-Sodom,) Jamie **Raskin** (D-Moscow,) Elaine **Lurita** (D-Zion,) and Zoe **Lofgren** (D-Hideous.)

**WEAPONIZING JUSTICE:** More recently, Biden's **JEW** Attorney General Merrick **Garland** adopted a tactic that's unprecedented in American History: he has begun illegally and unconstitutionally using the FBI and Justice Department to literally wage war against innocent members of his political opposition to frame them with false charges. Recently, AG Garland even ordered the FBI to execute an unprecedented search of Donald Trump's private home in a *fishing* expedition to find incriminating evidence for the **House January 6 Committee**. The search warrant was issued by another **JEW**, Federal Magistrate Bruce **Rinehart** almost certainly based on sketchy if not fraudulent "*evidence*." Garland has also dispatched the FBI to harass and investigate Trump loyalists like attorneys Rudi Giuliani and John East, and adviser Peter Navarro, who was wrongfully arrested in a public and humiliating manner to intimidate Trump's allies and supporters.

AG **Garland** has also targeted parents of public school students whom the Biden Administration deems "**domestic terrorists**" for exercising their First Amendment rights by speaking up at county school board meetings. Some criticized their local school boards for adopting the unabashedly Marxist *Critical Race Theory*, while others were incensed at elementary schools that engage in "*gender counseling*" of young kids, who are encouraged to consider becoming "*transgender*."

**CONCLUSION:** One irony of the Jewish orchestrated persecution of Donald Trump is that Trump's innocence has been conclusively

demonstrated each time a charge has been levelled against him. His affairs have been more thoroughly investigated and scrutinized than those of any human being in world history, yet no evidence of guilt has ever been established. Meanwhile, it was the very accusers of Trump, such as Hillary Clinton, who were revealed to have actually "*colluded*" with Russia in the ***Uranium One Deal***, and Joe Biden who actually extorted Zelenskyy's predecessor in the Ukraine and benefitted from election fraud in 2020.

**What these ironies indicate is that Trump's Jewish accusers routinely engage in what psychologists call "*PROJECTION*," where people with profound character flaws and moral defects assume that everyone else is equally corrupt as themselves. Ironically, each investigation of Trump by his Jew accusers has merely exposed their own corruption. They assumed their jaundiced perceptions of Trump gave them *carte blanche* to destroy him, but each time their efforts merely exposed THEIR OWN CORRUPTION AND DISHONESTY.**

These people should **NEVER** be trusted with the reins of power. This cabal of treasonous and Marxist Jews has engaged in an unrelenting assault upon law-abiding whites, Christians, Republicans and conservatives that probably began during the Roosevelt Administration, when their ancestors and ideological mentors spied for the Soviet Union and against America.

**Their *putsch* was revived in earnest during the administration of fellow-communist Barack Hussein Obama. More recently, during the Biden Administration it has marshalled its influence to assume permanent control of the reins of government in Washington. Their ultimate goal is to "*transition*" America into the international socialist orbit and "*One-World Government*," run by classy folks like themselves...**
