

Prediction !

Boston Children's Hospital recently ran an ad in which it appeared to crow about performing so-called "***gender transitioning surgery***" on a number of kids, some as young as three years old! So-called "*gender counseling*" and "*gender transitioning surgery*" are rapidly growing industries. Yet, few kids recognize that *gender transitioning* is not like changing your hair color.

A 12 year-old girl in Florida attempted suicide twice in two days following gender counseling by her school that enabled her transition to a "*male*" identity. Administrators attempted to hide the girl's decision from her parents, who only learned of this tragic situation after the girl's second suicide attempt.

This situation is similar to another case in Florida in which school officials encouraged a 13 year-old girl to pursue gender transitioning without parental notification. Her parents only learned what was transpiring when the girl mentioned offhandedly that the school had asked her which bathroom she preferred, which she thought was odd.

Both sets of parents have sued their school districts, and are being represented by the non-profit ***Child and Parental Rights Campaign***. Its President, Vernadette Broyles, introduced an astonishing degree of common-sense into this issue by stating that gender transitioning is ***"a serious mental health decision that school personnel are not qualified, not competent, and not authorized to make...parents must be involved in these important decisions."***

I'm gonna stick my neck out and make a few predictions on this subject: First, I predict that 10 to 15 years from now, some of those kids who were encouraged to undergo *gender transitioning surgery* -- but now have monumental regrets and profound psychological problems -- are going

to stalk, hunt down and murder school counselors who encouraged their life-altering surgeries. They may do the same to those physicians who performed the surgeries, as well.

I also suspect that the parents of young kids who underwent *gender transition surgery* -- especially parents who were misled or were never properly informed of the radical and irreversible nature of these surgeries -- will also attempt to murder those responsible. The father of that 12 year-old in Florida was seething with anger, and it does not appear the 12 year-old had even received any medical treatment.

An equally interesting phenomenon may be that *petit juries* and grand juries in many locales may decide to acquit or "hang" either transgendered individuals or their parents in murder trials for dispatching those who were responsible for encouraging gender transitioning surgeries on their naive and vulnerable children.

If a child of mine were given *gender transition surgery* without my knowledge, I would seriously contemplate ways to murder everyone

responsible, especially if the results turned out catastrophically. I suspect I'd feel the same even if the results had merely turned out poorly.

To quote one unidentified but insightful commentator, *"If you found an adult discussing sexual acts with your elementary school kid, you'd be justified in punching them out and calling the cops. When it occurs in your public school, you must not only shut up about it, you must pay the pedophile's salary."*
