

Suggested Immigration Reforms

President Trump initiated many bold and necessary reforms in the area of immigration, but they were summarily ended by the current illegal and treasonous occupant of the White House. Returning to Trump's immigration policies would be a good start in 2025, but there are many more solutions desperately needed to resolve the problem of 40 million (or more) illegal aliens residing in this country.

First, we need a **MORATORIUM ON ALL IMMIGRATION**. Let's have a real debate for once, and not continue to allow the Jews' Media, the RINO "*Donor Class*," K-Street immigration lobbyists and the traitors who call themselves "*Democrats*" to dictate our immigration policy. This would also force Congressional Republicans to reveal their true support for immigration "*reform*," just in case their constituents back home were interested.

The U.S. should immediately return to the policy of "**REMAIN IN MEXICO**" and complete Mr. **TRUMP'S BORDER WALL**. The latter should be financed with funds withheld from the *U.S. Foreign Aid Budget* -- originally earmarked for Latin American nations -- where the bulk of illegal immigration originates. This is a fairly logical use of pre-existing funds, and would send a message to Latin Nations that we don't intend to be a repository for the dregs of their society.

The Supreme Court should be petitioned under *Article 4, Section 4* of the Constitution to **REVERSE ITS DECISION IN U.S. v. ARIZONA**, which held that the federal government had sole authority to enforce U.S. immigration laws, even when it abdicates that responsibility. If we are not successful in reversing ***U.S. v. Arizona***, an effective long-term reform requires a Constitutional Amendment that **GRANTS TO EVERY STATE,**

CO-EXTENSIVE AND PARALLEL AUTHORITY TO ENFORCE EXISTING IMMIGRATION LAWS.

A federal statute or Constitutional Amendment should also include a provision granting the federal government and all 50 states the power of **"ASSET FORFEITURE"** over illegal immigrants, to encourage self-deportation to their nations of origin. The sums collected might fund each state's enforcement efforts without a tax increase. Depending on the costs of enforcement, some seized assets might be returned to their owners once they repatriate, creating a *"carrot"* to accompany the *"stick."*



Origins & Entrance Points

Hundreds of billions of dollars are annually transferred by illegals through **Western Union** -- and other companies making **wire transfers of cash** -- to families remaining in their nations of origin. Asset forfeiture

would allow authorities to seize and hold those funds until an illegal alien *sender* returned to his nation of origin. Return of those funds could be made contingent upon their cooperation with ***Immigration Control and Enforcement*** (ICE) officials.

BLUE "*sanctuary*" states such as CA, NY, IL, VT, CO, CN, MA, NJ, NM, OR, and WA would inevitably try to subvert the provisions of such an Amendment: Here, the federal government should routinely **WITHHOLD DISCRETIONARY FUNDING** from "*sanctuary*" states, cities and counties to cool their enthusiasm for harboring illegals. Their receipt of federal funds should be entirely dependent upon their cooperation with ICE.

Despite a predictable lack of cooperation by some **BLUE** states, the federal government would still retain the authority to enforce existing immigration laws, even where states refused to assist. Federal immigration authorities would quickly recognize which states were cooperative, and could more effectively **target their resources** by concentrating their efforts on state having large populations of illegals, and where state authorities refuse to cooperate.

Obviously, most illegals come here for **excessively generous benefits** such as free food, free healthcare, free schools, transfers of income and free cellphones. Those who illegally enter the U.S. should be prohibited from receiving ANY free benefits of any kind. Any immigration reform must include a provision to **DENY PUBLIC ASSISTANCE TO ILLEGALS**. We will never stop the flow of illegal immigrants until we do so.

Finally, serious reform efforts must permanently **DENY BIRTHRIGHT CITIZENSHIP TO "ANCHOR-BABIES,"** who are merely the litters dropped by illegal immigrants. We must also **END "CHAIN MIGRATION,"** which permits newly-legalized immigrants to bring their entire extended nuclear families here.

The late Nobel Laureate Milton Friedman warned us that you cannot simultaneously have both open borders and a welfare state. The 40 million illegal foreign nationals now residing in this country are testament to the clarity of his insight.

Unfortunately, illegal aliens tend to bring their problems with them, and their chronic failure to assimilate quickly creates "*barrios*" that are a glimpse at what awaits this country if "*open borders*" are not closed. 40 million illegal foreign nationals have the potential to eventually recreate here, the very slums they fled in their native lands.
