

Failing "Up"

One of the many fascinating characteristics of the ***New Communist Party of the USA*** (NCPUSA) -- laughingly called "*Democrats*" -- is that no matter how badly their officials fail when given the opportunity to govern, they are invariably promoted to higher office and given positions of greater authority and responsibility. Facetiously, they are said to "***fail up.***"

This phenomenon is probably attributable to the invincible ignorance of NCPUSA voters who watch "*filtered*" news if they bother to get any news at all. It may also be a tactic employed by the treasonous scum who control the NCPUSA, that attempt to obscure the failings of its members by promoting them to appointive office or some cushy sinecure. They declare "*victory*" and then retreat, much as Biden did in Afghanistan.

One recent example of this was former New York Mayor **Bill de Blasio**, whose eight years in office witnessed skyrocketing violent crime, ludicrous spending priorities, and the nation's most dramatic population decline experienced by a city. His tenure as mayor was an unmitigated disaster by any measure, but he's now a "*teaching fellow*" at **Harvard University**, where he can share his genius for governing with future members of America's *Nomenklatura*. The NCPUSA looks out for its own.

Another example is Treasury Secretary **Janet Yellin**, whose 17 years in the *Federal Reserve System* set the stage for our current bout of inflationary recession, or "*stagflation.*" As a member of the *Federal Reserve's Board of Governors* and its eventual Chairman, she participated in the Fed's purchase of \$13 Trillion worth of *Electronically-Traded Funds* (ETFs) to prop up the stock and bond markets during the Obama Regime. This was done to camouflage Obama's incompetence and artificially stimulate his moribund economy to make it appear vibrant.

For her partisan loyalty, Biden promoted her to *Treasury Secretary*, where she repeatedly declared that the inflation she helped generate during her earlier tenure at the Fed would be "*transitory*." She also endorsed Biden's ludicrous plan to "*spend our way out of inflation*" with the laughably-named ***Inflation Reduction Act of 2022***. In addition, she (and others) have attempted to redefine "*recession*" to hide its grim reality from the public.

The NCPUSA's Senate candidate in Pennsylvania is an equally vivid example of *failing up*. He is a Jewish Marxist named **John Fetterman**, and like Bernie Sanders, he never held a job until he was about 40 years old. Until he was 46, he was subsidized by his parents with what the press called an "*adult allowance*" totaling hundreds of thousands of dollars. Somehow he failed to pay state and federal income taxes 67 times on those *allowances*, but is now campaigning to raise everyone else's taxes!

The closest he's come to a job was being elected mayor of the disintegrating town of Braddock, Pennsylvania in his late 30s, where he served for 13 years at a cumulative salary of \$1,800. Braddock got what it paid for, because it continued its steady decline under Fetterman's stewardship. Somehow, he later became the *Lieutenant Governor of Pennsylvania* from 2019 until the present: in that position -- as head of the state's *Board of Pardons* -- he voted to release a number of dangerous animals from prison, and openly advocated emptying Pennsylvania's prison system until he was forced to "*walk it back*" during his campaign.

Like John Fetterman (above,) **Crazy Bernie Sanders** never had a job until he was 40. Like every socialist, he hates capitalism but he sure loves money! He was evicted from the commune he joined in his 30s because he didn't want to work, and sat around philosophizing all day. One of those issues he pontificated about was certainly the *nationalized health*

care system envisioned by Karl Marx, in which the federal government is the single-payer for health care in the U.S. However, when he had a heart-attack in 2016, he insisted on retaining private physicians and private hospitals for his care rather than be admitted to a public hospital.

As President of the now-defunct ***Burlington College*** in 2010, Crazy Bernie's wife committed bank fraud by exaggerating the school's pledged donations in order to secure a \$6.7 Million loan to purchase 33 acres of lakefront property for the school. That wasn't Crazy Bernie's fault, although there are some allegations that Crazy Bernie may have pressured the bank to make the loan, using his seat on the *Senate Finance Committee* to pressure the bank to look favorably upon the loan. The school went bankrupt because of the land purchase for which Mrs. Crazy Bernie exaggerated the assets of the school in her loan application.

At the moment, **Gavin Newsome** appears to be front-runner for the NCPUSA's 2024 nomination for president. This schmuck has done more to damage California than the 1989 San Francisco earthquake by signing terrible legislation, imposing oppressive taxes, and by exposing his own gross incompetence and hypocrisy. California leads the universe in homeless populations, high taxes, destructive laws, and it is doing

everything in its power to drive away businesses and tax-payers, while welcoming illegal aliens. For the first time in its history, California had a net loss of population in 2020 and the trend has accelerated in 2021 and 2022.

By that time, Jamie Gorelick had already been transferred to the **Federal National Mortgage Association** ("*Fannie Mae*,") to serve as its Vice Chairman, where she did her part to bring about the "*Sub-Prime Mortgage Crisis*" by falsifying financial records that failed to include \$9 Billion in losses. This legerdemain made Gorelick and other top

executives at *Fannie Mae* eligible for millions in bonuses in 1998. The sub-prime mortgage crisis cost American Taxpayers trillions of dollars to cover the foreclosures that resulted.

It's fair to say that everything **Hillary Clinton** has touched in her adult life has been defiled by corruption. As the *de facto* Attorney General from 1993 until January of 2001, she is the reason the FBI and Justice Department are now run by criminals and other traitorous garbage who are little better than the mobsters they arrest and prosecute.
