Our Mortal Enemies

America's "***political class***" has routinely betrayed America in its dealings with foreign enemies, repeatedly undermining our national security in the process. Not surprisingly, it has often managed to enrich itself while doing so. The Biden Administration's recent sale of one million barrels of crude oil from our ***Strategic Petroleum Reserve*** -- to a Chinese firm in which Hunter Biden has a financial interest -- is just one example in a long tradition of treachery.

Licking its chops at the prospect of a billion new consumers during the Clinton Administration, America's *political class* and its masters in the "*Donor Class*" aggressively lobbied for China's admission to the ***World Trade Organization*** (WTO) and the grant of *Most Favored Nation* (MFN) trading status to China. Soon flush with gains from investments in Chinese firms and U.S. firms doing business in China, our political class willfully turned a blind eye to China's corrupt trade practices and its flagrant violations of every agreement it made to enter the WTO and receive MFN. China's aggressive and threatening posture toward smaller Asian nations like Taiwan was also studiously ignored for decades.

We now find ourselves in a situation where our political class has irresponsibly encouraged the export of much of our manufacturing base to China. We are now glaringly dependent upon **Red China** to manufacture 90% of our antibiotics and other pharmaceuticals, 96% of all shipping containers, 80% of all Lithium batteries, and most of the solar panels, windmills and other "***green***" technological devices required for our ludicrous transition to "*soft*" energy. Meanwhile, our "*political class*" has done everything imaginable to project weakness to our Chinese, Russian and Iranian adversaries. They've studiously overlooked China's

aggressive and expansionist designs in southeast Asia, initially ignored Russia's buildup on Ukraine's eastern border, and are now intent on reviving the "*Iran Deal*." In doing so, our *political class* is merely carrying on its long tradition of betraying America's national security.

SALE OF HI TECHNOLOGY: In the late 1970s, the Carter Administration approved the sale of state-of-the-art **Bryant Centalign-B** precision ball-bearing grinders to the Soviet Union. These possessed tolerances of 26 ten-millionths of an inch (.0000026 inches) and were used by the USSR to improve the accuracy of the warheads on their *Inter-Continental Ballistic Missiles* (ICBMs) to the point that they became as accurate as our own. Prior to Carter, the Soviets had more ICBMs with more warheads, but America's warheads were far more accurate. This was no longer the case after the sale of the *Centalign-B* grinders to the Soviets, which shifted the "*balance of terror*" in favor of the USSR.



In 1996, Bill Clinton personally approved the sale of **Loral Space Corporation's** state-of-the-art **missile guidance system** to communist China. Because of its national security implications, *Slick Willy* had to overrule his own State Department, Defense Department and intelligence community to approve the sale, but it was worth it. Clinton's reward came in the form of a bribe from **Loral's** founder and Chairman, Bernard Schwartz, and it consisted of a \$6 Million contribution to the **Democrat National Committee** to assist in Clinton's 1996 reelection.

Likewise, under the Obama Administration, Hunter Biden and his business partners at **Rosemont Seneca Partners** received \$31 Million from communist China as a commission for investing \$1.5 Billion for them. In return for its generous employment of Hunter Biden's firm, communist China's government -- through its **Aviation Industry Corporation of China** -- was permitted to purchase Michigan's **Henniges Automotive**, a producer of **strategic technologies** that reduce engine vibrations to enhance their "stealth" features. Despite the fact that the sale involved "stealth" technology with military applications, it was brokered by **Rosemont Seneca Partners** and personally approved by Barack Hussein Obama.



CHINESE ESPIONAGE: After decades of **Red China** spying with impunity on America, the Trump Administration created the "**China Initiative**" in 2019 to engage in counter-espionage against China's legions of spies operating virtually unconstrained in America. Among China's targets are the *Pentagon*, academia, "*journalists*," and witless politicians like Eric Swalwell. China's spy networks consist of seasoned professionals who are assisted by 400,000 Chinese students studying in America, and the staff of its 100 *Confucius Institutes* also located here. All are expected to cooperate with China's spy networks if called upon. Their highest priorities are the blueprints for *state-of-the-art weapon systems*, and cutting-edge technological research at American universities.

Despite China's extensive penetration of American institutions, the Biden Administration cancelled the *China Initiative* in February of 2022. Its ludicrous explanation was that the program contributed to "*racial profiling*." The obvious truth is that Red China **OWNS** our thoroughly-compromised president, and has extorted endless concessions from him to avoid publicizing his role in Hunter Biden's international extortion racket, sometimes referred to as the ***Biden Family Crime Syndicate***.

SUBSIDIZING COMMUNISM: Our political class has frequently found lame excuses to bail out the failing economies of our communist enemies, such as the USSR and China. This was often alleged to be beneficial because it supposedly demonstrated our peaceful intentions to them, and was often couched in terms of making *capitalist* allies out of ideological enemies. In reality, U.S. loans and "*trade credits*" to the Soviet Union in the 1970s allowed the USSR to divert resources from its agricultural and consumer goods sectors, and then amass the largest and most aggressively expansionist military in world history.

Likewise, for three decades the rapid growth of China's economy was achieved primarily at the expense of U.S. national security and our own economic growth. China considers rapid growth to be an essential prerequisite for the military build-up it plans to challenge American

economic and military preeminence in coming decades. Hapless administrations and Congresses allowed China to join the *World Trade Organization* and also granted it *Most Favored Nation* trade status, but then turned a blind eye to China's annual theft of \$500 Billion worth of U.S. proprietary technologies. They also ignored China's recurring \$500 Billion trade surpluses with the U.S., resulting from its currency manipulation and its imposition of large tariffs on U.S. imports to China.

URANIUM ONE: Barack Hussein Obama turned a blind eye to corruption and treason in his administration, and probably helped orchestrate much of it himself. As Obama's Secretary of State, Hillary Clinton sold 20% of America's precious Uranium reserves to Russia -- in the so-called "***Uranium One Deal***" -- in return for tens of millions of dollars in bribes from Russian Oligarchs to the ***Clinton Family Crime Foundation***. That Uranium is no doubt found in some of those Russian nuclear weapons with which Vladimir Putin recently threatened America, to discourage us from aiding the beleaguered people of the Ukraine after Russia invaded and laid waste to that nation. No doubt much of the bribe money received by the ***Clinton Family Crime Foundation*** also ended up as "dark" contributions to the campaigns of Hillary Clinton and other so-called "*Democrats*."

WUHAN LAB: There should no longer be any doubt that the COVID-19 "*ChinaVirus*" was a product of "*gain-of-function*" research conducted at China's Level IV ***Wuhan Institute of Virology***. Most unbiased experts believe this, and even the head of the ***World Health Organization*** -- who owes his job to China -- has admitted this fact in private. What is equally clear is that this *gain-of-function* research at the *Wuhan Lab* become a critical component of the Chinese military's *virologic warfare program* that was partly funded by millions of dollars in grants from the U.S. Pentagon and Anthony Fauci's NAIAD during the Obama regime. COVID-19 killed at least eight million people, worldwide, and over one million Americans, but our political class has ignored this betrayal because of its

holdings in Chinese businesses and American firms doing business in China.



PANAMA CANAL: Likewise, Jimmy Carter and a "*Democrat*" Senate surrendered the ***Panama Canal Zone*** -- that America built -- to the nation of Panama in 1979. Arguably, the Canal Zone has greater strategic significance than any other geographic location in the Western Hemisphere, since two-thirds of all commercial shipping to or from the U.S. pass through its locks each day. China now effectively controls the Canal Zone after having made itself indispensable to Panama through its "*Belt and Road Initiative*" that funds and constructs infrastructure projects in strategic locations within *Third World* nations. The Canal Zone has become the potential strategic *flashpoint* that opponents of the *Panama Canal Treaty* had warned about in the late-1970s.

IRAN DEAL: When Obama entered into the "**Iran Deal**" in 2015, it effectively rewarded Iran for being the largest sponsor of international terrorism over many decades. It transferred to Iran more than \$150

Billion in frozen Iranian assets and included a "*gratuity*" in the form of \$2 Billion in U.S. currency. In return, the Obama regime received vague and unverifiable promises from Iran not to pursue its nuclear weapons program, but Iran took the money and continued *full speed ahead* developing nuclear weapons. Its true purpose was to grant America's first black, Moslem and communist President an illusory foreign policy "*success*" to justify his ludicrous receipt of the *Nobel Peace Prize*. The Iran Deal will continue to cost innocent lives and generate conflict in the Middle East for decades to come.

"WOKE" MILITARY: While China was feverishly building an enormous and powerful military, our political class has relentlessly pursued the creation of a "woke" military whose *Chairman of the Joints Chiefs* recently experienced a tearful and public epiphany over so-called "*White Privilege*." *Critical Race Theory* is now a standard topic of indoctrination among recruits in the basic training of every branch, where tolerance of queers, lesbians and transgenderism is demanded. As a result, this has helped to create a military that is politicized, weakened and humiliated, and one where every branch has experienced recruitment and enlistment rates far below their minimum quotas.

If Stalin, Lenin or China's Xi had dictated America's trade and national security policies for the last 50 years, they could not have done a better job of subverting America than the ***New Communist Party of the USA*** -- wrongly called the "*Democrat*" Party -- has done without their direct assistance. In fact, all they've had to do was sit back and gloat as the NCPUSA tirelessly worked to destroy the U.S., even without the direct participation of these mortal enemies.

Vladimir Lenin is alleged to have vowed that "***Capitalists will sell us the rope that we'll use to hang them.***" Although the Clintons, Obama, Biden and most "*Democrats*" are hardly "*capitalists*" -- they are really organized crime figures and Marxists -- they nevertheless ***DO*** love money and are easily bribable.
