## Philadelphia: "Sunset City"

(So-called "*sunset towns*" enacted ordinances that prohibited blacks after sunset. It was a tactic to reduce property crimes.)

The *Philadelphia City Council* recently approved a permanent 10 p.m. to six a.m. curfew for teenagers under 18. Now, all it needs is the mayor's signature. This ordinance is a modest response to the city's skyrocketing crime rates, a phenomenon denied by Philadelphia D.A. Larry Krasner, a George Soros-funded Jewish liar.

The city implemented a temporary teen curfew over the summer of 2022, but couched it in terms of "*keeping teens safe*" from escalating gun violence. That original curfew ended in September. City leaders now appear to have discarded the charade of protecting teens, and seem to acknowledge its true purpose as establishing a "*sunset city*" to control marauding nigra teens.



The *City of Brotherly Love* has dabbled with curfews for teens over several decades, but so-called "*experts*" claim they've been ineffective at reducing juvenile crime or crime victimization. (These are probably the

same "*experts*" who advocated *soft-on-crime* policies such as decriminalizing shop-lifting, ending cash bail for felons and granting felons early release from incarceration.)

While more youths were shot last summer than during any other summer on record, approximately 75 percent were shot **BEFORE or AFTER** the curfew, and only the 25 percent remainder were shot during curfew hours of 10 p.m. to six a.m.

Naturally, as black imbeciles always do, Philadelphia's *City Council* extracted any teeth from the new ordinance, rendering it hopelessly ineffective. For example, fines up to \$200 (first offense,) \$350 (second offense,) and \$500 (third offense) were eliminated from last summer's curfew ordinance.

Also, an exception was made for youths loitering on the stoop of their own residences or its sidewalks during curfew hours. (Can't imagine them getting into mischief doing that...)



Under the new curfew, police must return violators to their guardians: if guardians can't be located, then offenders must be escorted to a police station or admitted to one of Philadelphia's new *Community Evening Resource Centers*. (Despite skyrocketing violent crime, Philadelphia's

police force will now be tasked with playing chauffeur to teenage miscreants.)

A permanent curfew for teenagers is a small but necessary step in the direction of reducing crime. Many black teens receive no parental guidance, and sleep the day away only to later become "*nightcrawlers*." Since blacks are nearly synonymous with property crimes and violent crimes, restricting their access to victims each night is definitely a good start.

Who knows, the black tribal leaders currently destroying our largest BLUE cities may eventually be compelled to return to the "*Separate but Equal*" policies of *Plessy v. Ferguson*...
