

Vicious Cycle

Clearly, we give black political office-holders far too much credit for what little intellect they may actually possess. In particular, members of the ***Congressional Black Caucus*** seem to be even dumber than the average, an impression they reinforce with regularity.

For example, Sheila Jackson Lee (D-TX-18th) recently introduced an unconstitutional ***House Bill*** (H.R. 61) to criminalize whites who tell unpleasant truths about blacks, no matter how accurate their criticism. She defines any criticism of blacks to be a "***conspiracy to commit white supremacy,***" merely because nigras are often offended by the truth. Enforcement of the law would be triggered if the DOJ can contrive some connection between the offending words, and any black-on-white hate crime committed at a later date.

This novel legal theory has a very personal connection for me: the Jews' Media tried to destroy both the CofCC and myself in 2015 after Dylann Roof murdered all those innocent black churchgoers in Charleston. For three days I had every Jew, n*gger, communist and homo in the East Texas media on my front lawn because Dylann Roof credited the CofCC's website for his knowledge of black-on-white violent crime.
