

Ever Lower Standards

Phyllis Schlafly frequently argued that the staggeringly low standards of conduct among the left always inspires its enablers to **LOWER** the bar even further rather than raise it. That principle is on display in Maryland, where a very stupid niggress recently submitted a bill to exempt those under the age of 25 from being charged with felony murder. (***Maryland House Bill 1180.***)

Fraudulently labeling her bill ***The Youth Accountability and Safety Act***, Maryland House Delegate Charlotte Crutchfield's (D-MD House-19) bill would essentially legalize murder by Baltimore's nigs under 25, even though they are responsible for nearly 100 percent of all murders committed by her tribe in Baltimore. Her justification is that prior to the age of 25, criminals do not possess fully developed ***frontal lobes*** and cannot comprehend the consequences of their actions.



Evolved Frontal Lobes

For decades, neuro-scientists and physical anthropologists have consistently demonstrated that **MOST** blacks possess under-evolved *frontal lobes*, which probably explains their many failings beyond their near monopoly on violent crime. Ironically, while her sponsorship of HB 1180 would reduce the penalties for murderous nigra gang-bangers in Maryland, Charlotte Crutchfield is the same black imbecile who sponsored a "*hate crime*" bill in 2021 that would have **ENHANCED** civil and criminal penalties against whites who commit so-called *hate crimes* against non-whites.
