

## **Corrected** Reparations Calculations

Since the "*Democrats*" seem intent on giving blacks reparations for slavery, let's consider some logical methods to calculate that amount. Among its many proposals, the costs vary from \$16 Trillion down to \$1.5 Trillion. Knowing nigra race-hustlers as I do, most will insist on the most "*white man money*" possible, or the \$16 Trillion figure.

**I CAN LIVE WITH REPARATIONS TO BLACKS FOR SLAVERY, even though slavery was abolished 157 years ago, no living American black has ever been a slave or known one, and despite the fact that it will be funded by those who never owned slaves. I just want to make certain that we settle ALL accounts, and use what accountants call the system of "*double entry accounting*" to correctly calculate what is owed and to whom.**

For example, the late economist Walter Williams pointed out many years ago that in constant dollars, the modern U.S. welfare state has cost American taxpayers about \$1 Trillion per year since the mid-1960s. Since blacks dominate our "*urban welfare programs*" by taking advantage of more programs and staying on them longer -- particularly ***Medicaid, SNAP, AFDC and Section 8*** -- we should offset the proposed \$16 Trillion figure for reparations payments by half of the \$28.5 Trillion spent on *urban welfare* in the last 57 years. That leaves a balance of \$1.75 Trillion owed to blacks for reparations. **(\$16 Trillion in reparations less \$14.25 Trillion in welfare benefits going to blacks = \$1.75 Trillion balance owed by whites to blacks.)**

However, blacks are not merely synonymous with welfare, they are also synonymous with violent crime and property crimes. In addition to the construction and maintenance costs of the buildings used in our criminal justice system, there are also the salaries of all the law

enforcement officers, judges, court officials, prosecutors, probation officers, prison guards, prison officials and court-appointed attorneys needed to process criminals. These costs -- at both the state and federal level -- have been estimated at about \$500 Billion each year in the U.S.

But black domination of the FBI's *Uniform Crime Reports* isn't recent, it began in the mid-1960s. Thus, the total owed for black reparations should also be offset by 57 years of the criminal justice system's costs of **processing black criminals** from arrest through parole, an amount totaling \$14.25 Trillion. (57 years X 1/2 the \$500 Billion per year expense of administration.) Hence, blacks should also be assessed \$14.25 Trillion more in order to compensate whites and others for the administrative costs of their criminality and violence. **(\$1.75 Trillion in reparations owed to blacks (balance carried forward) less the \$14.25 Trillion for processing black criminals = \$12.50 Trillion owed by blacks to whites.)**

Yet, the cost of processing garbage through the criminal justice system is hardly the only cost associated with black criminality. There are the direct costs to victims of property crimes and the victims of violent crimes such as rape, robbery, murder and aggravated assault. 30 years ago an Australian newspaper reported that blacks in the U.S. had murdered 100,000 whites since the mid-1960s, a phenomenon that has only increased in frequency.

The Jews' Media studiously spike such reportage, but it's routinely covered in the new and more honest alternative news media. I don't know what the average judgement in a civil action for *Wrongful Death* brings these days, but let's just assume it's \$1 Million. Since blacks have probably also murdered an additional 100,000 whites since the earlier reportage, in that case blacks owe whites an additional \$200 Billion for the costs of their **white murder victims**, alone. **(\$1 Million per victim X 200,000 white victims = \$200 Billion. \$200 Billion +**

**\$12.50 Trillion (balance carried forward) = approximately \$12.7 Trillion owed by blacks to whites.)**

But this figure doesn't reflect the costs associated with **property crimes**, such as the value of stolen cars or the value of assets stolen during endless burglaries. It also doesn't reflect the costs associated with armed robbery, nor the medical costs incurred when recovering from black-on-white aggravated assaults or rapes.

In 2017, the *Government Accounting Office* made a serious attempt to estimate the **annual cost of crime** in the U.S., and concluded the total fell between \$3.41 Trillion and \$690 Billion. If we average these two figures we get an estimate of about \$2 Trillion for each year going back to the mid-1960s when black criminality really began to "*hit its stride.*" 57 years at 1/2 the \$2 Trillion annual cost per year totals \$57 Trillion that whites are additionally owed by blacks for property crimes and violent crimes other than murder since the mid-1960s. **(\$1 Trillion per year X 57 years = \$57 Trillion. \$57 Trillion + \$12.7 Trillion (balance carried forward) = \$69.7 Trillion owed by blacks to whites.)**

Finally, another cost of black crime is the enormous expense that's incurred in trying to prevent it. Security guards, video cameras, fences, locks, chains, bars, security systems, car alarms, life insurance, auto insurance, guns, ammo, and many other expenditures are expensive **security precautions** and a fact of life. Many years ago I saw an estimate that the U.S. spends about 10% of its *Gross Domestic Product* (GDP) on the cost of residential, commercial and government security.

Since the current U.S. GDP was about 25 Trillion per year prior to the Biden Administration, that means an annual expenditure of about half of this \$2.5 Trillion figure goes to preventing primarily black criminals from committing property crimes or violent crimes at our homes, businesses and government facilities. **(That's \$1.25 Trillion per year X**

**57 years = \$71.25 Trillion. \$71.25 Trillion + \$69.7 Trillion (balance carried forward) = \$141 Trillion total owed by blacks to whites.)**

Hence, before the federal government cuts any checks to blacks for slavery they've never experienced -- to be funded by those who never owned slaves -- it would be smart to offset the projected amount of reparations by the amount that blacks historically owe whites.

**According to my computations, that final figure would be \$16 Trillion owed by whites to blacks, less the \$157 Trillion owed by blacks to whites, for a net of \$141 Trillion, or \$141,000,000,000,000 they owe to whites !**
