

"First, Do No Harm"

Anthony Fauci was the architect, the general contractor, the promoter and the realtor who sold the *house-of-cards* known as the COVID-19 Vaccination. Thus, it should come as no surprise that nearly every statement uttered about the safety and efficacy of the COVID Vax was a bald-faced lie. *Big Pharma*, U.S. public health authorities, and the governments of both the USA and the U.K. lied like Clintons concerning the vax.

Thanks to *Judicial Watch* and its lawsuit under the *Freedom of Information Act*, we now know that immediately prior to FDA approval of *Pfizer's* vax, health officials in the U.K. and America agreed to enter into a **"mutual confidentiality agreement"** to hide the adverse effects of this new vaccine. In an exchange of e-mails, they even discussed specific **adverse reactions** which they agreed to hide from the public, proving they were well aware of its dangers.



In these e-mails, U.S. and U.K. health officials specifically discussed **"anaphylactoid reactions,"** the breakdown of skeletal muscles (*rhabdomyolysis*) in addition to its risk to **pregnant women**. It also revealed that *Pfizer* was well aware of the **declining effectiveness** of its vaccine by April of 2021, but didn't publicly acknowledged this fact until July of 2021.

Moreover, the Wall Street research firm **Phinance Technologies** recently published its 2022 **Vaccine Damage Report** that quantifies some of the human and economic costs of the vax. They report that the mass inoculation of 148 million full-time American workers **harmed** 26.6 million people, **disabled** another 1.36 million, and precipitated 300,000 **"excess" deaths**.

The report indicates that between 2019 and 2022, there was a 50% increase in **lost work-hours** and a 28% increase in **absentee rates** among the 26.6 million full-time employees who experienced either mild or moderate injuries after received the vax. Since 2021, they also discovered a 24.6 percent increase in **disabilities** among our civilian labor force (ages 16 to 64,) involving an estimated 1.36 million workers.

There was also an estimated 300,000 **"excess" deaths** in the years 2021 and 2022 (combined) among those vaxed, ages 25 to 64. This was a 23 percent increase above anticipated mortalities based on actuarial rates. The report adds that the financial cost of the vax to this nation was **\$150 Billion in lost economic activity**.

Some good news is that Texas Attorney General Greg Paxton intends to investigate whether **Pfizer, Moderna** and **Johnson & Johnson** engaged in **"gain-of-function"** research, and if they misrepresented the **safety and efficacy** of their vaccines. Although Congress earlier granted immunity to these pharmaceutical companies, those activities to be investigated would fall outside that immunity granted by Congress.

Paxton will be investigating whether these companies violated the **Texas Deceptive Trade Practices Act** by exaggerating the effectiveness of their vaccines, or by minimizing the likelihood of transmitting COVID-19 after receiving the vax. The investigation will also pursue any evidence of **manipulation of vaccine trial data** by these companies.
