

## **REAL Republicans**

Two Republican Congresswomen have introduced different resolutions to expunge the two fraudulent impeachments brought against former President Donald Trump. They are **Marjorie Taylor Greene** (R-GA-14th District) and **Elise Stefanik** (R-NY-21st District.)

Greene's resolution targets President Trump's **first impeachment** -- in late 2019 -- which was based on the false accusation that Trump extorted Ukrainian President Volodymyr Zelenskyy in a phone call. Trump asked Zelenskyy if he were pursuing an investigation of then-Vice President Joe Biden's **ACTUAL** extortion of Ukraine, one in which Biden threatened to withhold \$1 Billion in U.S. Aid unless Ukraine's Chief Prosecutor -- Victor Shokin -- were fired.

**The inspiration for Greene's resolution is an allegation made by a paid FBI informant that appears in an FBI document (FD 1023) recently uncovered by the *House Oversight Committee*. The informant claimed both Joe Biden and Hunter Biden received bribes totaling \$5 Million from the founder of *Burisma Holdings*, in return for a promise to reverse U.S. Foreign Policy towards Ukraine.**

As it unmistakably appears on videotape during a meeting of the ***Council on Foreign Relations*** (CFR) in January of 2018, Biden bragged about withholding one billion dollars in U.S. aid unless Ukraine's then-President, Petro Poroshenko, **FIRE**d Chief Prosecutor Viktor Shokin. When he was fired, Shokin was investigating millions of dollars in bribe money paid to the ***Biden Family Crime Syndicate*** by Ukraine's ***Burisma Holdings***, a natural gas company run by crooks very much like the Bidens. Joe Biden was actually crowing about his successful extortion of Ukraine's government to those globalists assembled at the CFR.

Congresswoman Greene's resolution states as follows:

**“Resolved, That the December 18, 2019, impeachment of President Donald John Trump is expunged, as if such Articles had never passed the full House of Representatives, as the facts and circumstances upon which such Articles were based did not meet the burden of proving the commission of ‘*high Crimes and Misdemeanors*,’ as set forth in section 4 of Article II of the Constitution.”**

Stefanik’s resolution targets Trump's **second impeachment**, which took place as he was leaving office. This time, the false charges brought against Trump -- almost exclusively by corrupt, commie Jews in the House -- asserted without any evidence whatsoever, that Trump had personally “*incited an insurrection*” on January 6th, 2021.

The events of January 6th -- a mostly peaceful protest against a stolen presidential election -- were willfully mischaracterized by commie Jews as an “***insurrection***.” However, in the speech he made that day to tens

of thousands of supporters, Trump specifically requested that supporters ***“march over to the Capitol building to peacefully and patriotically make your voices heard.”***

Fortunately, in 2023 Speaker Kevin McCarthy released 40,000 hours of the Capitol Building's video footage of January 6th to Tucker Carlson. That footage exposed the lies of the *January 6 Committee*, which claimed that Trump supporters had been violent and destructive. In addition to proving Trump supporters were mostly nonviolent, the videos also exposed the use of ***agents provocateurs*** by the FBI and other swamp creatures to incite violence.

Stefanik's resolution reads as follows:

***“Resolved, That the January 13, 2021, impeachment of President Donald John Trump is expunged, as if such Article had never passed the full House of Representatives, as the facts and circumstances upon which such Article was based met the burden of proving neither that President Trump committed ‘high Crimes and Misdemeanors,’ as set forth in section 4 of article II of the Constitution, nor that President Trump engaged in ‘insurrection or rebellion against the United States,’ such that he is forever precluded from ‘hold[ing] any office... under the United States’ pursuant to section 3 of the 14th Amendment to the Constitution.”***

Let's just hope that the ostensibly male colleagues of these two fearless women have as much in the way of b@lls as Congresswomen Greene and Stefanik have, and can gird their courage to enact these two resolutions. That has rarely been the case in the past 50 years, where puff pieces in the ***WASHINGTON POST*** and feathering one's nest have usually been the highest priority among Republicans, with the noteworthy exception of the *Freedom Caucus* in the House.
