

NOW You're Talking !

On June 28th, the Republican majority in Wisconsin's State House passed **Senate Resolution 3**, initiating the process to remove the state's *Administrator of Elections* from office for defying Wisconsin's election laws on multiple occasions. The Wisconsin Senate quickly followed by voting to hold hearings to remove Meagan Wolfe, the state's Elections Administrator.

Wisconsin is one of several "*swing*" states where massive voter fraud in statewide and national elections has produced the anomaly of "*Democrat*" control of most **statewide offices**, while **Republicans** simultaneously control both houses of Wisconsin's **legislature**.

As I argued in "*Anomalies or Fraud?*" in late 2022, "*Democrats*" find it easiest to steal elections for **national** and **statewide** offices. On the other hand, it would be a far more difficult task for "*Democrats*" to organize vote fraud schemes in enough state house and senate districts to "*flip*" its legislature. "*Democrat*" control of statewide offices through voter fraud, particularly the office of governor, enables them to perpetuate election fraud by appointing unscrupulous individuals to important positions, such as Meagan Wolfe to the office of *Administrator of Elections* in Wisconsin.

More specifically, it is easiest for "*Democrats*" to orchestrate statewide vote fraud schemes from within each swing state's **LARGEST CITY, especially those cities possessing large black populations. The fraudulent votes routinely generated in black areas enable "*Democrats*" to monopolize statewide offices because the volume of fraudulent returns from large cities overwhelm returns from the rest of the state. In Wisconsin, voter fraud originates in Milwaukee.**

Wisconsin has been plagued by massive voter fraud for years, but the problem became too obvious to ignore following the 2020 Presidential Election. Afterward, a well-respected and retired Wisconsin Supreme Court Justice was appointed ***Special Counsel*** to investigate allegations of vote fraud occurring in 2020. His Report exposed widespread election fraud on numerous fronts, including hundreds-of-thousands of fraudulent ballots harvested and then dumped in those ***ballot drop boxes*** conveniently supplied by Mark Zuckerberg.




Mules Dumping Ballots in the Dead of Night

Among other conclusions, Special Counsel Michael Gableman pointed out that Wisconsin mailed out more than two million unsolicited Absentee Ballots in 2020, of which 90 percent were returned. Moreover, in a legislative hearing, he accused one non-governmental agency of illegally using \$8.8 Million in Zuckerberg grants to "get-out-the-vote" in black areas, which violates state bribery laws. ("Get-out-the-vote" money often involves "walking around money.") He also courageously recommended that state lawmakers explore the possibility of "decertifying" the 2020 election.

Gableman's report prompted a conclusion by the **Wisconsin Supreme Court** on July 8th of 2022 that the 2020 national election results were illegitimate because state election laws had been ignored and violated. This decision followed an October of 2021 report by the state's *Legislative Audit Bureau* that documented multiple issues involving election integrity -- like the anomaly of **100 percent voter turnout** in some counties -- that clearly affected the outcome of the 2020 election.

Similarly, in March of 2022, Katherine Englebrecht's organization **True the Vote** estimated a minimum of 137,551 illegal ballots were cast in Wisconsin in the 2020 elections after being harvested and trafficked by "Democrat" mules.
