Nigs & Guns

America doesn't have a "gun-problem" as "Democrats" and other communists allege: we have a "n*ggers-with-guns problem." This fact was recently demonstrated by the American Medical Association in one of its publications, JAMA Network Open.

It took nearly 30 years -- from 1990 to 2020 -- for the U.S. homicide rate to increase 50 percent. Yet, it increased 26 percent in just the last three years after many **BLUE** cities foolishly adopted insane criminal justice "reforms."

To the astonishment of no one but George Soros-funded prosecutors in the "*Democrat*" Party, black males were the overwhelming majority of gun homicide victims in the years since 2019. From 2019 to 2021, the homicide rate for black males aged 20 to 24 increased 48 percent, from approximately 95 per 100,000 population to 141.



The study's senior author, Dr. Eric Fleegler of *Harvard Medical School* describes such increases as "*completely unprecedented*." He attributes the increase in gun deaths to the fact that "*There has been significant economic insecurity and instability with a lingering mental health crisis that has dramatically worsened over the past two years."*

A much better explanation for accelerating U.S. homicide rates is that urban areas dominated by *Africanus criminalis* and other imbeciles have enacted laws that actually *ENCOURAGE* violent crime. Many **BLUE** cities have eliminated cash bail, routinely grant early release from jail, fail to prosecute many violent crimes, and have adopted the insane policy of de-funding their municipal police. They are crazy to expect anything other than skyrocketing violent crime.

The study is based on data from the *Center for Disease Control* (CDC,) but the CDC often willfully misleads the public on the subject of firearms because it has been an outspoken critic of the *Second Amendment* for decades. Not surprisingly, the study fails to distinguish between murder and the lawful self-defense killing of an assailant by an innocent, but armed citizen. Just to skew the numbers even more, the CDC also threw in *suicide-by-firearms* in their data.

One earlier example of such slimy tactics used by the CDC was to lump together the tiny number of accidental fatal shootings of children by other children, with the endless murders of teenage gang-bangers by rival gang-bangers. This was done to inflate the incidence of accidental child shootings and make it appear as if such tragedies were skyrocketing. Yet, when gang-bangers gun each other down in the middle of the night on the mean streets of our BLUE cities, it can be called a lot of things, but "accidental" isn't one of them.

Exposing the true purpose of the study, gun control advocates quickly claimed the study demonstrates the need to enact stricter "gun removal"

measures," including what it terms "red flag" laws that confiscate the firearms of citizens that authorities allege are dangerous.



What this study really exposes is just how easy it is to obtain grants from the NIH or CDC if your subject matter involves leftist politics masquerading as "public health." Then, one is free to employ quack assumptions and dubious methodologies to assist other leftists in attacking their traditional targets, so-called "white privilege" and the Second Amendment.
