

Fauci's "*Swan Song*"

It's impossible to understand America's response to the COVID pandemic without considering the arrogance and narcissism of that *mad scientist*, Dr. Anthony Fauci. When the COVID virus first appeared, Fauci was 80 and well past retirement. His enthusiasm for appearing before any TV camera suggests he saw the COVID pandemic as an opportunity to establish a heroic legacy for himself -- before he retired -- by "*defeating*" the COVID virus and saving the world. He might even have fantasized about receiving a *Nobel Prize for Medicine*!

Whether or not Fauci intended the actual release of the COVID virus to effectuate his scheme may never be known with certainty. What is known is that Fauci had been illegally funding *gain-of-function* research at China's ***Wuhan Institute of Virology*** for years, and it's now indisputable that this was the source and epicenter of the COVID-19 pandemic that killed one million Americans and eight million people, worldwide. **Fauci's funding of the newly-engineered COVID virus -- and the opportunity it afforded him to become a hero -- seems too coincidental to ignore.**

Another coincidence that can't be ignored was Fauci's incestuous relationship with the pharmaceutical industry. In his book, ***The Real Anthony Fauci***, Robert F. Kennedy Junior (RFK) accuses Fauci of converting his *National Institute for Allergies and Infectious Diseases* (NIAID) into "*an incubator*" for pharmaceutical products. His NIAID sponsored and funded the messenger-RNA research being conducted at *Pfizer, Moderna* and other pharmaceutical companies in their quest for a COVID vax. Each had ten\$ of billion\$ of taxpayer dollar\$ thrown at them by Fauci: afterwards, the results of their clinical trials were rubber-stamped by panels consisting almost exclusively of those with vested interests in their approval. **THE NIAID THEN SPLIT THE PATENTS AND ROYALTIES FROM THESE VACCINES WITH THEIR DEVELOPERS.**

Not surprisingly, Fauci acted as though he had a **proprietary interest** in COVID vaccines, which is understandable in terms of the stream of royalties they generated from their worldwide sales, much of which accrued to the NIAID. U.S. taxpayers spent about \$30 billion to fund the research and marketing of *Pfizer's* COVID vax, which became the highest-selling drug on the planet and earned *Pfizer* about \$35 Billion in 2021. This explains Fauci's opposition to *Hydroxychloroquine Sulfate* (HCQ) and *Ivermectin*, two anti-viral drugs in great supply and already *on-the-shelf*, both of which had a long history of being effective and free of side-effects. Somehow, Congress was also persuaded to grant *Big Pharma* immunity from any harmful side-effects associated with their new vaccines.

Anthony Fauci's incestuous relationship with *big pharma* -- and vested financial interest in their vaccines -- was exposed when he arbitrarily sabotaged (HCQ) and *Ivermectin* as approved treatments for COVID. He convinced the *Food and Drug Administration* to revoke its earlier approval of both drugs, in favor of a new and expensive pharmaceutical called *Remdesivir*. This drew outrage from many physicians who found the existing drugs to be both safe and effective in treating COVID. Some

of them even denounced the FDA's baffling decision, claiming it led to hundreds of thousands of unnecessary American deaths because physicians abandoned both drugs from fear of malpractice suits from treating COVID patients with drugs that weren't FDA-approved.

This was **NOT** an accident or a coincidence: after being appointed Director of the *Office of AIDS Research* in 1988, Fauci engaged in **identical tactics** during the AIDS "*epidemic*" that he later engaged in with *Remdesivir* and the COVID vax. He sabotaged every alternative treatment or protocol that relied on cheap, effective and non-toxic drugs, while promoting **AZT**, a drug that is alleged to have killed 330,000 AIDS patients. As RFK put it in his book, "**He killed...any protocol that competed with his pharmaceutical enterprise** (and) **cheated terribly on the clinical trials.**" That is, despite its toxicity, Fauci successfully guided AZT through the regulatory process by giving huge numbers of blood transfusions to those receiving AZT, so they could survive the eight week trial despite being poisoned. Similarly, many COVID patients who later received *Remdesivir* also required regular blood transfusions due to its toxicity.

Fauci also blacklisted the critics of **Remdesivir** and prevented them from receiving NIH research grants, just as he had earlier done with the critics of **AZT**. Moreover, while Fauci was promoting AZT -- a toxic and expensive AIDS treatment -- many physicians were successfully treating their AIDS patients with "**repurposed**" anti-viral drugs that mitigated the symptoms of AIDS and kept them alive. This situation was uncannily like those physicians who successfully treated COVID patients with **HCQ** and **Ivermectin**, only to see the FDA revoke its earlier approval. **This seeming anomaly may be attributable to the fact that AZT cost \$5 dollars per dose to manufacture, but a yearly treatment regimen cost \$10,000.**

After 50 years at the NIAID, Fauci had established a system of incentives that alarmingly conflicted with the public health responsibilities to which

he was entrusted. RFK claims in his book that 68% of Fauci's \$437,000 per-year salary came from the Pentagon, making him the highest paid federal employee in the government. That's because the NIAID receives \$1.6 Billion per year in **bio-weapons research funding**, which accounted for two-thirds of Fauci's salary, the largest in the federal government and more than the president's salary. **RFK opines that Fauci felt compelled to fund gain-of-function research at the Wuhan Lab to maintain his exorbitant salary.**



Moreover, during his tenure as head of the NIAID, Fauci controlled the distribution of **\$930 Billion in research funding** to various universities, private research institutions, and the pharmaceutical industry. As he recently demonstrated with COVID -- and in the 1980s with AIDS -- he can be extremely arbitrary and capricious in censoring, de-credentialing, discrediting and shutting off the funding of his critics.

It's a very unpleasant thought to ponder, but it appears that the lives of one million Americans -- and many million more lives, worldwide -- were sacrificed so that Anthony Fauci could perform a heroic *swan song*

before he retired. HIS *REAL* LEGACY IS THAT HE IS NOW A POSTER-CHILD FOR TERM LIMITS FOR FEDERAL BUREAUCRATS.
