

Mad-Hatter's Housing Policy

Much like its earlier manifestation in the old Soviet Union, the ***New Communist Party of the USA*** (NCPUSA) -- often wrongly called the "*Democrat*" Party -- has waged a relentless war against America's middle class. In particular, it has repeatedly proposed and enacted policies intentionally designed to damage middle-class whites, a demographic it rightly considers its largest source of political opposition.

In the recent past, these NCPUSA policies consisted of the following: COVID "***lockdowns***" that killed many small businesses; **Open borders** that welcomed seven million illegal Third World parasites; An insane war against oil and gas that's precipitated higher **energy costs**; **Stand-down orders** to police in **BLUE** cities that invited BLM to burn down businesses with impunity; **Inflation** that has raised the cost of food and energy by nearly 20%; And ludicrous "***justice reforms***," that have generated skyrocketing increases in violent crime in all **BLUE** cities.

The NCPUSA has also conspired with social media to **cancel** their political opposition, its members have willfully exported our **manufacturing base** to communist China, and it has disenfranchised white voters by orchestrating massive **voter fraud** in **BLUE** cities. In addition, it has dispatched the FBI to **harass parents** who criticize local school boards for the Marxism and perversion in their kids' curriculum, and have worked relentlessly to **disarm** law-abiding citizens so they can't defend themselves.

The latest NCPUSA outrage is a policy to destroy white and stable suburban neighborhoods with what is euphemistically referred to as "*low-cost housing*." Its purpose is to disrupt white neighborhoods with an invasion by *Africanus criminalis*, in order to lower property values

and make suburban housing more affordable to blacks who have already destroyed *THEIR OWN* neighborhoods. It should be called the "*Mad-Hatter's Housing Policy*," because it constantly displaces whites from stable neighborhoods and compels them to relocate elsewhere in order to pave the way for the NCPUSA's most demanding constituency, *Africanus criminalis*.

To carry out its war against the white middle-class, the NCPUSA must first usurp local zoning laws and ordinances that prohibit construction of high-rise, low-income apartment buildings in single-family "*bedroom communities*." "*High-rise, low-income housing*" is a euphemism for **Section 8** and other "*HUD Housing*" to accommodate *Africanus criminalis*, whose rents are funded by the same white taxpayers the NCPUSA now wishes to displace. This was an agenda initiated in the 1990s during the Clinton Administration, when *HUD* Secretary Chris Cuomo began funding "*Scattered-Site Housing*" in stable white neighborhoods. It was also an agenda of the Obama Administration, which spent hundreds of billions of dollars doing the same thing.

The NCPUSA's intent is to replace white, single family communities with high-rise, low-income housing to destabilize them. Unfortunately, this policy found its way into Biden's ***Infrastructure Reconciliation Act*** enacted in November of 2021. It is also being promoted by state government in Connecticut, and by America's dumbest governor, Kathy Hochul of New York. The NCPUSA's enthusiasm for destabilizing white neighborhoods is a mindless repetition of disastrous federal housing programs from the 1950s through the 2010s, when the NCPUSA was in its earlier incarnation as the "*Democrat*" Party.

Within the reconciliation package is a provision called the "***HOME Act***," which would allow the department of *Housing and Urban Development* (HUD) to ignore local zoning regulations, and build low-income housing in stable, suburban neighborhoods. As often happens when the federal government intervenes, there's both a carrot and a stick involved: local governments which refuse to comply with HUD will be denied any future HUD funding. The ***HOME Act*** would also permit the ***Department of Transportation*** to freeze transportation grants to the states of non-compliant communities.

By attempting to destroy the middle-class, the NCPUSA seeks to impose a new socialist agenda on America, where everyone is equally poor and largely dependent upon scraps from the NCPUSA and its commissars. Meanwhile, the NCPUSA's political allies -- such as the plutocrats of social media -- are granted political favors and political protection in exchange for censoring all opposition to their agenda. The NCPUSA then does the bidding of the extremely wealthy, which obligingly funds them with billions in "*bundled*" campaign contributions, and lavish sinecures once they retire from public office.

The litany of "*ghetto*" behaviors that inevitably accompany low-income housing are all-too apparent in East St. Louis, Detroit, Washington, Philadelphia, Milwaukee, Chicago, Birmingham, Newark, Minneapolis, St. Louis, Atlanta, and every other predominately black city in America.

These behaviors include ubiquitous drug sales and usage, skyrocketing murder rates and endless violent crime, auto theft, a disintegrating housing stock, teenage gangs, and a declining tax base because most whites won't live around *Africanus criminalis*. It's just that simple.
