

The REAL Communist Threat (Part 1)

Readers may tire of me describing the misnamed "*Democrat*" Party as the ***New Communist Party of the USA*** (NCPUSA,) but it's no exaggeration and it's definitely ***NO JOKE!*** For 70 years, the NCPUSA has worked to subvert the intent of most common-sense principles found in the U.S. Constitution, the practical source of our most cherished liberties. They've worked feverishly to replace the *Bill of Rights* and many other of its provisions with tortured logic and phony "*interpretations*" designed to undermine it. They also routinely violate its provisions.

The NCPUSA has successfully wrought profound damage upon this document, exposing its animus for both the Constitution and the men who framed it. The NCPUSA's contempt stems from the limitations the Constitution imposes on their ability to effectively subvert and destroy the United States. Specifically, it obstructs their efforts to usher in a Zionist, socialist and Afro-Marxist "*New World Order,*" run by the same classy folks who brought you the *Bolshevik Revolution*. **The following article describes their subversion of the First and Second Amendments, and a subsequent article will detail their subversion of additional Amendments.**



FIRST AMENDMENT: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances

One early example of its agenda was the NCPUSA's substitution of the phony "doctrine" of the "Separation of Church and State" -- a phrase **NEVER APPEARING** in the Constitution -- for the true and original intent of the Framers in drafting the First Amendment's "**Establishment Clause.**" It escaped the leftist Warren Court, but as every undergraduate at *Hillsdale College* knows, the *Establishment Clause* was intended to prohibit the establishment of an official, state religion, while simultaneously endeavoring to **ENCOURAGE** religion in general. The Framers never dreamed that it might someday be used to purge religious observances from public life, as the NCPUSA has nearly done. The NCPUSA recognized decades ago that a well-informed, white and Christian nation would forcefully resist their Marxist agenda.

Regarding the "**free exercise**" clause of the First Amendment, an internal FBI memo was recently exposed that recommended targeting and surveilling what it called "*Traditional Catholics*," which the memo equated with "**potential domestic terrorists.**" As he's done many times before, FBI Director Chris Wray perjured himself in front of the *House Judiciary Committee* by claiming the memo was exclusively a product of the Richmond, VA, field office, and that he was appalled by it and quashed the idea. That was just another of Wray's many lies, because he knew at the time that similar memos were circulated by the Portland and Los Angeles field offices, as well. The FBI's mission has been so badly subverted by eight years of both the Clinton and Obama regimes, that it now considers *Pro-Life Catholics* to be *potential domestic terrorists*, and worthy of targeting and surveillance by federal law enforcement.

The NCPUSA's contempt for religious traditionalists pales in comparison to its contempt for the First Amendment's "*freedom of speech*" and "*freedom of the press*" clauses. In 2011, the NCPUSA became concerned during the Obama regime that internal leaks might expose the full extent of the NCPUSA's subversion of America, so corrupt FBI officials obtained search warrants to surveil dozens of professional journalists -- including James Rosen and other **Fox News** reporters -- to discover their sources. Its surveillance included "*taps*" on the phones that **Fox New** used in its White House, State Department and Pentagon reportage, in addition to Rosen's movements and conversations. Obama and his DOJ were so contemptuous of "*Freedom of the Press*" that they used the **Espionage Act** from World War One to jail dozens of journalists in an attempt to force them to divulge their sources. They used the **Espionage Act** more than all other presidents, combined.

Likewise, we now know from depositions taken from FBI agents acting on behalf of the NCPUSA that its officials routinely conspired with social media platforms like **Twitter** and **Facebook** to censor the "*free speech*" of **EVERYONE** posting comments harmful to Joe Biden's presidential

aspirations in 2020. These included posts concerning Hunter Biden's laptop, and those from anyone mentioning the ***Biden Family Crime Syndicate's*** sale of influence around the globe. After the 2020 election, the FBI continued to conspire to censor those critical of Biden's mandatory vax policies during COVID, and anyone skeptical of the 2020 election results. They also urged social media platforms to close the accounts of the NCPUSA's many critics.

Moreover, the arrest and imprisonment of January 6 demonstrators by the Biden regime exposes equal contempt for the First Amendment's "***peaceably assemble***" and "***redress of grievances***" clauses. Many of the January 6th demonstrators -- who never entered the Capitol Building nor misbehaved during their protest -- were arrested and held for months without formal charges, and many have had their trials delayed for years. Some were beaten by guards, many were subjected to vile conditions, and some had their access to legal counsel and religious materials obstructed by officials at the DC Jail. Clearly, these January 6th protestors are being punished by NCPUSA officials for attempting to exercise their First Amendment rights to "***peaceably assemble***" and to "***petition the government for a redress of grievances.***"



SECOND AMENDMENT: A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

The NCPUSA's **2020 Party Platform** endorsed universal background checks, proposed ending *on-line* sales of both guns and ammo, and proposed banning the manufacture or sale of so-called "*assault weapons*" and high capacity magazines. It also endorses state licensing requirements for firearm ownership, and "**red flag**" laws that allow the courts to seize firearms from those who are *suspected* of being dangerous. It further intends to hold gun manufacturers liable for the illegal misuse of their products, over which these manufacturers have no control after the point of sale. **These restrictions would convert a Constitutional Right into a privilege granted by governments at their whim.**

Accordingly, every prominent member of the NCPUSA who has run for public office in the past 30 years has vowed to subvert America's Second Amendment rights in one way or another. As a presidential candidate, in 2020, V.P. Kommie Harris vowed to do so by Executive Order, apparently too stupid to realize that a president cannot overturn a provision of the Constitution by *fiat*. (Kommie Harris is an attorney in the same sense that Al Sharpton is a clergyman, or Jeffrey Dahmer was a *gourmand*.) In 2020, Joe Biden, Beto O'Rourke and Pocahontas Warren vowed to disarm America by outlawing what they called "*assault weapons*," a term none of them could define. Meanwhile, **BLUE** cities run by black "*Democrats*" have the nation's highest rates of murder and car-jackings, accompanied by the nation's most restrictive gun laws. (*Go figure!*)

The **FIRST** and **SECOND AMENDMENTS** are merely the first two of ten original Amendments we call the *Bill of Rights*, and the NCPUSA's efforts to subvert them tell us all we really need to know about that party's intentions and commitment to the Rule of Law. Its real objection to the

Constitution is that it has too many provisions that militate against the adoption of a Marxist or socialist government, with the power to weaponize law enforcement and then erase any civil rights that are inconvenient to them. These Constitutional safeguards are anathema to every communist, socialist and other would-be tyrant or dictator.



Americans should be wary of traitors who seek to revise or subvert the genius of the Constitution, which has allowed America to endure for two and a half-centuries despite the relentless efforts of the NCPUSA over the past century following the Bolshevik Revolution. We should be extremely wary of those who would seek to transform America's Constitution into an instrument capable of reproducing the Soviet Gulag, Mao's "Cultural Revolution," Castro's firing squads, or the killing fields of Cambodia's Khmer Rouge.

The NCPUSA dismisses real-world examples of socialist genocide as mere "deviations" from Marxist Theory. This conveniently allows them to turn a blind eye to the 100 million innocent victims of Marxism in the 20th Century alone, as they continue their relentless pursuit of the powers denied them by the Constitution, the practical source of all our cherished liberties.
