

Anomalies or Fraud?

I've always been baffled by states with **Republican state legislatures** and "**Democrat**" **Governors**. There are six states that currently possess this seeming anomaly in 2023, and it's **NO** coincidence that all six -- Arizona, Kansas, Kentucky, Louisiana, North Carolina, and Wisconsin -- are considered potential "**swing states**." It's been theorized that voters in these states intentionally balance power between the two major parties by dividing state government: however, a far more likely explanation is systemic **VOTER FRAUD**.

It would be difficult for "**Democrats**" to organize vote fraud schemes in enough state house and state senate districts within **RED STATES** to reverse Republican majorities and give "**Democrats**" control of their state legislatures **AND** their governorships. For example, investigating voter fraud in counties with relatively small populations would be fairly simple to audit -- and fraud much easier to expose -- because of the fewer and more manageable vote counts there. In most **RED** counties, "**Democrats**" would probably have difficulty even finding election officials who would dare to engage in voter fraud.

On the other hand, it's a far simpler task to orchestrate statewide vote fraud schemes from within the **LARGEST CITY in each *swing state*, especially those possessing large black populations. This enables "**Democrats**" to occasionally *flip* critical statewide elections -- such as those for Governor, Attorney General, Secretary of State or U.S. Senator -- by generating a sufficient number of fraudulent votes to overwhelm the legitimate votes originating outside these large cities.**

This accounts for the seeming paradox of "**130% turnout**" often reported in places like Philadelphia. The term refers to the total of votes cast relative to the total number of eligible voters residing in each of Philadelphia's five counties.



Disgruntled Voter

Decades ago, so-called "Democrats" began to recognize that their inability to govern competently and their unrelenting drift toward international socialism alienated most decent, middle-class Americans. In the 1972 Presidential Election, Richard Nixon won every state except Massachusetts, and *The Gipper* won 93 states in the combined elections of 1980 and 1984. Rather than surrender a significant majority of **RED STATES** to unchallenged **Republican** control, "**Democrats**" deviously began to employ black voter fraud in their largest **BLUE** cities to salvage as many statewide offices and U.S. Senate seats as possible.

It was a "*no-brainer*" for "Democrats" to use blacks for their voter fraud schemes because most blacks will steal anything that isn't bolted down and doesn't require much effort. Moreover, many blacks find it easy to rationalize engaging in vote fraud after convincing themselves that they are victims of racism: thus, whatever their personal disappointments in life may be, all are attributed to slavery, or "*white privilege*," or "*systemic racism*" rather than to alcoholism, drugs, felony convictions, welfare-dependency, illegitimacy, or sleeping through 12 years of expensive, taxpayer-funded public schooling.

In more than 50 years of political activism, I'm **NOT** aware of a single incident of organized **Republican** voter fraud committed anywhere in the U.S. That's in stark contrast to the massive "*Democrat*" voter fraud exposed in Atlanta, Detroit, Milwaukee, Minneapolis, Philadelphia and Phoenix during the 2020 Presidential Election using mass-mailed and "*harvested*" ballots.



Election laws and the will of the majority of voters in some *swing states* were intentionally subverted by "*Democrat*" governors in 2020. It was an outrage that frustrated both the will of each affected state's majority and the authority of their state legislatures to establish honest elections.

The Jewish "*Democrat*" governor of Pennsylvania arbitrarily and capriciously subverted the state's election laws immediately prior to the 2020 Presidential Election. He paved the way for an estimated 275,000 fraudulent votes in a state that Biden supposedly "*won*" by less than 82,000 votes. (See the documentary *2000 Mules*.) The difference was massive vote fraud from mass-mailed ballots, phony same-day voter registration, likely illegal alien and deceased voters, fictitious registrations, and other varieties of voter fraud.

That's my theory for the seeming anomaly of **Republican**-controlled state legislatures and "*Democrat*" Governors.
