

# In the Footsteps of Stalin

Some well-meaning conservatives and white nationalists argue that we should abandon the term "*communist*" because it is "*antiquated*" and no longer relevant in the 21st Century. Ironically, communism is a greater threat to America now than it has ever been: the difference from earlier eras is that communism is now an **INTERNAL THREAT** masquerading in the guise of the so-called "*Democrat*" Party, along with its Jews' Media allies and the treasonous "*deep state*" they've created.

The hallmark of true freedom resides in the extent to which one's government will recognize and defend a society's civil liberties, and foremost among these is a legitimate and meaningful plebiscite. **The USSR, Cuba and the Eastern Bloc nations all sponsored "*elections*," but they were as fraudulent as the massive majorities their communist dictators predictably received.** It is no coincidence that America recently experienced its own stolen national Election in 2020, resulting from massive voter fraud carefully orchestrated by the ***New Communist Party of the USA*** (NCPUSA,) often wrongly called the "*Democrat*" Party.



Immediately following the stolen 2020 election, pathological liars in the Jews Media like Chris Hayes at MS-NBC, Bolsheviks like AOC (D-Puerto Rico) and Jewish swamp creatures like former Clinton Labor Secretary Robert Reich proposed a "**Truth and Reconciliation Commission**" to punish Trump supporters for their political views. More recently, that idea was resurrected in early October of 2023 by Hillary Clinton who proposed "**formal deprogramming**" of Trump supporters because she claims their loyalty to Trump resembles that of a cult. **Their inspiration for such an program was the old Soviet "Gulag," whose purpose was to ensure that dissidents "GOT THEIR MINDS RIGHT."**

A further glimpse into the NCPUSA's march toward Bolshevism was evident at the "**show-trial**" of General Michael Flynn. Despite conclusive proof that Flynn was innocent and framed by corrupt Obama holdovers, the n\*gger judge sitting on Flynn's four-year inquisition refused to dismiss his case **EVEN AFTER THE JUSTICE DEPARTMENT DROPPED ALL CHARGES AGAINST FLYNN**. In doing so, Judge Emmett Sullivan – a Bill Clinton appointee, of course – assumed the functions of both **PROSECUTOR AND JUDGE** by arbitrarily, illegally and unconstitutionally assuming both roles and then perpetuating Flynn's show trial for additional years.

The Flynn indictment was an effort by the NCPUSA to scare away potential reformers of the Washington "*cesspool*" by falsely charging them and attempting to coerce them into testifying against Trump. They clearly did this to *General Flynn*, using fabricated charges against him before the Trump Administration could even take office. More recently, the FBI has been exposed for targeting Trump supporters, in order to intimidate them and discourage their political activism. **Sullivan was merely following in the tradition of Soviet judge and prosecutor Andrey Vyshinsky, who conducted the infamous Moscow Show Trials of the early 1930s. These were Stalin's technique for eliminating political rivals, and apparently, Biden's as well.**

The Flynn case was by no means the only "*show trial*" by communists who control the "*deep state*." Its majority in the House enabled the NCPUSA to Impeach President Trump twice, using demonstrably false and **fabricated charges** both times. The second impeachment even took place while Trump was in the process of leaving office. **This was reminiscent of Stalin sending a hit-squad of NKVD assassins to Mexico to murder Stalin's Menshevik rival, Leon Trotsky, long after Trotsky had fled the Soviet Union and was no longer a serious threat to Stalin.**

The NCPUSA is also engaged in a war against America's middle-class, or what communists refer to as the hated "*bourgeoisie*." It should now be obvious that the real purpose behind prolonged COVID "*lockdowns*" of small businesses in New York, California, New Jersey, Michigan and other deep "**BLUE**" states was a broader strategy to **destroy the middle class** which built or owns those small businesses. Biden and his NCPUSA allies who control **BLUE** cities and states recognize that small business owners are their **GREATEST POLITICAL OPPOSITION**, since most tend to be conservative, libertarian, Republican, or are at the very least, independent-minded.

By using the pretext of the Wuhan Virus, politicians in the NCPUSA knowingly shuttered millions of businesses and **sabotaged the livelihoods** of their political opposition by bankrupting many of the businesses they've spent their adult lives building. **This is reminiscent of the way Stalin intentionally starved to death 10 million middle-class Ukrainian "Kulaks" in 1932 and 1933, who had the temerity to resist his "agricultural collectivization."** Stalin's commissars forcibly confiscated most of their agricultural output and left them to starve to death over the winter of 1932 -- 1933, which 10 million obligingly did.



By destroying small businesses, the NCPUSA sought to impose a new socialist agenda on America, one in which the middle-class is decimated and the impoverished masses that result are entirely dependent upon scraps from NCPUSA commissars. Meanwhile, its political allies -- such as the plutocrats of social media -- are granted legislative favors and immunity from liability, to reward their support in the form of massive campaign contributions to the NCPUSA, and their participation in censoring any conservative opposition. **In this sense, Twitter, Facebook, Instagram and Google have joined the Jews' Media to become part of an American "Nomenklatura."**

The NCPUSA's war against the "*Bourgeoisie*" is one reason why police in **BLUE** cities were told to "*stand down*" while rioters looted and burned small businesses to the ground. It is also why no rioters were ever charged with a felony for torching or looting someone's business. In fact, many prominent NCPUSA officials -- including now-Vice President Commie Harris -- established a **FUND TO POST BAIL** for those charged with violent felonies in several large cities. She needn't have bothered: few if any were ever charged or prosecuted.



Another example is the NCPUSA's **war against religion**, which began in the early 1960s with the leftist and traitorous Warren Court's "*re-interpretation*" of the First Amendment's *Establishment Clause*. They reversed its original intent and substituted the fraudulent notion that the Framers intended to establish an entirely secular society and promote *irreligion*. A more recent example was the NCPUSA's persecution of

religious services in many **BLUE** states during the COVID-19 scamdemic, by closing churches and places of worship, even as abortion clinics, liquor stores and marijuana shops were permitted to remain open.

With the exception of the phony "*lip service*" some give it -- such as Nancy Pelosi and Joe Biden -- most NCPUSA officials correctly recognize they must pursue an unrelenting war against religion. Their crusade against religion is based on the principle that religious faith cannot co-exist with Marxism, since Marxists reject the "*Natural Rights*" philosophy of the Framers of the Constitution. This is the belief that our basic rights are bestowed upon us by God, and not merely granted to us by the state. That's why religion was cruelly suppressed in the Eastern Bloc, Cuba, China and most communist regimes, and why the NCPUSA must suppress it here, as well. **Communists demand that their subjects pay homage to their central government because Karl Marx is a jealous god.**

George Orwell once stated that "*The most effective way to destroy people is to deny and obliterate their own understanding of their history.*" The culture war waged against America by the NCPUSA does NOT merely target Southern culture and its heroes, it targets every aspect of America's **political and cultural traditions** all the way back to its pre-colonial days. Even Washington's memory isn't safe from its commissars, nor is that of Abraham Lincoln or Christopher Columbus or any Framer of the Constitution. Like the Bolsheviks, the NCPUSA and its henchmen are intent on extinguishing America's historical and cultural traditions, root and branch.

**In this the NCPUSA has closely followed the Bolsheviks, who immediately set about destroying Russia's historical and cultural memory and "rewriting" history upon seizing power.** Thousands of Russian Orthodox Churches were burned to the ground or "*re-purposed*," and most educational and historical texts were "*revised*" by the Bolsheviks. Meanwhile, the only legal sources of news were state-sponsored organs of the *Communist Party* -- such as **TASS, PRAVDA** or

**IZVESTIA** -- which immediately set about brainwashing the Russian people while creating a *cult of personality* surrounding Josef Stalin.

**All would-be totalitarian communists find it essential to outlaw the private ownership of firearms -- lest THEY also become targets -- so Immediately after the Bolshevik Revolution, the private ownership of firearms was prohibited by the Communist Party of the Soviet Union.**

Likewise, one of the very highest priorities of the Biden Administration and the NCPUSA is to **disarm America** by whatever means are available, the Second Amendment notwithstanding. The NCPUSA hates firearms because they are just about the only deterrent still obstructing the NCPUSA's agenda to impose a one-world socialist state upon us, run by “enlightened” and “superior” folks like themselves. Biden has repeatedly floated a proposal to tax, register and ultimately confiscate what are ludicrously called “assault rifles.” The NCPUSA is also intent on holding firearms manufacturers liable for the criminal misuse of their products **AFTER** the point of sale. Every prominent NCPUSA office-holder has advocated the piecemeal repeal of the Second Amendment.



On January 6th of 2021, mostly well-intentioned Trump supporters walked into the **biggest sucker-punch in the history of American politics.** They were exercising their First Amendment Rights to peaceably assemble and petition the government for redress of grievances because they were indignant over the theft of the presidential election in

November of 2020. Unfortunately, Pelosi, Schumer and the NCPUSA were prepared for them, and set a devious trap into which these mostly law-abiding Trump supporters ventured with their eyes wide shut.

Nancy Pelosi and Chuck Schumer repeatedly rejected President Trump's offer to call up the National Guard to maintain order on January 6th because they had a very different objective in mind than maintaining order: they wanted to precipitate a riot they could exploit politically as an "*insurrection*" and blame Trump for instigating it. Their many *agents provocateurs* and Capitol Hill Police opened doors and welcomed demonstrators into the Capitol Building in order to trap them and create a phony "*insurrection*." The result is that two and one-half years later, hundreds of Trump supporters remain in the D.C. jail without charges and without legal representation, and many have been sentenced to 20 years in federal prison for participating in what the NCPUSA ludicrously claims was an "*insurrection*." Even House members have been denied access to them. **Their mistreatment is far worse than that accorded murderers and terrorists, and no doubt inspired by the old Soviet Gulag, where dissidents were sent "to get their minds right."**

It should be patently obvious that the many similarities between communism and what is mistakenly called the "*Democrat*" Party are not some sort of coincidence, and that to reject the term "*communist*" when characterizing the modern "*Democrat*" Party would be an egregious error. No better or more appropriate framework or template exists for analyzing the lies and traitorous activities of what is essentially, the ***New Communist Party of the USA***.

**Those who recommend that we discard the term "*communist*" should do a bit of soul-searching to examine just how much their opinion has been manipulated by the corrupt, state-controlled and compliant fake news media, who are the comrades and the PR firms of the NCPUSA. It**
