Proxy Voting & "Walking-Around Money"

Newt Gingrich and others have repeatedly pointed to the practice of early voting as an advantage that favors "*Democrats*" and disadvantages Republicans. They characterize this advantage in terms of Republican candidates being forced to play "*catch-up*" on election day in order to overcome massive "*Democrat*" vote totals from early voting.

Yet, there's a lot more going on in our elections than the presumptive advantage early voting gives "*Democrats*." It boils down to simple arithmetic: barring systemic fraud, Republican candidates win when they receive a majority of legitimate votes cast in an election, and even large, early "*Democrat*" vote totals *shouldn't* overcome a plurality of votes cast for Republican candidates on election day.

Thus, early voting is not, in itself, the cause of Republican defeats, it merely provides a greater **opportunity for systemic vote fraud**. The real advantage to "*Democrats*" from month-long voting is that it gives them a longer *window of opportunity* to get blacks and other trash to sell their votes or ballots to "*Democrat*" canvassers in return for "**walking around money**."

Some also point to contrasting approaches to elections taken by the two major parties, with "*Democrats*" focusing on the **mechanics of elections**, while Republicans focus more on "**messaging**" by GOP candidates. They insightfully point to the fact that President Joe Biden, Arizona Governor Katie Hobbs, and Pennsylvania Senator John Fetterman engaged in little

messaging, but each supposedly defeated a vastly superior and more energetic Republican opponent in their general elections.



Three Losers Who Supposedly "Won"

Month-long voting allows "*Democrats*" additional weeks to seek out registered voters who are too lazy, too drunk, too high, too unreliable, or those merely ambivalent about elections. That's why voter registration is so important to "*Democrats*," and why it receives year-long priority and funding. "*Democrat*" operatives "*harvest*" those ballots, and then **VOTE THEM**, just as the film "*2000 Mules*" exposed. **But first they have to REGISTER them.** In return, these marginal citizens receive some reward, such as a \$100 bill or its equivalent.



I first witnessed this phenomenon in our April, 1991 St. Louis City School Board election. Quislings in the 27 largest corporations in St. Louis contributed \$400,000 to our corrupt, black and Marxist opponents, allowing them to steal that critical election. This ended our anti-busing coalition and quickly sounded the death knell for St. Louis City as a viable urban center. After repeated attempts by the *Missouri Secretary of State* to obtain an accurate accounting of all that money spent by our opponents -- more than a year after the election -- \$170,000 of it was eventually designated "**walking around money.**"

Essentially, the campaign run by our opponents paid every drunken n*gger and homeless shit-bum \$50 apiece to vote. That may be why election officials began handing out those "**I VOTED**" stickers, so "*Democrat*" operatives would know to whom they should distribute all that **walking around money.** (By the way, most of those corporations that funded our opponents have since fled St. Louis City, and the St. Louis Public Schools are now well beyond hopeless.)



There's another variety of voter fraud that was used in our 1991 St. Louis School Board election, and it's probably still being used by "*Democrats*" in other **BLUE** cities to this day. That's the practice of "*Democrat*"

election officials in all-black wards and precincts **casting ballots** for voters who fail to appear at the polls on election day. Since *legitimate* GOP election officials in all-black areas are rarer than unicorns -- most are really black "*Democrats*" in disguise -- there are no safeguards on the conduct of election officials in those areas. This situation is an invitation for black "*Democrats*" to subvert our electoral system.

After our April of 1991 school board election, five black election officials in north St. Louis confessed under oath to the FBI that they had engaged in this practice of "*voting*" everyone in their ward who didn't show up on election day. Since former Missouri Senator Roy Blunt (R-Coward) was *Secretary of State* at the time -- and the cowardly George Bush Senior was president -- these crooked, black election officials experienced **NO PUNISHMENT** for their illegal conduct, except to be barred from serving as election officials in future elections.

If voter fraud had been engaged in by white Republicans, each would have been indicted under the *Voting Rights Act* of 1965, and faced \$10,000 in fines and served 3.5 years in federal prison *ON EACH COUNT*.



In contrast to the last four elections, if someone with ability were ever to assume the Chairmanship of the *Republican National Committee*, one essential task meriting a lot of attention and resources **SHOULD** be for Republican state parties to recruit **REAL** black Republicans to serve as election officials in all-black wards and precincts. This would be an effective means of uncovering black voter fraud at the polls.

If any of this sounds far-fetched, bear in mind the following: "Democrats" have weaponized the FBI and DOJ to terrorize innocent political opponents; they've conspired with social media to censor their critics on social media platforms; they've intentionally created an energy shortage to enrich their supporters and contributors in the "green energy" industry; they've welcomed 8,000,000 unvetted illegals into the U.S.; and they attempted a "coup" against President Trump using fabricated charges and perjured testimony given to a FISA Court.
