

Essential Election Reforms

America's elections are in desperate need of reform, and the 2020 Presidential Election is clear and irrefutable proof. The best solution is a federal statute requiring **UNIFORM STANDARDS** that apply to specific aspects of state elections. Any efforts toward reform **SHOULD** include the following:

EVERY voter in every state should be required to produce a PHOTO I.D. issued by a state or federal agency each time they vote. The phony claim that voters have a difficult time acquiring a photo I.D. is a lie used to obscure the massive voter fraud that occurs almost exclusively among illegal aliens, America's "*Stepford Children*," and black "*Democrats*." None seem to have much difficulty acquiring SNAP cards, Medicaid cards, or EBT cards, so that claim is really a *smoke-screen*.

The practice of **EARLY VOTING** should be prohibited in the days or weeks prior to election day. Every state should also be prohibited from accepting **LATE-ARRIVING BALLOTS** that appear after midnight of an election day, which can deviously extend "*election day*" for days or weeks afterward. Late arriving ballots offer too many opportunities for voter fraud, and always drag out the count beyond the day of an election, as recently occurred in many **BLUE** and "*swing*" states.

ABSENTEE BALLOTS should be permitted wherever they are genuinely needed, but they must be accompanied by a valid justification, a signature, proof of identification, and must be returned before election day. These should be opened and counted prior to election day and in front of representatives of both parties to avoid chicanery and overwhelming vote-counters on election day. **In Wisconsin, nearly 2.0 million voters supposedly voted with an Absentee Ballot during the 2020 national election, including 5,010 illegal aliens.**

The Wisconsin Legislature's investigation of the 2020 national election may have exposed Milwaukee's *Central Count* facility's practice of holding back the Absentee Vote count until all other returns are received. This allows "*Democrat*" officials to inflate the Absentee Vote count enough to achieve victory. The same investigation even uncovered an e-mail from the *Zuckerberg Group* thanking Wisconsin election officials for (paraphrase) "***knowing exactly how many ballots were needed at midnight before reporting the results.***"

BULK-MAILED BALLOTS should be prohibited by federal law, and severe penalties attached to their use. The same prohibition should apply to ***BALLOT DROP-BOXES***. These are invitations for massive voter fraud, because of the opportunity they create for "*ballot harvesting*" and "*proxy voting*" by unscrupulous individuals and those not qualified to vote. **An estimated 250,000 fraudulent Absentee Ballots were deposited in Wisconsin's 573 Zuckerberg-provided ballot drop-boxes during the 2020 Presidential Election that Biden supposedly won by 20,000 votes.**

Fourth, state legislatures should require that state and county election authorities **POST A BOND** to ensure that they do not engage in illegal activities. They should forfeit their bond as a penalty if they are convicted of engaging in voter fraud of any kind, or plead guilty to doing so.

Judicial Watch has exposed a great many counties where the number of registered voters exceed the voting age populations of that particular county. It is no coincidence that those counties are where most voter fraud occurs. Hence, counties in which Voter Rolls exceed a county's voting age population should automatically trigger **INVESTIGATIONS** by a newly-reorganized Justice Department.

The Wisconsin Legislature's investigation of its 2020 Presidential Election revealed that, statewide, its voter rolls total 7.5 million names. Among these are **3.9 million dubious voter registrations**, since Wisconsin has only 3.6 million residents that are of voting age.



Counties that persist in using tainted voter rolls should be given a reasonable period -- say, 60 or 90 days -- to **PURGE** ineligible names from their rolls, including illegal voters, duplicate voters, dead people and those who have moved elsewhere. If they fail to comply during such a "grace" period, election officials should be sued by the DOJ and

assessed crushing damages and penalties. If they persist, criminal indictments should be brought against those responsible.

Every state should require a voter's hand-written SIGNATURE after they show their photo ID and before they receive a ballot. A THUMB-PRINT would also be useful. Those electronic "*signature*" devices are a source of fraud, and can be set at such a low tolerance that even professional handwriting experts can't determine if a given signature is legitimately made by the voter in question. These electronic signature devices must be prohibited.

Finally, every state should be required to adopt "STAND-ALONE" vote tabulating systems, which read, tabulate and store numbered PAPER BALLOTS. This would eliminate the chicanery that probably took place with those *Dominion Voting System* devices and their use of "*Hammer*" and "*Scorecard*" software. It would also make any county or statewide recount or audit a relatively simple undertaking.

The *National Election* of November 3rd, 2020 has been called the most dishonest election in U.S. history. This is debatable, because the so-called "*Democrat*" Party has engaged in massive voter fraud for decades: the difference is that in the presidential election of 2020, they left a rich trail of evidence that has awakened most honest Americans to their criminal and treasonous electoral strategies.

Unfortunately for "*Democrats*," President Trump and his supporters are fighters rather than "*gracious losers*" in the long, Republican *tradition* of Nixon, McCain, Romney, and the Bush Family. In any event, the need for federal standards in national elections could not be more glaring.
