

## Land of Oz: "♪ Ding, Dong ♪"

**HERE'S THE BACK-STORY:** Being a "progressive" locale, in 2021 *Loudon County's School Board* (LCSB) adopted a policy that permitted "transgendered" male students to use restroom facilities normally reserved for biologically-female students in less *enlightened* areas. The

**Yet, on May 28th of 2021, a 15 year-old white girl at Loudon County's Stone Bridge High School was raped and sodomized in one of its girls' restrooms by a "transgendered" n\*gger. The rapist was a 15 year-old sociopath who often wore a dress to school to enable him to use the school's female restrooms.**

Strange things happen in areas governed by *enlightened "progressives,"* and Loudon County is no exception. At its meeting on June 22nd of 2021, the LCSB was busily engaged in lying to concerned parents about its "*transgender*" bathroom policy,

**CLAIMING THAT NO RECORD EXISTED OF ANY INCIDENTS THAT MIGHT DEMONSTRATE THE POLICY WAS A POOR IDEA.** This prompted the father of the first rape victim, Scott Smith, to angrily repudiate the LCSB's lies and attempt to tell parents in attendance the truth about the rape and sodomizing of his daughter, which had been carefully concealed by the LCSB and the Jews' Media.
