Promises, Promises!

For 50 years the **Republican National Committee** (RNC) has dangled "hot-button" issues in front of rank-and-file members to stir their blood and inspire them to donate to the party. A favorite tactic is a questionnaire asking recipients if they want the following reforms enacted? Then the RNC will list 20 or 25 hot-button issues along with some "suggested reforms" conservatives have promoted for decades.

Those hot-button issues have often included building a "border wall," ending race quotas, ending voter fraud, requiring "workfare" to replace welfare handouts, a Constitutional Amendment permitting a "Line-Item Veto," a Constitutional Amendment requiring a balanced-budget, and federal statutes permitting what is often called "school choice." These are routinely dangled before middle-class GOP contributors to inspire donations. Yet, rarely have any of those reforms been seriously considered -- much less enacted -- even when the GOP had majorities in both houses of Congress and a Republican in the White House.

For many decades, the RNC has been run by whores who see their primary allegiance being to the dilettantes and self-dealers in the Republican "donor class," the party's largest contributors. To appease its masters, the RNC frequently promotes RINO candidates for public office who, once elected, are quickly seduced by donor class money and then do its bidding, while simultaneously betraying their constituents. Serious people have begun to ask if the GOP donor class actually want a GOP majority after all, or are many REALLY just "Democrats" who fund RINOs they know will stifle significant reforms by the GOP's conservative base? By reelecting a mediocrity like Ronna McDaniel over the brilliant Harmeet Dhillon to chair the RNC in 2023, the donor class answered that question loudly and clearly. Campaign contributions by the *donor class* to RINOs act like a "*governor*" on a vehicle, a device that prevents it from gaining much momentum. Whatever their true motives may be, the *donor class* works aggressively behind the scenes to ensure that *MEN AND WOMEN OF COURAGE AND PRINCIPLE ARE NEVER PERMITTED TO LEAD THE REPUBLICAN PARTY.* That's why it favored Gerald Ford over Ronald Reagan in 1976 and George Bush Senior over Reagan in 1980. (Reagan's that guy who won the *Cold War* without firing a shot, while reducing inflation and unemployment simultaneously. He also created 22 million new jobs.)

That's also why it favored Jeb Bush or anyone else over Donald Trump in 2016: the dilettantes in the *donor class* are naturally suspicious of independently-minded men and women who possess enough honor and integrity that they can't be bought by the *donor class* or its lobbyists.

That's also why, in truly Machiavellian fashion, the *donor class* has repeatedly used its power and influence to ensure the GOP is usually led by mediocrities or traitors who muzzle our conservative enthusiasms and obstruct conservative reforms that **CAN** work, and should have been enacted decades ago. Examples would be Mitch McConnell as Senate Majority Leader, the uninspiring presidential campaigns of Mitt Romney and John McCain, and the elevation of a devious traitor like Paul Ryan to *Speaker of the House*. That's also why a *"Republican"* House majority forced out Newt Gingrich from the *Speakership* in 1999, only five years after he produced the first Republican Majority in the House since 1952, and then delivered three straight years with a balanced federal budget. (It's no coincidence that contributors to Nicki Haley's 2024 presidential primary campaign are mostly wealthy *"Democrats."*)

There are rarely any penalties imposed on RINOs for their betrayals, with the exception of their inevitable electoral defeat down the road. That's because the RNC -- and the Republican *donor class* that controls it -- have no qualms deceiving their own *rank-and-file* with empty promises at fundraising time. The primary interest of the GOP's *donor class* is to elect candidates for public office who will do their bidding. In particular, they are intent on electing individuals who won't interfere with our dangerous addiction to China trade, or with Biden's *open borders* immigration policies that have swamped America with Third World garbage.

As a result of this "house divided against itself," many who donate to Republican candidates frequently ask themselves, what's the point of supporting RINO candidates who vote with our mortal enemies on the big issues like open borders or China trade? The New Communist Party of the USA (NCPUSA) -- often mistakenly called "Democrats" -- are clearly intent on destroying America by "transitioning" it away from the stewardship of whites, Christians, Republicans, Libertarians and heterosexuals, and then handing over what's left to the international socialist orbit they euphemistically call the "New World Order."

Moreover, what's the point of electing RINO candidates who are easily bribed into doing the bidding of a corrupt and often treasonous *donor*

class, whose preferred candidates have helped the NCPUSA amass a \$34 Trillion *National Debt,* while studiously ignoring black voter fraud and running from *school choice* to replace our rotten public schools? This is why GOP majorities in Congress inevitably erode until the GOP once again becomes the minority party after only one or two election cycles. Most rank-and-file Republicans feel bitter and betrayed by many they send to Washington, and with very good reason.

For example, Chris Salcedo recently revealed on **NewsMax** that Senate Minority Leader Mitch McConnell (RINO-KY) has conspired with Majority Leader Chuck Schumer (D-Shylock) to concoct some kind of immigration "reform" legislation. Naturally, its true contents will be obscured with a benign-sounding name, so any RINOs gullible and corrupt enough to support it can claim to their constituents back home that they are "fighting illegal immigration and open borders." Pat Buchanan once quipped that "if "Democrats" proposed a bill to burndown the Capitol Building, "Republicans" would offer an alternative amendment to phase it in over three years." This proposal is a good example of Washington's "UniParty" in action.

The McConnel and Schumer "immigration reform legislation" reportedly does nothing to end Biden's open borders policy that has welcomed 10 million illegals into the U.S. in only three years. However, it **DOES** provide illegals with government-funded lawyers, eventually grants **Green Cards** to illegals, and also grants them government-issued I.D. cards so they can vote. That's the same Mitch McConnel who, years ago, denied funding for President Trump's border wall, forcing Trump to take funds from *Homeland Security*. McConnell was also a big supporter of "**The Dream Act**" some years back, a proposal to grant citizenship to the litters that illegal aliens previously dropped in the U.S. after illicitly sneaking across the border. McConnell is probably the biggest whore for the *donor class* in the U.S. Senate, and has gotten filthy rich from China trade. A similar betrayal was evident on November 13th of 2023, when **eight Republican House Members** voted with "*Democrats*" to protect *Homeland Security* Secretary Alejandro Mayorkas from impeachment by the House. Mayorkas is the primary architect and defender of America's "open borders" policy, which has welcomed at least 10 million unvetted illegal aliens into this country from approximately 150 nations since January of 2021. Yet, Mayorkas has routinely perjured himself before Congress and while under oath by declaring that the border is "*secure,*" which is a staggering lie on its face.

The stated rationale of those eight "*Republicans*" was that impeachment should follow committee hearings, but the **REAL** reason is because they received their marching orders from their *donor class* supporters, who want cheap labor at any cost and don't care who crosses the border to provide it. (If they don't have the courage to impeach **THIS GUY**, why did they even bother to run for Congress as "*Republicans*"?)

Similarly, the *January 6 Committee* in the House was conducted much the way Stalin's *Moscow Show Trials* were conducted in the 1930s: the

conclusions came first and the "evidence" came later, because it was really a device to eliminate the NCPUSA's Number One political rival, Donald Trump. In a uniquely unprecedented and arbitrary act in 2021, Speaker Nancy Pelosi (D-Gambino) capriciously rejected the designees from House Minority Leader Kevin McCarthy (R-CA,) to staff the committee, one of whom was current **Judiciary Committee** Chairman and tenacious battler, Jim Jordan (R-OH.) Pelosi accepted only two ostensible Republicans on the **January 6 Committee**, both of whom were Trump-haters, and one of whom was that donor class whore, **Liz Cheney** (Traitor-WY.)

The *January 6 Committee* intentionally misinterpreted Trump's words, carefully *cherry-picked* video evidence, and permitted no opportunity for rebuttals by Trump or his defenders at their hearings. Eventually, the NCPUSA found it necessary to destroy nearly **ALL** the committee's accumulated evidence and records when their corrupt tactics began to see the light of day. After voting with the NCPUSA to impeach Trump for a second time, LIz Cheney lost her 2022 *PRIMARY* reelection by 40 points, despite her incumbency and despite outspending her primary opponent 28 to one! Most of Liz Cheney's largest contributors came from the donor class of both major parties, and from Washington's sleazier lobbies.

One final example: on December 29th, the last business day of 2023, **Ohio Governor Mike DeWine** vetoed House Bill 68, which was designed to protect minor children from gender transition therapies. It also prohibited biological males from competing against biological females in athletic competitions. This bill was designated the **Saving Adolescents from Experimentation Act** (SAFE,) and was passed by majorities of 70 percent or more in both houses. Incredibly, DeWine vetoed this bill, proving he is not only a clueless moron, but a donor class whore, as well.

DeWine was probably given marching orders by lobbyists from whom he accepted campaign donations in the past, or from whom he expects to receive them in future campaigns. These probably include donations from hospitals that perform transgender surgeries, or from queers in the *Log Cabin Club*, (which *should* be renamed the *"Gay Bath House Club."*) I just hope he wasn't swayed by lobbyists from the *North American Man-Boy Love Association* (NAMBLA,) to veto the bill. Within a week he had scrambled to issue an *"emergency declaration"* rescinding much of his veto because of the furor it generated. Meanwhile, both houses of the Ohio Legislature are working on bills to over-ride DeWine's idiotic veto.

In summary, for many decades wealthy elites have misguided both U.S. domestic and foreign policy by manipulating Republican office-holders using their influence and financial resources as leverage. The GOP donor class has intentionally stifled conservative candidates and conservative reforms, and in the process, they have done grave harm to the Constitution, the GOP, and to the fabric of our political and cultural

institutions. It often appears as though they DON'T REALLY want the GOP to prevail, because that would lessen their influence over the insipid "UniParty" they have created and consider their hobby.

Bluntly stated, the *donor class* has made a hash out of just about every policy that bears its influence. However, the one thing our *donor class* has actually done well is to insulate itself from the ravages of its own failed policies. After all, the children of our *donor class* need never compete with immigrants for employment or academic opportunities where race quotas discriminate against whites and Asians. Likewise, our *donor class* will never need to enroll their kids in the squalid and dangerous cesspools we charitably call the U.S. public school system. Nor will they ever be forced to live near the squalid barrios and ghettos their open border immigration policies have generated here in the U.S.

More than anything, the election of Donald Trump in 2016 was a repudiation of the flawed 50-year treasonous *"leadership"* of our self-anointed *donor class*. That's why the Republican *donor class* has worked so diligently to defeat him and has even attempted to destroy him. In the process they have come very close to destroying the very soul of America under the guise of promoting their greedy, twisted, narrow and anti-democratic self-interests.

Many sincere Republicans often fail to vote in their state's primary elections, where their turnout is sometimes as low as 25 percent. However, it is in these primaries where real change can occur. Primary elections afford an opportunity for Republicans to reject RINOs and other traitors in favor of more conservative candidates, but by the time of the general election it's too late.

Republicans who pay attention to politics only a few times each year often aren't sufficiently familiar with the candidates in their state's primary election to recognize who their best choice is. However, the *donor class* has often made that an easy decision: **it's usually safe to**

vote against the candidate who is the most heavily-funded and runs the most TV ads, because that person will usually be the candidate supported by the *donor class*, not working class Americans.
