

Subverting Science

The subversion of America's institutions and cultural traditions by Marxists has advanced rapidly. Regrettably, their influence can be seen and felt in the arts, education, philanthropy and even sports. Cultural Marxism has also made great inroads into the U.S. financial system, the federal Jewdiciary, the "*Democrat*" Caucuses in the U.S. Congress, the Jews' Media, and what is laughingly called "*higher*" education.

Those who share the vile ideology of Marxism do not feel constrained by democratic principles, Rule of Law, Christian humility, *The Golden Rule*, objective truth, or the *Ten Commandments*. Most have abandoned the God of the *Old and New Testaments* for the new gods of Marx, Lenin and Saul Alinsky. They seek power and wealth, exclusively, so they were a natural "*fit*" for the "*Democrat*" Party, where the pursuit of power at any cost is its singular focus.

Incredibly, *Cultural Marxism's "long march through the institutions"* has even led to the **SUBVERSION OF SCIENCE in order to advance its ideology. Yet, since the *Enlightenment*, it has been science that allowed Western Man to objectively distinguish fact from superstition and truth from falsehood, and do so independently of prevailing belief systems. Harnessing the atom, revealing the mysteries of the DNA molecule, space travel and the digital revolution have been among its many blessings. Now, however, science is under assault by Cultural Marxists because it often exposes the flaws in Marxist dogmas.**

This rejection of scientific consensus may have first reared its ugly head when a Soviet "*geneticist*" named Trofim Lysenko claimed in the 1930s to have devised a technique allowing **ACQUIRED** traits to be transmitted **GENETICALLY** to subsequent generations. The notion that the physical characteristics of an organism could be altered by environmental forces,

and then transmitted genetically to subsequent generations, was a concept that had been rejected by modern science since the pioneering research of Gregor Mendel in the mid-19th Century.

Although no scientist could duplicate Lysenko's results -- an essential element of the scientific method -- his claims greatly impressed Josef Stalin and the Soviet leadership, to whom Lysenko's absurd claims were a perfect "*fit*" for their equally absurd Marxist Ideology. That is, if mankind could genetically transmit acquired characteristics, then socialists of the world needed only to arrange a "*proper*" environment in which to mold their subjects into the "***New Soviet Man.***" The Orwellian environment they envisioned was one defined by Marxist Theory.

Thus Lysenko was appointed by Stalin to head the powerful and influential ***Soviet Institute of Genetics.*** In doing so, Stalin replaced a dedicated scientist named Nikolai Vavilov, who had devoted his entire life to the task of increasing agricultural production in the USSR in order to feed his fellow citizens. Vavilov, like millions of others before and after, was sentenced to death and died in prison.

Predictably, Soviet agriculture soon began to lag ever further behind the West, with little or no innovation in the realm of hybridization or any other area of genetic research. Lysenko's pseudo-science made it inevitable that Soviet agricultural output would fail to feed its people despite the USSR possessing more arable land than any other nation. As experts in the West wryly observed in subsequent decades, Lysenko's directorship of the **Soviet Institute of Genetics** -- in combination with the Soviet Union's system of collectivized agriculture -- produced **"72 consecutive years of bad weather."**

CLIMATE ALARMISTS: Speaking of "bad weather," the most obvious current practitioners of this subversion of science are those who are most accurately referred to as "**climate alarmists.**" This should **NOT** come as a great surprise: when the *Soviet Bloc* began to fly apart like a molecule at critical mass in the early 1990s, communists the world over sought to camouflage themselves against possible retaliation by hiding within the "environmental movement." Essentially, **RED** became **GREEN**, but its agenda never changed.



The objective of *climate alarmists* is not to alert the world to changes in the Earth's surface temperatures, their agenda is entirely political. Their origin as the "**Global Warming**" movement was inspired by a modest increase of 0.7 degrees Fahrenheit in the Earth's *average, ambient surface temperature* between 1970 and 1998. Since then, sincere efforts to correct the scientific record on "*climate change*" have been reflexively attacked, censored, and de-funded, despite clear evidence that *climate alarmists* have profoundly exaggerated the threat from "global warming." And, more often than not, they have also intentionally misrepresented the data in pursuit of their political agenda.

For a number of years, climate alarmists and their allies in the corrupt leftist media regularly claimed that each succeeding year was the warmest on record and that every extreme and destructive weather event was somehow the result of "*global warming*." The solution they aggressively promote is to transition away from fossil fuels and substitute "*soft*" and allegedly "*sustainable*" green energy sources that have a lower "*carbon footprint*."



One tactic employed by *climate alarmists* has been to hype every **record high temperature** whenever and wherever they have occurred, in order to convince lawmakers and the public that the Earth really is warming to dangerous levels. However, the highest temperature ever recorded on Earth was 136 degrees Fahrenheit in Libya in 1922, and the highest recorded temperature in the U.S. was 134 degrees Fahrenheit in Death Valley, California in 1913. Likewise, the **most oppressive heat wave** ever recorded in the U.S. occurred in July of 1936, creating record high temperatures in half of all 48 U.S. states at that time. **Yet, fossil fuel emissions in 1936 were about four percent of today's fossil fuel emissions, and an even lower percentage in 1913 and 1922.**

Since that particular data is a matter of historical record (Cristopher Burt. *Extreme Weather*. W.W. Norton and Company, 2007,) the political agenda of climate alarmists was forced to transition from "**global warming**" to "**climate change**." Afterwards, extreme weather events of **ANY** kind have been routinely cited as evidence of the Earth's impending destruction caused by man-made carbon emissions.

Thus, America's **coldest year** ever recorded was 1899, when temperatures declined below zero degrees Fahrenheit in all 48 states: yet, fossil fuel emissions were significantly lower in 1899 than in 1936, a year associated with many record high temperatures. Conversely, the **coldest temperature** recorded on Earth was minus-129 degrees Fahrenheit in Vostok, Antarctica in 1983, when carbon emissions from fossil fuels dwarfed all previous years. Likewise, the coldest temperature ever recorded in the lower 48 U.S. states was in Embarrass, Minnesota in 1996, a year that climate alarmists typically associate with the very peak of their alleged warming trend. **Clearly, the notion that increased carbon emissions can produce EITHER excessively COLD or HOT weather events is not scientific, and isn't even conducive to testing. Therefore, this obsession with carbon emissions from fossil fuels can't**

realistically be considered the cause of their dubious claims of "*climate change*," whether generating warmer or colder temperatures.

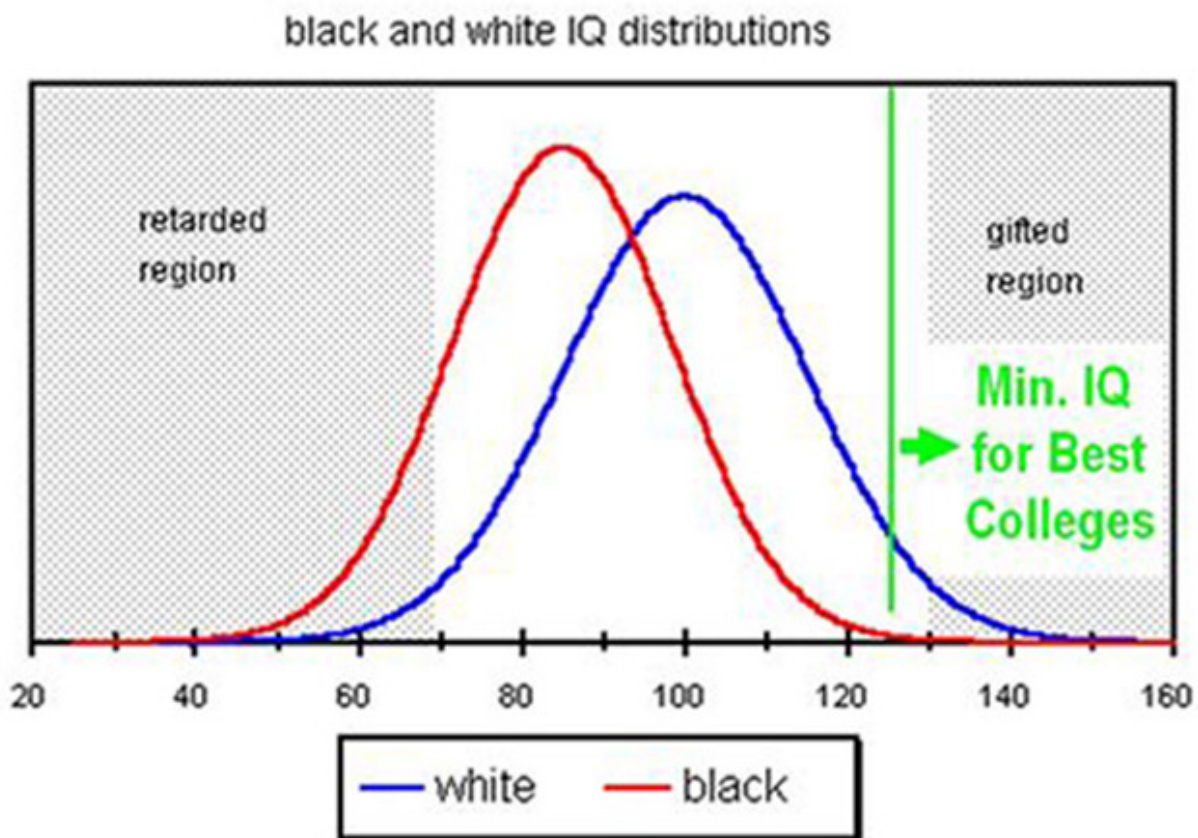
Climate alarmists have engaged in a very unethical **cherry-picking** of record high and record low temperatures in isolated locales in order to "*illustrate*" the existence of either *global warming* or *climate change*. Their agenda is not scientific and its ultimate purpose is to impose harsh controls on America and the West -- while curiously excluding their communist allies such as China -- to help transition the West into a socialist world government. That "*New World Order*" is to be run by Marxist technocrats, who would enjoy seeing America and the West bicycle back to the 19th Century while their commissars, like John Kerry, fly around the globe in private jets.



RACE & IQ: There is NO phenomenon in the social sciences that has been more thoroughly documented than the relationship between race and IQ, consistently demonstrating a 10 to 15 point average IQ disparity

favoring whites over blacks. There have been over 650 empirical studies proving this difference. (See Herrnstein & Murray. *The Bell Curve*.)

Despite truly mountainous evidence of this IQ disparity, Cultural Marxists aggressively "*spike*" this evidence to ensure that it is forbidden and never comes to the attention of the American public or its policy-makers. Not only is such evidence carefully censored, but anyone who dares to utter such a truth quickly becomes a pariah and the target of media "*feeding frenzies*" by Cultural Marxists and their useful idiots. It has become such *verboten* subject matter in either research or in conversation that Dr. James Watson, *Nobel Laureate* and co-discoverer of the molecular structure of DNA, was fired from his research and administrative positions at the *Cold Harbor Laboratory* in Virginia merely for offering his personal opinion on this immensely important subject in an interview.



The suppression of this profoundly critical fact has paved the way for the Pharisees of the Jews' Media, race-hustlers, the "*Democrat*" Party, and myriad charlatans in the field of education to automatically attribute ANY racial disparities in academic achievement or income to "*systemic race discrimination*" or "white privilege" rather than IQ differences. **They subvert science by assuming a false equality of outcome IN ADVANCE, and then censor all evidence disproving their assumptions. You can call that a lot of things, but it's NOT "science."**

Their failure to honestly acknowledge the true cause of racial disparities in academic achievement and income has paved the way for endless transfers of wealth and a litany of destructive and expensive "*remedies*" imposed on public education, housing patterns and employment decisions. In public education, these include a "*dumbed-down*" curricula, federal court-ordered *desegregation*, the charade known as *Common Core*, the *No Child Left Behind* law, a *Critical Race Theory* curriculum, and a variety of other fraudulent and destructive educational policies which have cost trillions of dollars, but failed miserably and even managed to aggravate the situation.

Their Marxist Ideology compels them to assume that the chronic failure of blacks to attain income levels, or levels of academic achievement commensurate with whites, must demonstrate *de facto* evidence of systemic race discrimination by whites. As usual, not only are whites wrongly defamed, but they must also bear the social and economic costs of remedying a situation for which they bear no responsibility, and one which is genetically determined and probably irremediable.

GENDER: Lenin is often credited with declaring that "*the first duty of the propagandist is to subvert the meaning of words.*" George Orwell illustrated Lenin's tactic in his books *1984* and *Animal Farm*, and Lenin's disciples often give themselves away by unabashedly following his

advice. Nowhere is this more obvious than the Marxist effort to redefine gender to accommodate their constituencies of transgenders, queers, perverts, bisexuals and cross-dressers. Cultural Marxists have deviously attempted to redefine what gender means and how it is ascertained.

Yet, for 6,000 years of recorded history, no civilization ever experienced difficulty distinguishing between men and women. The noted British legal scholar and jurist, William Blackstone, is often credited with the facetious remark that Britain's Parliament could do anything except make a woman a man. However, modern "*feminism*" has nearly succeeded in the reverse, and has done so with nothing more than its twisted and delusional propaganda.

Feminists -- ***The Ladies' Auxiliary of Marxism*** --are probably responsible for being the first to promote the laughable delusion that "***gender is a false construct.***" Although a Biden nominee to the Supreme Court doesn't know this, it's really a very simple task to objectively determine gender: biological males have an "X" and a "Y" chromosome in their cell nuclei, while women possess two "X" chromosomes.



It was this neurotic and delusional rejection of the very concept of "gender" by *feminists* that spawned the controversy involving biological males competing as "**transgenders**" against biological females in athletic competitions. In the fevered minds of feminists, if gender distinctions are an illusion, then there's no reason to separate athletic competitions between men and women, or retain those distinctions anywhere else. This outrage allowed unprincipled "*transgenders*" to steal awards and accolades from many young women who had trained much of their lives to compete in high school and college athletic events.

Cultural Marxists in the Biden Administration have also pandered to queers by aggressively promoting other varieties of "**transgenderism**," including the funding of "**gender counseling**" in public grade schools. Normal people recognize that *grade-schoolers* are too young and naive to appreciate the consequences of "*reassigning*" their gender, but many young children cannot resist the prompting of *gender counselors* with appallingly poor judgement. Meanwhile, unethical hospitals willing to perform **gender reassignment therapy and surgery** have sprung up all over the nation like mushrooms after a warm rain.

This has created a great deal of confusion and cognitive dissonance among those gullible enough to believe it. Moreover, many individuals who have undergone hormone therapy or surgical mutilation to "*reassign*" their genders have later experienced profound *buyer's remorse*, and feel their lives have been ruined as a result. Queers in the *North American Man-Boy Love Association* (NAMBLA) seem intent on creating more victims for homosexual pederasts, as well as patients for the psychiatric profession that their victims will require in later years.

Another novel idea promoted by our "*bettors*" within the centers of political and cultural power is that **homosexuals should receive all the protections and benefits of marriage**, and that these should include the **privilege to adopt and raise children**. This outrage has greatly undermined the institution of marriage, because now there are no

definable or legitimate limits as to what constitutes a legally recognizable "marriage." Moreover, it is highly unlikely that children raised by "two daddies" or "two mommies" are going to be well-adjusted.

Marxists have nothing but contempt for *REAL* science, and apply it only when they can misuse it. That's because Marxist ideology defines truth as anything that advances its agenda.

The Marxist subversion of scientific inquiry has harmful consequences for the integrity of science as well as for public policy. The lessons illustrated by the Soviet Union's experience with "*Lysenkoism*" should stand as a warning to scientists and policy-makers, alike. Policies based on falsehoods must inevitably fail, and with disastrous consequences.
