

# Urban Reform

Hopefully, we will again be governed by honorable, patriotic and competent leaders, and no longer at the mercy of the most corrupt, hapless and treasonous grifters this nation has ever witnessed. In Washington, the misnamed "*Democrat*" Party has subverted nearly everything it has touched, including our elections, our financial system, our "*justice system*," our public schools, the nation's energy policy, the fake news industry, foreign policy, and our national security.

The following are some **suggested reforms** that might make these BLUE cities once again inhabitable by *REAL* Americans, rather than just the violent criminals, welfare addicts and grifters who currently occupy them. When insolvency eventually looms, the federal government will be in a unique position to demand significant reforms in return for any financial bailouts. Here are some of my suggested reforms, which are by no means comprehensive:

First and foremost, *EVERY* city's elected officials shall immediately **resign** from office and be permanently **barred** from ever again running for or serving in public office. While their cities are preparing for both a primary and general election to replace these disgraced officials, each city's financial affairs shall be administered by a **three-person commission**, whose task will be to root out waste and corruption, while carrying out the *TRADITIONAL* functions of municipal government.

These commissions will be appointed by the President or his designee, in consultation with the Secretary of the Treasury. Each commission will consist of three members -- a competent and reputable attorney and two veteran CPAs -- each with lengthy **experience** in public finance, and each possessing the ability to effectively conduct the business affairs of their assigned city.

Most **BLUE** cities are run by corrupt black imbeciles who have been elected with the assistance of voter fraud. Voter fraud in each city can be greatly diminished if every voter is required to show a valid **photo ID** issued by either the state or federal government. This requirement shall be mandatory.

Moreover, each city shall use **ONLY paper ballots** that are read, counted, and securely stored by "*stand-alone*" vote tabulating devices. Voters must also be required to affix their **signature** as a precondition for voting, and those ridiculously insecure electronic signature devices

are prohibited. Such reforms would benefit the entire nation, not just those honest residents who may still reside there.



**Voting from the Grave**

**EVERY** monument, memorial or statue commemorating American heroes -- that has been removed or damaged in prior years -- must be **restored** to their previous condition and **reinstalled** in their original locations. This requirement includes memorials to the Heroes of the Confederacy, as well as those of national heroes like Cristopher Columbus. This condition pertains to all monuments, memorials, statues and flags of any kind that have been removed and discarded by far less worthy individuals since January 1st of 2015.

Likewise, any and all government buildings, parks and public school buildings shall be restored to the **original names** with which they were christened, and may not be changed again under any circumstances. No city will be eligible for financial assistance until it has completed and faithfully observed all these requirements to the satisfaction of that

city's three-person commission and the U.S. Treasury Department. Moreover, the resulting expense must be borne by each **BLUE** city from either its own tax revenues or private and voluntary donations.

Law enforcement in each **BLUE** city *MUST* receive an adequate level of funding, so their police **budgets** shall be restored to levels prevailing prior to the *Black Liars Murder* and *Antifa* riots of 2020. Thereafter, the law enforcement budget in each city must be **increased** each fiscal year by at least the previous year's *Consumer Price Index*, as determined by the *Department of Labor*.
