

# A Greater Threat Than China

George Orwell once insightfully remarked that *"We have now sunk to a depth at which restatement of the obvious is the first duty of intelligent men."* While the following may be patently obvious to normal people, it most assuredly is **NOT** obvious to those in the misnamed "Democrat" Party, or its accomplices in the Washington Cesspool and the fake news industry. What was once the "Democrat" Party has now become the **New Communist Party of the USA** (NCPUSA.)

Like Fani Willis in Fulton County, in a number of other venues the NCPUSA is currently **prosecuting many of its political rivals**, just as every previous communist regime has done. This is similar to Stalin's "**Moscow Show Trials**" of the 1930s, or the way black *banana republics* routinely do it. Prosecutors across the nation -- who have been funded by that communist Jew, George Soros -- have indicted Donald Trump on **91 charges**, each of which is demonstrably bogus. That's only because Donald Trump will probably be elected president in a landslide election come November of 2024, and this is the only way the NCPUSA believes it can avoid its own bloodbath, felt all the way *down-ballot* to dog-catchers and those who scrape dead animals off the road.

Likewise, the NCPUSA's **January 6 Committee** was a **kangaroo court**, consisting of two hand-picked "*Republicans*" who hate Trump, with the balance of the committee comprised of vicious Jewish liars and *House-n\*ggers* from the NCPUSA. The committee withheld **exculpatory evidence** and destroyed **exonerating evidence**, and behaved exactly as Andrey Vyshinsky did while serving Stalin's interests as judge and prosecutor during the **Moscow Show Trials** of the late 1930s. Not surprisingly, in the past the NCPUSA has often found lame excuses to bail out the failing economies of our **mortal enemies**, such as the USSR, China and Iran. This was often alleged to be beneficial, because it supposedly demonstrated our peaceful intentions. It was sometimes masked in terms of making *capitalist allies* out of ideological enemies.

Those trillions in U.S. loans and “*trade credits*” to the USSR in the 1970s were never repaid, but they **DID** allow the Soviets to divert resources from its agricultural sector, and then enable the USSR to build the largest and most aggressively **expansionist military** in modern history. Afghanistan was the first victim of the NCPUSA's misdirected trade policy in 1979, when the USSR invaded that nation and assassinated its central government before installing a “*puppet*” regime loyal to Moscow.

Similarly, in the 1970s under Jimmy Carter, the NCPUSA gave away the **Panama Canal**, the Western Hemisphere's most important strategic asset, which is now under China's dominion. Even worse, the Carter Administration sold the Soviets **Bryant Centalign-B Precision Ball-Bearing Grinders**, allowing that mortal enemy to dramatically upgrade the accuracy of their ICBMs aimed at America's largest cities. Later, in the 1990s under Clinton, the NCPUSA sold state-of-the-art **Loral Missile Guidance Systems** to Red China for *their* ICBMs and those of North Korea. More recently, Biden un-froze hundreds-of-billions in **Iranian oil revenues** so that rogue nation could continue to fund Islamic terrorism around the globe. And, while draining America's **Strategic Petroleum Reserve**, Biden also quietly sold millions of barrels to China.

For decades, Red China has spied with impunity on America by successfully penetrating academia, the fake news industry, and witless politicians like Eric Swalwell (Traitor-CA-14) and Senator Diane Feinstein (Senility-CA.) To counter-surveil China's legions of spies operating virtually unconstrained in America, the Trump Administration created the “**China Initiative**” in 2019. Not surprisingly, the Biden Administration cancelled the **China Initiative** in February of 2022, with the ludicrous explanation that it “*contributed to racial profiling.*” The obvious truth is that Red China **OWNS** our profoundly-compromised president, and has extorted endless **concessions** from him to avoid China exposing his family's international extortion racket, more accurately referred to as the **Biden Family Crime Syndicate**.

Moreover, while China has feverishly built an enormous and powerful military, the NCPUSA has aggressively pursued the creation of a **"woke" and insipid military**. One symptom of this was evident when Biden's former *Chairman of the Joints Chiefs of Staff* experienced a tearful and public epiphany over so-called "*White Privilege*." *Critical Race Theory* is now a standard indoctrination technique among recruits in the basic training of every branch, where tolerance for queers, lesbians and transgenders is demanded. As a result, the Biden Administration has created a military that is **politicized, weakened and humiliated**, and one where every branch has experienced severe recruitment and retention rates well below their minimum requirements.
