

Decentralization & America's Future

The American Electorate's awakening to the true agenda of the **New Communist Party of the USA** (NCPUSA) -- laughingly called "*Democrats*" by those blind to irony -- may herald what Lincoln termed "*a new birth of freedom*" in America. Cultivating and preserving those freedoms will require a great many reforms, among the most important of which may be the **DECENTRALIZATION** of policy-making, an approach more compatible with federalism and the Ninth and Tenth Amendments.

One significant form of decentralization is already abounding: it is the American electorate's growing reliance upon **alternative news sources** and opinion, rather than traditional sources found within the fake news media's oligopoly. (*You are participating in this trend right now.*) In addition to often being more accurate and honest in their reportage than the fake news media, these "*decentralized*" and non-traditional sources of news do not "*filter*" their reportage, as fake news does.

Here's another example: when the bright and fearless Christina Bobb covered the Arizona Senate's audit of Maricopa County's 2020 election returns for **One America News**, she pointed out the critical importance of **tabulating election returns** at the **LOCAL LEVEL**. The current practice is to transport ballots from surrounding Wards, Precincts and counties to a **central tabulating facility**, where the NCPUSA's voter fraud machines are already staffed with experienced operatives. This clearly facilitates the NCPUSA's primary electoral strategy of voter fraud, as Detroit, Minneapolis, Milwaukee, Atlanta, Philadelphia and Maricopa County amply demonstrated in 2020. The vote fraud originating in these areas was sufficient to steal the presidency from Donald Trump. Decentralization through vote-tabulating at the local level would greatly hinder almost any vote fraud scheme.



One of many benefits resulting from decentralized ballot tabulation is that it would greatly complicate the NCPUSA's efforts to engage in *large-scale* vote fraud by isolating that fraud and effectively "*quarantining*" it at its points of origin. This reform would also make it much easier to investigate and audit evidence and allegations of voter fraud, if ballots remain at the smaller and more easily manageable Ward or Precinct level. **It would circumvent the formidable task of auditing the immense number of ballots that accumulate at a *central tabulating facility*.** (The audit in Maricopa County involved over 2 million votes and took two months to complete.)

Another obvious example of the need for decentralization is evident in the area of **public school curricula** and policy. Remote learning during COVID forced parents to recognize that most public school systems are more interested in indoctrinating their kids with Marxist ideology than in educating them. Many school systems have mindlessly adopted the **perverse curricula** cooked up by NCPUSA charlatans at the **U.S. Department of Education** (DOE.) These traitorous ideas include *Critical*

Race Theory, gender identity counseling, No Child Left Behind, white skin privilege, and ethno-math with no wrong answers. Such ridiculous and subversive theories and practices are then adopted by traitorous teachers' unions -- such as the misnamed **National Education Association**, and the equally despicable **American Federation of Teachers** -- which are intent upon handing over a dumbed-down and ignorant America into the international socialist orbit.

The DOE permits far too much centralization of education policy and curricula from Washington, a situation affording those with sinister motives a much greater opportunity to substitute radical indoctrination for education. Since the DOE is primarily concerned with brain-washing students with Marxist Theory -- and far less concerned with traditional subject matter -- a High School diploma today has become the equivalent of a Grade School diploma prior to 1970. Hence, we as a nation are routinely humiliated with results from the **Program for International Student Assessment** (PISA.) In its most recent 2023 results, the U.S. placed 34th in Mathematics and 16th in Science. Yet, parents who criticize local school boards have found themselves targeted by the FBI

and labeled "*domestic terrorists*" at the request of the ***National School Boards Association*** and the misnamed DOE. The quality of U.S. education would be dramatically improved by chloroforming the DOE, and decentralizing education policy by returning that authority to individual states and local school boards.

Our uniform and *centralized* approach to **public health policy** has been equally disastrous, as the U.S. response to the COVID-19 *scamdemic* amply demonstrated. Uniform policies imposed by Washington, DC bureaucrats at the ***National Institutes of Health*** (NIH) were easily hijacked and misused by corrupt and devious politicians. This public health "*emergency*" created an opportunity for "*Democrat*" officials in **BLUE** counties and states to **seize power** through *lockdowns*. It also created the rationale for them to engage in systemic voter fraud by mass-mailing ballots to every registered voter, former resident, fictitious voter, illegal alien, deceased voter, cat and dog in their state. Biden's vaccine mandate became a prerequisite for traveling by commercial airliner, or for keeping one's job in the military or in many public sector jobs. It was the centralization of public health authority by the NIH that made their power grabs possible.



Asleep at the Switch

A monolithic and centralized public health policy enables powerful lobbyists to **unduly influence** public health officials, such as *Big Pharma's* incestuous relationship with Anthony Fauci at the NIAID. It was Fauci who rejected the inexpensive, proven and readily-available therapies for treating viral infections, such as *Ivermectin* and *HCQ*. Instead, he advised President Trump to throw Trillions of dollars at *Big Pharma* to *rush-to-market* what has proved to be an ineffective vaccine with dangerous side-effects. However, the COVID-19 vaccine **HAS** been extremely profitable for the pharmaceuticals, despite its lack of efficacy and dangerous side-effects. Moreover, it was recently revealed that Fauci used \$50 Million from public funds to bribe prominent physicians and health officials into reversing themselves and supporting his lie that COVID-19 was a naturally-occurring virus rather than man-made.

In the hands of corrupt and incompetent officials, **U.S. energy policy** made in Washington has been equally disastrous for most Americans. In his first official act after stealing the presidency, the godfather of the ***Biden Family Crime Syndicate*** arbitrarily, capriciously and unilaterally cancelled the *Keystone XL Pipeline* and prohibited oil and gas exploration on public lands. His Executive Orders also forced the closing of several natural gas pipelines that provide heat for many homes in the Midwest and Northeast. He clearly wants to make petroleum products so expensive that drivers will convert to electric vehicles, of which his administration approves and in which his energy secretary is heavily invested.

As a result, the price of petroleum products has skyrocketed and America's 50-year goal of **energy self-sufficiency** ended with a whimper. (That whimper was Biden begging OPEC and Russia to increase production and lower costs.) While the U.S. had previously become a net energy *exporter* under Trump, it has since become a crude oil importer from unstable areas such as the Middle East and Latin America. Biden's energy policies also raised the price of heating oil, propane and

natural gas for those dependent on these sources of energy to heat their homes in the winter. The Biden Administration's energy policy consists of adopting the most insane, irresponsible, and destructive policies that phony "environmentalists" in the NCPUSA can dream up, even though most couldn't distinguish a BTU from their BUTT !



Centralized power in the federal government has allowed it to impose outrageous "**gender identity**" policies and programs with which the rest of America is expected to comply. Activist federal judges are *champing at the bit* to **expand the definition of "gender"** to create ridiculous new rights for a seemingly endless variety of queers, perverts and pederasts. Unprincipled federal judges appointed by Clinton, Obama, or Biden would love to expand the meaning of "sex" in the **1964 Civil Rights Act** to include every disgusting manifestation of perversion, including "*sexual preference*" and "*gender identification*." Their aim is to appease the kinds of circus freaks who harassed and sued a Christian-owned bakery, to force its owners to bake wedding cakes for homosexual "*marriages*." This insanity has also caused people to lose their jobs when choosing the wrong pronoun to describe some mentally-ill queer.

Many states and localities are afraid to defy these new definitions of "gender" for fear of ending up in federal court with Merrick Garland's ***Department of Injustice*** as the Plaintiff. The fraudulent and ludicrous nature of these new policies surrounding gender have been exposed in many ways, especially where biologically-male "transgender" are permitted to compete in "women's" athletic competitions, where they usually dominate their biologically-female opponents. This does a grave disservice to women and girls who have trained much of their lives to compete in their events. It is the fear of **civil litigation or criminal charges** under the ***Civil Rights Act*** that silence those who might otherwise stand against ludicrous and non-traditional definitions of gender.

Similarly, Article 1, Section 4 of the Constitution authorizes individual states to set the "***Times, Places and Manner of Holding Elections.***" Yet, through federal legislation, the NCPUSA intends to federalize the very techniques it used to steal the 2020 Presidential Election. The NCPUSA is intent on enacting a bill that end-runs the Constitutional authority of state legislators by centralizing **state voting requirements** with federal legislation from Washington. Their fraudulently labeled bill was originally titled the ***For the People Act***, which was passed by the NCPUSA-

controlled House in March of 2021. It was later renamed the ***John Lewis Voting Rights Advancement Act***, and is an example of the dangers and treachery that result from allowing Washington to centralize election laws by usurping state authority.



If enacted, this legislation guarantees that the massive voter fraud -- and the endless confusion and delays following the 2020 Presidential Election -- would become a **permanent feature of U.S. elections**. It would ensure that U.S. elections mirror those in *Banana Republics* or sub-Saharan Africa: It permits **same-day voter registration**, so registrants can't be properly vetted; It expands the practice of **mass-mailed Absentee Ballots** that created so much fraud and delay in 2020; It **prohibits states from requiring any ID** other than a signature; It allows **felons to vote from prison**; It explicitly permits "**vote harvesting**"; It **prohibits sharing data bases** between states, so dead or living "*Democrats*" can vote from multiple locales; And it permits **on-line voter registration**, so no paper trail exists for verification.

Finally, in 2012, the Supreme Court ruled in ***U.S. v. Arizona*** that the federal government has **sole authority** to carry out U.S. immigration policy, even where it willfully neglects its responsibility for enforcement.

Yet, Article IV, Section 4 of the **U.S. Constitution** states: "**The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion...**" This provision of the Constitution was conveniently ignored by the Supreme Court in **U.S. v. Arizona**, and its result has been the 12,000,000 illegal aliens who have crossed our southern border since January of 2021. Meanwhile, the Biden Administration played *Welcome Wagon* by encouraging even more to come here, legally or otherwise.

A reasonable approach to decentralizing immigration policy would be for the Supreme Court to reconsider **U.S. v. Arizona**. Alternatively, a new and honorable Congress might enact a federal statute granting every state coextensive and **parallel authority** to enforce existing immigration laws, so long as they don't conflict with federal law. This was the *status quo* before **U.S. v. Arizona**. The Supreme Court sometimes acts rashly

when there is no guidance from other branches, and such a law might well persuade the Court to modify the erroneous decision in ***U.S. v. Arizona***, and allow states to enforce federal immigration laws, so long as their actions complement federal laws.

Rick Grenell -- President Trump's *Ambassador to Germany* and one-time ***Acting Director of National Intelligence*** -- recently revived the decades-old debate surrounding the question *why must all federal agencies be located in Washington, D.C.?* **Distributing some federal agencies** throughout *real* America might have a profoundly beneficial effect on the perspective of cabinet members and their subordinates. It would certainly help to decentralize decision-making by the federal government, and move several federal bureaucracies away from the corrupting influences of both K-Street lobbyists and the ***WASHINGTON POST***.

There doesn't seem to be any good reason why the ***Department of Agriculture*** can't be located in Iowa. Likewise, why can't the ***Interior Department*** be located in Utah? If you want honest federal juries that will convict criminals -- but won't convict innocent citizens on dubious charges -- why not move the ***Justice Department*** to Tyler, Texas? Moreover, the ***Energy Department*** would be safer in West Texas than in the DC cesspool, just as it would make more sense to move the ***Transportation Department*** to Florida. If it isn't abolished, the ***Education Department*** should be moved to Barrow, Alaska.

The Ninth and Tenth Amendments exist for a reason: The greatest fear of the Framers was that a centralized governmental authority would become too powerful and tyrannical. To a man, they would be aghast at the extent to which Washington has accumulated power and authority beyond even their wildest and most skeptical imaginings. They would also be ashamed at the rest of us for permitting such a malignancy to grow, a grotesque and inexcusable abdication of our civic responsibilities.
