

# Fake News Treason

In the late 1940s, the *House Committee on Unamerican Activities* (HUAC) exposed several communist spies within the upper-echelons of the federal government's *Treasury* and *State Departments*. The committee's successes were followed in the early 1950s by Joe McCarthy's *Senate Permanent Subcommittee on Investigations*. These Congressional investigators faced two obstacles that frustrated their ability to effectively warn American citizens of the treason taking place within their own federal government.

One obstacle was the natural skepticism of many Americans who could not believe other Americans would spy for our mortal enemy and harm America in doing so. We had it too good: Americans enjoyed far greater freedom and prosperity than the citizens of any other nation, particularly those residing anywhere in the USSR or the *Soviet Bloc*. For many, it was incomprehensible that *any* American citizen could possibly prefer the Soviet system to that of our own.

A second problem was the competing narratives originating among some of America's most prominent news sources in those days. In addition to criticism from Edward R. Murrow, Senator Joe McCarthy (R-WI) was routinely vilified by Drew Pearson, a highly influential syndicated columnist of that era. Only decades later would it be exposed by academic researchers exploring the *Archives of the Soviet Union* that Pearson's two most trusted researchers were themselves, Soviet spies. Thus, many Americans were deliberately misled about the extent of Soviet penetration of our federal government by the USSR's own "**agents of influence,**" posing as American journalists and using Drew Pearson as their voice.

Fortunately, after 12 years of Obama and Biden, most Americans now find it undeniable that our federal government is swamped with traitors, many of whom are rabidly hostile to democratic institutions and pluralism. The latter have substituted euphemisms like "*New World Order*" for the utopian visions of Marxism, but it's the same ideology, nonetheless. Meanwhile, most Americans have experienced a similar *epiphany* when it comes to the believability of the fake news industry, whose relentless efforts to run interference for the "*deep state*" rarely consist of anything but disinformation.

David Karr was the more influential of the two Soviet agents hired by Drew Pearson. McCarthy once called him "*Drew Pearson's KGB controller,*" which wasn't too far from the truth. After enduring persistent attacks by Pearson, out of frustration, McCarthy read into the *Congressional Record* the testimony of Howard Rushmore, a former CPUSA member and former editor of the CPUSA's official publication, the *DAILY WORKER*. Rushmore testified that Karr was a CPUSA member who wrote for the *DAILY WORKER* and other communist publications such as *FIGHT*. Evidence of Karr's espionage activities were found in the Soviet

Archives, indicating Karr regularly provided sensitive information to Soviet intelligence agencies. There is also at least one documented instance of Karr providing classified information to a Soviet NKVD Agent named Samuel Krafzur, whose Soviet code-name was "*Ide*."

Likewise, Walter Duranty was the Moscow correspondent for the **NEW YORK TIMES** during the 1930s. He is best remembered for his glowing dispatches praising Stalin's brave new experiment in governance. Somehow, he overlooked the 10 million Ukrainian farmers that Stalin intentionally murdered during the winter of 1932 -- 1933 by seizing their entire agricultural output during the *Holodomor*, (which translates as "*death by starvation*.") Duranty also conveniently managed to miss the Moscow "*show trials*" of 1936 through 1938, in which Stalin eliminated his political opposition. In return for his loyalty, Duranty was given a large *dacha* and official passes to the food stores and retail outlets normally reserved for the Soviet *Nomenklatura*. Naturally, he was rewarded with a *Pulitzer Prize* for his unique "*reportage*."

Similarly, Herbert Matthews was the Havana correspondent for the **NEW YORK TIMES** following the Cuban Revolution of 1959 that brought Castro

to power. Like Duranty before him, he lied religiously to depict Castro as a great and heroic reformer, and worked diligently to encourage the U.S. government to recognize Communist Cuba and renew diplomatic relations with Castro. The persistent volleys from Castro's seemingly endless **firing squads** did not trouble Matthews in the least, because under Marxist Theory, anything that works to advance the revolution is, by definition, advancing history and the truth. Castro lavishly eulogized Matthews when he eventually achieved room temperature.

The phenomenon of ideological bias within the fake news industry has been a persistent pattern for decades. However, their betrayal doesn't consist exclusively of the **narratives they fabricate** to promote their ideological comrades, as in the cases of Walter Duranty and Herbert Matthews. Nor is it merely their disinformation efforts -- like those of David Karr -- intended to **libel and slander** those investigating their fellow Marxists. Of equal importance are the news stories they **conspire to censor** by refusing to investigate or report them, as if they never happened. This phenomenon occurs when a particular news story is damaging to their Marxist allies, and especially so when damaging to some prominent member of the misnamed "*Democrat*" Party.

The vile traitors who work to advance the same cause as Karr, Duranty and Matthews are now ubiquitous among the fake news media and can be found this very day at the *Ashkenazy Broadcasting Corporation*, (**ABC**), the *Nigro Broadcasting Corporation* (**NBC**), *National Prevarication Radio* (**NPR**), the *Communist Broadcasting System* (**CBS**), and the *Proletariat Broadcasting System* (**PBS**.) They are also found among the *Mindless Squads of Nigro and Bolshevik Communists* (**MS-NBC**), and **CNN**, the *Communist News Network*. They are equally common among the Pharisees of the *NEW YORK SLIMES* and the *WASHINGTON COMPOST*.

For decades, each has proved perfectly comfortable perpetuating treasonous lies that damage their enemies, like the "*Russia Collusion*" and "*election interference*" charges levelled against Trump. With equal ideological discipline, they *spiked* the Hunter Biden laptop scandal immediately prior to the 2020 election and for years afterwards. They also refused to investigate the dubious nature of Barack Hussein Obama's Constitutional eligibility. And, they now cheerlead for the prosecutors in Trump's *show trials* -- based on fraudulent charges, as always -- taking place in hostile venues controlled by the NCPUSA. The ideology hasn't changed, but their names and faces have.

Just prior to the presidential election of 2020 -- every fake news organ in the U.S. "*spiked*" the evidence found in Hunter Biden's laptop and dismissed it as "*Russian disinformation*." None bothered to fact-check its contents to justify their actions, which were readily available in the *NEW YORK POST*, an honest newspaper and not part of their cabal. collaborated in this treasonous conspiracy. The contacts who handed them the *Steele Dossier* to publish were all well-known Hillary Clinton bagmen: one was a **State Department** subordinate of Hillary Clinton's named Jonathon Winer, and the other was Clinton lawyer Michael Sussman. All these fake news "*journalists*" willingly participated in what turned out to be a treasonous criminal conspiracy to destroy a duly-elected president, who has since been demonstrably and conclusively vindicated and exonerated of **EVERY** charge levelled against him.

Finally, the fake news industry has made it a habit to "*fact-check*" practically every statement Trump happens to utter.
