

Not *Revenge* !

Moreover, although it received scant attention from the Jews' Media, thanks to the tireless efforts of Special Counsel John Durham, it was eventually revealed in February of 2022 that **Hillary Clinton's Spy Network** illegally intercepted Donald Trump's e-mail when he was a candidate, and then later **WHILE PRESIDENT**. She recruited and paid a team of computer experts from **Georgia Tech** and a company called **Neustar** to intercept Trump's e-mails to-and-from *Trump Tower* in 2016, and later to-and-from the Oval Office while he served as president.

America's first nigra, communist, Moslem and probably homosexual president -- **Barack Hussein Obama** -- condoned and coordinated the treasonous "soft coup" against Donald Trump during his presidency called "**Crossfire-Hurricane.**" It consisted of corrupt holdovers from Obama's FBI and DOJ who lied to four **FISA Court** Judges to obtain warrants to spy on Trump. He **weaponized** the FBI and DOJ to spy on parents angered by their local school boards, as well as *Traditionalist Catholics* who prefer the Latin Mass. Trump supporters were set up by House Speaker **Nancy Pelosi**, the *Capitol Hill Police*, and Washington's niggress Mayor, **Muriel Bowser**. Prior to January 6th, outgoing President Donald Trump had offered 10,000 National Guardsmen to both Pelosi and Bowser to ensure a peaceful demonstration on January 6th, but both "*Democrats*" rejected his offer.

Although Pelosi lied for three years by denying Trump had made the offer of the National Guard, a conversation recorded by her niece's smart phone eventually surfaced in which she basically admits to rejecting Trump's offer.

A host of **FBI and DOJ conspirators** from the Obama Administration **perjured themselves** before four FISA courts to obtain warrants to spy on Donald Trump and several of his advisors from 2015 until 2018. At first, they were hoping to find some misdeed that Hillary Clinton could use against Trump in her 2016 campaign for president, but found none. An FBI lawyer even **altered a CIA e-mail** to allow continued FBI surveillance of Trump advisor Carter Page. This enabled these

treasonous conspirators in the DOJ and FBI -- participating in what they called operation "**Crossfire-Hurricane**" -- to continue their surveillance and wiretapping of Trump, both before and after Trump's election. Their plan was to destroy Trump by entrapping advisors like Page, and forcing them to give false testimony against Trump to save themselves from prosecution for supposed "*misdeeds*" they didn't even commit.

Finally, the **Antifa and BLM riots** of 2020 were carefully staged to take place in large cities controlled by "*Democrats.*" There, political authorities could safely order police to "*stand down,*" even as rioters engaged in **arson, murder and aggravated assault** against innocent civilians and law enforcement.
